QUESTION OF ANTARCTICA

## Report of the Secretary-General

1. On 30 November 1987, the General Assembly edopted resolution 42/46 B on the question of Antarctica.

2. While reaffirming, inter alia, that any eventual minerals régime on Antarctica should take fully into account the interests of the international community, the General Assembly, in paragraph 3 of the rerolution called upon the Antarctic Treaty Concultrive Pettier 1/ to impose a moratorium on the negotiations to establish a minerals régime until all members of the international community could participate fully in such negotiations.

3, On 30 June 1988, the Secretary-General received a letter from the Chargé d'affaires a.i. of the Permanent Mission of Australia to the United Nations conveying a statement of Mr, C. D. Beeby, Chairman of the Antarctic Treaty Special Concultstive statement of Australia Resources, regarding the adoption on 2 June 1988 of a Convention on the regulation of mineral resource activities in Antarctica, The letter and the statement attached to it were circulated as an official document of the Goneral Assembly (A/43/434),

4. On 18 August 1988, the Secretary-General received a letter from the Chargé d'affaires a.i. of the Permnnont Mission of New Zealand to the United Nations conveying an authenticated copy of the Final Act of the Fourth Antarctic Treaty Special Consultative Meeting on Antarctic Mineral Resources.

5, On 8 June 1988, the Secretary-General received A letter from the Chargé d'affaires a.i. of the Permanent Mission of Malaysia to the United Nations on

behalf of the representative of Antigua rnd Barbuda, Bangladesh, Brunei Darussalam, Cameroon, the Congo, Ghana, Indonesia, Kenya, Malaysia, Nepal, Nigeria, Oman, Pakirtan, Rwanda, Sri Lanka, the Sudan, Uganda, Zambia end Zimbabwe, This letter expressed the utmoet regret and deep concern about the adoption of the aforementioned Convention, The letter was circulated as an official document of the General Assembly (A/43/396).

6. In its resolution 42/46 B, the General Assembly also called upon the Antarctic Treaty Consultative Parties to invite the Secretary-General or his representative to all meetings of the Treaty parties, including their consultative meetings and the minerals régime negotiationa, and requested the Secretary-General to submit a report on him evaluations thereon to the Assembly at its forty-third session.

7. The Secretary-General was not in receipt of an invitation to n vetings of the Antarctic Treaty Consultative Parties, and therefore is not in a position to provide any evaluations thereon,
