# IMPLEMENTATION OF THE DECLARATION ON THE DENUCLEARIZATION OF AFRICA

## Nuclear capability of South Africa

### Report of the Secretary-General

#### INTRODUCTION

1. On 7 December 1988, the General Assembly adopted resolution 43/71 El, the operative part of which reads as follows:

"The General Assembly,

- "...
- "1. Takes note of the report of the Secretary-General on South Africa's nuclear capability;
- "2. Condemns the maesive'buildup of South Africa's military machine, in particular its frenzied acquisition of nuclear-weapon capability for repressive and aggressive purposes and as an instrument of blackmail;
- "3. Also condemns all forms of nuclear collaboration by any State, corporation, institution or individual with the recist régime of South Africa, in particular the decision by some Member States to grant licences to several corporations in their territories to provide equipment and technical and maintenance services for nuclear installations in South Africa;
- "4. Reaffirms that the acquisition of nuclear-weapon capability by the racist régime constitutes a very grave danger to international peace and security and, in particular, jeopardises the security of African States and increases the danger of the proliferation of nuclear weapons;

- "5. Expresses its full support for the African States faced with the danger of South Africa's nuclear capability;
- "6. <u>Commends</u> the actions taken by those Governments which have taken measures to restrict co-operation with South Africa in nuclear and other fields;
- "7, <u>Demands</u> that South Africa and all other foreign interests put an immediate end to the exploration for and exploitation of uranium resources in Namibia;
- "8. Calls upon all States, corporations, institutions and individuals to terminate forthwith all forms of military and nuclear collaboration with the racist régime;
- "9. Requests the Disarmament Commission to consider once again as a matter of priority during its substantive session in 1989 South Africa's nuclear capability, taking into account, inter alia, the findings of the report of the United Nations Institute for Disarmament Research on South Africa's nuclear capability;
- "10. Requests the Secretary-Qeneral to provide all necessary assistance that the Organization of African Unity may seek regarding the moderaties and elements for the preparation and implementation of the relevant convention or treaty on the denuclearization of Africa;
- "11. Commends the adoption by the Security Council of resolutions
  55% (1984) of 13 December 1984 and 591 (1986) of 28 November 1986 on the
  question of South Africa, with a view to blocking the existing loopholes in
  the arms embargo so as to render it more effective and prohabiling, in
  particular, all forms of co-operation and collaboration with the racist régime
  of South Africa in the nuclear field:
- "12. <u>Demands once again</u> that South Africa submit forthwith all its nuclear installations and facilities to inspection by the International Atomic Energy Agency J
- "13. Requests the Secretary-General to follow very Closely South Africa's evolution in the nuclear field and to report thereon to the General Assembly at its forty-fourth session, "
- 2. Pursuant to paragraph 13 of the resolution, the Secretary-Qeneral has continued to follow very closely South Africa's evolution in the nuclear field. In order to obtain information that would be of assistance in the preparation of his report he has, inter alia, been in contact with the International Atomic Energy Agency (IAEA) and the Organization of African Unity.

- 3. In response to the inquiry of the Secretary-Qoneral, the Director General of the International Atomia Energy Agency has informed him that at its thirty-third regular session, which ended on 29 September 1989, the General Conference of the Agency adopted a resolution concerning South Africa's nuclear capabilities (GC(XXXIII)/RES/524), which is submitted herewith (see annex),
- 4. Should the Secretary-General receive any further information on the subject, he will bring it to the attention of the General Assembly without delay.

#### **ANNEX**

Resolution on South Africa's nuclear capabilities adopted by the General Conference of the International Atomic Energy Agency ac its 322nd plenary meeting, on 29 September 1989 (GC(XXXIII)/RES/524)

### The General Conference,

- (a) Recalling the recommendation of the Bosrd of Governors to suspend South Africa from the exercise of the privileges and rights of membership of the Agency as contained in its report GC(XXXI)/807 pursuant to General Conference resolution GC(XXX)/RES/468,
- (b) Stressing that, despite the requests of the General Conference and the international community, South Africa has persistently violated international law as well as the purposes and principles of the United Nations, upon which the Agency's activities are based in accordance with Articles III.B.1 and IV.B of the Statute,
- (c) Also stressing that the acquisition of a nuclear weapons capability by the racist régime of South Africa constitutes a very grave danger to international peace and security, and in particular jeopardizes the security of African States and increases the danger of the proliferation of nuclear weapons, and
- (d) Equally recalling the resolve of the General Conference to take a decision on the suspension of South Africa expressed in General Conference resolution GC(XXXII)/RES/503 in accordance with Article XIX.B of the Statute,
- 1. <u>Vehemently condemns</u> South Africa for its persistent refusal to comply with successive resolutions of the United Nations General Assembly and the General Conference of the Agency, as well as its refusal to adhere to the principles and purposes of the United Nations Charter and the Statute of the Agency;
- 2. Resolves to consider and take a decision on the recommendation of the Board of Governors contained in its report GC(XXXI)/807 to suspend South Africa from the exercise of the privileges and rights of membership of the Agency in accordance with Article XIX.B of the Statute at the Conference's thirty-fourth regular session;
- 3. Requests the Director General to continue to take all possible measure8 to ensure the full implementation of resolution GC(XXX)/RES/468 and to report to the General Conference at its thirty-fourth regular session in this regard;
- 4. Further requests the Director General to bring this resolution to the attention of the Secretary-General Of the United Nations; and
- 5. <u>Decides</u> to include in the agenda for itS thirty-fourth regular session an item entitled "South Africa's nuclear capabilities".
