Reaffirming the views set forth in their previous communications of 15 June, 9 and 11 July, 21 and 26 November 1990 and 9 and 26 May 1991, the

members of the Permanent *Commission* for the South Pacific reiterate *their* categorical opposition **and strong** objection to the conduct of nuclear tests by France in view of the **dangerous** consequences which the dumping of radio active waste has for the marine **environment** and marine resources, and they demand the **immediate and** permanent cessation of such tests,

ANNEX

Statement by the Permanent Commission for the South Pacific
issued at Santiago on 31 May 1991

According to reports in the media on 29 May 1991 France conducted its third nuclear-test explosion in the Pacific basin since its renewal of such tests on 7 May 1991. The test was conducted at Fangataufa atoll, with a yield far higher than those of the two previous explosions.

In response to this development, the secretariat of the Permanent Commission for the South Pacific is constrained to restate its categorical opposition and strong objection to the conduct of such disquieting tests, and to make a firm demand for the immediate and permanent cessation of such testing. This is done in accordance with the secretariat's previous statements on behalf of the member States of this regional maritime organization issued on 9 and 28 May 1991 in connection with previous tests, further to their common policy for the defense and protection of the marine environment and in the discharge of the mandate conferred upon it by both the Ministers for Foreign Affairs of the member States and the meetings of the Permanent Commission.
