#### ANNEX

### Letter dated 23 July 1991 from the Minister for Foreign Affairs of Peru addressed to the Secretary-General

The end of the cold war, the 1997 Treaty on the Elimination of Intermediate-Range and Shorter-Range Missiles, the conclusion of the Strategic Arms Reduction Treaty (START), the American-Soviet Agreement on Destruction and Non-Production of Chemical Weapons, the progress made at Geneva towards the adoption of a Convention on the Universal Prohibition of Chemical Weapons, the recent Treaty on Conventional Armed Forces in Europe and the Charter of Paris of the Conference on Security and Cooperation in Europe have created an international climate without precedent since the creation of the United Nations for strengthening international peace and security.

To this we must add President Bush's recent initiative to control transfers of weapons of mass destruction to the Middle East, **Fresident** Mitterrand's disarmament plan, the Paris meeting of the five permanent members of the Security Council to control sales of conventional weapons, and the recent agreement at the London summit meeting of the Group of Seven to establish a register of arms transfers and arms sales under United Nations auspices.

In view of these positive developments in the areas of disarmament, arms control and confidence-building and security measures, President **Alberto** Fujimori, on the occasion of the first Ibero-American Summit, said that the time had come to tackle the issue of Latin American disarmament both in theory and in practice. To this end, he proposed a regional disarmament policy based on arms limitation and on the **use** of the resources thus released to promote the region's economic and social development, **in** the framework of a new concept of **defence wimed** at preserving the stability of legitimately constituted Governments **in** the face of internal threats such as drug trafficking and terrorism which have assumed regional dimensions.

Accordingly, the Government of Peru has invited the Foreign Ministers of the Rio Group to attend a **special** meeting at Lima, at which agreement would be reached on jointly renouncing all kinds of weapons of mass destruction, particularly nuclear, chemical and biological weapons.

The meeting would also reach agreement on prohibiting the future purchase, transfer and manufacture of new generations **of** advanced conventional weapons **systems**, principally medium- and short-range ballistic missiles, fuel air explosives, laser-guided bombs and munitions, multiple launch rocket **systems**, anti-radar missiles and mini-conductors, nuclear-powered submarines and Stealth technologies.

The Lima meeting would also seek to reach agreement on security, confidence-building and transparency measures between the democracies of the Rio Group countries, such as increased contacts between military high commands, reduced'levels of troops and offensive weapons in border **areas**, reciprocal notification **of** military manoeuvres, invitations to observe military manoeuvres, visits to military installations and the creation **of** a centre for the registration of **arms** transfers and **arms** production in our countries.

I am sure you will agree that the Lima meeting will serve to strengthen security, development and democracy in Latin America and to project an image of the Rio Group's interest in and contribution to the process of peace and security that is under way in the world, I should therefore like to request that you convey the above information to the States Members of the United Nations.
