THE FINANCIAL SITUATION OF THE UNITED NATIONS

Report of the Secretary-General

1. The present report, based on the data available as at 15 July 1992, is issued to update the information previously provided to Member States on the financial situation of the United Nations (A/46/600 and Add.1 and 2).
2. Current disbursements from the regular budget amount approximately to \$90 million per month. By the end of July, it is expected that the cash available will be slightly above \$20 million. Assuming that the major contributor will pay all or a very large portion of its assessment for 1992 in October, this "surplus" will turn into a deficit in August and September and again in November and December. The projected deficit in September will be roughly the equivalent of a monthly expenditure.
3. By mid-July, of the 163 Member States subject to assessments in 1992, only 52 had paid in full their dues to the regular budget of the United Nations. Unpaid assessed contributions totalled \$908.5 million. Annex I provides detailed information on the status of contributions to the regular budget, and annex II lists the Member States that have paid their assessments in full.
4. For the period from 1 July to 31 December 1992, monthly expenditures for all peace-keeping operations, within current mandates, shall amount to approximately \$220 million. While unpaid contributions to peace-keeping operations remain high - \$844.4 million - current projections suggest that sufficient cash might be available to meet the requirements of these operations through mid-October. These projections assume a slightly improved pattern of payments for new peace-keeping operations within the first three months of their assessments.
5. Considering regular budget and peace-keeping operations together, for both receipts and disbursements, an overall deficit of approximately

\$55 million will occur in November and reach \$81 million by the end of December. At that time, it will not be possible to effect short-term loans from peace-keeping operations to the regular budget. Without an immediate inflow of cash, the Organization would have to cease its operations.

6. Annex III provides a listing in order of magnitude of the outstanding contributions from Member States for both the regular budget and the peace-keeping operations financed by assessed contributions. Overall, unpaid assessed contributions amounted to \$1,752.9 million by mid-July. This represented a marginal improvement from the situation at the end of April when such outstanding contributions totalled \$1,898.7 million.

7. It will be recalled that the Secretary-General put forward in an earlier report (A/46/600/Add.1) certain proposals designed to provide financial stability and to build a significantly stronger financial base for the Organization. It will also be recalled that in a report on preventive diplomacy, peacemaking and peace-keeping, entitled "An Agenda for Peace" (A/47/277), the Secretary-General made further recommendations regarding the financing of United Nations activities. These proposals aim at improving the financial situation of the Organization in the medium and long term. They would have no immediate effect on the cash situation for the second half of 1992 as briefly described above.
