I. Organizational matters

A. Membership

1. The General Assembly, in its resolution 43/222 B of 21 December 1988, decided to retain the Committee on Conferences as a permanent subsidiary organ. Pursuant to the provisions of that resolution, in 2001 the Committee was composed of the following Member States: Algeria, Argentina, Austria, Benin, Chile, Equatorial Guinea, Finland, France, Jamaica, Japan, Jordan, Kenya, Kyrgyzstan, Lithuania, Namibia, Nepal, Peru, Philippines, Russian Federation, Sierra Leone and the United States of America.

B. Officers

2. The Committee held its organizational session for 2001 on 19 April and 22 June 2001 (434th and 435th meetings). At its 434th meeting, on 19 April, the Committee elected the following officers to serve in 2001:

3. At the same meeting, the Committee agreed in principle that the Chairman would undertake informal consultations with a view to determining the composition of its Bureau in 2002.

C. Organization of work

4. At its 434th meeting, on 19 April, the Committee agreed to follow the guidelines adopted in 1994 and 1995 with regard to consideration of inter-sessional departures from the approved calendar of conferences and to meet as required to review proposals affecting the schedule of conferences and meetings during sessions of the General Assembly.

5. At its 435th meeting, on 22 June, the Committee, after reviewing the draft biennial calendar of

conferences and meetings of subsidiary organs of the Economic and Social Council for 2002-2003, recommended the adoption of the draft calendar and agreed to bring its comments to the attention of the President of the Council.

6. The Committee convened its substantive session from 27 to 29 August 2001 (436th to 441st meetings).

7. The Under-Secretary-General for General Assembly Affairs and Conference Services addressed the Committee at the opening of its organizational and substantive sessions.

D. Programme of work

8. At its organizational session for 2000, the Committee had requested the Secretariat to submit a draft agenda for 2001 at its organizational session for 2001. At its 434th meeting, on 19 April, the Committee adopted the proposed agenda (A/AC.172/2001/L.1). At the same meeting, the Committee requested the Secretariat to submit a draft agenda for 2002 at the organizational session for 2002.

E. Participation of observers

9. The following States Members of the United Nations were represented as observers: Bahamas, Belgium, Botswana, India, Morocco, Portugal, the Republic of Korea, the Syrian Arab Republic, Uganda and the United Kingdom of Great Britain and Northern Ireland. Switzerland was also represented as an observer.

10. At its 440th meeting, on 29 August 2001, the Committee reconsidered the procedure regarding the participation of observers in its work adopted at its 423rd meeting, on 1 September 1999, as set forth in paragraph 172 of the report of the Committee on Conferences for 1999.¹ In view of the valuable contribution of observers to the work of the Committee, subparagraph (c) of paragraph 172 was amended to read as follows:

“(c) The observer would be allowed to make one statement on each item on the agenda of the Committee. In addition, the observer would be allowed an opportunity to make a follow-up comment subsequent to receipt of clarifications sought from the Secretariat. The length of

statements by the observer would be limited in accordance with the practices normally followed for the organization of special sessions of the General Assembly".

11. The Committee decided to keep the procedure on the participation of observers under review.

F. Work of the Committee during the main part of the fifty-fifth session of the General Assembly, from 11 September to 23 December 2000

12. The Committee was seized of the request and took the action set out below.

Organ: Special Committee on Peacekeeping Operations

Request: To convene five meetings of the Committee and its working group at the end of October 2000 prior to the meetings of the Special Political and Decolonization Committee. The meetings were envisaged as the result of the issuance of the report of the Panel on United Nations Peace Operations and the report on the implementation of the recommendations of the Panel.

Action taken: The Committee and its working group were added to the list of bodies recommended for authorization by the General Assembly to meet during the main part of the fifty-fifth session.

II. Calendar of conferences and meetings

A. Matters related to and inter-sessional departures from the approved calendar for 2001

13. The General Assembly, in its resolution 55/222 of 23 December 2000, approved the revised calendar of conferences and meetings of the United Nations for 2001 as submitted by the Committee on Conferences and amended by subsequent decisions taken by the

Assembly at its fifty-fifth session. The approved calendar was issued as document A/AC.172/2001/2.

14. At its 373rd meeting, on 26 August 1994, the Committee had decided that requests for inter-sessional departures submitted to the Committee should in future be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.

15. At its 379th meeting, on 23 March 1995, the Committee had agreed that proposed changes to the calendar that did not have programme budget implications could be dealt with by the Secretariat, in consultation with the Bureau of the Committee.

16. At its substantive session of 1995, the Committee had decided that requests for inter-sessional departures submitted to the Committee that involved a change of venue should be referred to the members for approval. Departures that involved other types of changes, as the Committee had decided at its substantive session of 1994, should be reviewed by the Bureau, in consultation with the Secretariat, for subsequent action.

17. The requests submitted in 2001 for changes of venue or additional sessions and the action taken by the Committee are shown below.

Organ: International Civil Service Commission

Request: To convene its fifty-third session from 11 to 29 June 2001 in Montreal rather than New York, upon the invitation of the International Civil Aviation Organization to host the session at its headquarters in Montreal. Section I, paragraph 4 (g), of General Assembly resolution 40/243 of 18 December 1985 provides that, if more than one session is required in any one year, the Commission may accept an invitation from one of its participating organizations to hold its other session at the headquarters of that organization. For 2001, the Commission had decided to hold a single joint session of three weeks in Montreal instead of two sessions of two weeks each, and a focus group meeting in New York from 29 January to 2 February 2001, in lieu of the formal spring session.

Action taken: Request approved.

<i>Request:</i>	To convene the second session of the Committee for five days in February 2001 in New York instead of Geneva, pursuant to a decision related to General Assembly resolution 55/214.	
<i>Action taken:</i>	Request approved.	
<i>Organ:</i>	Ad Hoc Group of Experts on International Cooperation in Tax Matters	
<i>Request:</i>	To convene the tenth meeting of the Group of Experts in Geneva from 10 to 14 September rather than from 23 to 27 April 2001 in New York, pursuant to Economic and Social Council decision 2001. The meetings of the Group of Experts are regularly convened in Geneva rather than New York for reasons of convenience and cost-effectiveness since most of the Group's members and observers are based in Geneva, thus enabling larger participation at a lower cost.	
<i>Action taken:</i>	Request approved.	
<i>Organ:</i>	Commission for Social Development acting as the preparatory committee for the Second World Assembly on Ageing	
<i>Request:</i>	To convene a resumed session of the Commission acting as preparatory committee on 30 April and 1 May and for one week, from 10 to 14 December 2001, to complete the work of its first session.	
<i>Action taken:</i>	Request of 30 April to 1 May approved.	
<i>Organ:</i>	Commission on the Status of Women	
<i>Request:</i>	To convene a resumed session of the Commission from 9 to 11 May 2001 in order to complete the work of its forty-fifth session on two major issues: (a) agreed conclusions on the	
<i>Action taken:</i>	Request approved.	
<i>Organ:</i>	Advisory Board on Disarmament Matters	
<i>Request:</i>	To convene the thirty-seventh session of the Board from 25 to 27 July 2001 in Geneva rather than New York in order to give members an opportunity to confer with participants in the Conference on Disarmament. Moreover, since the Board also serves as the Board of Trustees of the United Nations Institute for Disarmament Research, the Geneva venue permits Board members to be in close contact with the staff of the Institute.	
<i>Action taken:</i>	Request approved.	
<i>Organ:</i>	Meeting of Government Experts of Landlocked and Transit Developing Countries and Representatives of Donor Countries and Financial and Development Institutions	
<i>Request:</i>	To convene the fifth session of the Meeting of Government Experts from 30 July to 3 August 2001 in New York rather than Geneva because, while few landlocked developing countries have permanent missions in Geneva, they all have missions in New York. Therefore, the only way to ensure the effective participation of landlocked developing countries in the above meeting is to hold it in New York.	
<i>Action taken:</i>	Request approved.	

Organ: The Commission on Human Rights acting as the preparatory committee for the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance

Request: To convene a third session of the Commission acting as preparatory committee in Geneva from 30 July to 10 August 2001 to continue the negotiations and drafting of the Declaration and Programme of Action of the Conference initiated at its second session.

Action taken: Request approved.

Organ: Committee on Information

Request: To convene a resumed session of the Committee for three days, from 5 to 7 September 2001, because the Committee had requested the Secretary-General to submit to it a final report on the results of the pilot project on the development of an international radio broadcasting capacity for the United Nations by August 2001, and had expressed its intention to take a final decision on the mandate and allocation of the necessary resources for the establishment of a permanent international radio broadcasting capacity for the United Nations during the main part of the fifty-sixth session of the General Assembly. The one-year pilot project began on 30 August 2000.

Action taken: Request approved.

B. Adoption of the draft calendar of conferences and meetings for 2002-2003

Introduction and overview

18. At its 437th meeting, on 27 August 2001, the Committee on Conferences reviewed the draft calendar of conferences and meetings for 2002-2003 (A/AC.172/2001/CRP.2 and Add.1).

19. The Committee also heard an introduction on the matter by the representatives of the Secretariat and considered graphs showing the peak meeting periods at the New York, Geneva and Vienna duty stations for 2000 and 2001.

Discussion

20. Interest was expressed in seeing similar graphs for the regional commissions and it was requested that further information on simultaneous peak periods at the various duty stations be provided in future reports.

Conclusions and recommendations

21. The Committee recommended that the General Assembly:

(a) Adopt the draft calendar of conferences and meetings for 2002-2003, taking into account the observations of the Committee;

(b) Authorize the Committee to make any adjustments to the calendar of conferences and meetings for 2002-2003 that might become necessary as a result of actions and decisions taken by the General Assembly at its fifty-sixth session.

22. The Committee noted with satisfaction that, in drafting the 2002-2003 calendar of conferences, the Secretariat had taken into account the arrangements referred to in General Assembly resolutions 54/248 and 55/222 concerning Orthodox Good Friday on 3 May 2002 and 25 April 2003.

23. The Committee recommended that, when planning the calendar of conferences and meetings, every effort should be made to avoid simultaneous peak periods at the various duty stations and welcomed the efforts that were being made to promote more effective coordination with a view to achieving that objective.

C. Improved utilization of conference-servicing resources and facilities

1. Meeting statistics of United Nations organs; limiting meeting duration

Introduction and overview

24. At its 436th meeting, on 27 August 2001, the Committee on Conferences reviewed the report of the Secretary-General containing the meeting statistics of a core sample of bodies that had met in New York, Geneva, Vienna and Nairobi in 2000 (A/AC.172/2001/3). The data included the planning accuracy factor, the meeting ratio and utilization factor and indices for assessing compliance with the deadlines for the submission of pre-session documentation and availability of such documentation for bodies based in those locations.

25. The Committee also considered the note by the Secretariat (A/AC.172/2001/CRP.6) containing statistical information on and analysis of extended meetings and sessions and presenting proposals aimed at limiting meeting duration. In introducing the note, the representative of the Secretariat emphasized that the document was meant to initiate discussion on the subject with the aim of formulating guidelines to limit meeting duration.

Discussion

26. The view was expressed that the Secretariat should continue its efforts to sensitize the chairpersons of intergovernmental bodies about the need to utilize the applicable benchmark figure of their allocated resources consistently and to strive for 100 per cent utilization, if possible. The Secretariat should utilize the available performance data to improve the accuracy with which conference resources were allocated to various organs.

27. The view was also expressed that timely issuance of documentation could improve the utilization factor. Attention was drawn to document A/AC.172/1999/CRP.8, containing a note by the Secretariat, which stated that: (a) when all the documents were issued by the opening of the session, an organ was three times more likely to have a high utilization factor of conference services than to have one below the benchmark rating; and (b) additional costs were incurred by document-processing services if

and when overtime and/or additional general temporary assistance were used to compress turnaround time to compensate for late submission.

28. Concern was expressed at the increase in the number of extended meetings and sessions. It was noted that this state of affairs placed an undue burden not only on the Bureau of the Committee and the Secretariat but also on Member States, particularly smaller ones. It was suggested that intergovernmental bodies would be less likely to have recourse to meeting beyond regular hours if they could be made aware of the financial consequences of doing so and that the Secretariat could inform the secretariats of such bodies in advance of the overtime costs involved.

Conclusions and recommendations

29. The Committee again recommended that chairpersons institute time limits for the presentation of standard documents by the Secretariat.

30. The Committee noted with appreciation that the 2000 utilization factor (a) for the four United Nations offices overall had exceeded the benchmark of 80 per cent; (b) for Geneva had increased by 3 percentage points; (c) for Vienna had decreased 5 percentage points, but for Nairobi had increased 16 percentage points to 100 per cent.

31. The Committee noted, moreover, that 62 per cent of the bodies in the sample had utilized 80 per cent or more of their available conference-servicing resources, an increase of 3 percentage points over 1999.

32. The Committee also took note of the information provided in the note by the Secretariat on limiting meeting duration (A/AC.172/2001/CRP.6).

33. The Committee endorsed the guidelines contained in paragraph 10 of document A/AC.172/2001/CRP.6, as amended, and recommended them to the General Assembly for adoption as follows:

(a) Meetings should be held during regular meeting hours, namely, from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m., on working days;

(b) Meetings held beyond regular hours and especially past midnight should be highly

exceptional and limited to organs that have finite closing dates, such as special sessions, conferences and final preparatory meetings for such sessions and conferences, or to when postponing the item is not a viable option because of legislative mandates or other extraordinary imperatives. In these cases, requests to hold meetings beyond regular meeting hours should be formally decided upon by the States members of the body concerned within its allotted meeting time;

(c) Intergovernmental bodies should undertake the review of their meeting patterns and, in coordination with the Department of General Assembly Affairs and Conference Services, adjust their meeting requests for subsequent sessions accordingly;

(d) Requests for the extension of sessions beyond the originally scheduled dates, resumed sessions and other inter-sessional departures would continue to be submitted to the Committee on Conferences and handled in accordance with General Assembly resolution 43/222 B and with past practice as agreed by the Committee (see A/AC.172/2001/CRP.5/Add.1, paras. 2-4).

2. Consultations with/letters to bodies concerning utilization of the conference services available to them

Introduction and overview

34. At its 436th meeting, on 27 August 2001, the Committee on Conferences considered an oral report by the Chairman on consultations with bodies concerning the utilization of the conference services available to them.

35. In keeping with section II, paragraph 1, of General Assembly resolution 55/222, the Chairman of the Committee reported that he had sent letters to 13 intergovernmental bodies that had been identified as having utilized less than the applicable benchmark figure of their allocated resources for the past three sessions, and had held consultations with them. Attention had been drawn to the ways that conference services could be used efficiently, such as eliminating avoidable cancellations of meetings; convening meetings in a timely manner, without a quorum if necessary; scheduling, to the extent possible, informal consultations with interpretation services; cancelling

scheduled meetings in advance, particularly if no delegation expressed a wish to speak, and holding working group meetings in their place; if time remained at the end of a scheduled meeting, considering other items or holding informal consultations; considering releasing unused services for regional or other major groupings of Member States; and making efforts to improve the accuracy with which the number of fully serviced meetings was forecast.

36. A main factor in a low utilization rate was the time lost due to late starting and/or early ending of meetings. While starting on time could to a certain extent be influenced by the clearly stated intentions of the chairperson, early ending was more difficult to avoid. It had been noted that early ending might actually be indicative of efficiency in accomplishing the stated task. Possible alternatives had been discussed with the chairpersons, depending on the specific working methods and the nature of the mandates of the bodies concerned.

37. Some chairpersons had expressed concerns about the way in which the utilization factor was calculated, since it ignored the ultimate goal of the organs, which was to conduct their business successfully.

Discussion

38. The view was generally expressed that late starting could be avoided by an effort of education on the part of the chairperson.

39. With regard to the methodology of calculating the utilization factor, it was pointed out that unrelated reassessments were subtracted from the number of cancelled meetings and thus not counted as wastage by the body concerned. The aim should be to identify underutilizers that did not plan ahead sufficiently to enable conference facilities to be used.

40. The view was expressed that any change in the indices should be carefully considered in order not to encourage the increased use of informal consultations without interpretation, which often resulted in the exclusion of some delegations for language reasons.

41. It was recalled that using conference services flexibly was not always easy to reconcile with the mandate of the given body.

42. It was pointed out that some underutilizers had a long history, extending over many sessions, which

suggested that the problem was a matter of planning rather than chance.

Conclusions and recommendations

43. The Committee noted with appreciation the oral report by the Chairman on the actions taken pursuant to the requests of the General Assembly set forth in section B, paragraphs 6 and 7, of its resolution 54/248 concerning the utilization of conference services, and requested the Chairman to continue to consult on its behalf with the chairpersons of bodies that had consistently utilized less than the applicable benchmark figure of their allocated resources over the past three sessions with a view to making appropriate recommendations in order to achieve the optimum utilization of conference-servicing resources.

44. The Committee also noted the concerns expressed by chairpersons of intergovernmental bodies on the methodology used to calculate the utilization factor and looked forward to receiving a further analysis and review of the indices, including possible benchmark figures for the planning accuracy factor and the meeting ratio, among others, and a measurement of the degree to which unutilized services were reallocated.

3. Improved utilization of conference facilities at the United Nations Office at Nairobi

Introduction and overview

45. The Division of Conference Services was established at Nairobi, effective 1 September 2000, as an organizational unit of the Department of General Assembly Affairs and Conference Services, operationally reporting to the Under-Secretary-General for General Assembly Affairs and Conference Services. A permanent interpretation service was created at Nairobi as of January 2001. Within the period under review, the Department, in cooperation with the United Nations Office at Nairobi, took a number of steps to strengthen the capacity and increase the utilization of the conference-servicing facilities at Nairobi. Subsequently, administrative instruction ST/AI/2001/6 was issued, amending administrative instruction ST/AI/342, entitled "Guidelines for the preparation of host government agreements falling under General Assembly resolution 40/243". It defined the responsibility of the Department for servicing meetings

globally using the available conference-servicing resources of United Nations Headquarters and the United Nations Offices at Geneva, Vienna and Nairobi in the most cost-effective manner.

46. At its 438th meeting, on 28 August 2001, the Committee on Conferences arranged a videoconference in which the Chief of Conference Services at Nairobi, the Chief of the Translation and Editorial Service and the Chief of the Interpretation and Meetings Section at Vienna, the Director of the Conference Services Division at Geneva and other relevant managers at the respective duty stations participated.

47. The Chief of Conference Services of the United Nations Office at Nairobi introduced the report of the Secretary-General on the improved utilization of conference facilities at the United Nations Office at Nairobi (A/56/133 and Corr.1). The report described the steps taken to establish a permanent interpretation service at Nairobi and projected the positive effect of the availability of such an important facility on the meetings activities of the Office to the end of the current biennium and beyond.

Discussion

48. Members of the Committee sought additional information as to how the creation of the permanent interpretation team at Nairobi had led to more productive intergovernmental consultations; what kinds of meetings were held without interpretation; the number of weeks per year during which the team would be assigned to meetings at Nairobi rather than at other duty stations; whether there was a perception that the conference facilities at Nairobi competed with those at Addis Ababa; the reasons for the persisting high vacancy rates in the English and Arabic booths at Nairobi; whether the overall allocation of interpreter posts was sufficient, given the expectations of increased demand; why a number of important meetings of the United Nations Environment Programme (UNEP) were scheduled to be held outside Nairobi in the second half of 2001; and whether consideration had been given to holding the next meeting of the UNEP Governing Council and Global Ministerial Environment Forum at Nairobi.

49. Replying to the questions raised, the Chief of Conference Services at the United Nations Office at Nairobi said that prior to the establishment of the permanent interpretation team, it had been difficult for

non-English-speaking missions in Nairobi to have full input into discussions of important documents prepared in English; since May 2001, multilingual interpretation had been provided to the Committee of Permanent Representatives at that duty station. Meetings held without interpretation were technical consultations without diplomatic representatives. The increase in the number of non-calendar meetings reflected a trend towards the utilization of interpretation services for meetings of subsidiary bodies of UNEP and other agencies based at Nairobi, as well as new reporting requirements. While priority in interpreter assignments would continue to be given to United Nations meetings at Nairobi, the sharing of interpreter resources with other duty stations was consistent with the recommendation contained in the report of the Advisory Committee on Administrative and Budgetary Questions on the proposed programme budget for the biennium 2002-2003. Nairobi's new potential was not expected to be detrimental to the operation of the conference facilities at Addis Ababa, since the Economic Commission for Africa did not have its own interpretation team and there was no significant overlap in their clientele. The 100 per cent vacancy rates for English and Arabic interpreters stemmed from the fact that the competitive examinations in those languages had not yielded a sufficient roster of candidates to be considered for recruitment. Efforts were being made to convince some of the successful candidates to accept an initial appointment to Nairobi. The allocation of posts was adequate and it was hoped that a full team of 20 interpreters would be working in all six languages by the end of the year. The headquarters rule had been repeatedly brought to the attention of permanent representatives.

Conclusions and recommendations

50. The Committee noted with satisfaction that the conference-servicing facility of Nairobi was becoming organizationally, functionally and budgetarily an integral part of the Department of General Assembly Affairs and Conference Services.

51. The Committee noted with appreciation: (a) **the statement contained in the report of the Secretary-General that the number of multilingual meetings to be held in Nairobi and with the Nairobi team's participation elsewhere in 2001 and 2002 was increasing;** and (b) **the cost-saving effect of the establishment of the Nairobi interpretation service**

for the regular budget in terms of temporary assistance.

52. The Committee looked forward to receiving further information on the utilization of the conference facilities at Nairobi.

53. The Committee recommended to the General Assembly that it request UNEP and the United Nations Centre for Human Settlements (Habitat) to comply with the headquarters rule and to hold all their meetings at the United Nations Office at Nairobi, in order to increase further the utilization of the conference facilities at Nairobi.

4. (a) Improved coordination and utilization of conference services

Introduction and overview

54. At its 437th meeting, on 27 August 2001, the Committee on Conferences considered an oral report by the Chief of the Central Planning and Coordination Service, Department of General Assembly Affairs and Conference Services of the United Nations Secretariat, on the improved coordination and utilization of conference services.

55. The second Secretariat-wide coordination meeting of conference services managers, held on 2 and 3 July 2001 at Geneva, had been attended by representatives of the four duty stations and the regional commissions, with the exception of the Economic Commission for Latin America and the Caribbean. The International Court of Justice had also participated as an observer. Discussions had centred on nine major areas of conference servicing:

- (a) Assignment of responsibility for servicing meetings away from established headquarters;
- (b) Lateral transfers of language staff;
- (c) Coordination of technical advances;
- (d) Development of performance measurement mechanisms;
- (e) Drafting of operating guidelines;
- (f) Financial reports;
- (g) Improved coordination in the area of contractual translation;

(h) Common examination for written language functions;

(i) Language issues related to the United Nations web site.

56. With regard to meetings away from established headquarters, the responsibility for conference services coordination was assigned to the headquarters location of the substantive secretariat, pursuant to the agreement reflected in the relevant paragraph of the administrative instruction on the guidelines for the preparation of host government agreements falling under General Assembly resolution 40/243; that paragraph had been issued as administrative instruction ST/AI/2001/6. In 2002, services would be provided to six sessions being held away from established headquarters. Discussions had centred on broad policy aspects, such as coordinating clearance procedures for the headquarters agreements, establishing teams composed of staff from all locations, financial arrangements and inclusion of smaller duty stations. Trials of coordinated workload-sharing pointed to potential efficiency gains. For example, in 2001, a Vienna-based body meeting in New York had been provided with all of its in-session documentation via remote processing based at Vienna, which had reduced a potential bottleneck of documentation in New York.

57. With regard to the lateral transfers of language staff, the new human resources management system approved by the Fifth Committee in June 2001 would first be applied within the Department at the four duty stations and then gradually extended to other duty stations.

58. Enhanced coordination of technological advances was necessary in order to avoid duplication of development efforts and to make the most efficient use of limited resources. A working group had been set up to formulate the specific projects of the ongoing programme and elements of an information technology strategy for the Department. The established practice of designating a lead duty station as the focal point for information-sharing and coordination had been reiterated and elaborated upon to ensure the role to be played by smaller duty stations.

59. Senior managers of the Department had been reminded of the importance and urgency of developing performance measurement mechanisms and the drafting of operating guidelines. Smaller groupings of managers had exchanged ideas and experience.

60. A smaller working group had been established to develop guidelines for the preparation of financial reports and to analyse existing procedures for their clearance prior to submission to other units of the Secretariat.

61. Discussions on improved coordination in the area of contractual translation had focused on applying existing policies in order to achieve resource harmonization among duty stations and to share rosters of contractual translators.

62. Following presentations on the experience gained in the common examination for written language functions, the Executive Office at Headquarters would prepare an analysis for presentation to the Office of Human Resources Management. That action was especially necessary in order to address further the lack of functional mobility of language staff, to move staff to meet peak workload periods and to improve career prospects.

63. Lastly, the use of official languages on the United Nations web site was a sensitive issue, involving the equal treatment of all of them. The principle must be respected and efforts should be made to increase the content in all languages. While the Department's output on the web was available in all six languages, it would be affected by eventual decisions in that area, especially in terms of resources.

Discussion

64. Replying to questions concerning the common examination for written language functions, the Director of the Translation and Editorial Division said that expectations of its leading to improved career prospects and better utilization of language staff had not materialized. The common examination had attracted fewer candidates than the specialized examinations because the function of verbatim reporter essentially did not exist outside the United Nations. In addition, candidates who possessed the requisite skills to pass the translation portion of the examination had been unwilling to accept posts as verbatim reporters. Moreover, because peak periods tended to occur in all sections simultaneously, it had proved impractical to rotate staff among different language functions. Nevertheless, in order to take advantage of economies of scale it had been decided to hold a common examination over three days, leading to three separate rosters of translators, editors and verbatim reporters.

65. With regard to the assignment of responsibility for servicing meetings away from established headquarters, it was noted that net budgeting in 1998-1999 had improved the situation with regard to workload-sharing. It was to be hoped that there would be up-front reimbursement to duty stations suffering from resource constraints.

Conclusions and recommendations

66. **The Committee on Conferences took note with appreciation of the oral report by the Secretariat on improved coordination of conference services.**

67. **The Committee welcomed the efforts and results of the Secretariat to coordinate conference services globally in accordance with the revised administrative instruction (ST/AI/2001/6) and encouraged further steps in that area.**

68. **The Committee requested that it be kept informed of the workload statistics and of the adequacy of financial resources at the various duty stations.**

69. **The Committee concluded that the Inter-Agency Meeting on Language Arrangements, Documentation and Publications should further promote cooperation between the United Nations and other international organizations on the use of conference services and should put forward concrete proposals that would make it possible to share translation, interpretation, editorial and printing services.**

70. **The Committee recommended to the General Assembly that it study the possibility of strengthening the oversight and supervisory functions of the Committee on Conferences, inter alia, in order to increase the effectiveness of its work, and of strengthening its role as a subsidiary organ of the General Assembly.**

(b) Utilization of the United Nations conference centres in Bangkok and Addis Ababa

Introduction and overview

71. At its 439th meeting, on 28 August 2001, the Committee on Conferences considered the report of the Secretary-General on the utilization of the United Nations conference centres in Bangkok and Addis

Ababa (A/56/293), which was introduced by a representative of the Secretariat.

72. The Committee learned that greater utilization of the two conference centres continued to be constrained by uncertainty about the appropriate use of the facilities, particularly as venues for private sector and commercial events; limited opportunities for rerouting meetings from the calendar of conferences; inadequate staffing structures for management of the centres; lack of funds for marketing and promotional activities; and regional instability. In the case of Bangkok, the conversion of a conference room to more flexible seating would make marketing easier.

73. Notwithstanding those constraints, efforts had been made to staff and manage the centres better and to attract more users, and utilization statistics over the two-year period from 1998 to 2000 had shown steady improvement.

74. The Under-Secretary-General for General Assembly Affairs and Conference Services had visited the centres and conducted in-depth discussions with their management on the coordination of conference services at the various duty stations and better utilization of their facilities.

Discussion

75. The view was expressed that the Secretariat's efforts to work with the regional commissions in Addis Ababa and Bangkok constituted an encouraging example of the value of sharing experience and expertise.

76. Clarification was received from the Secretariat that the conversion of the conference room in Bangkok, referred to in paragraph 72 above, was not foreseen during the next biennium.

Conclusions and recommendations

77. **The Committee noted with appreciation the report of the Secretary-General and the encouraging trend in the utilization of conference facilities at the two regional centres.**

78. **The Committee encouraged the Economic and Social Commission for Asia and the Pacific and the Economic Commission for Africa to continue their efforts to improve further the utilization of their conference centres and to keep the Committee informed of developments.**

79. The Committee encouraged the sharing of experience and expertise between conference services managers of the Secretariat and those of the regional commissions.

5. Provision of interpretation services to meetings of regional and other major groupings of Member States

Introduction and overview

80. As requested by the Committee on Conferences at its substantive session of 2000, during the course of the year the Chairperson wrote to the chairpersons of intergovernmental bodies (as reported in A/56/299, annex I), bringing to their attention the need to anticipate requests for meetings of regional and other major groupings during their sessions so as to allow for adequate consultations.

81. At its 436th meeting, on 27 August 2001, the Committee on Conferences considered the report of the Secretary-General on the provision of interpretation services to meetings of regional and other major groupings of Member States (A/56/213 and Corr.1), which was introduced by a representative of the Secretariat. In accordance with established practice, such meetings were provided with interpretation services on an ad hoc basis from existing resources not used owing to the cancellation of meetings of calendar bodies.

Discussion

82. The importance of conference services to regional and other major groupings of Member States was stressed. It was noted that there was a linkage between all aspects of providing conference services: any deficiency or improvement in one area inevitably affected every other area.

83. Satisfaction was expressed at the improvement in the provision of interpretation services over the past three years and the continued relevance of the Committee's recommendations in its previous report² was noted.

Conclusions and recommendations

84. The Committee noted with appreciation that the percentage of requests met for meetings with interpretation in New York by regional and other major groupings of Member States had risen

steadily, from 84 per cent during the period 1999-2000 to 90 per cent for the period from July 2000 to June 2001 and that, overall, for all four duty stations (New York, Geneva, Vienna and Nairobi), 92 per cent of requests for interpretation had been met.

85. The Committee recommended that duty stations continue to keep statistics of requests for servicing of meetings.

86. The Committee concluded that a key factor in providing interpretation services to regional and other major groupings of Member States was a sustained effort by intergovernmental organs, in cooperation with the Department of General Assembly Affairs and Conference Services, to predict the availability of such services. Flexibility in scheduling meetings by regional and other major groupings of Member States could also be instrumental in that regard.

87. The Committee again urged intergovernmental bodies to spare no effort at the planning stage to take into account meetings of regional and other major groupings of Member States, to make provision for such meetings in their programmes of work and to notify the Department of General Assembly Affairs and Conference Services well in advance of any cancellations so that unutilized conference-servicing resources might, to the extent possible, be reassigned to meetings of regional and other major groupings of States.

D. Requests for exceptions to section I, paragraph 7, of General Assembly resolution 40/243

Introduction and overview

88. At its 439th meeting, on 28 August 2001, the Committee on Conferences considered a note by the Secretariat (A/AC.172/2001/CRP.3) to which were annexed requests from subsidiary bodies for exceptions to be made to section I, paragraph 7, of General Assembly resolution 40/243, in which the Assembly decided that no subsidiary organ of the General Assembly would be permitted to meet at United Nations Headquarters during a regular session of the Assembly unless explicitly authorized by the Assembly. Statistical information was also provided on the number of meetings, if any, that the bodies concerned had held during the fifty-fifth session of the

Assembly and the efficiency with which they had utilized the resources made available to them.

Conclusions and recommendations

89. **The Committee recommended to the General Assembly that it explicitly authorize the following bodies to meet in New York during the main part of its fifty-sixth session, on the understanding that all such meetings would be allocated conference services on an as-available basis, from within existing resources, in such a way that the work of the General Assembly and its Main Committees would not be impeded:**

- (a) Committee on the Exercise of the Inalienable Rights of the Palestinian People;
- (b) Commission for Social Development acting as the preparatory committee for the Second World Assembly on Ageing;
- (c) Committee on Relations with the Host Country;
- (d) Working Group on the Financing of the United Nations Relief and Works Agency for Palestine Refugees in the Near East;
- (e) Executive Board of the United Nations Development Programme and the United Nations Population Fund;
- (f) Executive Board of the United Nations Children's Fund.

III. Documentation- and publication-related matters

A. Availability of documentation

Introduction and overview

90. In its resolution 55/222, the General Assembly invited intergovernmental bodies, during their organizational sessions or other appropriate periods before the commencement of their substantive work, to review with author departments the question of the availability of documentation for the proper functioning of those bodies and to report thereon to the Assembly at its fifty-sixth session through the Committee on Conferences.

91. At its 437th meeting, on 27 August 2001, the Committee on Conferences considered an interim report of the Secretary-General (A/56/299) containing a summary of replies received by 10 August 2001 from the chairpersons of intergovernmental bodies to a letter from the Chairman of the Committee, who had invited them to respond to the Assembly's request. The Committee also heard an introduction by a representative of the Secretariat.

Discussion

92. At its substantive session of 2000, the Committee had endorsed the proposals of the Secretariat for improving the availability of documentation. Reference was made in that connection to the example set by various bodies in monitoring the preparation of their pre-session documentation.

Conclusions and recommendations

93. **The Committee took note of the information contained in the report of the Secretary-General (A/56/299) and looked forward to obtaining a comprehensive review of the availability of such documentation after the biennial cycle of conferences and meetings had ended and additional replies had been received from the bodies concerned.**

94. **The Committee recommended that the General Assembly request the Secretary-General to provide a detailed report on the existing capacity in the Secretariat for efficient and effective delivery of conference services and ways and means of enhancing the timely availability of documentation to Member States.**

B. Submission of documentation

Introduction and overview

95. At its 437th meeting, on 27 August 2001, the Committee on Conferences considered the report of the Secretary-General on the submission of documentation consistent with the six-week rule (A/56/300). The Committee also heard an introduction by a representative of the Secretariat who indicated that the report addressed upstream issues in the preparation of documentation and that it was preliminary.

Discussion

96. Some delegations welcomed the Secretariat's accountability and responsibility measures and suggested actions such as those described in the report, while others had reservations, especially concerning paragraphs 12 and 13 of the report.

97. It was agreed that, since late issuance of documentation was a long-standing and complex problem, there were no simple solutions.

98. The view was expressed that the low rate of compliance with the six-week rule was due mainly to late submission of documentation by author departments rather than delays in processing. It was noted that manuscripts were often not in conformity with the rules concerning formatting, number of pages and footnotes. The Department of General Assembly Affairs and Conference Services should be encouraged to improve coordination with submitting departments in order to identify bottlenecks and other problems.

99. It was generally agreed that the increase in the number of meetings and conferences of intergovernmental bodies had given rise to a larger volume of documentation and that comparative statistics would be useful to reflect the trends developed over the years.

Conclusions and recommendations

100. **The Committee, while noting the measures taken by the Secretariat to identify responsibility and establish accountability in the preparation and submission of documentation consistent with the six-week rule, recommended to the General Assembly that it invite the Secretary-General to develop an effective accountability and responsibility system within the Secretariat in order to ensure timely submission of documents for processing.**

101. **The Committee encouraged the Secretariat to continue to make concerted efforts to remedy the situation of late issuance of documentation. In that connection, the Committee drew attention to the proposals contained in the report of the Secretary-General (A/56/300) and encouraged the Secretariat to proceed with a more extensive analysis of the reasons for the late issuance of documentation and of the resulting additional costs, using, inter alia, comparative statistics.**

IV. Translation- and interpretation-related matters

A. Use of remote interpretation

Introduction and overview

102. At its 437th meeting, on 27 August 2001, the Committee on Conferences considered the report of the Secretary-General concerning the second experiment in remote interpretation conducted by the United Nations (A/56/188). In addition, a representative of the Secretariat presented an oral report on the matter.

103. The representative of the Secretariat indicated that after the second experiment, it could be concluded that (a) that the cost-effectiveness of remote interpretation must be ascertained on a case-by-case basis; (b) efforts to find technological solutions that could bring the physical environment of remote interpretation as close as possible to normal on-site conditions had not been successful; (c) maintaining an acceptable level of quality of service in conditions of remote interpretation required additional physical and psychological effort; and (d) in those conditions, typical individual workloads expected from interpreters during on-site work needed to be reduced if remote interpretation was to be used.

Discussion

104. The view was expressed that the report of the Secretary-General on the second experiment in remote interpretation conducted by the United Nations should be read in conjunction with the report issued in 1999 on the first experiment (A/54/176). It was thus evident that the conditions under which remote interpretation could be done were in a state of flux. Although improvements had been made in the technical means used, they were still not sufficient to ensure a completely favourable environment. The two experiments had confirmed that remote interpretation was technically feasible, but only at the cost of increased stress and fatigue among interpreters. The experiments also showed that current conditions did not make it possible to comply with the quality requirements for remote interpretation specified by the General Assembly in its resolutions 54/248 and 55/222.

105. The number of members of delegations who had responded to the survey on the quality of the remote interpretation services during the second experiment

had been extremely low, providing a very limited picture of the views of Member States. Efforts should be made to arrive at a much wider cross-section of opinions in the future. It was also essential to pursue research on the cost-effectiveness of remote interpretation, including more variables in addition to communications costs and daily subsistence allowances.

106. Further experiments should be conducted if there was a noticeable change in the basic parameters that determined the effectiveness of remote interpretation, such as improvements in the quality of video technology so as to reduce stress and fatigue among interpreters and the cost of communications. In the meantime, the approach described in paragraph 63 of the report of the Secretary-General (A/56/188) provided a good basis for continued work in the field of remote interpretation.

Conclusions and recommendations

107. **The Committee noted with appreciation the report of the Secretary-General (A/56/188) and reiterated the principles that should be followed when considering future work in the field, namely, those contained in General Assembly resolution 55/222.**

108. **The Committee expressed support for the intention of the Secretariat, as spelled out in paragraph 63 of the report, to foster the accumulation of experience among interpreters working on-site at meetings that had some of the characteristics of remote meetings, namely, a videoconference component, so as to facilitate the process of adaptation to a new working environment. It also requested the Secretariat to assess future advances in the videoconferencing and communications areas to determine whether they could offer solutions to the outstanding technical problems of remote interpretation. It noted that the Secretariat did not currently foresee conducting further experiments.**

109. **The Committee requested that a report on developments in those areas, as well as any activities in the field of remote interpretation carried out by other international organizations, be submitted to the General Assembly at its fifty-seventh session through the Committee on Conferences.**

B. Language services recruitment-related issues

Introduction and overview

110. At its 437th and 438th meetings, on 27 and 28 August 2001, the Committee on Conferences considered the report of the Secretary-General on excessive vacancy rates in language services at some duty stations and issues relating to the recruitment of language staff (A/56/277), which had been prepared in response to requests made by the General Assembly in section IV, paragraphs 11 and 12, of its resolution 55/222.

111. The Committee was reminded that the statistical information in the tables reflected the situation as at 30 June 2001. Percentages of vacancies could change dramatically over a short period at duty stations where small numbers of posts were involved.

112. The Committee also heard an update concerning information technology projects, on which a report would be submitted to the General Assembly at its fifty-sixth session.

Discussion

113. The report was commended for underscoring the importance of coordination among duty stations in overcoming the problem of excessive vacancies. Achieving a balance between cost-efficiency and equal quality of services was a complex staffing problem. The cost-effectiveness of temporary assistance varied greatly for duty stations. Whereas the Geneva duty station, for example, could draw on a large pool of local skills, smaller duty stations generally had to hire non-local freelances at higher cost, hence the greater urgency of filling vacant regular posts at such duty stations.

114. The view was expressed that the ceiling on annual United Nations earnings for United Nations retirees should be raised because it limited access to a valuable, highly skilled resource, which was part of a small pool of highly qualified freelancers. When that pool had been fully tapped, the quality of services could suffer.

115. Concern was expressed that rates of self-revision exceeded recommended levels. Translation quality became a problem when there was a lack of revision capacity. It was pointed out, however, that self-revision

did not necessarily result in a loss of quality when there was a high proportion of experienced translators at a duty station.

116. Support was expressed for the training initiative proposed in the report and for increased cooperation between the Organization and universities and other institutions offering language training.

117. The view was expressed that it would be hard to resolve recruitment problems without a radical change in approach to open up what had become a closed system. What was needed was a system of selection and rotation of staff that regularly brought in interpreters and translators conversant with contemporary language. The recommendations in the report were sound as far as they went, but the Committee should closely monitor developments in the area of recruitment.

118. The problem of high or excessive vacancy rates in the language services could only be overcome by a package of incentives. The view was expressed that mobility was the most effective approach to addressing vacancies in language services and welcomed the streamlined procedures for lateral transfers of language staff as a step in that direction. The view was also expressed that the need for parity of treatment of language and non-language staff limited the possible effectiveness of a system of incentives in the absence of a Secretariat-wide comprehensive scheme for encouraging and rewarding mobility between duty stations. The view was further expressed that the specific requirements of language services at duty stations with chronically high vacancy rates should be duly taken into consideration in the further development of criteria for mobility and of mechanisms to provide adequate incentives for mobility between duty stations, as requested by the General Assembly in section V of its resolution 55/258 of 14 June 2001 on human resources management.

Conclusions and recommendations

119. **The Committee noted with appreciation the report of the Secretary-General (A/56/277).**

120. **The Committee welcomed the decrease, since the last reporting date, of the overall vacancy rate for language services, and the significant improvement recorded at all duty stations with a history of chronically high vacancy rates.**

121. **The Committee nevertheless remained concerned about the persistence of excessive vacancy rates, particularly for some languages or language functions, at most duty stations with small or medium-sized language services.**

122. **The Committee recognized that the persistence of excessive vacancy rates at some duty stations reflected mostly the insufficient mobility of language staff, while the still fairly high overall vacancy rate for language services was attributable to recruitment problems, particularly for specific languages and/or language combinations.**

123. **While commending the determined efforts made by the Secretariat to fill vacancies in the newly established Interpretation Section at the United Nations Office at Nairobi, the Committee expressed concern about the lack of success, so far, in filling vacant interpreter posts for some languages. The Committee recommended that, as indicated in paragraph 9 of the report, top priority be given to filling such posts, as well as vacant interpreter posts at the United Nations Office at Vienna, in the recruitment of candidates successful in the 2001 competitive examinations for Arabic and English interpreters, and that the United Nations Office at Nairobi and United Nations Office at Vienna also be given priority in the recruitment of candidates successful in the competitive examinations for French and Spanish interpreters to be held in January 2002.**

124. **The Committee recommended that the Secretariat continue its practise, which had produced encouraging results, of closely monitoring the vacancy situation at duty stations with chronic vacancy problems and of approaching such problems in a proactive fashion.**

125. **On recruitment issues, the Committee expressed concern about the low yield of some competitive language examinations, particularly of examinations for interpreters with specific language combinations, and about the fact that candidates successful in such examinations often repeatedly refused offers of employment made by the Organization.**

126. **The Committee recommended that the Secretariat pursue its efforts to target the advertising of competitive language examinations more effectively by focusing on language schools,**

other educational institutions and professional associations.

127. In view of the very high success rates achieved in the past through the in-house training programme for interpreters, as described in paragraph 31 of the report, the Committee also recommended that the programme be reinstated for an initial period of one year, subject to the submission to the General Assembly at its fifty-seventh session, through the Committee on Conferences, of information on the results of the training activities undertaken, the continuing need for the programme and related financial arrangements.

128. The Committee welcomed the inter-agency initiative to address training issues at their source through cooperation between the United Nations and other international organizations, on the one hand, and language schools and other educational institutions, on the other. The Committee requested the Secretary-General to keep it informed on progress achieved through that initiative.

129. The Committee recommended to the General Assembly that it initiate a comprehensive review of the norms and standards of productivity in the language services in the light of ongoing technological innovations in their work.

V. Review of the proposed programme budget for the biennium 2002-2003: Department of General Assembly Affairs and Conference Services

Introduction and overview

130. At its 440th meeting, on 29 August 2001, the Committee on Conferences considered the programme narrative on General Assembly affairs and conference services of the proposed programme budget for the biennium 2002-2003 (A/56/6 (sect. 2)) and heard an introduction by the Secretariat on the matter.

131. Activities programmed under the relevant section of the budget fell under programme 6, General Assembly and Economic and Social Council affairs and conference services, of the medium-term plan for the period 2002-2005, as revised (A/55/6/Rev.1). The

Department of General Assembly Affairs and Conference Services was responsible for implementing the activities programmed in the context of programme 6 of the medium-term plan and for attaining its objectives.

132. The demand for services in the biennium 2000-2001 had been higher than originally anticipated because of, *inter alia*, a greater than average number of meetings of intergovernmental and expert organs and the extension of the sessions of several bodies beyond their scheduled closing dates. Consequently, the overall level of resources for the biennium 2002-2003 of \$423,865,400 reflected a net increase of \$8,488,900, or 2 per cent, as compared with the revised appropriation for the biennium 2000-2001.

133. The regular budget resources would be supplemented by extrabudgetary resources of \$21,461,100, which would be derived largely from reimbursement income to be received in payment for services provided to extrabudgetary activities, funds and programmes, as well as from contributions to specific trust funds established to fund certain activities in the conference-servicing area.

134. The Department intended to continue implementing cost-saving measures, including improved control of resources budgeted for temporary assistance for meetings, increased capacity utilization, the introduction of computer-assisted working methods and the application of new technologies, with a view to enhancing conference services and increasing their efficiency and cost-effectiveness.

Discussion

135. The view was expressed that it was useful to examine the section of the proposed programme budget relating to conference services in the context of the other agenda items considered by the Committee and its conclusions and recommendations pertaining thereto. It was noted that, in the view of the Secretariat, the level of funding requested was the minimum needed to maintain high-quality conference services in a time of increasing demands on the Organization.

136. The view was also expressed that the proposed programme budget section failed to justify all performance indicators in the context of the requested funding.

137. The view was further expressed that resource constraints were evident in such areas as the distribution of documentation in electronic format in all six official languages and in the lack of a sufficient number of posts, which represented an increased workload for translators and interpreters.

138. The view was expressed that the sharing of workloads among duty stations, comparisons of best practices and consolidation within the Department, as well as greater efficiency in the utilization of conference services by Member States, might alleviate the difficulties.

139. The view was also expressed that, during its consideration of the proposed programme budget for the biennium 2002-2003, the General Assembly would need information on distribution of temporary assistance among the six official language services.

Conclusions and recommendations

140. The Committee noted the programme narrative on General Assembly affairs and conference services of the proposed programme budget for the biennium 2002-2003.

141. The Committee noted with appreciation the consolidation under section 2, of the resources related to conference services of the United Nations Office at Nairobi.

142. The Committee recommended that the General Assembly give careful consideration to the proposed programme budget for the biennium 2002-2003 for conference services, taking into account the conclusions and recommendations contained in the report of the Committee concerning the relevant items on its agenda.

143. The Committee expressed support for the recommendation made by the Committee for Programme and Coordination in paragraph 71 of its report (A/56/16).

144. The Committee recommended that, in future budget submissions under the section entitled "General Assembly Affairs and Conference Services", publishing be separated from interpretation and presented as part of translation and editing. That was important given the need to combine similar services in a given subprogramme.

VI. Information technology

A. Policy issues regarding the translation of non-parliamentary and public information material into all official languages

Introduction and overview

145. At its 439th meeting, on 28 August 2001, the Committee on Conferences heard a presentation by a representative of the Department of Public Information on the multilingual development, maintenance and enrichment of the United Nations web site and a report by the Secretary-General on the subject (A/AC.198/2001/8) was made available to the members of the Committee.

Discussion

146. A number of questions were raised by members of the Committee. The view was expressed that the state of affairs with regard to the development of a multilingual United Nations web site contradicted de facto the principle of equal treatment of all United Nations languages. Some delegations drew attention to the statement by the Secretary-General in paragraph 21 of his report, regarding significant expenditures, which indicated that the achievement of full parity among the official languages would require additional resources.

147. The representative of the Department of Public Information said that, with regard to the building of modular parity on the web site among the six official languages, the Department was following the policy set out in draft resolution B, adopted by the Committee on Information at its twenty-third session and submitted to the General Assembly at its fifty-sixth session (see A/56/21, chap. V). The draft resolution stressed the impact on the multilingual nature of the United Nations of integrating the optical disk system with the United Nations web site. It also requested the Working Group on Internet Matters to include in the Internet Publishing Guidelines specific recommendations towards the goal of making all documentation on the web sites available in all six official languages.

148. The view was expressed that the General Assembly should encourage the Secretary-General to develop, as a matter of priority, new proposals for consideration by the relevant United Nations bodies, as envisaged in Assembly resolution 55/136 B.

Conclusions and recommendations

149. The Committee expressed serious concern about the growing disparities that existed on the United Nations web site between English and the other official languages.

150. The Committee requested the Secretariat to include Nairobi and Vienna together with New York and Geneva on the web site entitled "About the United Nations".

B. Re-engineering of the optical disk system

Introduction and overview

151. At its 439th meeting, on 28 August 2001, the Committee considered the report of the Secretary-General on the re-engineering of the optical disk system (A/56/120) and heard an introduction with updated information concerning the matter.

152. The optical disk system (ODS) was developed in 1991 and its production operations began in 1992. Since then, technological changes had made the current system obsolete, expensive to maintain and inflexible for growth.

153. In the new ODS (currently being called the Official Document System), Windows 2000 and Lotus Notes were used with magnetic media instead of optical disks. Magnetic disks were fast, reliable and inexpensive even for the large amounts of storage space required by the system. The new system was to be delivered in two phases. The first phase, nearly completed, was a one-to-one migration of the system to the new platform; the second would provide for non-Roman language support functions, allowing users to access it and search the documents using any of the six official languages of the United Nations. Phase 2 production operations were expected to start in January 2002.

154. The implications of a purely web-based system were sweeping. Geographical distance would be irrelevant. Although staff at duty stations would be connected via the Intranet, for outside users, the direct Integrated Service Digital Network connections to ODS would no longer be necessary, since anyone with an Internet connection could potentially have access to it.

155. Currently, ODS was provided free of charge to staff members and Member States and was available to others for a fee. Once it was well-established and tested, the new ODS would have as much capacity as the United Nations web site. Effective immediately, the number of users Governments might register was being increased from 10 to 20.

Discussion

156. The view was expressed that the update provided by the Secretariat was extremely valuable and that the information should be published in an addendum to the report of the Secretary-General. Support was voiced for an increase in the system access quota and it was suggested that all permanent missions be informed of the change.

157. Replying to the questions raised by the Committee, the representative of the Secretariat stated that it was not clear at what point the new ODS would be made available to the public without limitations. The impact of its usage was being monitored and restrictions might be relaxed slowly if it were felt that the system could withstand an even larger number of users. Phase 2 parallel operation would begin in December 2001; by January 2002, it should be possible to operate ODS in any one of the six official languages, thanks to Lotus Notes, which had language support for non-Roman languages. The Intranet was by definition internal; hence, there were no plans to make it available to permanent missions. Nevertheless, an "Extranet" was being developed that would allow information to be shared among all United Nations agencies. The Extranet could be accessed by the permanent missions in the future. It was noted that the content of the new ODS was identical to that of the old one.

158. The view was expressed that the General Assembly should consider ending fees for current users on 31 December 2001.

Conclusions and recommendations

159. The Committee took note of the information contained in the report of the Secretary-General (A/56/120) and welcomed the efforts that were being made to bring the optical disk system up to date. It also commended the results of those efforts and the introduction of the new system.

160. The Committee encouraged the Secretary-General to continue those efforts and requested that a report on the progress achieved, as well as on the impact of re-engineering on access to the Official Document System at all duty stations, be issued as an addendum to the report of the Secretary-General for consideration by the General Assembly at its fifty-sixth session.
