Introduction

The 2006 resumed substantive session of the Economic and Social Council was held on 11 October, 30 November and 11 and 15 December 2006. The action taken by the Council at that session is summarized herein.

Chapter VII

General segment

B. Coordination, programme and other questions

1. Reports of coordination bodies

1. The Council resumed its consideration of agenda item 7 (a) (Reports of coordination bodies) at its 44th meeting, on 11 October 2006. An account of the discussion is contained in the relevant summary record (E/2006/SR.44). It had before it the report of the Committee for Programme and Coordination on its forty-sixth session (A/61/16).¹

2. At the same meeting, on 11 October, the Council heard an introductory statement by the Chairperson of the Committee for Programme and Coordination.

Action taken by the Council

3. On the proposal of the President of the Council, the Council decided to take note of the report of the Committee for Programme and Coordination on its forty-sixth session. See Council **decision 2006/257**.

G. Non-governmental organizations

4. The Council resumed its consideration of agenda item 12 (Non-governmental organizations) at its 47th meeting, on 11 December 2006. An account of the discussion is contained in the relevant summary record (E/2006/SR.47). It had before it the following documents:

(a) Report of the Committee on Non-Governmental Organizations on its 2006 regular session (E/2006/32 (Part I));²

(b) Report of the Committee on Non-Governmental Organizations on its resumed 2006 session $(E/2006/32 \text{ (Part II)}).^2$

5. Under agenda item 12, the Council adopted decisions 2006/259, 2006/260, 2006/261 and 2006/262.

Application of the Danish National Association for Gays and Lesbians

6. At its 47th meeting, on 11 December, the Council had before it a draft decision (E/2006/L.24), entitled "Applications for consultative status", submitted by the observer for Finland³ on behalf of the States Members of the United Nations that are members of the European Union, recommending the granting of consultative status to the Danish National Association for Gays and Lesbians.

7. At the same meeting, a statement was made by the representative of Guinea-Bissau.

8. Also at its 47th meeting, the Council adopted the draft decision by a roll-call vote of 23 to 16, with 11 abstentions. See Council **decision 2006/259**. The voting was as follows:

Albania, Armenia, Australia, Austria, Belgium, Brazil, Canada, Colombia, Czech Republic, Denmark, France, Germany, Iceland, Italy, Japan, Lithuania, Mexico, Panama, Poland, Republic of Korea, Spain, United Kingdom of Great Britain and Northern Ireland, United States of America.

Against:

Bangladesh, Benin, Chad, China, Democratic Republic of the Congo, Guinea, Indonesia, Madagascar, Mauritania, Namibia, Nigeria, Pakistan, Russian Federation, Saudi Arabia, Tunisia, United Arab Emirates.

Abstaining:

Angola, Belize, Costa Rica, Guyana, Haiti, India, Paraguay, South Africa, Sri Lanka, Thailand, Turkey.

Application of the International Lesbian and Gay Association — Europe

9. At its 47th meeting, on 11 December, the Council had before it a draft decision (E/2006/L.25), entitled "Applications for consultative status", submitted by the observer for Finland³ on behalf of the States Members of the United Nations that are members of the European Union, recommending the granting of consultative status to the International Lesbian and Gay Association — Europe.

10. At the same meeting, the Council adopted the draft decision by a roll-call vote of 23 to 17, with 10 abstentions. See Council **decision 2006/260**. The voting was as follows:

In favour:

Albania, Armenia, Australia, Austria, Belgium, Brazil, Canada, Colombia, Czech Republic, Denmark, France, Germany, Iceland, Italy, Japan, Lithuania, Mexico, Panama, Poland, Republic of Korea, Spain, United Kingdom of Great Britain and Northern Ireland, United States of America.

Application of the Lesbian and Gay Federation in Germany

11. At its 47th meeting, on 11 December, the Council had before it a draft decision (E/2006/L.26), entitled "Applications for consultative status", submitted by the observer for Finland³ on behalf of the States Members of the United Nations that are members of the European Union, recommending the granting of consultative status to the Lesbian and Gay Federation in Germany.

12. At the same meeting, the Council adopted the draft decision by a roll-call vote of 24 to 16, with 10 abstentions. See Council **decision 2006/261**. The voting was as follows:

In favour:

Albania, Armenia, Australia, Austria, Belgium, Brazil, Canada, Colombia, Costa Rica, Czech Republic, Denmark, France, Germany, Iceland, Italy, Japan, Lithuania, Mexico, Panama, Poland, Republic of Korea, Spain, United Kingdom of Great Britain and Northern Ireland, United States of America.

Against:

Bangladesh, Benin, Chad, China, Democratic Republic of the Congo, Guinea, Indonesia, Madagascar, Mauritania, Namibia, Nigeria, Pakistan, Russian Federation, Saudi Arabia, Tunisia, United Arab Emirates.

Abstaining:

Angola, Belize, Guyana, Haiti, India, Paraguay, South Africa, Sri Lanka, Thailand, Turkey.

13. A statement in explanation of vote after the votes on the three draft decisions was made by the representative of the Russian Federation.

14. After the adoption of the draft decisions, statements were made by the representatives of China and Benin.

H. Economic and environmental questions

1. Sustainable development

21. The Council resumed its consideration of agenda item 13 (a) (Sustainable development) at its 48th meeting, on 15 December 2006. An account of the discussion is contained in the relevant summary record (E/2006/SR.48). It had before it the report of the Committee for Development Policy on its eighth session (E/2006/33).⁴

Action taken by the Council

22. Under agenda item 13 (a), the Council adopted decisions 2006/265 and 2006/266.

Inclusion of Papua New Guinea in the list of least developed countries

23. At its 48th meeting, on 15 December, the Council had before it a draft decision (E/2006/L.38), entitled "Inclusion of Papua New Guinea in the list of least developed countries" submitted by the Vice-President of the Council, Léo Mérorès (Haiti), on the basis of informal consultations.

24. At the same meeting, the Council adopted the draft decision. See Council **decision 2006/265**.

Recommendation contained in the report of the Committee for Development Policy on its eighth session concerning Samoa

25. At its 48th meeting, on 15 December, on the proposal of the President, the Council decided to defer to its 2007 substantive session consideration of recommendation 2, concerning Samoa, contained in the report of the Committee for

2. Science and technology for development

26. The Council resumed its consideration of agenda item 13 (b) (Science and technology for development) at its 48th meeting, on 15 December. An account of the discussion is contained in the relevant summary record (E/2006/SR.48). It had before it the report of the Commission on Science and Technology for Development on its ninth session (E/2006/31).⁵

Action taken by the Council

28. At its 48th meeting, on 15 December, the Council had before it a draft decision (E/2006/L.39), entitled "Enlargement of the Commission on Science and Technology for Development" submitted by the Vice-President of the Council, Dalius Čekuolis (Lithuania), on the basis of informal consultations.

29. At the same meeting, the Council adopted the draft decision. See Council decision 2006/267.

Report of the Commission on Science and Technology for Development on its ninth session

30. At its 48th meeting, on 15 December, on the proposal of the President of the Council, the Council decided to defer further consideration of the report of the Commission on Science and Technology for Development on its ninth session to its 2007 organizational session. See Council decision 2006/268.

I. Social and human rights questions

7. Human rights

31. The Council resumed its consideration of agenda item 14 (g) (Human rights) at its 46th meeting, on 11 December 2006. An account of the discussion is contained in the relevant summary record (E/2006/SR.46). It had before it the report of the Committee on the Rights of the Child (A/61/41 and corrigendum).⁶

32. At its 46th meeting, on 11 December, on the proposal of the President, the Council decided to take note of the report of the Committee on the Rights of the Child. See Council **decision 2006/258**.

8. Permanent Forum on Indigenous Issues

33. The Council resumed its consideration of agenda item 14 (h) (Permanent Forum on Indigenous Issues) at its 48th meeting, on 15 December. An account of the discussion is contained in the relevant summary record (E/2006/SR.48). It had before it the report of the Permanent Forum on Indigenous Issues on its fifth session (E/2006/43).⁷

Action taken by the Council
