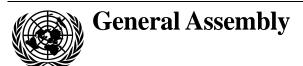

Report of the Special Political and Decolonization Committee (Fourth Committee)

- 1. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-first session the item entitled "Revitalization of the work of the General Assembly" and to allocate it to all the Main Committees and the plenary of the General Assembly for the sole purpose of considering and taking action on their respective tentative programmes of work for the next session.
- 2. The Special Political and Decolonization Committee (Fourth Committee) considered the item at its 18th meeting, on 30 October 2006 (see A/C.4/61/SR.18).
- 3. At the same meeting, the Chairman drew the attention of the Committee to a paper entitled "Draft provisional guidelines: approximate dates for the consideration of items by the Special Political and Decolonization Committee (Fourth Committee) at the sixty-second session of the General Assembly".
