Revitalization of the work of the General Assembly

Report of the First Committee

1. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-second session the item entitled “Revitalization of the work of the General Assembly” and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work for 2008.
2. The First Committee considered the item at its 25th meeting, on 2 November 2007 (see A/C.1/62/PV.25).
3. At the 25th meeting, the Chairman made a statement and introduced the proposed programme of work.
4. At the same meeting, the Committee adopted its proposed programme of work and timetable for 2008, annexed to the present report.
5. The First Committee recommends to the General Assembly the adoption of the following draft decision:
