

I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the sixty-second session of the General Assembly in accordance with Assembly resolution 58/316 of 1 July 2004.
- 2. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include the item in the agenda of its sixty-second session and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work for 2008.
- 3. The Sixth Committee considered the item at its 28th meeting, on 19 November (A/C.6/62/SR.28).

II. Consideration of draft decision A/C.6/62/L.21

- 4. At the 28th meeting, on 19 November, the Chairman introduced a draft decision on the provisional programme of work for the sixty-third session of the General Assembly as proposed by the Bureau (A/C.6/62/L.21).
- 5. At the same meeting, the Committee adopted draft decision A/C.6/62/L.21 (see para. 7).
- 6. Before the adoption of the draft decision, the representatives of the Dominican Republic (on behalf of the States Members of the United Nations that are members of the Rio Group), Uganda, Egypt, Trinidad and Tobago (on behalf of the States Members of the United Nations that are members of the Caribbean Community), New Zealand, Sierra Leone, Portugal (on behalf of the States Members of the United Nations that are members of the European Union), El Salvador, the Democratic Republic of the Congo (on behalf of the Group of African States) and Morocco made statements in explanation of position (see A/C.6/62/SR.28).
