I. Introduction

1. The previous recommendation made by the Fifth Committee to the General Assembly under agenda item 117 appears in the report of the Committee contained in documents A/63/649 and A/63/649/Add.1.
2. The Fifth Committee resumed its consideration of the item at its 55th meeting, on 25 June 2009. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary record (A/C.5/63/SR.55).
