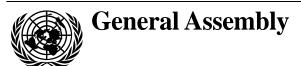

Appointment of members of the Committee on Contributions

Note by the Secretary-General

- 1. The Secretary-General has received notification of the resignation of Vyacheslav Anatolievich Logutov (Russian Federation) from the Committee on Contributions, with effect from 20 May 2010. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Mr. Logutov, which expires on 31 December 2011.
- 2. The Government of the Russian Federation has nominated Andrei Vitalievitch Kovalenko to fill the vacancy arising from the resignation of Mr. Logutov.
- 3. In a communication dated 28 May 2010, the Secretariat was informed by the Chairperson of the Group of Eastern European States that the candidature of Mr. Kovalenko had been endorsed by the Group.
