- 4.1 General and complete disarmament under strict and effective international control remains the ultimate goal of all efforts in the field of disarmament. The main responsibilities for disarmament lie with Member States. The United Nations, in accordance with its Charter, has a central role and primary responsibility in supporting Member States in this area.
- 4.2 The mandate for the programme derives from the priorities established in relevant General Assembly resolutions and decisions in the field of disarmament, including the Final Document of the Tenth Special Session of the General Assembly, the first special session devoted to disarmament (resolution S-10/2). The programme is also guided by the United Nations Millennium Declaration (see resolution 55/2) and takes into account other relevant resolutions of the United Nations. Weapons of mass destruction, in particular nuclear weapons, continue to be of primary concern to the Organization. Conventional disarmament, especially with regard to major weapons systems, small arms and light weapons and landmines, has received increased attention from the international community in view of the havoc that such weapons are inflicting on people's daily lives, in particular in conflict-ridden regions.
- 4.3 Within the Secretariat, substantive responsibility for the programme is vested in the Office for Disarmament Affairs. The Office's strategy in meeting the programme's objectives is designed

around five subprogrammes and is based on its role in and responsibility for facilitating and encouraging, as appropriate, disarmament and non-proliferation measures at all levels. The Office will continue to assist Member States in promoting, strengthening and consolidating multilaterally negotiated principles and norms in all areas of disarmament and non-proliferation in all its aspects. It will support efforts of Member States in the areas of disarmament and non-proliferation in all its aspects in order to help maintain international peace and security and contribute to global efforts against terrorism. In order to do so effectively, the Office will enhance its capacity/capability for more in-depth analysis keeping track of developments in these areas and to provide Member States with timely and practical advice as requested. It will continue to assist Member States in their efforts to prevent the destabilizing and excessive accumulation of, illicit trafficking in and manufacture of small arms and light weapons in all their aspects. Moreover, the Office will facilitate and promote efforts for the further implementation of the Programme of Action adopted at the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, as well as practical disarmament measures. It will promote transparency, based on the principle of undiminished security for all, and confidence-building measures in the field of disarmament. Through its regional centres for peace and disarmament, the Office will assist Member States in promoting regional approaches to disarmament, non-proliferation in all its aspects and regional and international peace and security. It will also continue to contribute to efforts to enhance disarmament expertise in Member States, particularly in developing countries.

- 4.4 The Office will seek to achieve the objectives of the programme by facilitating the process of multilateral deliberation and negotiation. This will include providing substantive organizational support to the First Committee, the Disarmament Commission and other subsidiary bodies of the General Assembly, the Conference on Disarmament and its subsidiary bodies, review conferences and other meetings of parties to multilateral disarmament agreements, as well as to expert groups mandated by the General Assembly. This will also include monitoring and assessing current and future trends in the field of disarmament, non-proliferation in all its aspects and international security.
- 4.5 The Office will continue to be a source of impartial and factual information on disarmament and security-related matters for Member States, organizations of the United Nations system, intergovernmental and regional organizations and non-governmental organizations and will expand its educational outreach programmes. Training and advisory services will continue to be provided, through the United Nations disarmament fellowship, training and advisory services programme and the United Nations Institute for Disarmament Research (UNIDIR), to Member States, in particular developing countries, to enable them to enhance their expertise in disarmament, so that they may participate more effectively in international deliberating and negotiating forums. The Office will also assist Member States in increasing understanding of the relationship between disarmament and development.
- 4.6 Gender mainstreaming will continue to be an integral part of the activities of the programme through the implementation of a gender plan of action aimed at raising awareness and increasing commitment to and capacity for gender mainstreaming in disarmament affairs.
- 4.7 The Office carries out its activities in cooperation with other departments and offices of the Secretariat, entities of the United Nations system and entities external to the United Nations, including treaty organizations, intergovernmental, interregional, regional and national organizations, non-governmental organizations and academic communities. Such cooperation includes the preparation of reports, participation in meetings, briefings, technical and substantive support and sharing of information and experience.

- 4.8 The issue of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown below in summary and as described in the output information for each subprogramme.

- 4.9 The overall level of resources for the Office for Disarmament Affairs for the biennium 2010-2011 amounts to \$22,636,100, reflecting growth of \$176,400 (0.8 per cent). The growth shown in table 4.5 can be summarized as follows:
- (a) The net increase of \$8,900 under executive direction and management relates to higher requirements for general temporary assistance and overtime during peak workload periods for the Office of the High Representative and the Office of the Director;
  - (b) The net increase of \$139,300 under programme of work relates to:
    - (i) A net decrease of \$112,600 under subprogramme 1 resulting from a reduction in requirements for grants and contributions based on expenditure pattern;
    - (ii) A net decrease of \$279,900 under subprogramme 2 resulting from the elimination of the requirements for consultants and experts owing to the completion of the report on the issue of missiles in all its aspects;
    - (iii) A net decrease of \$781,400 under subprogramme 3 for non-post requirements owing to completion of the work of the Groups of Governmental Experts on the issues of ammunition; on the continuing operation of the United Nations Register of Conventional Arms and its further development; and on the examination of the feasibility, scope and draft parameters of a comprehensive, legally binding instrument establishing common international standards for the import, export and transfer of conventional arms;
    - (iv) A net increase of \$301,700 under subprogramme 4 resulting from the additional number of meetings of the Group of Governmental Experts on developments in information and telecommunications in the context of international security;
    - (v) A net increase of \$1,011,500 under subprogramme 5 resulting from the establishment of two P-3 posts and two General Service (Local level) posts and the inclusion of the core operational requirements of the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean and the Regional Centre for Peace and Disarmament in Asia and the Pacific in line with General Assembly resolutions 63/74 and 63/77, respectively. In addition, there is an increase in non-post costs relating to the additional requirements for consultants and experts for the convening of the ministerial and other meetings of the Standing Advisory Committee;
  - (c) The increase of \$28,200 under programme support for non-post requirements relates to the contribution to support central data-processing services provided by the Office of Information and Communications Technology.

- 4.10 During the biennium 2010-2011, projected extrabudgetary resources would amount to \$10,466,600, including \$3,793,000 for the Trust Fund for UNIDIR. The extrabudgetary resources will be utilized for activities related to organizing the tenth and eleventh annual meetings and the review conference of the States Parties to the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction; promoting greater mutual confidence among Member States in the field of conventional arms and addressing the destabilizing and excessive accumulation of and illicit trafficking in and manufacture of small arms and light weapons, as well as promoting a reduction in armed violence; providing impartial and factual information on disarmament to Member States, organizations of the United Nations system and intergovernmental, regional and non-governmental organizations; and providing opportunities for regional cooperation, coordination and collaboration in matters related to disarmament non-proliferation and regional peace and security. The decrease is due to the finite nature of the funding provided by a donor to subprogramme 2 for activities in the biennium 2008-2009.
- 4.11 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation activities would amount to \$145,700, representing 6.25 work-months of staff at the Professional level and 4.25 work-months of staff at the General Service level, of which \$126,700 will be funded from the regular budget and \$19,000 from extrabudgetary resources.
- 4.12 The estimated percentage distribution of the resources of the programme in the biennium 2010-2011 is as shown in table 4.4, and the distribution of resources is summarized in tables 4.5 and 4.6.

## A. Policymaking organs: Conference on Disarmament

### *Resource requirements (before recosting): \$43,400*

- 4.13 The Conference on Disarmament was set up in accordance with paragraph 120 of the Final Document of the Tenth Special Session of the General Assembly (resolution S-10/2) as the single multilateral disarmament negotiating forum of the international community. Following the expansions of its membership in 1996 and 1999, the Conference is open to the five nuclear-weapon States and 60 other States, including States of key military significance. In addition, every year some 40 non-member States are invited, upon their request, to participate in its work. The Conference on Disarmament conducts its work by consensus, adopts its own rules of procedure, rotates its presidency among all its members every four weeks, adopts its own agenda taking into account the recommendations made to it by the General Assembly and the proposals presented by the members of the Conference, and submits a report to the General Assembly annually, or more frequently, as appropriate. The Conference divides its 24-week annual session into three parts and, if necessary, continues its negotiations on priority issues between sessions. Meetings thus may take place during six to nine months each year.
- 4.14 Pursuant to paragraph 120 (c) of the Final Document of the Tenth Special Session of the General Assembly, the Secretary-General, following consultations with the Conference on Disarmament, appoints the Secretary-General of the Conference, who also acts as his Personal Representative, to assist the Conference and its Presidents in organizing the Conference. As requested by the Assembly in its resolution 34/83 L, the Secretary-General provides staff, as well as the assistance and services needed by the Conference and any subsidiary bodies that it might establish, in accordance with the arrangements contained in its rules of procedure. The secretariat of the Conference consists of officers of the Conference on Disarmament Secretariat and Conference Support Branch (Geneva) of the Office for Disarmament Affairs.
- 4.15 The Conference on Disarmament successfully concluded the negotiation of the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction (1992) and the Comprehensive Nuclear-Test-Ban Treaty (1996), with the participation of all five nuclear-weapon States and other militarily significant States. The Conference is currently conducting a comprehensive review of the priorities on the contemporary international disarmament agenda.

- 4.16 The non-post resources provide for travel of Geneva-based officials to attend meetings of the General Assembly and its subsidiary bodies, as well as other consultations and meetings hosted at Headquarters.

## B. Executive direction and management

*Resource requirements (before recosting): \$2,918,700*

- 4.17 Executive direction and management of the programme consists of the Office of the High Representative and the Office of the Director.
- 4.18 The Office of the High Representative is responsible for monitoring the implementation of the programme of work, as well as for the overall direction, supervision and management of the Office for Disarmament Affairs, including its financial and administrative activities. The High Representative provides the Secretary-General with advice and support on all disarmament and related security matters, and in that respect represents him as required, while also providing authoritative analysis and assessment of developments in these fields for policy guidance and decision-making purposes and acting as focal point on these matters between the Secretariat and Member States. The High Representative undertakes advocacy work to advance the disarmament agenda, in partnership with the relevant parts of the United Nations and other international organizations, as well as with civil society, the media, academia and foundations.
- 4.19 In the exercise of his responsibilities, the High Representative is assisted by the Director, who acts as deputy and assumes charge of the Office for Disarmament Affairs in the absence of the High Representative. The Director provides support to the High Representative on executive direction and management of the Office and ensures efficient coordination, synergy between branches and the delivery of the programmatic mandates of the Office. The Director advises the High Representative and makes recommendations on all substantive, organizational, administrative, personnel and budgetary matters. The Office of the Director is responsible for preparation of the programme of work, monitoring programme implementation and coordinating programme evaluation, as well as the overall coordination and revision of the outputs of the Office for Disarmament Affairs for the strategic framework and the programme budget. The Director is accountable to the High Representative.

### External factors

- 4.20 The programme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) the political environment will be supportive of disarmament efforts; (b) political developments relating to international peace and security will be conducive to the facilitation of negotiations on new arms limitation and disarmament agreements; (c) Member States will be willing to implement the recommendations, resolutions and decisions of relevant meetings and conferences; (d) international organizations will provide cooperation; (e) the required financial and human resources are made available; and (d) national institutions will be supportive of gender balance and mainstreaming issues.

### Outputs

- 4.21 During the biennium 2010-2011, the following final outputs will be delivered:
- (a) Substantive inputs and contributions, including political advice and analysis, to the Secretary-General on disarmament and non-proliferation-related matters in the form of briefing materials, statements and talking points;
  - (b) Advocacy on disarmament and non-proliferation issues with Member States and civil society through speaking engagements, conferences, information dissemination, raising public awareness and representation of the Secretary-General at international events and forums as appropriate;
  - (c) Regular monitoring of the Office's branches to ensure continued timely preparation and submission of parliamentary documentation and recurrent and non-recurrent publications;
  - (d) Support for multilateral efforts in the field of disarmament and non-proliferation, and cooperation with Member States, intergovernmental organizations and civil society, including at the regional level;
  - (e) Preparation, organization and substantive servicing of meetings and/or activities related to relevant disarmament bodies, conferences and meetings, such as the Conference on Disarmament, the First Committee of the General Assembly, the Disarmament Commission, review conference of parties to multilateral disarmament agreements and groups of governmental experts established by the General Assembly;
  - (f) Posting of vacancy announcements and the finalization of the interview process to ensure timely recruitment and placement of staff, while giving due consideration to gender and geographical balance and underrepresented Member States.

- 4.22 The amount of \$2,918,700, representing an increase of \$8,900, would provide for the continuation of eight posts, including five in the Professional category and above and three in the General Service category, as well as related non-post resources. The increase in non-post costs is attributable to the additional requirements for general temporary assistance and overtime during periods of peak workload in the Office of the High Representative and the Office of the Director.

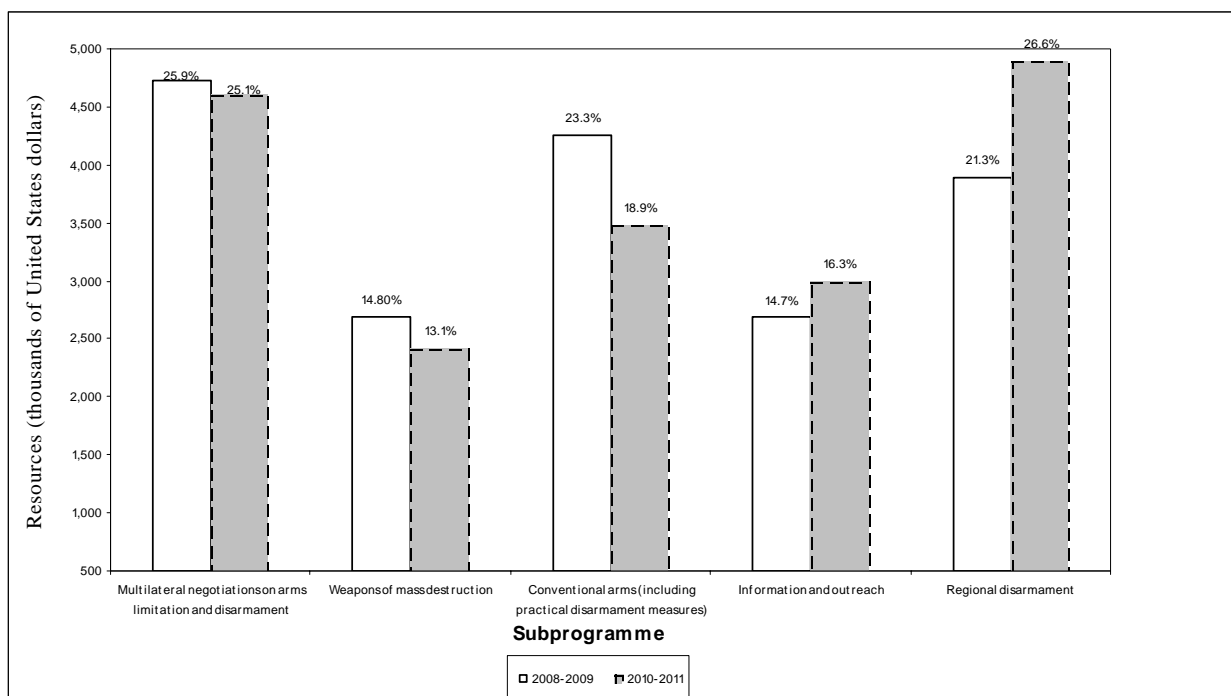

- 4.23 Substantive responsibility for this subprogramme is vested with the Conference on Disarmament Secretariat and Conference Support Branch at the United Nations Office at Geneva. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 1 of programme 3 of the strategic framework for the period 2010-2011.

- 4.26 The amount of \$4,611,600, reflecting a decrease of \$112,600, would provide for the continuation of eight posts, including five in the Professional category and above and three in the General Service category, as well as non-post resources for overtime, travel of staff, supplies, furniture and equipment and grants and contributions, including a subvention of \$558,200 to UNIDIR. The decrease in the non-post requirements reflects a lower provision for the fellowship programme based on the pattern of expenditure.
- 4.27 The amount of \$802,000 from extrabudgetary resources will be utilized to fund the tenth and eleventh annual Meetings and/or review conference of the States Parties to the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction and contribute to the Organization's objective of providing support to States parties to existing multilateral arms limitation and disarmament agreements, including through the purchase of specialized books and publications for the Disarmament Research and Reference Collection in order to provide up-to-date information for use by Member States in their negotiations on multilateral arms limitation and disarmament agreements, as well as by the substantive secretariat, research institutions and the general public.

- 4.31 The amount of \$2,414,600, reflecting a decrease of \$279,900, would provide for the continuation of eight posts, including six in the Professional category and above and two in the General Service category, and non-post resources for other staff costs, consultants and experts and travel of staff. The decrease in non-post requirements (\$279,900) reflects a lower provision for consultancy services owing to the finalization of the work of the Panel of Governmental Experts on the issue of missiles in all its aspects.
- 4.32 The amount of \$482,100 from extrabudgetary resources will be utilized to fund regional meetings on the implementation of Security Council resolution 1540 (2004), as well as transparency and confidence-building in the field of security, and to promote regional peace and security. The decrease is due to the finite nature of the funding provided by a donor to the subprogramme in the biennium 2008-2009.

- 4.36 The amount of \$3,475,400, reflecting a decrease of \$781,400, would provide for the continuation of 10 posts, including 7 in the Professional category and above and 3 in the General Service category, as well as related non-post resources. The decrease in non-post requirements of \$781,400, relating to other staff costs, consultants and experts, is due to the completion of the work of the Groups of Governmental Experts on an arms trade treaty and on ammunition, and the revised provision for expert group meetings based on the fact that the duration of meetings is to be shorter by one week.
- 4.37 The amount of \$777,000 from extrabudgetary resources will be utilized to support activities in promoting international cooperation and assistance in the implementation of the Programme of Action and the International Instrument on small arms and light weapons; promoting and supporting practical disarmament measures, including weapons-collection programmes and the reduction of armed violence; promoting and supporting practical confidence-building measures in the field of conventional arms; promoting and supporting the United Nations standardized instrument for reporting military expenditures; and promoting and supporting participation in the United Nations Register of Conventional Arms. The decrease is due to the discontinuation of the Trust Fund for the Consolidation of Peace through Practical Disarmament Measures in the biennium 2010-2011.

## Subprogramme 4 Information and outreach

**Resource requirements (before recosting): \$2,987,100**

- 4.38 Substantive responsibility for this subprogramme is vested with the Information and Outreach Branch. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 4 of programme 3 of the strategic framework for the period 2010-2011.

- 4.41 The amount of \$2,987,100, reflecting an increase of \$301,700, would provide for the continuation of eight posts, including five in the Professional category and above and three in the General Service category, and non-post resources for other staff and consultancy and expert group requirements. The increase in non-post resources of \$301,700 is attributable to the convening of the Advisory Board on Disarmament Matters and the Group of Governmental Experts on developments in information and telecommunications in the context of international security.
- 4.42 The amount of \$93,600 from extrabudgetary resources will be utilized to fund the services of consultants for the disarmament and non-proliferation component of the United Nations Cyberschoolbus website and the *Disarmament Yearbook*.

- 4.46 The amount of \$4,895,700, reflecting an increase of \$1,011,500, would provide for 17 posts, including 10 in the Professional category and above and seven in the General Service category; and non-post resources for other staff costs, consultants and experts, and travel. The increase in post requirements (\$570,400) is related to the proposal to establish four posts (two P-3 posts for Political Affairs Officers and two for Administrative Assistants (General Service/Local level)). This proposal is in line with General Assembly resolutions 63/74 and 63/77, wherein the Secretary-General was asked to provide from the biennial regular budget, starting in 2010-2011, the necessary support to ensure the sustainability of the core activities and operations of the Regional Centre for Peace, Disarmament and Development in Latin America and the Caribbean and the Regional Centre for Peace and Disarmament in Asia and the Pacific. The increase in non-post requirements (\$441,100) relates to the additional provision for other staff costs, consultants and experts for the meetings of the Standing Advisory Committee on Security Questions in Central Africa and the inclusion of a provision for the core operational expenses of the Regional Centre in Latin America and the Caribbean and the Regional Centre in Asia and the Pacific. Currently, core activities and operations of the Regional Centre for Peace and Disarmament in Africa are funded from the regular budget.
- 4.47 The amount of \$4,011,300 from extrabudgetary resources will be utilized to fund the following: (a) conferences, seminars and meetings organized by the three Regional Centres; (b) various projects on capacity-building, peacebuilding, security reforms and technical support; (c) supporting the activities of the Standing Advisory Committee; (d) operating costs of the three Regional Centres; and (e) promoting existing disarmament and non-proliferation agreements.

## D. Programme support

### *Resource requirements (before recosting): \$1,289,600*

- 4.48 The Executive Office provides services to the Office for Disarmament Affairs in connection with personnel, budgetary and financial administration, resource planning and use of common services, together with administrative support for meetings of policymaking organs and other meetings, as required.

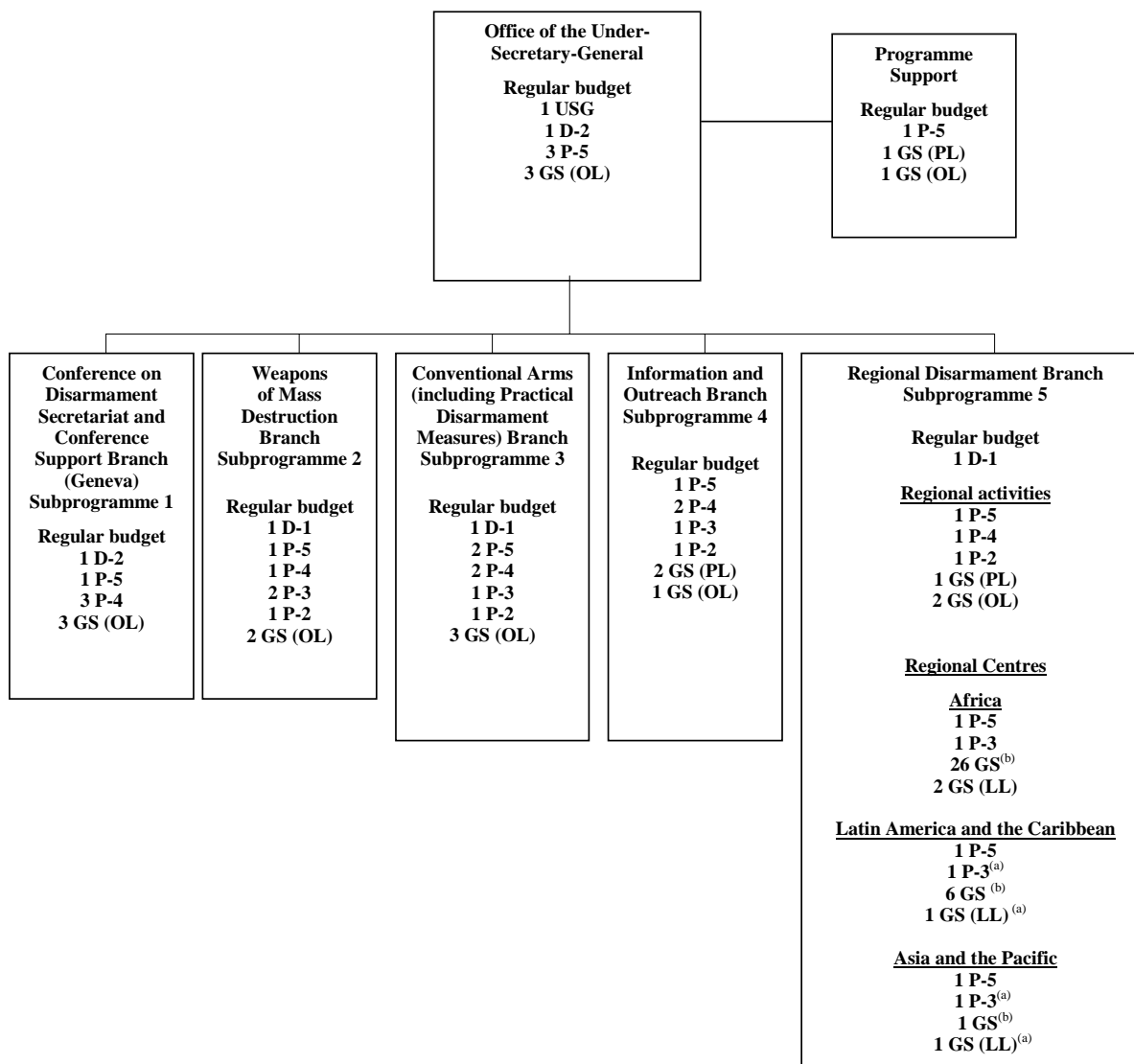

- 4.49 The amount of \$1,289,600, reflecting an increase of \$28,200, would provide for the continuation of three posts, including one in the Professional category and above and two in the General Service category, as well as non-post resources. The increase in non-post requirements of \$28,200 is due mainly to the provision for the contribution to support central data-processing services provided by the Office of Information and Communications Technology, partially offset by a decrease in the requirements for furniture and equipment.
- 4.50 The amount of \$507,600 from extrabudgetary resources relates to general temporary assistance for support in the management of the various trust fund accounts in the Office for Disarmament Affairs.
