**Mr. Landveld** (Suriname), Rapporteur of the Second Committee: It is a great pleasure, privilege and honour for me to introduce to the General Assembly the reports of the Second Committee on the agenda items allocated to it by the Assembly at its sixty-sixth session. At this juncture, I wish to express my gratitude to the Group of Latin American and Caribbean States, which endorsed my candidature for my current position as Vice-Chair in the Bureau of the Second Committee.

The reports of the Second Committee contained in documents A/66/437 to A/66/451 include the texts of draft resolutions and decisions recommended to the General Assembly for adoption. For the convenience of delegations, a checklist of the action taken in the Second Committee was prepared by the Secretariat and is contained in document A/C.2/66/INF/1.

During the main part of the sixty-sixth session of the General Assembly, the Second Committee held 38 formal meetings and six special events. In addition, the Committee held two joint formal meetings with the Economic and Social Council. I would like to take this opportunity to recommend that the Committee continue with that practice and take every opportunity available to improve its cooperation with the Economic and Social Council. The Second Committee adopted a total of 42 draft resolutions, 4 of which were adopted with a vote, and six draft decisions. There is also one draft resolution on which the Committee did not take action.

May I also take this opportunity to thank most sincerely our distinguished Chair, His Excellency Mr. Abulkalam Abdul Momen of Bangladesh, as well as Vice-Chair Denis Zdorov of Belarus, who, after nine years of work on the draft resolution on trade, this year managed to ensure that the draft resolution was adopted by consensus instead of by voting. That was a tremendous achievement. I also wish to thank Vice-Chairs Philippe Donckel of Luxembourg and Bitrus Vandy Yohanna of Nigeria for their extraordinary collaboration and partnership during this challenging and successful session of the Second Committee. It was indeed a pleasure to know and work together with them. I would also like to thank Mr. Tauhedul Islam of Bangladesh for his cooperation with the Bureau.

May I also thank the secretariat of the Second Committee for its outstanding assistance and support to me and to all the members of the Bureau. My thanks also go to Ms. Jennifer DeLaurentis, as well as to Ms. Vivian Pliner, who I heard might be moving on to greener pastures. I wish her well in her future endeavours. I also thank Ms. Radhika Padayachi, Ms. Maria Olvida and Ms. Mary Constable, as well as, from the Department of Social and Economic Affairs, Mr. Navid Hanif, Mr. Neil Pierre, Mr. Eric Olson and all others who made the work of the Bureau possible and who supported the negotiations to a successful conclusion.

I would like to request that any delegations that have queries about corrections to the text of the draft resolutions that were adopted by the Second Committee to communicate as soon as possible with the secretariat of the Second Committee in order for those corrections to be made prior to the final issuance of texts as resolutions of the General Assembly.

Finally, on a more personal note, I would like to take this opportunity to express my very best wishes to

all for a wonderful holiday season and the occasion to spend a well-deserved break from our work. Last, but not least, I wish everyone peace and prosperity in the new year.

**The President** (*spoke in Arabic*): I thank the Rapporteur of the Second Committee.

May I also remind delegations that, also in accordance with decision 34/401, explanations of vote are limited to 10 minutes and should be made by delegations from their seats. When a report contains more than one draft resolution, delegations will have an opportunity to explain their positions before and after the General Assembly takes action on all of the draft resolutions.

Before we begin to take action on the recommendations contained in the reports of the Committee, I should like to advise representatives that we are going to proceed to take decisions in the same manner as was done in the Second Committee, unless the Secretariat is notified otherwise in advance. I should therefore hope that we may proceed to adopt without a vote those recommendations that were adopted without a vote in the Committee.

The President (*spoke in Arabic*): The Assembly has before it two draft resolutions recommended by the Second Committee in paragraph 13 of its report. The Assembly will now take action on the two draft resolutions.

We turn first to draft resolution I, entitled "International trade and development". The Second Committee adopted it. May I take it that the Assembly wishes to do the same?

## (b) International financial system and development Report of the Second Committee (A/66/438/Add.2)

**The President** (*spoke in Arabic*): The Assembly has before it two draft resolutions recommended by the Second Committee in paragraph 18 of its report. The Assembly will now take action on the two draft resolutions.

Draft resolution I is entitled "International financial system and development". The Second

Committee adopted it. May I take it that the Assembly wishes to do likewise?

Draft resolution I was adopted (resolution 66/187).

**The President** (*spoke in Arabic*): Draft resolution II is entitled "Addressing excessive price volatility in food and related financial and commodity markets". The Second Committee adopted it. May I take it that the Assembly wishes to do likewise?

Draft resolution II was adopted (resolution 66/188).

**The President**: I now give the floor to the representative of the Dominican Republic, who wishes to speak in explanation of position.

**Mr.** Alcántara Mejía (Dominican Republic) (*spoke in Spanish*): The delegation of the Dominican Republic would like to underscore the special significance of resolution 66/188, entitled "Addressing excessive price volatility in food and related financial and commodity markets", which the General Assembly just adopted. This is a new resolution whose theme reflects an initiative by the President of our country, Leonel Fernández Reyna, which was taken up by the Group of 77 and China. It is a resolution that President Fernández Reyna instructed us to orient towards four primary goals.

The first objective was that the resolution should posit the recognition of the existence of a disturbing phenomenon in the futures markets, namely, excessive price volatility, particularly with respect to food. Secondly, it should indicate that this phenomenon is having an adverse impact, both on producing countries as well as on net importers of food. Thirdly, it should establish a mechanism whereby the issue could be addressed in depth at the Organization. That forum, as the resolution has established, will be a high-level thematic debate in which the Dominican Head of State will participate alongside senior representatives of Member States as well as experts and scholars on the subject, representing the agencies of the United Nations and other relevant international organizations. And, fourthly, the resolution would recommend that those organizations and agencies continue with their analysis and investigation into the topic of excessive food price volatility in futures markets.

At this point, our delegation would like to express its appreciation for the constructive and flexible manner in which all delegations undertook the discussion of the resolution, and in particular for the support of the Group of 77 and China, which early on in the process expressed their commitment to the issue. We never thought that the opposing positions that were aired during the negotiations would become irreconcilable differences. As coordinators of the resolution, on behalf of the Group of 77 and China, the representatives of the Dominican delegation proceeded with the conviction that solutions arose from cooperation. Throughout the negotiations, which had their difficult moments, a constructive spirit prevailed. I am pleased to report that flexibility and cooperation ultimately prevailed.

Problems such as those articulated by the resolution belong to everyone. Problems that concern us all are not going to be resolved by counting the votes on the resolutions that address them, nor by avoiding the necessary political discussions thereon. It has been repeatedly proven at the United Nations that our best chance for overcoming them lies in cooperative joint action. That is exactly what we have achieved with this resolution, namely, consensus.

Before concluding, I would like to make two additional points. The first is anecdotal. Both during the adoption of the draft resolution within the Group of 77 and China as well as during the final consensus stage, what we refer to here as the silent procedure became a suspense procedure for the delegation of the Dominican Republic. My second point is to emphasize that this is a landmark. The fact that the resolution takes note of the initiative of President Leonel Fernández Reyna will make him and his initiative historic reference points in the way that the Organization addresses, discusses and takes decisions on the matter of excessive food price volatility in futures markets.

(a) Follow-up to the Fourth United Nations Conference on the Least Developed Countries

## Draft decision (A/66/L.30)

The President: The General Assembly has just adopted resolution 66/213, recommended in the report of the Second Committee on the implementation of the Fourth United Nations Conference on the Least Developed Countries (A/66/443/Add.1). Paragraph 16 of the resolution

"Requests the President of the General Assembly to establish, in consultation with Member States and the Secretary-General, an ad hoc working group to further study and strengthen the smooth transition process for the countries graduating from the least developed country category and to submit a report to the General Assembly during its sixty-seventh session with specific recommendations, consistent with the Istanbul Programme of Action".

As members will recall, the Istanbul Programme, which was adopted in May, in its paragraph 143, invited the General Assembly to establish such a group.

To follow up on that mandate, and in line with resolution 66/213, I have undertaken extensive consultations with Member States, in particular the major groups that are closely involved in this matter, namely, the Group of Least Developed Countries, the Group of 77 and China, the European Union and the Group of Friends of the Least Developed Countries, which represents a variety of Member States, including key development partners, as well as with the Secretary-General. The draft decision before the Assembly contained in document A/66/L.30 is the product of those consultations, and has been submitted for adoption to the General Assembly by me in my capacity as its President.

In that connection, I would like to propose an oral revision in order to insert a reference to resolution 66/213. The draft decision should therefore read as follows:

"The General Assembly, recalling its resolutions 65/280 of 17 June 2011, 65/286 of 29 June 2011, and 66/213 of 22 December 2011,

decides to adopt the terms of reference of the ad hoc working group to further study and strengthen the smooth transition process for countries graduating from the least developed country category annexed to the present decision."

In that regard, I would like to draw the Assembly's attention to the oral statement that was made in the Second Committee by the Secretariat relating to the programme budget implications of paragraph 16 of resolution 66/213, indicating that there would be no such implications for the programme budget for the biennium 2012-2013.

I would emphasize that the proposed ad hoc working group would undertake an important responsibility vis-à-vis achieving one of the key objectives of the Istanbul Programme with regard to the graduation of Least Developed Countries (LDCs) and the needed smooth transition process for those graduating. To be in a position to complete its work and submit its report to the sixty-seventh session of the Assembly in time, the ad hoc working group needs to commence its work very early in 2012. I suggest that the group convene its first meeting in mid-January to organize its work and prepare a road map for its substantive work for completion by early September 2012.

I would underscore the need for the Secretariat to attach high priority to the work of the working group and to extend its full support in every possible way. In that regard, I would particularly emphasize the support to be provided by the United Nations Office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States as the secretariat of the group, as well as by the Department for Economic and Social Affairs and the United Nations Committee for Development Policy and its secretariat.

I will closely follow the progress in the work of this group. As I have reiterated time and again, the Least Developed Countries and their Programme of Action should be a top priority for the international community as a whole. I would call for the wholehearted engagement of the United Nations system and its leadership, of its Member States and of all other development partners in the full and effective implementation of the LDC Programme. The working group is open-ended and any Member State that wants to contribute substantively to its work will be able to do so. Relevant non-State partners, including think tanks, research bodies, development institutions and private sector and civil society representatives could be invited by the co-chairs, in consultation with group members, to make their contribution.

In view of the substantial overlap in the composition of the Group of Small Island Developing States and the Group of Landlocked Developing Countries with the Group of LDCs, I would strongly recommend that the Chairs of those groups should at least participate regularly in the work of the working group, in addition to individual members of their Groups who would decide to participate.

I would like to take this opportunity to announce that I have decided to appoint Ambassador Jan Grauls, Permanent Representative of Belgium, and Ambassador Brian Bowler, Permanent Representative of Malawi, as co-Chairs of the ad hoc working group. I wish them every success in their work.
