

Annex to the letter dated 16 September 2013 from the Permanent Representative of Argentina to the United Nations addressed to the Secretary-General

Charter of the Group of Friends of Spanish at the United Nations

The representatives of the Spanish-speaking Member States to the United Nations,

Convinced of the central role of languages in promoting understanding among peoples, tolerance and respect for cultural and linguistic diversity,

Committed to respect for multilingualism as a guiding principle of all United Nations activities, with a view to spreading its message of peace among the peoples of the world in their own languages,

Committed also to respect for the principle of parity in the use of the six official languages of the United Nations, equitably and without discrimination,

Encouraged by the growing use of Spanish as a universal language and, as such, as a vehicle for peace, respect for human rights and social and economic development among peoples that speak that language,

Recalling that Spanish is one of the six official languages of the United Nations and a working language of the General Assembly and its committees and subcommittees, of the Security Council and of the Economic and Social Council,

Convinced that the use and spread of the Spanish language contribute to the ideals, purposes and principles of the Organization,

Encouraged, in particular, by the growing interest of Spanish-speaking peoples in the work of the United Nations, which has been having an impact on the activities of the Organization through increased and ongoing consultations, interactions and demands on the part of the Spanish-speaking public worldwide,

Convinced that strengthening cooperation between the United Nations and a group of friends encompassing the Spanish-speaking countries will be of benefit to the ideals, purposes and principles of the United Nations and the general welfare of peoples,

Expressing the desire to strengthen, develop and reinforce their existing ties in the political, economic, social and cultural fields,

- 1. *Decide* to establish the "Group of Friends of Spanish" within the context of the United Nations, with a mandate based upon the aforementioned aims;
- 2. Authorize the Group of Friends of Spanish to coordinate and carry out activities to promote the use and spread of the Spanish language in the work of the United Nations, including the coordination of a common voice in those efforts, bearing in mind the purposes for which that mandate was conferred;
- 3. Also authorize the Group of Friends of Spanish, to that end, to hold regular meetings, including with the relevant authorities of the Secretariat and other United Nations organs, as well as with other language groups within the United Nations:

4. *Invite* other Member States that share the values and objectives set forth in this charter to become observers of the Group of Friends of Spanish, with a view to contributing to the aims on which its mandate is based.
