### **Permanent memorial to and remembrance of the victims of slavery and the transatlantic slave trade: status of the United Nations Trust Fund for Partnerships — Permanent Memorial**

#### **Report of the Secretary-General**

#### **I. Introduction**

1. In paragraph 12 of its resolution [68/7](#), the General Assembly requested the United Nations Office for Partnerships, through the Secretary-General, to submit a comprehensive report to the Assembly at its sixty-ninth session on the status of the United Nations Trust Fund for Partnerships — Permanent Memorial, established with a view to implementing the initiative to erect a permanent memorial in honour of the victims of slavery and the transatlantic slave trade.
2. The present report is submitted pursuant to that request.

#### **II. Status of the Trust Fund**

3. As at 31 May 2014, a total of \$1,448,065 had been recorded as income received from contributions and interest under the United Nations Trust Fund for Partnerships — Permanent Memorial, which includes voluntary contributions from Member States amounting to \$1,288,519 and public and private donations totalling \$108,612. The breakdown of the contributions received is provided in the annex to the present report. With regard to expenditure, an amount of \$402,429 had been utilized, primarily towards the international design competition (see below), the cash prize for the winning artist and initial construction fees. The Fund had an unspent balance of \$1,074,085.

4. In keeping with the intention of the General Assembly, as expressed in its resolutions [64/15](#) and [65/239](#), the Committee of interested States established to oversee the permanent memorial project (Permanent Memorial Committee), the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the United Nations Office for Partnerships signed a tripartite memorandum of understanding to conduct an international competition to select a design for the permanent memorial. The goal of the competition was to identify an outstanding artistic complement to the iconic landscape of United Nations Headquarters that would deepen, both visually and spiritually, the experience of visitors.

5. After receiving 310 entries from across the world, UNESCO shortlisted 16 entries to be evaluated in the second phase of the competition. A panel of five internationally acclaimed professionals with diverse backgrounds (an architect, a curator, a cultural adviser, an academic and an educator specialized in art) then selected seven finalists. The judges met in New York in August 2013 to evaluate the proposals. Following their deliberations, the judges selected *Ark of Return*, by Rodney Leon, as the winning design.

6. The winning design was unveiled by the Secretary-General at a ceremony at United Nations Headquarters on 23 September 2013. Speakers at the event included the President of the sixty-eighth session of the General Assembly, John W. Ashe; the Prime Minister of Jamaica, Portia Simpson Miller; the Director General of UNESCO, Irina Bokova; and the Chair of the Permanent Memorial Committee, Courtenay Rattray.

7. In February 2014, the Permanent Memorial Committee entered into an agreement with the winning architect to provide design services in order to establish a framework for the final scope of the construction and erection of the memorial. The Committee is working towards completing the erection of the memorial in the first quarter of 2015.
