## Groups of countries in special situations

### Report of the Second Committee\*

1. At its 2nd plenary meeting, on 16 September 2016, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-first session the item entitled:

“Groups of countries in special situations:

“(a) Follow-up to the Fourth United Nations Conference on the Least Developed Countries;

“(b) Follow-up to the second United Nations Conference on Landlocked Developing Countries”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 16th meeting, on 19 October 2016. Attention is also drawn to the general debate held by the Committee at its 2nd to 5th meetings, on 3 and 4 October.<sup>1</sup> An account of the Committee’s further consideration of the item is provided in the addenda to the present report.
