Report of the Second Committee*

1. At its 2nd plenary meeting, on 16 September 2016, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-first session the item entitled:

“Operational activities for development:

“(a) Operational activities for development of the United Nations system;

“(b) South-South cooperation for development”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 6th and 7th meetings, on 6 October 2016.
