#### NOTE

The resolutions and decisions of the General Assembly are identified as follows:

#### **Regular sessions**

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

#### Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter "S" and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter "S" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

#### **Emergency special sessions**

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters "ES" and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters "ES" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).

In each of the series described above, the numbering follows the order of adoption.

(*a*) Reiterated its request to the International Tribunal to complete its work and facilitate the closure of the Tribunal as expeditiously as possible with the aim of completing the transition to the International Residual Mechanism for Criminal Tribunals (the Mechanism) and, in the light of Security Council resolution 1966 (2010) of 22 December 2010, to redouble its efforts to review its projected case completion dates, with a view to shortening them as appropriate, and to prevent any additional delays;

(b) Took note of the commitment of the International Tribunal to complete its judicial work no later than 30 November 2017;

(c) Also took note of the request of the President of the International Tribunal for a final extension of the terms of office of the permanent judges of the Tribunal, until 30 November 2017 or until the completion of the cases to which they were or would be assigned, if sooner, and strongly emphasized that the following extensions and reappointment should be final;

(*d*) Decided, under that condition:

(i) To extend the terms of office of the following permanent judges at the International Tribunal, who were members of the Trial Chambers and the Appeals Chamber, until 30 November 2017 or until the completion of the cases to which they were or would be assigned, if sooner:

2003, the general debate would begin on Tuesday, 20 September 2016, decided that the general debate would continue on Saturday, 24 September 2016, in order to maximize the number of speakers during that week.

#### 71/504. Adoption of the agenda and allocation of items

Also at the same meeting, the General Assembly, on the recommendation of the General Committee as set forth in its first report,<sup>31</sup> decided to include in the agenda of its seventy-first session the item entitled "Request for an advisory opinion of the International Court of Justice on the legal consequences of the separation of the Chagos Archipelago from Mauritius in 1965", under heading F (Promotion of justice and international law), on the understanding that there would be no consideration of this item by the Assembly before June 2017 and that thereafter it may be considered upon notification by a Member State.

At its 35th plenary meeting, on 27 October 2016, the General Assembly, on the recommendation of the General Committee as set forth in its second report,<sup>32</sup> decided to include in the agenda of its seventy-first session an additional item entitled "Observer status for the Central American Bank for Economic Integration in the General Assembly" as agenda item 174, under heading I (Organizational, administrative and other matters), and to allocate it to the Sixth Committee.

At its 68th plenary meeting, on 23 December 2016, the General Assembly decided to consider directly in plenary meeting agenda item 20 entitled "Implementation of the outcomes of the United Nations Conferences on Human Settlements and on Housing and Sustainable Urban Development and strengthening of the United Nations Human Settlements Programme (UN-Habitat)", under heading A (Promotion of sustained economic growth and sustainable development in accordance with the relevant resolutions of the General Assembly and recent United Nations conferences), and to proceed expeditiously with the consideration of a draft resolution.<sup>33</sup>
