

# Revitalization of the work of the General Assembly

## Report of the Sixth Committee

Rapporteur: Mr. Peter Nagy (Slovakia)

### I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the seventy-second session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 15 September 2017, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the purpose of discussing their working methods and considering and taking action on their respective tentative programmes of work for the seventy-second session of the General Assembly.
- 3. The Sixth Committee considered the item at its 29th and 30th meetings, on 6 and 10 November 2017. The views of the representatives who spoke during the Committee's consideration of the item are reflected in the relevant summary records.<sup>1</sup>

## II. Consideration of draft decision A/C.6/72/L.24

- 4. At the 30th meeting, on 10 November, the Chair introduced a draft decision containing the provisional programme of work of the Committee for the seventy-second session of the General Assembly, as proposed by the Bureau (A/C.6/72/L.24), and orally revised the dates of the consideration of the agenda items listed in the provisional programme of work.<sup>2</sup>
- 5. At the same meeting, the Committee adopted draft decision A/C.6/72/L.24, as orally revised (see para. 6).
