I. Introduction

1. By its resolution [71/323](#), the General Assembly decided to establish, at its seventy-second session, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:

(a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation;

(b) To submit a report thereon to the Assembly at its seventy-second session.

2. The General Assembly also decided that the Ad Hoc Working Group should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-first session ([A/71/1007](#)), and, as a result, to continue to update the inventory to be attached to the report to be submitted to the Assembly at its seventy-second session. The present report and the recommendations contained herein are submitted pursuant to the provisions of that resolution.

3. During the seventy-second session of the General Assembly, the President of the General Assembly appointed the Permanent Representative of Colombia to the United Nations, María Emma Mejía Vélez, and the Permanent Representative of Croatia to the United Nations, Vladimir Drobnjak, as Co-Chairs of the Ad Hoc Working Group.

II. Proceedings

4. The Working Group held a total of seven meetings, on 20 February, 9 and 20 March, 16 and 27 April and 12 September 2018.

5. The programme of work was organized as follows: general discussion and exchange of views; and thematic meetings. In accordance with paragraph 36 of resolution [71/323](#), the general debate and the thematic meetings were webcast.

6. The themes identified by the Co-Chairs for consideration in the four thematic meetings comprised:

(a) The role and authority of the General Assembly;

(b) The working methods of the Assembly;

(c) The selection and appointment of the Secretary-General and other executive heads of the United Nations system;

(d) The strengthening of the institutional memory of the Office of the President of the General Assembly.

7. In addition, one meeting was held as part of the interactive dialogue between permanent missions and the Secretariat (5 April 2018). A presentation of the zero draft of the resolution was made at an informal meeting on 25 May 2018.

A. General discussion

8. The first meeting of the Working Group was convened by its Co-Chairs on 20 February 2018 (the list of speakers was subsequently continued, and exhausted, immediately prior to the first thematic meeting, on 9 March) and was attended by the President of the General Assembly. Following introductory remarks by the President,

the participants of the meetings heard interventions from 23 delegations, including on behalf of major groups (the remainder of the list of speakers was exhausted immediately preceding the second meeting, on 9 March). The Working Group also had before it a tentative timetable for the thematic discussions; the report of the Secretary-General on mandates addressed to the Secretariat that had not been implemented (A/72/736), issued pursuant to resolution 71/323; and a draft updated inventory chart of all revitalization mandates, which was uploaded on the dedicated revitalization link accessible from the website of the General Assembly (<http://www.un.org/en/ga/revitalization/>).

9. In his opening remarks, the President of the General Assembly pointed to a significant increase in the work of the General Assembly over the past several decades, citing, for example, a rise in the number of agenda items and resolutions adopted and in the number of issues that are considered directly in plenary meetings. He cited the inclusion and participation of other stakeholders as an opportunity to further enhance the Assembly's work. The President cautioned, however, that there was currently no adequate system in place to support the Office of the President of the General Assembly in that process. The President further argued that, in spite of a number of steps taken during previous sessions, such as the introduction of handover reports and a retreat bringing together the incoming and the outgoing presidents, the Office had almost no institutional memory. That was compounded by a lack of preparation time, as the President assumed office one week before the high-level week. Furthermore, Presidents-elect were tasked every year with mobilizing the funds to sustain a year-long budget, which, the President suggested, led to a lack of predictability that could have an adverse effect on the activities of the Office. The President looked forward to the Working Group's consideration during the session of a possible code of conduct to guide election campaigns. Another major opportunity was the innovation of holding informal dialogues with candidates for the post of President and their presentation of a vision statement.

10. In the subsequent debate, speakers overwhelmingly noted the importance of the revitalization process and highlighted the significant achievements realized during the previous sessions, citing, in particular, the adoption of resolutions 69/321, 70/305 and 71/323. The webcasting of the meetings of the Working Group was welcomed as an enhancement of the transparency and accountability of the General Assembly.

11. A group of Member States underscored the importance of preserving the intergovernmental, inclusive and democratic nature of the United Nations and stressed the imperative need to consult with Member States within the Organization. Member States emphasized the need to respect the Charter-based prerogatives of each of the principal organs. Other delegations focused on enhancing the General Assembly's efficiency and effectiveness and called for concrete steps to deliver in better and more efficient ways and to ensure that the Organization worked within the agreed budget levels. One delegation called for vigilance about budgetary implications and stressed that efficiency entailed operating within existing resources.

12. The desire to streamline the agenda of the General Assembly was widely shared, including through the biennialization, triennialization, clustering and elimination of agenda items. One group of States strongly believed that certain resolutions should be on the basis of a biennial and triennial cycle. Another speaker proposed reducing the number of agenda items as an issue of urgent importance, arguing that it would enhance the Assembly's ability to address challenges with increased efficiency and effectiveness. Several speakers referred to the option of introducing a sunset clause. One delegation cautioned, however, that any streamlining of the agenda needed to be done on a case-by-case basis and in consultation with the Member States concerned. Speakers also recalled past and ongoing efforts to streamline the agendas of the

General Assembly and the Economic and Social Council with the 2030 Agenda for Sustainable Development.

13. Member States touched upon the scheduling of high-level meetings during the high-level week in September. Many stressed that such meetings should be kept to the absolutely critical minimum in order to preserve and strengthen the sanctity of the general debate. Noting that the high-level week was already extremely busy, one speaker suggested that new high-level meetings should be spread out over the rest of the year and should focus on subjects relevant to the entire membership. Another encouraged Member States to be bold enough to take the steps necessary to reduce the schedule of high-level events on the margin of the general debate, noting Member States' responsibility for the proliferation of such meetings. One delegation called for the finalization of the calendar of high-level meetings at least six months before September and its timely distribution to Member States in order to give sufficient time to plan participation. A delegation also expressed the wish that the list of speakers for the general debate should be produced in a manner that more accurately reflects the political context of individual Member States in which the Head of State performs a ceremonial or symbolic role and the Head of Government holds the highest political office.

14. Some delegations called upon the General Committee and the Secretariat to further coordinate in order to avoid scheduling conflicts between plenary meetings and subsidiary bodies that dealt with issues involving the same experts. In general, the scheduling of meetings should take into account the capacities of permanent missions from developing countries.

15. Several speakers welcomed the steps taken regarding the provision of the *Journal of the United Nations* in digital format in all six languages. Many delegations encouraged the taking of additional steps to improve its accessibility even further. The need for full implementation of rule 55 of the rules of procedure of the General Assembly was reiterated. One delegation expressed the specific wish that the information regarding the ratification of treaties be provided in all six languages. Another encouraged the Secretariat to make available on handheld devices information on cancellations of meetings, as currently displayed on screens at United Nations Headquarters. Some speakers looked forward to the continuation during the seventy-second session of the comprehensive dialogue established between permanent missions and the Secretariat.

16. Attention was given to the selection process of the Secretary-General and other executive heads. A group of States referred to its conclusions from the most recent selection process ([A/72/514-S/2017/846](#)) and, together with other groups, argued for the consolidation of the historic achievement attained. Improved interaction between the Security Council and the General Assembly was highlighted as a topic for further discussion. Another group underlined that, at whatever stage a candidature was presented, the new procedure would always be followed in the future, and encouraged a deadline for the presentation of candidates. This group also wished to further consider the possibility of submitting multiple candidates to the General Assembly; the application of practices used in the selection of other executive heads; and updating the oath of office. The same group wished to see extensive consultations on the draft resolution on the appointment of the Secretary-General and the conduct of a secret ballot in the Assembly.

17. Another delegation, however, argued against a non-renewable single term and in favour of appointment by consensus so as to ensure that the Secretary-General enjoyed the unified support of the entire membership. It was stressed that any new proposals must be studied very carefully to ensure their conformity with the Charter

of the United Nations and that the viability of innovative ideas ought to be borne in mind before they were tabled.

18. Regarding the appointment of other executive heads and senior officials in the Organization, one group advocated that the Secretary-General should exercise independence in appointing senior officials, while securing the highest standards of efficiency, competence and integrity, as well as equal and fair distribution based on gender and geographical balance. While commending the Secretary-General for the steps already taken, many delegations wished to receive a clearer overview from the Secretariat regarding vacancies for all senior posts and a broader and timely dissemination to the wider membership of positions available at the level of Under-Secretary-General and other senior posts. It was stressed that, in line with past resolutions, no country or group of countries should hold any type of monopoly on senior positions in the Secretariat.

19. With regard to the strengthening of the Office of the President of the General Assembly, several delegations welcomed the steps taken to ensure greater transparency and accountability. A group of States wished to see additional posts in the Office of the President of the General Assembly on a permanent basis, as well as sufficient human and financial resources from the United Nations regular budget. It also highlighted the need for successful transition from one presidency to the next. One delegation proposed holding the election of the President earlier than June in order to afford the President-elect sufficient time to assemble a team and adequately prepare for the handover. The informal dialogue with candidates for the post was cited as an important innovation that would serve to ensure that the best candidate was elected.

20. Several speakers noted that only 3 of the 72 Presidents to date had been women and that it was of the utmost importance that the next President should be a woman from Latin America. Noting that the President had become a global interlocutor at the highest international levels, and pointing out that Presidents were elected in their personal rather than national capacity, one delegation stressed that the person must have the best qualifications to accomplish the ever more complex tasks inherent to the office. The creation of informal dialogues therefore was of the highest significance to ensure that Member States had the best information at their disposal to decide which candidate to support. A group of States, which noted that the President's role over the years had transcended ceremonial and procedural aspects, appealed to the current President to make sure that all information — including financial, staffing and official travel information — was updated regularly. Another group encouraged the President to continue improving the digital publishing of documents. Yet, it was emphasized that any proposal on enhancing the institutional memory of the Office of the President of the General Assembly needed first to be considered by the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee.

21. In concluding remarks, the Co-Chairs noted the wide range of substantive issues raised and emphasized that their main objective would continue to be to listen to Member States' interventions during the forthcoming thematic debates. The views and positions would form the basis for the zero draft of the resolution to be circulated before the commencement of the negotiations.

B. Thematic meetings

First thematic meeting: the role and authority of the General Assembly

22. In the course of the first thematic meeting, held on 9 March 2018, 22 delegations made statements, including on behalf of major groups (immediately prior to the first

thematic meeting, the Working Group exhausted the list of speakers from the first meeting, which had been dedicated to a general debate). Following opening remarks by the Co-Chairs a briefing was provided by Under-Secretary-General for Global Communications on efforts by the Department of Public Information to enhance the visibility of the work of the General Assembly.

23. The Under-Secretary-General for Global Communications affirmed that the General Assembly continued to be at the centre of the efforts of the Department of Public Information to tell the United Nations story to the global public every day, in as many languages and via as many platforms as possible. The Under-Secretary-General cited the live and archived webcast coverage of the meetings of the plenary and the Main Committees as well as same-day press releases in English and French summarizing the proceedings. She also noted the practical support provided by the Department to the Office of the President of the General Assembly, which included making a staff member available to support the communications team of the Office, producing and disseminating the annual General Assembly press kit and providing year-round media support to the President, for example, assisting in the placement of op-eds, amplifying social media content, arranging media interviews and providing media monitoring when the President was travelling.

24. In the subsequent interactive segment, one delegation expressed its serious concern that press releases produced by the Department in different languages were not identical in all versions. Another pointed to the potential loss of meaning in the interpretation from one language to another. Noting that there were no clear criteria as to when the Secretariat provided official photography services, one delegation suggested that a notice should be placed in the *Journal* to inform delegations in advance, which would assist smaller permanent missions in particular in their daily work. A link could also be placed in the *Journal* to access photographs that had been taken. Another delegation highlighted the need for web pages to be updated more regularly. The Under-Secretary-General took note of the concerns raised and assured the delegations that the Department would look into them. She also assured them that the Department was committed to being as accurate as possible in its press releases in different language versions, which by their nature had to be produced simultaneously, and stressed the Department's commitment to further engage with Member States on the issue.

25. In the course of the subsequent debate, delegations focused on the role and authority of the General Assembly, especially from the perspective of the Assembly's relationship with the other principal organs, in particular the Security Council.

26. Many Member States stressed the importance of strengthening the authority of the General Assembly, including in matters of peace and security. For example, one group of States stressed the necessity of complete observance by the Security Council of all Charter provisions, as well as of General Assembly resolutions, and urged the Council to submit a more comprehensive and analytical annual report to the General Assembly. Other speakers stressed that the best way to enhance the role and authority of the Assembly was to improve its efficiency and effectiveness, pointing to, among other elements, the respective and complementary functions of the General Assembly and the Security Council.

27. Referring to a proposal for the Working Group to elaborate a code of conduct for election campaigns during the seventy-second session, one delegation noted that a more realistic innovation would be to offer Member States a platform to engage with candidates for seats on the Security Council and the Human Rights Council regarding their track record and commitment to the principles set out in the Charter and in the resolution establishing the Human Rights Council, respectively.

28. In the context of efficiency, a group of States underscored the need to take steps to find new and creative ways to work to achieve a more effective delivery of mandates and sustainable use of resources. Some delegations emphasized the importance of including other stakeholders in the work of the General Assembly. Arguing that it was not too early to focus on the commemoration of the seventy-fifth anniversary of the United Nations, it was suggested that the Working Group could pave the way for the formal preparatory process.

29. A large majority of delegations called for greater coherence in the work of the various principal organs and greater coordination among them through regular meetings of their Presidents. Efforts to that end should include rationalizing their respective agendas, in particular those of the General Assembly and the Economic and Social Council — and their subsidiary organs — in the light of the 2030 Agenda. More generally, it was argued that the voluminous agenda of the Assembly was a burden for Member States, which was exacerbated by the heavy load of documentation.

30. With regard to the interactive and comprehensive dialogue between permanent missions and the Secretariat, which was established under the cluster of this thematic debate, a group of States looked forward to the practical implementation of the new provisions agreed the previous year. Some delegations sought an update on the implementation of the “one-stop-shop” application.

31. One delegation expressed concern over a perceived lack of coordination within the Secretariat and called for greater responsiveness by the Secretariat to Member States’ requirements. An important means of identifying such requirements — in addition to the formal dialogues established by the Working Group — could be holding informal exchanges at the working level.

32. Against the backdrop of the forthcoming election of the President of the seventy-third session, one speaker advocated equitable geographical rotation in the election of the Presidents of the General Assembly; whereas another looked forward to the informal dialogue with candidates pursuant to resolution [71/323](#).

33. In concluding remarks, the Co-Chairs noted the wide range of substantive issues raised and highlighted in particular the proposal to pave the way for preparing the commemoration of the seventy-fifth anniversary of the United Nations.

Second thematic meeting: the working methods of the General Assembly

34. The second thematic meeting was convened by the Co-Chairs on 20 March 2018. In accordance with paragraph 21 of resolution [71/323](#), the meeting participants heard briefings from the Chairs and representatives of the six Main Committees. During the interactive question-and-answer segments that followed, delegations had an opportunity to pose questions.

35. The Co-Chairs, in their opening remarks, outlined several achievements attributable to resolution [71/323](#) and identified certain topics that might be addressed during the session. Regarding the latter, they looked forward to hearing from Member States, including on a possible code of conduct to guide election campaigns; reducing the number of side events in September; the pattern of rotation of Main Committee Chairs; and the possibilities of rationalizing the agenda of the General Assembly. Another matter that had been discussed in the previous session related to the possibility of bringing forward the opening of the Assembly’s session to an earlier date, without, however, changing the start of the general debate. The Co-Chairs invited delegations to evaluate the revised format, production and editing of the *Journal*, noting general satisfaction with the substantial innovation undertaken over

the year. The Co-Chairs thanked the Secretariat for having organized tutorials on the use of the new “one-stop-shop” portal.

Briefings by the Chairs of the Main Committees

36. The Chair of the First Committee noted the development of the Committee’s working methods over the years, as seen in relevant General Assembly resolutions. The use of the e-Speakers and e-Sponsors tools had added convenience for delegations and increased the transparency of the proceedings. The recommendations of the previous Bureau had been taken into consideration in the improvement of the e-Sponsors tool. The First Committee “Place” had been introduced in 2017 to provide services through a single portal. Great emphasis had been placed on time management and the Committee had been able to achieve a utilization factor of 97 per cent, in spite of a record number of speakers. The Chair applauded delegations’ efforts to deliver their statements within the time limits set, which was facilitated by a buzzer system. There was, however, scope for greater participation by civil society.

37. The Rapporteur of the Fourth Committee conveyed the Bureau’s support for the ongoing efforts to further streamline and rationalize the agenda of the General Assembly. The Committee had continued its practice of holding interactive dialogues with high-level representatives of the Secretariat and agencies, in accordance with resolution [58/316](#). With a view to achieving closer coordination and cooperation among the Main Committees, a joint panel discussion was held by the First and Fourth Committees on the issue of space security. This was the second such joint panel discussion: the first had been held during the seventieth session. Time management had proved crucial for the successful conduct of work during the session. The use of a flashing light on microphones when one minute remained had proved to be helpful. With regard to e-services, while e-deleGATE served to simplify the flow of information, the greatest benefit had been seen in the use of the Fourth Committee “Place”, which had replaced the password-protected website and the mailing list that had been used in the past. The Committee had successfully launched a website for the submission of requests by petitioners (epetition.un.org).

38. The Chair of the Second Committee noted that the review of the Committee’s working methods was an ongoing process, which had led to early agreement on a programme of work; timely identification of facilitators; limitation of the number of side events to three; the convening of a joint meeting with the Economic and Social Council; the thematic clustering of agenda items; establishing time limits for interventions; deadlines for submission of draft resolutions; and increased use of e-deleGATE. Through proactive time management, it was possible to achieve the 80 per cent benchmark for utilization of conference servicing resources set by the Committee on Conferences. At the same time, negotiations — particularly against the backdrop of various ongoing reform initiatives — had proved time-consuming. Ultimately, the Committee had maintained its practice of striving for consensus. Outstanding issues concerned the alignment of the agenda in the light of the 2030 Agenda. Any discussions on the revitalization of the work of the Second Committee needed to be conducted in a coherent and complementary fashion and take into account other intergovernmental processes.

39. The Chair of the Third Committee recalled the conference room paper on the revitalization of the work of the Committee that had originally been prepared at the sixty-fifth session and had subsequently been updated. There had been a clear and consistent increase in the Committee’s workload, which further underscored the importance of time management. At the same time, efforts in that regard had probably been exhausted as the Committee was currently highly efficient in its working methods. For example, the introduction of proposals had been discontinued, thereby saving some eight hours of meeting time. The Chair shared an informal proposal, in

his personal capacity, to modify the terms of office of the President of the General Assembly and the Chairs of the Main Committees to align them with the calendar year.

40. The Chair of the Fifth Committee analysed the Committee's workload in terms of items allocated to it, as well as the additional implications arising from decisions taken by the Main Committees with potential budgetary consequences. Highlighting the Committee's special nature owing to its consensual decision-making practice and the fact that its resolutions were of a binding nature, rather than recommendatory, as was often the case for the other Main Committees, the Chair underlined the importance of the competence of the Secretariat staff, of the membership of the Advisory Committee on Administrative and Budgetary Questions and of the delegates assigned to the Fifth Committee. While the Committee *prima facie* dealt with issues of an administrative and budgetary character, its discussions were of a highly political nature, which was further accentuated by the direct impact of its outcomes on the entire United Nations common system. The Chair noted the importance of timely documentation, while at the same time acknowledging the complexity of the issuance cycle, which involved author departments, the Executive Office of the Secretary-General, the Department for General Assembly and Conference Management and the Advisory Committee on Administrative and Budgetary Questions.

41. The Vice-Chair of the Sixth Committee noted that, in preparing for the session, the Bureau had taken into account the proposals contained in the paper on lessons learned that had been prepared during the sixty-eighth session. During the current session, an exchange of views on the Committee's working methods had been held under the revitalization item. Regarding the provisional programme of work, the Bureau had proactively addressed the overlap with the schedule of the plenary meetings, especially concerning the consideration of the reports of the International Criminal Court and of the International Residual Mechanism for Criminal Tribunals, as a result of which dates had been agreed to facilitate the participation of smaller delegations. Member States had also benefitted from the practice of informal briefings and side events, which encouraged dialogue between Member States and other stakeholders. While welcoming the e-deleGATE portal and PaperSmart services, the Vice-Chair encouraged the Secretariat to continue to expand its electronic information resources. Lastly, the current Bureau intended to hold a handover meeting with its successor, once elected.

42. In the subsequent question-and-answer segment, seven delegations engaged the Main Committee representatives on the issues that they had raised or on specific proposals of their own as to how to further enhance efficiencies, including through better coordination. Among the points raised was the proposed change to the calendar of General Assembly sessions, in which regard delegations sought further clarification on the details and rationale of such an innovation.

Statements/debate

43. During the debate, 18 delegations made statements, including on behalf of groups. Speakers reviewed the implementation of the provisions adopted by the General Assembly under this thematic cluster during the seventy-first session, noting and highlighting various achievements. At the same time, the need to advance progress in streamlining the agenda and reducing the workload of the Assembly, including in the light of the 2030 Agenda, was raised frequently. A group of States stressed the urgent need for steps to be taken towards rationalizing the agenda in order to reprioritize, eliminate duplication and overlap and promote complementarity in the consideration and negotiations of similar and related issues. In that regard, the President of the General Assembly, together with the Main Committee Chairs and the

President of the Economic and Social Council, had an important role to play in finding synergies.

44. One speaker specifically encouraged the Main Committees to identify resolutions suitable for biennial or triennial review. Another referred to a clear and pressing need to streamline the work of the General Assembly by highlighting the steady increase in the number of items on the Assembly's agenda and the concomitant rise in the number of resolutions adopted each year. One delegation suggested biennializing the revitalization item itself, which would allow for greater focus on implementing previous resolutions rather than negotiating a new resolution every year. One group supported attempts at finding synergies and eliminating duplication and encouraged the exploration of possible avenues for the biennialization and triennialization of some agenda items with the aim of achieving tangible improvements in 2018. Another agreed that streamlining the agenda and programmes of work of the General Assembly and the Economic and Social Council in the light of the 2030 Agenda would be an inestimable contribution to the work of the Organization.

45. Another group noted, however, that more discussions were needed on the issue of adopting a biennial or triennial cycle for certain resolutions and that Member States' views, in particular those of the original sponsors, needed to be duly taken into account before taking any action.

46. The scheduling of meetings was identified as another important area for possible improvement in the working methods of the General Assembly, with one group of States stressing that meetings organized in parallel with the general debate should be kept to the absolutely critical minimum in order to preserve the integrity of the debate. The same group recalled that high-level thematic debates organized by the President of the General Assembly should be limited to current issues of critical importance to the international community. Another group looked forward to the implementation of existing provisions aimed at enhancing the coordination of high-level meetings to optimize their number and relevance, and stressed the role of the Secretary-General, the President of the General Assembly, including in his capacity as Chair of the General Committee, and of the Chairs of the Main Committee in that regard. One speaker supported spreading out high-level meetings across the year.

47. Several speakers noted room for improvement regarding the coordination among the Main Committees during the session and the transition from one session to the next. Similarly, some Member States recalled the mandate for the President of the General Assembly to make enhanced use of the General Committee. Main Committees and other bodies were encouraged to start meetings on time.

48. With regard to the possible modification of the opening date of the sessions of the General Assembly, one speaker raised different alternative options, namely 1 January, 1 August or 1 September, each with its own advantages and disadvantages. That speaker's delegation therefore suggested that the Secretariat be tasked with conducting a detailed study of all the possible options, which would help Member States to make an informed decision. Any such decision could take effect from the seventy-fifth session and would need to take into account the calendar of meetings of other bodies. One delegation supported advancing the assumption of office by the President of the General Assembly to allow more time for preparation. Another delegation advocated holding the election of the President earlier to address the same concern.

49. Some speakers encouraged the Working Group to focus on the development of a code of conduct for election campaigns with a view to improving standards of transparency, accountability and equity. It was suggested that candidates should not engage in negative campaigning against their opponents and should focus instead on

their own strengths. One group identified room for improvement regarding the scrutinization of candidates and their campaigns and proposed strengthening existing forums, as well as establishing new forums, in which the wider membership could engage with candidates regarding their commitment to the goals and principles of the bodies they wished to serve, suggesting that voluntary adherence to such initiatives by candidates could serve as a criterion for support.

50. Regarding the mandate from resolution [71/323](#) to prepare a rotation pattern for future elections of Main Committee Chairs, one group of States expressed a preference that such elections should take place six months before the opening of the subsequent session. It also proposed to elect the non-permanent members of the Security Council a full year before their term of office, instead of six months before, as provided for in resolution [68/307](#), and advocated expanding the membership of the Advisory Committee on Administrative and Budgetary Questions.

51. Many delegations welcomed the improved format of the *Journal*. One group, noting that the renewed *Journal* reflected the Organizations' commitment to multilingualism, called for further improving the ease of access to the *Journal* on electronic devices. Another group suggested that there was a need for further fine-tuning in order to achieve a more user-friendly platform with straightforward access, as envisaged by the membership the previous year. One group looked forward to steps to be taken to ensure the full implementation of rule 55, namely, publication of the *Journal* in the six official languages. One speaker considered the changes to the *Journal* to be a tangible success of the Working Group.

52. A group of States called on the Secretariat to come up with ideas for a workable solution to ensure that General Assembly meetings were provided with interpretation services, irrespective of whether they ran overtime. The group also requested the timely issuance of documentation. Regarding the e-services provided by the Secretariat, such as the webcasting of meetings and the PaperSmart portal, the group stressed that their use should not be interpreted as an alternative to the provision of hard copies. One delegation called for a user-friendly application on electronic devices to receive real-time updates of any changes to the time or venue of meetings.

53. A group of States supported the proposal put forward by another delegation at a previous meeting to initiate timely preparations for the seventy-fifth anniversary of the United Nations, in 2020, which would allow Member States to take stock of renewals and reforms, as well as their implementation. Referring to the Secretary-General's annual report on the work of the Organization, one delegation noted that, while the Secretary-General made a statement preceding the general debate pursuant to resolution [51/241](#), there was no presentation of the report itself at the actual time of the consideration of the agenda item in the plenary.

54. Two speakers advocated the removal of curtains from conference rooms, where applicable, citing the practice of the Sixth Committee during the seventy-second session, which had provided delegates with a view of the East River. One delegation called for proposals to address the lack of access by the staff of the permanent missions from developing countries to the Delegates' Dining Room at United Nations Headquarters owing to the cost, which undermined the quality of work of the General Assembly.

55. In concluding remarks, the Co-Chairs expressed gratitude for the rich debate and assured delegations that they had taken careful note of the views expressed, which would be duly taken into account.

Third thematic meeting: selection and appointment of the Secretary-General and other executive heads of the United Nations system

56. The Co-Chairs convened the third thematic meeting of the Working Group on 16 April 2018 and heard statements from 17 delegations, including on behalf of major groups. Before the debate, the Working Group received a briefing from the Office of Human Resources Management on the gender balance and regional origin of the executive heads of the United Nations system and the Senior Management Group of the Organization, in accordance with paragraph 65 of resolution [71/323](#).

57. The Director of the Learning, Development and Human Resources Services Division of the Office of Human Resources Management informed the Working Group that the number of staff in the Secretariat over the past 30 years had increased from some 14,000 to 38,105. Of those, 65 per cent were men and 35 per cent were women. Of the latter, 6,803 were from landlocked least developed countries. Of the 45 members of the Senior Management Group, more than half were women (the presentation was subsequently circulated in a letter dated 18 April 2018 from the President of the General Assembly to all Member States).

58. In an interactive question-and-answer segment, one speaker observed that the African Group was well represented within the Secretariat, but not at the highest level, and that, therefore, more efforts needed to be made in that direction. The same delegation argued that recent resolutions on the revitalization of the work of the General Assembly had not been fully implemented and called for consultations with Member States before deciding on senior appointments. In response, the Office of Human Resources Management highlighted the difference between appointments made by the Secretary-General and those of executive heads of other specialized agencies, over which the Secretary-General had no authority. He also stressed the improvements made over the past 30 years; and referred delegations to the Secretary-General's website, on which all senior vacancies were advertised.

59. In the subsequent debate, speakers overwhelmingly welcomed the selection process that had led to the appointment of the ninth Secretary-General, citing the various innovative steps taken as a result of resolution [69/321](#). Many delegations emphasized their expectation that the innovative procedure used in the most recent appointment process pursuant to resolution [69/321](#) (including the sending of a joint letter from the Presidents of the General Assembly and of the Security Council inviting candidates to come forward; the circulation of candidacies received as official documents; and the convening of informal dialogues) should be applied in all future selection processes. To safeguard the institutional memory and lessons learned from the most recent process, those delegations requested the Working Group to give priority to the consolidation of the appointment process. References were made to the notes containing lessons learned from the selection process ([A/71/774-S/2017/93](#) and [A/72/514-S/2017/846](#)), both of which, it was argued, could serve as an input to the discussion. One speaker requested either the Secretariat or the Co-Chairs to prepare a document that set out the process and new measures introduced to date.

60. A group of States called upon the President of the General Assembly at future sessions to play a proactive role and the Security Council to recommend more than one candidate for the Assembly's consideration. The same group encouraged the introduction of a deadline for the presentation of candidacies; the tabling of a draft resolution in the General Assembly, preceded by wide and extensive consultations with all Member States; and action on the recommendation by secret ballot. It also advocated the updating of the Secretary-General's oath of office. In general, the group was of the view that resolution 11 (I) of 1946 had been amended by relevant provisions from subsequent resolutions on the revitalization of the work of the General Assembly.

61. The possibility of considering the establishment of a single, non-renewable term was raised. One speaker specifically supported such an innovation as a measure against what was described as undue political pressure, and as providing the space necessary to develop a long-term vision for the Organization. The same delegation argued that the proposed change would also support a more consistent regional rotation of the post. Another delegation, on the other hand, opposed a single term, arguing that while the renewal of that term ought not to be taken for granted, neither should the possibility of reappointment be automatically precluded. Furthermore, seven years, which was frequently put forward as the proposed length of the single term, was too long. That same delegation also argued in favour of appointment without a vote, noting that the consensual aura of unified support enhanced a Secretary-General's capacity to accomplish his or her goals.

62. Various speakers touched upon the informal hearings with candidates, which they welcomed as a tangible improvement or, in the words of one group, as an essential component of the appointment process. Nevertheless, opportunities for further improving the format of those hearings were noted. One group encouraged civil society participation to assist Member States in their assessments. Another group, on the other hand, was of the view that civil society participation needed to be in accordance with Economic and Social Council resolution 1996/31. One delegation proposed that the President of the seventy-third session convene a forum for the candidate countries for the Human Rights Council, giving them the opportunity to discuss their commitment to human rights, as well as their priorities for the Human Rights Council should they win a seat.

63. One group of States proposed the consideration of possible ways of assessing the level of the General Assembly's support for the candidates throughout the process. At the same time, the group expressed the wish that the Council provide regular public briefings on the selection process and communicate openly the straw poll results. The group further noted that the personal qualifications of candidates should be the most important criterion, with due regard paid to geographical rotation and gender balance.

64. Other delegations underscored the need for full implementation of Article 97 of the Charter and stressed the role of the Security Council in the selection process of the Secretary-General, which had served the Organization well since its inception. Noting the innovative changes introduced during the most recent process, the delegations emphasized that any new proposals required in-depth examination, including with a view to ensuring their full compliance with the Charter. These delegations highlighted the importance of flexibility to ensure that the best person, regardless of gender and geographical origin, would be selected for the post of Secretary-General. One delegation opposed any automatic favouring of women candidates and argued against the excessive codification of the process, rejecting the request for the Council to publish straw poll results, which, it argued, could be embarrassing for the candidates. Furthermore, there should be no duplication of informal meetings with candidates between the Council and the General Assembly. Lastly, the suggestion of a single term could be perceived as an attempt to separate the Secretary-General from the work of the Organization.

65. Turning to senior appointments and the selection of executive heads, delegations welcomed the attainment by the Secretary-General of gender parity in the Senior Management Group. One group of States strongly encouraged the Secretary-General to continue along that path with a view to achieving gender parity within the Organization as a whole. Nevertheless, one delegation noted that equality and fairness should not depend on the actions of one man alone, which was why it welcomed the system-wide strategy on gender parity. One group called for briefings by the Office of Human Resources Management to become a routine feature of the Working Group's deliberations every year. Regarding gender parity, the group emphasized the

need to better ensure that efforts to achieve gender parity included women from small island development States and landlocked and least developed countries.

66. One group called upon the Secretariat to provide a clearer overview of vacancies and timelines for all senior appointments. Several delegations stressed the importance that recruitments be made on as wide a geographical basis as possible; and that there should be no monopoly on senior posts. It was argued that countries with a proven track record with their contributions should be adequately represented in the Secretariat.

67. In concluding, the Co-Chairs summarized the debate by contrasting areas of entrenched divergence with areas of potential convergence. Whereas the former had been exhaustively discussed at previous sessions (for example, term limit, secret ballot and multiple candidates), other improvements that could be considered during the current session included the introduction of a deadline for the presentation of candidacies; the consolidation of the modalities for the withdrawal of candidacies; and the updating of the Secretary-General's oath of office.

Fourth thematic meeting: strengthening the institutional memory of the Office of the President of the General Assembly

68. The Co-Chairs convened the fourth thematic meeting on 27 April 2018. It included briefings by the President of the General Assembly and the Under-Secretary-General for General Assembly and Conference Management. The briefings were followed by an interactive question-and-answer session and, subsequently, by remarks from 23 delegations, including on behalf of major groups.

69. The President of the General Assembly briefed the Working Group on the implementation of the mandates addressed to him by resolution [71/323](#) and on recent trends concerning the workload of the Office of the President of the General Assembly, highlighting the increasing demands on the President as a result of the Assembly's enhanced agenda, for example, the proliferation of mandates for high-level meetings during the opening of the seventy-fourth session, in spite of the Assembly's own repeated call to limit the number of such events during the general debate, as well as a high number of negotiation processes that require the President to play an oversight role. The President expressed gratitude to all Member States who supported the trust fund in support of the Office, which made up 88 per cent of its budget, whereas only 12 per cent came from the regular budget.

70. Secondly, the President spoke of the importance of the Office's institutional memory. Past steps to redress the situation in that regard included the introduction of a handover report; ongoing efforts to improve archiving; an annual retreat; and the induction training provided by the Department for General Assembly and Conference Management. However, the President suggested the possibility of opening the session earlier than a week before the general debate, which would give the Office more time to establish itself before the demands of the high-level week began.

71. Thirdly, the President referred to transparency and accountability, to which, he stressed, he was personally deeply committed, noting that he had been the first to voluntarily publish a summary of his financial disclosure online. Other details regarding the activities and financing of the Office were made available through the President's website. In the context of transparency, the President would soon convene the first interactive dialogue with candidates for President of the General Assembly, based on the mandate contained in resolution [71/323](#).

72. The Under-Secretary-General for General Assembly and Conference Management briefed the Working Group on the support provided by the Secretariat to the Office of the President of the General Assembly, which covered the staffing,

sources of funding and the regular Secretariat support available to the Office, while highlighting the wide range of support provided from within the Secretariat, which transcended any one Department. As to staffing, the Department covered the expenses of five staff members (2 D-2, 1 D-1, 1 P-5 and 1 General Service) in the Office and provided direct support by means of three Professional posts from within the Department. In addition, and also from within its own resources, the Department made available two General Service staff members, who were located in the Office, as well as translators and text processors, as needed. The Department of Management provided a car and driver for official purposes, as well as office space, including transitional office space during the three-month transition period. The Department of Safety and Security provided a detail of two security officers, including during travel. A spokesperson was provided by the Department of Public Information, and legal guidance was provided by the Office of Legal Affairs on an as-needed basis. Other substantive departments and offices were ready to accommodate the needs of the President, as required, for the work of the General Assembly.

73. With regard to funding, the regular budget allocation amounted to approximately \$326,000 per session. In the light of the static nature of the funding, a trust fund had been created in 2010, the importance of which had been stressed by Member States in General Assembly resolutions. Contributions were usually earmarked either for specific purposes, that is, in support of particular meetings, or for general administrative, logistical and management support, and were associated with a specific session. Noting the General Assembly's request to the Secretary-General to submit proposals to review the budget allocation to the Office in the context of the proposed programme budget for the biennium 2018–2019, and in accordance with the recommendation in the report of the Task Force on the functioning of the Office, the Secretary-General had included in the proposed programme budget for 2018–2019 a proposal to establish an additional P-5 position in the Office to ensure continuity and manage the transfer of knowledge between sessions and additional general temporary assistance resources corresponding to an overlap period of one month for four positions in the Office to maximize the use of the transition period for incoming Presidents. To this end, the proposed budget for the Office for the biennium 2018–2019 had reflected an increase of \$386,500. The Assembly, when it adopted the programme budget at the end of the main part of its seventy-second session, had decided against allocating those additional resources.

74. In terms of other support, the Department for General Assembly and Conference Management fulfilled the role of focal point and assisted the Office throughout the year through conference management support, protocol and institutional memory. The Department would also continue the practice of organizing an induction programme for incoming Presidents.

75. In an interactive exchange, one delegation underscored the importance of predictable funding for the Office, citing the findings of a report of the Joint Inspection Unit on voluntary contributions ([JIU/REP/2017/2](#)). Another delegation queried whether the reclassification of the existing posts allocated to the Office — for example, abolishing Director posts and creating more Professional positions — could be advantageous; and whether the Department could provide an indicative figure of the actual support provided if one took into account the non-budgetary provisions, noting for instance that the current President had already spent 57 days of his presidency travelling overseas. The same delegation raised the possibility of agreeing on a generic template for resolutions on the modalities of high-level meetings, which had the potential to drastically reduce the President's workload. In response, the Chef de Cabinet of the Office pointed out that it was not within the Office's remit to reclassify the existing posts and opined that it would be difficult for the membership to agree on generic modalities for high-level meetings as each

thematic issue was distinct. The Under-Secretary-General of the Department responded positively to the request for an overall figure for the support that is provided to the Office, which would be communicated to the Working Group through the Co-Chairs. If useful, such a figure could be provided on an annual basis.

76. In the subsequent debate, delegations touched upon a wide range of issues related to the Office, focusing on the perceived need to further enhance support for the Office in the light of the steady increase in the workload of the General Assembly over the years and the expansion of the role played by its Presidents in the recent past. On the other hand, it was pointed out that the President's original responsibilities were encapsulated in the rules of procedure, namely, to preside over the meetings of the Assembly. The recent achievements in terms of the adoption of an oath of office and a code of conduct were universally welcomed.

77. With regard to the budgetary provisions, many delegations supported adequate funding of the Office in the light of the increased workload of the President over the years. One group of States pointed out that a considerable amount of the expenses were covered by the country of origin of the President, which created a risk of inequality, in particular for developing countries. One speaker favoured the allocation of appropriate resources while highlighting the need to maintain budgetary discipline. Another supported "realistic proposals" for strengthening the Office, which needed to be considered in accordance with the relevant rules of procedure and resolutions [41/213](#) and [42/211](#), that is, through the Advisory Committee on Administrative and Budgetary Questions in the Fifth Committee. Furthermore, support for the Office should be provided by the Secretariat within existing budgetary resources. Another delegation expressed reservations on any proposals that could have budgetary implications, noting that United Nations reform was best served when it brought cost savings or was cost-neutral.

78. Concerning human resources, one group underlined the need for the assignment of additional posts to the Office on a permanent basis. Another group argued that the core staff of the Office should be recruited for periods of longer than one year to ensure continuous institutional memory. At the same time, it was pointed out that the Office should reflect the geographical diversity of the membership and that the practice of secondments should be continued. According to one delegation, that practice should continue in a more transparent and systematic manner.

79. To safeguard the Office's institutional memory and ensure a smooth transition between presidencies, several delegations welcomed recent innovations, such as the introduction of a handover report. They also called for improvements in the Office's archiving system. One group encouraged the President to continue efforts to make communication tools even more accessible. The need to continue improving the digital documents published by the President was stressed. One delegation noted that communications from the President did not have official document symbols and therefore could not be easily referenced. Another suggested that lessons could be learned from Member States who had held the presidency.

80. Efforts undertaken to reflect gender parity within the Office were welcomed. One Member State pointed out that nearly all facilitation processes were being led by gender-balanced teams of facilitators, which was a great achievement, bearing in mind that only 20 per cent of Permanent Representatives were women. At the same time, the future presentation of female candidates was encouraged.

81. One group encouraged Presidents to continue the practice of periodically briefing Member States on their activities, including official travel, noting that, as Chair of a principal organ, it was paramount that the President embodied transparency and accountability. Another group of States encouraged early contact between the

President-elect and the Working Group in order to determine the areas that needed to be addressed by the Group, including through the next resolution on revitalization.

82. Many delegations looked forward to the forthcoming first informal interactive dialogue between the General Assembly and candidates for the post of President, including against the backdrop of efforts to enhance transparency and accountability. While one speaker underscored that, in accordance with resolution 33/138, any member of the Group of Latin American and Caribbean States would be eligible in the forthcoming election, another emphasized that, during the previous 72 sessions of the Assembly, no Member State had held the presidency twice, which had ensured that all countries had had an equal opportunity to occupy the post once. The same delegation suggested that the modalities for the interactive dialogue, which was mandated by resolution 71/323, should also be delineated in a resolution of the Assembly.

83. Other matters raised in the debate included advancing the elections of the President to a point earlier in the session; changing the timing of the opening of sessions; circulating speakers lists for high-level meetings of the President before the meeting; discouraging negotiations after 6 p.m.; and establishing a mandate for the commemoration of the seventy-fifth anniversary of the United Nations.

84. In closing, the Co-Chairs informed the Working Group about the next steps, which included the presentation of a zero draft of the resolution — based on the thematic meetings during the seventy-second session — to be followed by negotiations. The zero draft would be accompanied by a code of conduct for elections and a proposed pattern of rotation for the election of the Main Committee Chairs.

III. Conclusion

85. In accordance with its mandate, the Working Group endeavoured to identify key issues of concern and possible consensus, to examine the current status of implementation of those issues, and either to take action or to indicate possible further action to be taken.

86. Some Member States or groups of States made several proposals for the draft resolution that did not gain consensus and in this regard called for the continuation of discussions on the issues concerned at the subsequent session of the Working Group.

87. At its final meeting, held on 12 September 2018, the Working Group considered and adopted the present report, including the draft resolution contained in section IV below (see para. 89).

IV. Recommendation

88. On the basis of a draft resolution circulated by the Co-Chairs, the Working Group formulated the resolution set out below.

89. At its final meeting, on 12 September 2018, the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly concluded its work for the seventy-second session. The Working Group recommended that the Assembly adopt the following draft resolution:

Revitalization of the work of the General Assembly

The General Assembly,

Reaffirming its resolution [71/323](#) of 8 September 2017 and all other previous resolutions relating to the revitalization of the work of the General Assembly,¹

Acknowledging that resolution [71/323](#) constitutes an important contribution to the strengthening of the role, authority, effectiveness and efficiency of the General Assembly as established by the Charter of the United Nations,

Underlining the need to further enhance the role, authority, effectiveness and efficiency of the General Assembly,

Reiterating that the revitalization of the work of the General Assembly is a critical component of the overall reform of the United Nations,

Emphasizing the need to align the agenda of the General Assembly in full support of the implementation of the 2030 Agenda for Sustainable Development,²

Welcoming the calls to increase the efficiency of the work of the General Assembly through streamlining its agenda, including by elimination of duplication and overlap of agenda items,

Recognizing the role of the General Assembly in addressing issues of peace and security, in accordance with the Charter, and acknowledging its role and authority, established in Article 10 of the Charter, to make recommendations to the Members of the United Nations or to the Security Council or to both, on questions or matters within the scope of the Charter, except as provided in Article 12 thereof,

Stressing the role of the General Assembly in taking forward the major reforms of the Organization, including reforms proposed by the Secretary-General, as contained in resolutions [72/199](#) of 20 December 2017, [72/266 A](#) of 24 December 2017 and [72/279](#) of 31 May 2018, adopted during its seventy-second session,

Reaffirming the central position of the General Assembly as the chief deliberative, policymaking and representative organ of the United Nations, as well as the role of the Assembly in the process of standard-setting and the codification of international law,

Reaffirming also the authority and increasing role of the General Assembly in global matters of concern to the international community, including in global governance, as set out in the Charter,

Mindful of the need to provide all Permanent Missions, regardless of their size and capacities, with ample opportunity to participate in the work of the General Assembly and its Main Committees,

Mindful that we have yet to achieve full gender and geographical balance within the United Nations, while encouraging further intergovernmental efforts in this regard, and convinced of the need to guarantee equal opportunities for women and men from all regional groups in their access to senior decision-making positions, including to the post of Secretary-General, bearing in mind the need to secure the highest standards of efficiency, competence and integrity,

Welcoming, in this regard, the efforts of the Secretary-General in achieving gender parity at senior management level, in particular the initiation of the system-wide strategy on gender parity,

Recalling the conclusion of the process of selection and appointment of the ninth Secretary-General, which was characterized by an enhanced degree of transparency, accountability and inclusivity, in accordance with resolutions 69/321 of 11 September 2015 and 70/305 of 13 September 2016,

Recalling also the fact that women constituted more than half of all of the candidates for Secretary-General presented by Member States in accordance with resolution 69/321, and emphasizing the need to strive for gender balance in the selection of other executive heads,

Recalling further that the selection and appointment of the Secretary-General should be considered in accordance with the relevant provisions of the Charter, and taking into account all relevant General Assembly resolutions, and recalling the exclusively international character of the responsibilities of the Secretary-General and the necessity of securing the highest standards of efficiency, competence and integrity,

Affirming that the work of the President of the General Assembly and of the Office of the President of the General Assembly shall be guided by the rules of procedure of the General Assembly and the principles of universality, objectivity, non-selectivity, constructive international dialogue and cooperation,

Welcoming the efforts of the President of the General Assembly to reinvigorate the revitalization of the work of the Assembly during its seventy-second session,

1. *Welcomes* the report of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly and the updated inventory of Assembly resolutions on revitalization annexed thereto;³

2. *Takes note with appreciation* of the multilingual web page devoted to the revitalization of the work of the General Assembly, accessible directly from the United Nations website, which exists in all six official languages, including an overview of major outcomes achieved under this agenda item, and invites the Secretariat to continue updating regularly and equally that web page and its substantive content in a cost-effective manner;

3. *Decides* to establish, at its seventy-third session, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:

(a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on the progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation;

(b) To submit a report thereon to the Assembly at its seventy-third session;

4. *Also decides* that the Ad Hoc Working Group shall continue its review of the inventory of General Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted at the seventy-second session and, as a result, continue to update the inventory to be attached to the report to be submitted at the seventy-third session of the Assembly, including the separate indication of relevant provisions that were not implemented, with reasons therefor;

5. *Takes note* of the report of the Secretary-General,⁴ and requests the Secretary-General to submit an update on the provisions of the General Assembly resolutions on revitalization addressed to the Secretariat for implementation that have not been implemented, with an indication of the constraints and reasons behind any lack of implementation, for further consideration by the Ad Hoc Working Group at the seventy-third session;

Role and authority of the General Assembly

6. *Reaffirms* the role and authority of the General Assembly, including on questions relating to international peace and security, in accordance with Articles 10 to 14 and 35 of the Charter of the United Nations, where appropriate, using the procedures set forth in rules 7 to 10 of the rules of procedure of the Assembly, which enable swift and urgent action by the Assembly, bearing in mind that the Security Council has the primary responsibility for the maintenance of international peace and security, in accordance with Article 24 of the Charter;

7. *Recognizes* that implementation of General Assembly resolutions, including those related to the revitalization of its work, enhances the role, authority, effectiveness and efficiency of the Assembly, and underlines the important role and responsibility of Member States in their full implementation;

8. *Reaffirms* that the relationship between the principal organs of the United Nations is mutually reinforcing and complementary, in accordance with and with full respect for their respective functions, authority, powers and competencies as enshrined in the Charter, and in this regard stresses the importance of further ensuring increased cooperation, coordination and the exchange of information among the Presidents of the principal organs and also with the Secretariat, in particular the Secretary-General;

9. *Recalls* the practice of holding periodic informal briefings by the Secretary-General on his priorities, travels and most recent activities, including his participation in international meetings and events organized outside the United Nations, and invites the Secretary-General to continue this practice;

10. *Welcomes* the holding of an interactive and comprehensive dialogue between the Permanent Missions and the Secretariat on 5 April 2018, as mandated in resolution [71/323](#), aimed at improving the work of the Secretariat in its interaction with the Permanent Missions, and requests the Co-Chairs of the Ad Hoc Working Group to continue to convene the interactive dialogue within the framework of the Ad Hoc Working Group, aimed at:

(a) Identifying issues in the interaction of the Secretariat with the Permanent Missions;

(b) Identifying solutions in better meeting the needs and requirements of the Permanent Missions regarding standard operating procedures used at United Nations Headquarters in New York;

11. *Reiterates* its decision to hold thematic dialogues periodically during the work of the Ad Hoc Working Group and to review this arrangement at the seventy-third session of the General Assembly;

12. *Invites* Member States to submit, through the Co-Chairs of the Ad Hoc Working Group, and prior to the holding of the interactive and comprehensive dialogue, specific issues on which action by the Secretariat might be needed, and requests the Secretariat to provide comprehensive answers within a reasonable

amount of time on the possible actions, and impediments, if any, to solve the issues raised;

13. *Welcomes*, in this regard, the active participation by the Secretariat during the seventy-second session, and in particular notes with appreciation the establishment of a “one stop shop” as a single entry point for requesting meetings services, while encouraging the Secretariat to make similar arrangements for other services provided;

14. *Recognizes* the value of holding interactive inclusive thematic debates on current issues of critical importance to the international community, and calls upon the President of the General Assembly to organize such debates in close consultation with the General Committee and the Member States, including with regard to the frequency and preliminary programme of such debates, in order to enable an adequate level of participation and an appropriate allocation of time for substantive interactive discussion during the debates so as to enable all interested delegations to state their positions and to facilitate, where appropriate, results-oriented and productive outcomes of such debates, and in this context welcomes the initiative of the President of the Assembly at its seventy-second session to select “Focusing on people: striving for peace and a decent life for all on a sustainable planet” as the theme of the general debate;

15. *Recommends*, in this regard, unless decided otherwise, that no other agenda items should be opened during the dates allocated for the general debate;

16. *Requests* the President of the General Assembly to limit high-level meetings to current issues of critical importance to the international community, with the interest of the wider membership in mind and with a focus on the most vulnerable, while encouraging the allocation of events of a strictly sectoral or thematic nature to the six Main Committees;

17. *Commends* improvements in the quality of the annual report of the Security Council to the General Assembly, including as presented in the note by the President of the Security Council,⁵ and welcomes the willingness of the Council to continue to consider other suggestions concerning improvements to the annual report;

18. *Requests* the Secretariat, including the Department of Public Information, while carrying out its activities, as mandated by the General Assembly, to continue its efforts to raise the visibility of the Assembly and to enhance world public and media awareness of the contribution made by the Assembly to the fulfilment of the goals of the Organization, as set out in the Charter;

19. *Requests* the Secretary-General, under relevant agenda items, to bring to the attention of the Member States constraints that have prevented the Secretary-General from implementing those provisions of General Assembly resolutions that are addressed to the Secretariat;

Working methods

20. *Reaffirms* existing relevant mandates related to the improvement of the working methods of the Main Committees, including section C of the annex to resolution 58/316 of 1 July 2004, paragraphs 7 to 13 of resolution 59/313 of 12 September 2005, cluster III of the annex to resolution 60/286 of 8 September 2006 and resolution 69/321, in particular paragraphs 16 and 17 thereof;

21. *Emphasizes* that the revitalization of the work of the General Assembly is interlinked with the strengthening the Main Committees;

22. *Requests* each Main Committee to further discuss its working methods at the beginning of every session, and in this regard invites the Chairs of the Main Committees to brief the Ad Hoc Working Group during the seventy-third session on any best practices and lessons learned with a view to improving working methods, as appropriate;

23. *Requests* the continuation of the established practice of holding handover meetings of the outgoing and incoming bureaux to exchange views on outcomes and the upcoming agenda, and of presenting a report by the Chairs of the Main Committees to their successors on best practices and lessons learned;

24. *Requests* the President-elect of the General Assembly to continue with the practice of meeting informally with the incoming members of the General Committee before the beginning of the regular session in order to review the proposed programme of work of the Main Committees, with a view to increasing their efficiency, improving complementarity and avoiding overlap of meetings of the Main Committees to the extent possible, in order to allow for wider participation by Member States;

25. *Calls for* the continuation of the practice of periodical meetings between the six Chairs of the Main Committees during the session of the General Assembly to share best practices and increase the coherence and complementarity of the work of the Main Committees;

26. *Welcomes* efforts to afford elected members of the Security Council appropriate opportunities to prepare for their tenure, and also welcomes the note by the President of the Security Council in which the elected Council members are invited to observe some of its meetings and activities as from 1 October immediately preceding their term of membership;⁵

27. *Emphasizes* that the General Assembly and its Main Committees, at the seventy-third session, in consultation with Member States, should continue their consideration of and make proposals for the further biennialization, triennialization, clustering and elimination of items on the agenda of the Assembly, including through the introduction of a sunset clause, with the clear consent of the sponsoring State or States, taking into account the relevant recommendations of the Ad Hoc Working Group;

28. *Recalls* the Guidelines on the Rationalization of the Agenda of the General Assembly, as adopted in its resolution [48/264](#) of 29 July 1994;

29. *Also recalls* the need to enhance synergies and coherence and reduce overlap where it is found to exist in the agendas of the General Assembly, especially of its Second and Third Committees, the Economic and Social Council and its subsidiary bodies, and the work of the high-level political forum on sustainable development convened under the auspices of the Council and the Assembly, as well as all other related forums, in accordance with relevant rules of procedure and in the light of the adoption of the 2030 Agenda for Sustainable Development,² and calls for the continuation of such efforts during the seventy-third session of the Assembly;

30. *Requests* the General Committee, while exercising its functions under rule 40 of the rules of procedure of the General Assembly, to pay special attention to reduction of such overlap;

31. *Requests* the President of the General Assembly at its seventy-third session to identify proposals, through consultations with all Member States and the President of the Economic and Social Council, as well as through the convening of the General Committee, aimed at addressing gaps and duplication in the agenda of the Assembly as they relate to the 2030 Agenda for Sustainable Development, taking into account the report on the strategic alignment of future sessions of the Assembly and other

relevant inputs, for the consideration of Member States during the seventy-third session of the Assembly;

32. *Encourages* Member States, in proposing and voting for candidates to subsidiary organs of the General Assembly, to seek to promote gender balance in all such bodies;

33. *Recalls* rules 153 and 154 of the rules of procedure of the General Assembly, and encourages the Chairs of the Main Committees and the Secretary-General to ensure observance of these rules, within their respective mandates;

34. *Also recalls* rule 72 of the rules of procedure of the General Assembly, and calls for strict adherence by each speaker to the time limits in the Assembly, where applicable, bearing in mind that all speakers shall get the same opportunity to deliver their statements within the allocated time limit, as set out in the rules of procedure of the Assembly;

35. *Reiterates its invitation* to the Chairs of meetings of the General Assembly and United Nations conferences, especially when there is very limited time available for debate, to consider recommending the “all protocol observed” principle, whereby participants are encouraged to refrain from listing standard protocol expressions during their statements;

36. *Requests* the Secretariat to ensure the availability through the eDelegate portal of provisional lists of speakers at United Nations meetings and conferences not later than by the end of the business day preceding the relevant meeting or conference;

37. *Recommends* that speakers should be mindful of the speed of statement delivery, bearing in mind the need for accuracy of interpretation;

38. *Urges* all presiding officers and Member States to strictly adhere to the scheduled starting time of meetings of the General Assembly and its subsidiary bodies;

39. *Calls upon* all officers chairing or facilitating intergovernmental processes to seek to conduct informal negotiations during regular working hours, in order to allow for the active and constructive participation of all Permanent Missions in the work of the United Nations;

40. *Decides* to continue to consider ways to rationalize the number of side events held during the high-level segment of the general debate, bearing in mind the need to enhance its decorum and significance, and encourages the scheduling of side events at United Nations Headquarters outside of the hours when the general debate is being held;

41. *Takes note* of the possibility for Member States to publish their side events under a dedicated section of the digital version of the *Journal of the United Nations*;

42. *Decides* that, in addition to the general debate and the thematic meetings, the interactive and comprehensive dialogue between the Permanent Missions and the Secretariat held within the Ad Hoc Working Group, as outlined in paragraph 10 of resolution [71/323](#), shall be webcast;

43. *Recalls* its resolutions 1898 (XVIII) of 11 November 1963, 2837 (XXVI) of 17 December 1971, [45/45](#) of 28 November 1990, [51/241](#) of 31 July 1997, [58/126](#) of 19 December 2003 and [58/316](#), and reiterates its call to the President of the General Assembly to continue to make full use of the General Committee throughout the session, with a view to reviewing the programme of work of the Assembly and its Main Committees, in line with rule 42 of the rules of procedure of the Assembly;

44. *Reiterates its invitation* to the President of the General Assembly and the Chairs of the Main Committees, in consultation with the General Committee and Member States, as well as to the Secretary-General, to enhance the coordination of the scheduling of the meetings of the Assembly, including high-level meetings and high-level thematic debates, with a view to optimizing their interactivity, effectiveness and distribution throughout the session, and to consider ways to decrease the number of high-level events held during the general debate;

45. *Requests* the President of the General Assembly, in order to enhance transparency, to continue to attach the list of speakers at high-level thematic debates organized by the President to the summary of those events;

46. *Encourages* the scheduling of future high-level meetings during the first half of the year, from within existing resources, taking into account the calendar of conferences and without prejudice to the current practice of convening one high-level meeting in September at the beginning of each session of the General Assembly;

47. *Requests* the Secretary-General to submit to the General Assembly at its seventy-third session a report on the possible alternative dates for the beginning of the regular session of the Assembly⁶ and the financial and logistical implications thereof, as well as on potential benefits and shortcomings of various options, based on the premise that any such change will not have an effect on the beginning of the general debate in September;⁷

48. *Decides* to establish the pattern for the rotation of the Chairs of the Main Committees for the forthcoming 10 sessions of the General Assembly, namely from the seventy-fourth to the eighty-third session, as contained in the annex to the present resolution;

49. *Also decides* to prepare arrangements concerning the rotation of the Chairs of the Main Committees for the following sessions no later than at its eighty-second session;

50. *Continues to encourage* Member States to seek gender balance in the distribution of the Chairs and bureau members of the Main Committees as well as the Vice-Presidents of the General Assembly, where applicable;

51. *Decides* to continue to consider, within the Ad Hoc Working Group, the potential concept and scope of guidelines how to conduct the election campaigns by Member States, with a view to improving the standards of transparency and equity;

52. *Welcomes* the efficient implementation of paragraphs 47 and 48 of resolution [71/323](#) relating to the conduct of elections in the General Assembly and the Main Committees;

53. *Notes* the practice implemented during the secret vote-counting procedure, whereby no use of mobile phones or other electronic communication devices is permitted in the room where counting is being conducted, thus ensuring the confidentiality of elections and the integrity of secret ballots, and requests the continuation of this practice;

54. *Encourages* Member States to make, to the extent possible, full use of e-services provided by the Secretariat, in order to save costs and reduce the environmental impact and improve the distribution of documents, and in this regard requests the Secretariat to further improve, harmonize and, where appropriate, unify

such services, under eDelegate, including the continuation of the practice of making available all official correspondence of the United Nations addressed to the Member States;

55. *Takes note* of the introduction of real-time updates with respect to the cancellation and postponement of meetings, and requests the continuation of this practice with further improvements, in particular with the introduction of the possibility of subscribing to relevant agenda items with automatic notifications to subscribers on their status;

56. *Emphasizes* that multilingualism remains a core value of the Organization, and reaffirms the need to achieve full parity among the six official languages in the United Nations, including on official websites;

57. *Welcomes* the publishing of electronic live versions of the Blue Book, the White Pages and the Yellow Pages;

58. *Takes note with appreciation* of the changes to the format, production and editing of the *Journal of the United Nations*, and requests the Secretariat to continue the improvement of the *Journal* in accordance with requirements provided in paragraph 51 of resolution 71/323 and to brief the Ad Hoc Working Group at the seventy-third session on the outcomes of that improvement;

59. *Affirms* the principle that the *Journal* shall provide an overview of all meetings taking place at the United Nations, and requests that meetings be listed under the established categories in contiguous order and that all meetings organized by States be included, provided that information has been submitted to the *Journal* unit in due time, and clarifies that the existence of web pages for sessions of bodies should not preclude the announcement of side events;

60. *Calls upon* all relevant intergovernmental bodies to continue to review the need for and content of the *Journal* summaries of their meetings and other announcements, and to take the steps necessary with a view to ensuring a more streamlined format for the *Journal of the United Nations*;

61. *Reiterates* the need to produce the *Journal* in all six official languages in strict compliance with rule 55 of the rules of procedure of the General Assembly;

62. *Emphasizes* the importance of the extension of the information in the *Journal of the United Nations* published in the six official languages, reiterates its request to the Secretary-General to brief the Ad Hoc Working Group, on a yearly basis, on the progress achieved in this regard, and requests the Secretariat to continue to explore cost-neutral options to that effect;

63. *Takes note* of the concerns raised by multiple Member States regarding the prohibitive cost of the use of the Delegates' Dining Room and other venues at the United Nations by delegations for holding diplomatic events, and requests the Secretary-General to provide, during the seventy-third session of the General Assembly, innovative proposals on solutions for the existing situation, including the possibility of introducing certain elements in future contracts with the vendor;

64. *Requests* the Secretariat to provide, in an electronic version only, a list containing the names of the President and the Vice-Presidents of the General Assembly and officers of the Main Committees, as well as members of the Security Council, members of the Economic and Social Council and Member States and observers of the United Nations;

Selection and appointment of the Secretary-General and other executive heads

65. *Encourages* future Presidents of the General Assembly to actively contribute to the implementation of provisions guiding the selection and appointment of the ninth Secretary-General, as contained in all relevant resolutions, in particular resolutions [69/321](#) and [70/305](#);

66. *Reiterates* that the process of selecting and appointing the Secretary-General differs from the process used with regard to the executive heads of the organizations of the United Nations system, given the roles of the Security Council and the General Assembly in accordance with Article 97 of the Charter, and emphasizes in particular that the process of selection of the Secretary-General is guided by the principles of transparency and inclusiveness, building on the best practices and the participation of all Member States;

67. *Stresses*, in particular, the need to ensure the appointment of the best possible candidate for the post of Secretary-General, who embodies the highest standards of efficiency, competence and integrity and who demonstrates a firm commitment to the purposes and principles of the United Nations, proven leadership and managerial abilities, extensive experience in international relations and strong diplomatic, communication and multilingual skills;

68. *Also stresses* that, in the course of the identification and appointment of the best candidate for the post of Secretary-General, due regard shall continue to be given to regional rotation and to gender balance;

69. *Reaffirms its commitment* to continue, in the Ad Hoc Working Group, in accordance with the provisions of Article 97 of the Charter, its thorough consideration of the issues under the third thematic cluster of the Working Group, on the revitalization of the work of the General Assembly, including the examination of innovative ways to improve the process of selecting and appointing the Secretary-General and other executive heads in all its aspects, and recalls all relevant resolutions, including resolutions 11 (I) of 24 January 1946, [46/77](#) of 12 December 1991, [47/233](#) of 17 August 1993, [48/264](#), [51/241](#), [52/163](#) of 15 December 1997, [55/14](#) of 3 November 2000, [55/285](#) of 7 September 2001, [56/509](#) of 8 July 2002, [57/300](#) of 20 December 2002, [57/301](#) of 13 March 2003, [58/126](#), [58/316](#), [59/313](#), [60/286](#), [61/292](#) of 2 August 2007, [62/276](#) of 15 September 2008, [63/309](#) of 14 September 2009, [64/301](#) of 13 September 2010, [65/315](#) of 12 September 2011, [66/294](#) of 17 September 2012, [67/297](#) of 29 August 2013, [68/307](#) of 10 September 2014, [69/321](#), [70/305](#) and [71/323](#), reaffirming the applicable procedures set out in the rules of procedure of the Assembly, in particular rule 141, and acknowledging existing relevant practices of the Assembly;

70. *Calls upon* the President of the General Assembly to monitor and review the implementation by the Assembly of these resolutions;

71. *Recalls* that informal dialogues and meetings with candidates for the post of Secretary-General, as provided for in paragraph 42 of its resolution [69/321](#), are an important part of the selection and appointment process, and encourages the President of the General Assembly to further improve, in close consultation with Member States, the modalities of these dialogues in order to increase their efficiency and interactivity with Member States;

72. *Recognizes* the possibility of providing the process of selection and appointment of the Secretary-General with notional timelines based on its resolution [69/321](#) and other relevant resolutions;

73. *Welcomes* the collaboration between the General Assembly and the Security Council in launching the process and circulating information on the

nominated candidates during the most recent selection of the Secretary-General, and encourages improvement in the interaction between the Council and the Assembly in all stages of the process to further enhance transparency;

74. *Decides* to review the oath of office of the Secretary-General during its seventy-third session;

75. *Welcomes* the ongoing efforts of the Secretary-General towards achieving equal and fair distribution in terms of the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, while securing the highest standards of efficiency, competence and integrity, in accordance with Article 101 of the Charter and its resolutions 46/232 of 2 March 1992, 51/241, and 71/263 of 23 December 2016, commends in particular the fact that gender parity was achieved in the Senior Management Group, and requests that further effective measures be taken in this regard;

76. *Takes note* of the call by the Secretariat to all Member States encouraging the nomination of candidates to supplement the Secretary-General's search to ensure a wide pool of candidates for positions at the senior level;

77. *Recalls* its resolution 52/12 B of 19 December 1997, in particular paragraph 2 thereof, in which it notes that the Secretary-General will appoint the Deputy Secretary-General following consultations with Member States, stresses that the process of appointments to senior posts by the Secretary-General within the Organization should be inclusive and transparent, in accordance with relevant rules of procedure and as set out in the Charter, and in this context calls upon the Secretary-General to announce such vacancies well in advance;

78. *Stresses* the need to ensure equal and fair distribution based on gender balance and as wide a geographical basis as possible, and in this regard recalls its resolutions 46/232 and 51/241, adopted without a vote, which contain the principles that the highest standards of efficiency, competence and integrity are the paramount considerations in the recruitment and performance of international civil servants and that, as a general rule, there should be no monopoly on senior posts in the United Nations system by nationals of any State or group of States;

79. *Reiterates its request* that the Secretary-General continue his ongoing efforts to ensure the attainment of equitable geographical distribution and gender balance in the Secretariat, while recalling its resolution 71/263, in particular the paragraphs thereof related to equitable geographical distribution and gender balance;

80. *Requests* the Office of Human Resources Management of the Secretariat to continue with the practice of providing a briefing to the Ad Hoc Working Group on the gender balance and regional origin of the executive heads of the United Nations system and the Senior Management Group of the Organization, and takes note of the practice of distributing said briefing to the Member States;

81. *Invites* the specialized agencies, funds and programmes to maintain updated information regarding the past and present executive heads on their official websites in order to strengthen transparency, as well as accessibility of the historical record;

82. *Requests* the Secretariat to brief the Ad Hoc Working Group at the seventy-third session on the issue of candidacies of senior United Nations officials currently holding office, in order to enhance transparency and equity of the appointment process;

Strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly

83. *Commends* the President of the General Assembly at its seventy-second session for strengthening the transparency and inclusivity of his Office, including through continuing the practices outlined in paragraph 66 of resolution 71/323, and for voluntarily presenting the summary of his personal financial disclosure, and requests future Presidents of the Assembly to follow these good practices;

84. *Notes with appreciation* the views expressed by the Office of the President of the General Assembly to the Ad Hoc Working Group on the strengthening of the accountability, transparency and institutional memory of the Office of the President and its relationship with the Secretariat and the measures already taken in this regard, while continuing to explore additional measures where feasible, and notes the support provided by the General Assembly and Economic and Social Council Affairs Division of the Department for General Assembly and Conference Management of the Secretariat to the Office of the President;

85. *Encourages* the President of the General Assembly to continue the practice of periodically briefing Member States on his or her activities, including official travel;

86. *Commends* the initiative of convening a retreat on the strengthening of the General Assembly, which brings together the incoming and outgoing presidencies of each session of the Assembly;

87. *Stresses* the importance of continuing with the practice of providing a handover report from the President of the General Assembly to their successors and all Member States, as well as of further efforts to improve archiving and record-keeping by the Office of the President of the General Assembly;

88. *Strongly welcomes* the organization of informal dialogues with candidates for the position of President of the General Assembly, as well as the circulation of vision statements, as outlined in paragraph 73 of resolution 71/323;

89. *Requests* the Ad Hoc Working Group to establish, in close consultation with the President of the General Assembly, the guidelines for the informal interactive dialogue with candidates for the position of President of the General Assembly, including the question of participants, duration and format;

90. *Highly commends* the President of the General Assembly at its seventy-second session for introducing the morning dialogues, envisaged as informal discussions among Permanent Representatives on the substantive and practical aspects of work of the Assembly, and strongly encourages the continuation of the valuable practice of regular meetings between the President and the Permanent Representatives;

91. *Invites* the Presidents of the General Assembly to maintain the practice of holding monthly meetings with the Secretary-General and the President of the Security Council in order to ensure cooperation, coordination and exchange of information on cross-cutting issues related to the work of the Organization;

92. *Expresses deep satisfaction* that at the seventy-third session, and for the fourth time in its history, the General Assembly will have a female President, in this regard invites Member States to consider presenting women as candidates for the position of future Presidents of the General Assembly, and encourages Presidents-elect to continue to ensure respect for balanced gender and geographical representation in the Office of the President of the General Assembly, both in terms

of numbers and level of responsibility, without prejudice to professional qualifications of potential candidates;

93. *Requests* the Secretary-General to report to the Ad Hoc Working Group at the seventy-third session of the General Assembly on the sources of funding and staffing of the Office of the President of the General Assembly, including on any technical, logistical, protocol-related or financial questions, and for more clarification on the budgetary basis for the provision of such support by the Secretariat;

94. *Recalls* its request to the Secretary-General and its invitation to the heads of specialized agencies, funds and programmes, upon request by the President of the General Assembly, to consider seconding staff to work in the Office of the President of the General Assembly on a more systematic basis;

95. *Notes* that the activities of the President of the General Assembly have increased markedly in recent years, recalls provisions regarding support for the Office of the President of the General Assembly in previous resolutions, and expresses continued interest in seeking ways to further support the Office, in accordance with existing procedures, in particular rule 153 of the rules of procedure of the Assembly, as well as to continue discussions within the Ad Hoc Working Group on further steps to strengthen the Office;

96. *Requests* the Secretary-General to submit, in the context of the proposed programme budget for 2020, proposals to review the budget allocation of the Office of the President of the General Assembly, in accordance with existing procedures, including rule 153 of the rules of procedure of the Assembly, and taking into account the deliberations of the Ad Hoc Working Group on the issue, and in this connection looks forward to considering such proposals during the main part of its seventy-fourth session;

97. *Takes note* of the practice of making non-staff programme budget resources available to Presidents of the General Assembly from the date of their election;

98. *Stresses* the importance of the contributions of Member States to the trust fund in support of the Office of the President of the General Assembly, and in this regard notes with appreciation the contributions that have been made to the fund, and encourages Member States to continue to contribute to the fund and to allow for unspent contributions from previous sessions to be made available for succeeding terms;

99. *Welcomes* the continuation of the practice of vetting all contributions from sources other than Member States through the Ethics Office, and urges adherence to this practice;

100. *Reiterates its call for* non-in-kind contributions to be channelled through the trust fund, and welcomes steps taken in this regard by the President of the General Assembly at its seventy-second session;

101. *Requests* the President of the General Assembly, in cooperation with the Secretariat, to report to the Ad Hoc Working Group at the seventy-third session of the Assembly on the implementation of all mandates accorded to her under the present resolution and previous relevant resolutions.

Explanatory note by the Co-Chairs of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly (seventy-second session)

1. In accordance with paragraph 4 of General Assembly resolution [71/323](#), in which the Assembly decided that the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-first session ([A/71/1007](#)) and, as a result, continue to update the inventory to be attached to the report of the Ad Hoc Working Group at the seventy-second session, the Co-Chairs, assisted by the Secretariat, have prepared the updated inventory chart for consideration by Member States.
2. The present inventory chart has been updated to reflect the progress achieved since the adoption of resolution [71/323](#).
3. The Co-Chairs, assisted by the Secretariat, obtained updated information, where possible, from relevant entities responsible for implementation.
4. The updated inventory chart retains the following two-part structure, which was also utilized in the report submitted at the seventy-first session:
 - (a) The first part contains unimplemented provisions, in order to focus on their follow-up;
 - (b) The second part contains implemented provisions, both those that required one-time action and those to be implemented on an ongoing basis, in order to keep track of previous achievements and provide the means to compare with and learn from past experience.
5. The inventory chart does not have a definite character and may be amended at any time by Member States through the Ad Hoc Working Group. Furthermore, it is not intended to, and does not, have any legal effect. It should serve only as a tool to facilitate discussions on the follow-up to the implementation of the previous related resolutions.
