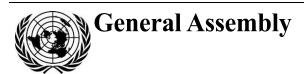

Expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court

Report of the Secretary-General

Summary

The present report is submitted pursuant to paragraph 19 of General Assembly resolution 72/3, in which the Assembly emphasized the need for the Secretary-General to inform the General Assembly at its seventy-third session of the expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court.

- 1. During the period from 1 July 2017 to 30 June 2018, Headquarters provided facilities and services to the International Criminal Court in the amount of \$205,071. This includes costs for staff who worked exclusively on matters pertaining to the Court, conference and related services, field security, library and other miscellaneous services.
- 2. Additional expenses in the amount of \$71,814 were incurred by the United Nations Office at Nairobi, the International Tribunal for the Former Yugoslavia, the United Nations Office at Geneva, the United Nations Support Mission in Libya and the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic for services provided for the same period.
- 3. The Court regularly reimbursed the United Nations upon receipt of invoices.
- 4. Itemized details of facilities and services provided to the Court by Headquarters for the period are provided in annex I, and by the various offices away from Headquarters for the same period in annex II.
