Revitalization of the work of the General Assembly

Report of the Special Political and Decolonization Committee (Fourth Committee)

Rapporteur: Mr. Luis Mauricio Arancibia Fernández (Plurinational State of Bolivia)

1. At its 3rd plenary meeting, on 21 September 2018, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-third session the item entitled "Revitalization of the work of the General Assembly" and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.

2. The Special Political and Decolonization Committee (Fourth Committee) considered the item at its 28th meeting, on 16 November.¹

3. For its consideration of the item, the Committee had before it a note by the Secretariat on the revitalization of the General Assembly (A/C.4/73/INF/4).

4. At its 28th meeting, the Committee had before it a draft decision entitled "Proposed programme of work and timetable of the Special Political and Decolonization Committee (Fourth Committee) for the seventy-fourth session of the General Assembly" (A/C.4/73/L.10), submitted by the Bureau.
