Report of the Special Political and Decolonization Committee (Fourth Committee)

1. At its 3rd plenary meeting, on 21 September 2018, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-third session the item entitled “Revitalization of the work of the General Assembly” and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.
2. The Special Political and Decolonization Committee (Fourth Committee) considered the item at its 28th meeting, on 16 November.¹
