Report of the Second Committee*

1. At its 3rd plenary meeting, on 21 September 2018, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-third session the item entitled:

“Operational activities for development:

“(a) Operational activities for development of the United Nations system;

“(b) South-South cooperation for development”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 20th and 21st meetings, on 22 and 23 October 2018. An account of the Committee’s discussion of the item is contained in the relevant summary records.¹ Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, on 8, 9 and 10 October.² An account of the Committee’s further consideration of the item is provided in the addenda to the present report.

6. At the 27th meeting, on 3 December, the representative of the Bolivarian Republic of Venezuela made a statement with regard to the draft resolutions adopted by the Committee.⁴
