The CTS is a USAID-funded criminal justice reform project aimed at ensuring effective and efficient investigations and prosecution of criminal cases through the promotion of inter-agency collaboration and information sharing among the key stakeholder agencies, from arrest to incarceration.

October 2015 to April 2018: Presiding Judge of the first High Court, established within a Prison facility in Ghana - the Nsawam Medium Security Prison - heard and determined appeals from judgments of the Circuit and Magistrate Courts. Delivered a total of 185 judgments. The objective of the programme is to uphold the remand prisoners’ right to expeditious trial and personal liberty and thereby decongest overcrowded prisons in Ghana.

14th August 2015: Permanent Judge Advocate for all Military Enquiries. I presided over all trials involving Military personnel at Court Martials and handled nine (9) cases in total.

– International Criminal Tribunal for Rwanda

November 2000 to 30 September 2013 – Legal Officer within the Court Management Section of the United Nations International Criminal Tribunal for Rwanda, (ICTR) based in Arusha, Tanzania. Employed as Courtroom Officer, I got promoted to Coordinator and then Officer-in-Charge of the Judicial Proceedings Unit of the Judicial and Legal Affairs Section of the Registry.

September 2012 to September 2013: Appointed Trial Monitor to monitor the trials of two (2) accused persons transferred from the UN Tribunal to Rwanda for trial within the national jurisdiction. My main duty was to observe the trial processes, the conditions of detention of the accused persons and the facilities made available to them by the Rwandan Government to ensure fair trial, treatment and disposition of their cases. I submitted periodic reports to the Tribunal, which were subjected to strict UN scrutiny to determine whether the accepted UN minimum standards for the treatment of prisoners were being complied with by the Rwandan Courts. The reports also formed the basis for the preparation of periodic report to the United Nations Security Council.

– Ghana Immigration Service

1997 to 2000: First Prosecutor for the Ghana Immigration Service, with the responsibility of bringing before the law courts, persons suspected to have flouted Immigration-related offences.

He served as the first chairman of the Israel Anti-Drug Authority, and as the first chairman of the Government Forum to Monitor Anti-Semitism.
