Report of the Human Rights Council

Programme budget for the biennium 2018–2019

Revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its thirty-seventh, thirty-eighth and thirty-ninth sessions, and twenty-eighth special session

Report of the Advisory Committee on Administrative and Budgetary Questions

I. Introduction

1. The Advisory Committee on Administrative and Budgetary Questions has considered the report of the Secretary-General on the revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its thirty-seventh, thirty-eighth and thirty-ninth sessions, and twenty-eighth special session ([A/73/477](#) and [A/73/477/Corr.1](#)). During its consideration of the report, the Committee met with representatives of the Secretary-General, who provided additional information and clarification, concluding with written responses received on 6 December 2018.

II. Format and presentation

2. The Advisory Committee recalls that it has previously commented on the format and presentation of the report of the Secretary-General, most recently in [A/72/7/Add.35](#), wherein it encouraged the Secretary-General to continue his efforts and make further enhancements so as to make the document more reader-friendly. In addition, the Committee recalls its view that a list of the mandates that had been discontinued or had expired could be included, with clear information on the related financial implications (see [A/72/7/Add.35](#), para. 2, and [A/71/688](#), para. 4). The Advisory Committee was informed, upon enquiry, that 139 Human Rights Council mandates had been established or extended between 1 January 2016 and 31 December 2018, while four mandates had been discontinued over the same period.



3. **The Advisory Committee notes the improvements made in the present report of the Secretary-General. The Committee encourages the Secretary-General to continue his efforts to make the report more reader-friendly.**

III. Financial implications arising from the resolutions and decisions adopted by the Human Rights Council

4. The report of the Secretary-General ([A/73/477](#) and [A/73/477/Corr.1](#)) reflects 55 resolutions (including 54 resolutions establishing or extending new mandates and one resolution terminating a mandate) adopted by the Council in 2018 at its thirty-seventh to thirty-ninth sessions, and twenty-eighth special session. The report states that the programme budget implications arising from the resolutions adopted at those sessions gave rise to total requirements of \$55,913,200, of which \$39,185,900 in additional requirements for the biennium 2018–2019 comprised:¹

(a) An amount of \$10,082,400, which relates to commitment authorities authorized by the Advisory Committee in 2018 under General Assembly resolution [72/264](#), and the related appropriation in the amount of \$7,753,900 being sought in the context of the first performance report on the programme budget for the biennium 2018–2019, taking into account actual expenditure experience;

(b) Additional requirements amounting to \$29,103,500, comprising \$1,456,400 under section 2, General Assembly and Economic and Social Council affairs and conference management, \$11,385,500 under section 8, Legal affairs, \$16,080,900 under section 24, Human rights, and \$180,700 under section 29F, Administration, Geneva, which are proposed to be appropriated as a charge against the contingency fund for the biennium 2018–2019.

5. Resource requirements for the year 2020 amounting to \$5,803,800 and for the year 2021 in the amount of \$107,800 are not being considered by the Committee at this stage. **The Committee trusts that the resources for 2020 and 2021 will be presented at the relevant time with full justifications for the consideration of the General Assembly (see [A/72/35/Add.35](#), para. 4).**

Budget implementation

6. Upon enquiry, the Advisory Committee was provided with information on budget implementation in the case of five resolutions of the Human Rights Council for which authorization had been granted by the Advisory Committee to enter into commitments. The Committee notes that the implementation rate for section 24, Human rights, as at 1 November 2018 was particularly low for resolution 38/20 (on technical assistance to the Democratic Republic of the Congo and accountability concerning the events in the Kasai region), which showed expenditures of \$128,437 against a commitment authority of \$1,500,000; resolution S-28/1 (on violations of international law in the context of large-scale civilian protests in the Occupied Palestinian Territory, including East Jerusalem), with expenditures of \$705,990 against a commitment authority of \$1,785,000; and resolution 37/31 (on the situation of human rights in South Sudan), with expenditures of \$1,011,207 against a commitment authority of \$2,138,000. **In view of the pattern of expenditures for the current period, the Advisory Committee recommends the following reductions to the proposed requirements for 2019: 5 per cent for resolution 38/20, 5 per cent**

for resolution S-28/1, and 10 per cent for resolution 37/31 under section 24, Human rights.

7. In this connection, in its report on the first performance report for the biennium 2018–2019, the Advisory Committee makes further observations, including the fact that balances arising from amounts authorized for previous mandates of the Human Rights Council should not be offset against requests for commitments relating to the extension of those mandates (see [A/73/625](#), para. 8).

Posts and positions

8. The Secretary-General proposes to establish as at 1 January 2019 one new temporary post at the P-3 level, under section 24, Human rights, to support the activities mandated by the Council in its resolution 37/4 (on adequate housing as a component of the right to an adequate standard of living, and the right to non-discrimination in this context). Upon enquiry, the Advisory Committee was informed that the function of the post was to support the Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context, with research and preparation of thematic studies relating to the implementation of the 2030 Agenda, and to advise States, intergovernmental organizations, civil society and other stakeholders on how to effectively respect, protect and fulfil the right to adequate housing and non-discrimination in this context.

9. The Advisory Committee was also provided, upon enquiry, with information on the 232 general temporary assistance positions that are proposed to be recruited for various durations over the course of the 2018–2019 period to implement the resolutions and decisions adopted by the Human Rights Council in 2018 (see annex to the present report). In addition, the Advisory Committee was informed that its comments and observations relating to staffing for the authorizations provided under commitment authority had been implemented (see para. 7 above).

Consultants

10. Upon request, the Advisory Committee was provided with information on the consultancy requirements for 2018 and 2019. For the implementation of resolution 39/16 (on the human rights situation in Yemen), it is proposed to engage three consultants at a P-4 equivalent level for a period of six months each in 2019 with expertise in the fields of humanitarian international law, military affairs and gender analysis to support the work of the National Commission of Inquiry of Yemen. **The Committee considers that the provision of expertise and support in the above-mentioned fields to a national commission of inquiry is part of the core activities of the Office of the United Nations High Commissioner for Human Rights, which should therefore rely on available internal resources in this matter. Consequently, the Committee recommends a reduction in the amount of \$203,200, corresponding to the proposed consultancy for the implementation of resolution 39/16. As a general principle, the Committee considers that every effort should be made to draw on existing United Nations expertise and capacity to the fullest extent possible.**

Travel

11. With respect to travel, the Advisory Committee was informed, upon enquiry, that the overall compliance rate of the Office of the United Nations High Commissioner for Human Rights (OHCHR) with the 16-day advance booking policy was 64.2 per cent in 2018 as at the end of November 2018. **The Committee notes a compliance rate which is relatively high compared with that of other Secretariat**

entities and encourages OHCHR to continue its efforts in this regard, with a view to attaining the 75 per cent target compliance rate.

12. The Advisory Committee sought information on the travels undertaken and planned in 2018 for mandates subject to Human Rights Council resolutions. Nevertheless, detailed justification, including on cities of origin, was not provided. **In the absence of adequate justification, the Committee recommends a reduction of 2 per cent in the proposed resources for travel.**

Meeting costs

13. The Advisory Committee notes the additional requirement of \$1,456,400 for the biennium 2018–2019 under section 2, General Assembly and Economic and Social Council Affairs and conference management. In the context of its consideration of different statements of programme budget implications resulting from draft resolutions before the General Assembly, the Advisory Committee was informed, upon enquiry, that some of the resources allocated to conference services in Geneva in support of meetings of the human rights treaty bodies could be redirected, as OHCHR had been unable to make full use of its meeting entitlements for the biennium 2018–2019. **In view of the foregoing and the actual expenditure experience in 2018 for section 2 (see [A/73/493](#), annex III), the Advisory Committee recommends a reduction of \$50,000 to the additional requirements sought under section 2.**

IV. Conclusion

14. The Secretary-General's proposed actions to be taken by the General Assembly are set out in paragraph 200 of his report ([A/73/477](#) and [A/73/477/Corr.1](#)). **Subject to its recommendations and observations in paragraphs 6, 10, 12 and 13 above, the Advisory Committee recommends the approval of the proposals of the Secretary-General.**
