I. Introduction

- 1. By its resolution 72/313, the General Assembly decided to establish, at its seventy-third session, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:
- (a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation;
 - (b) To submit a report thereon to the Assembly at its seventy-third session.
- 2. The General Assembly also decided that the Ad Hoc Working Group should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-second session (A/72/896), and, as a result, to continue to update the inventory to be attached to the report to be submitted to the Assembly at its seventy-third session. The present report and the recommendations contained herein are submitted pursuant to the provisions of that resolution.
- 3. During the seventy-third session of the General Assembly, the President of the General Assembly appointed the Permanent Representative of Jordan to the United Nations, Sima Sami I. Bahous, and the Permanent Representative of Slovakia to the United Nations, Michal Mlynár, as Co-Chairs of the Ad Hoc Working Group.

II. Proceedings

- 4. The Working Group held a total of seven meetings, on 28 February, 19 and 27 March, 16 and 30 April and 11 September 2019.
- 5. The programme of work was organized as follows: general discussion and exchange of views; and thematic meetings. In accordance with paragraph 42 of resolution 72/313, the general debate, the thematic meetings and the interactive dialogue between permanent missions and the Secretariat were webcast.
- 6. The themes identified by the Co-Chairs for consideration in the four thematic meetings comprised:
 - (a) The role and authority of the General Assembly;
 - (b) The working methods of the Assembly;
- (c) The selection and appointment of the Secretary-General and other executive heads of the United Nations system;
- (d) The strengthening of the institutional memory of the Office of the President of the General Assembly.
- 7. In addition, one meeting was held as part of the interactive dialogue between permanent missions and the Secretariat (9 April 2019). A presentation of the zero draft of the resolution was made at an informal meeting on 3 June 2019.

A. General discussion

8. The first meeting of the Working Group was convened by its Co-Chairs on 28 February 2019 and was attended by the President of the General Assembly. Following introductory remarks by the President, the participants of the meeting heard interventions from 28 delegations, including on behalf of groups of States. The

Working Group also had before it a tentative timetable for the thematic discussions; the report of the Secretary-General on mandates addressed to the Secretariat that had not been implemented (A/73/749), issued pursuant to resolution 72/313; the report of the Secretary-General on opening of the regular sessions of the General Assembly (A/73/723) and a draft updated inventory chart of all revitalization mandates, which was uploaded on the dedicated revitalization link accessible from the website of the General Assembly (http://www.un.org/en/ga/revitalization/).

- In her opening remarks, the President of the General Assembly noted that the revitalization of the Assembly was at the heart of her priorities, recognizing it as key to strengthening multilateralism. From the start of the session, she convened many activities and events to promote the process, including the first Morning Minga, two meetings of the General Committee and the meeting with the former Presidents of the General Assembly on the theme "Revitalization of the United Nations in favour of a strengthened multilateral rules-based system." Recognizing significant progress made during previous sessions, she outlined the following three areas requiring additional attention: the increasing role of the Assembly, possible alternative dates for the beginning of the regular sessions of the Assembly, and a need to further strengthen the Office of the President. Addressing the increasing role of the General Assembly, in the context of a growing numbers of resolutions and meetings, required the optimal use of limited resources, technical capacity and time. The President further drew attention to the growing number of side events and parallel activities to the general debate of the General Assembly and supported an idea expressed by some delegations to consider developing a set of guidelines to manage overall activities and enable all Member States to obtain greater benefit. She further called to collectively address the number and length of resolutions and other outcome documents, which were getting unmanageable, even for large delegations, and encouraged to streamline the agenda, with a focus on the implementation. Turning to the coordination of activities of the Charter bodies, the President informed that she continued the practice of having monthly meetings with the Presidents of the Security Council, Economic and Social Council and with the Secretary-General. In addition, she convened a dialogue on "Renewing Commitment to Multilateralism" jointly with the Presidents of the Security Council and Economic and Social Council on 31 October 2018 as well as the first ever joint briefing on related activities with the President of the Economic and Social Council on 31 January 2019. The President further underlined the need to ensure that activities of the Charter Bodies as well as their subsidiary organs are better coordinated. In terms of her convening power, the President mainly focused on mandated meetings and events, creatively using them to advance issues related to the priorities for the seventy-third session, while limiting the number of new initiatives.
- 10. Turning to the possible alternative dates for the beginning of the regular session of the Assembly, the President strongly encouraged to positively consider the change in the start of the session in order to provide more time for the incoming President before the start of the general debate. In this regard, she highlighted the challenges that she faced at the beginning of her presidency in preparation for the high-level week. While recognizing the steps undertaken in the area of strengthening the Office of the President, she believed that more had to be done to align the role and capacity of the President with the evolving role of the General Assembly. She said that instead of focusing on the activities for delivering on the growing number of mandates addressed to the President, the President-elect must struggle to raise funds and secure secondments as well as manage an administrative structure without the required support. The President thanked the Member States who seconded staff to the Office but stressed that relying on the good will of voluntary contributions was neither sustainable nor desirable. The President welcomed the decision of Member States to fund the transition periods between outgoing and incoming Presidencies, the practice of preparation of handover reports, as well as the convening of annual retreats. conclusion, the President announced her intention to convene an interactive dialogue with the candidate(s) for the President of the seventy-fourth session of the General Assembly in May, in accordance with the established practice, and looked forward to the elaborated guidelines by the ad hoc working group for the future informal dialogues.

- 11. The Under-Secretary-General for General Assembly and Conference Management, introducing the report of the Secretary-General entitled "Opening of the regular sessions of the General Assembly" (A/73/723), highlighted the procedural framework, historical background, the current practice of the Assembly regarding its programme of work and identified three possible alternative options for the opening dates of the Assembly. Under each option, the current practice of convening the general debate in September would remain unchanged. As a potential benefit under all options, the incoming Presidents would have additional time to settle into office and to become acquainted with the working methods of the Assembly before the general debate. In addition, the General Committee can convene its first meeting without time pressure. The three options included: option A, in which the General Assembly would open on the Tuesday of the first week in August; and option C, in which the General Assembly would open on the Tuesday of the second week in September.
- 12. In the subsequent debate, speakers overwhelmingly noted the importance of the revitalization process and highlighted the significant achievements realized during the previous sessions, citing, in particular, the adoption of resolutions 69/321, 70/305, 71/323 and 72/313. Many Member States reiterated that the revitalization of the Assembly is interlinked with the comprehensive reform of the United Nations. The webcasting of the meetings of the Working Group was welcomed as an enhancement of the transparency and accountability of the General Assembly.
- 13. A group of Member States underscored the importance of preserving the intergovernmental, inclusive and democratic nature of the United Nations and stressed the imperative need to consult with Member States within the Organization. Member States emphasized the need to respect the Charter-based prerogatives of each of the principal organs. Some delegations mentioned the politicization of the General Assembly and strongly opposed the use of the Assembly or any other organ of the United Nations as fora to promote national agendas and political interests by some Member States. On the other hand, one delegation reiterated the sovereign right of each Member State to propose agenda items. Other delegations focused on enhancing the General Assembly's efficiency and effectiveness, including through reprioritization and the elimination of overlap where necessary, and called to ensure that the Organization worked within the agreed budget levels. One delegation called for vigilance about budgetary implications and stressed that efficiency entailed operating within existing resources.
- 14. The desire to streamline the agenda of the General Assembly was raised, including through the biennialization, triennialization, clustering and elimination of agenda items. One group of States strongly believed that certain resolutions should be on the basis of a biennial and triennial cycle. Several speakers referred to the option of introducing a sunset clause. One delegation cautioned, however, that any streamlining of the agenda needed to be done on a case-by-case basis and in consultation with the Member States concerned. Speakers also recalled past and ongoing efforts to streamline the agendas of the General Assembly and the Economic and Social Council with the 2030 Agenda for Sustainable Development and underlined the need to eliminate duplication and overlap and promote complementarity in the consideration and negotiation of similar and related issues. In this regard, one group stressed the need to bring the work of the Second Committee

- of the General Assembly in line with the spirit of the 2030 Agenda and to transform it into a forum for meaningful and cross-regional discussions on how to best achieve the Sustainable Development Goals. One delegation was in favour of reducing redundancies and resolutions that have been overtaken by events. Another speaker suggested to adopt a rule according to which no new agenda item or sub-item should be added without simultaneous deletion of another item, which lost its relevance.
- 15. Member States touched upon the scheduling of high-level meetings during the high-level week in September. Many stressed that such meetings should be kept to the absolutely critical minimum in order to preserve and strengthen the sanctity of the general debate. Noting that the high-level week was already extremely busy, one speaker suggested that new high-level meetings should be spread out over the rest of the year and should focus on subjects relevant to the entire membership. Some speakers supported efforts to consider the proliferation of high-level meetings seriously, including in the discussions in the General Committee. Delegations supported the idea to discuss guidelines to optimise the efficiency and effectiveness of side events during the general debate, so as to bring order and discipline to the current overload of events. A delegation also expressed the wish that the list of speakers for the general debate should be produced in a manner that more accurately reflects the political context of individual Member States in which the Head of State performs a ceremonial or symbolic role and the Head of Government holds the highest political office.
- 16. Member States also discussed alternative possible dates for the opening of the session and generally thanked the Under-Secretary-General for introducing the report (A/73/723). Some delegations supported option C, in which the General Assembly would open on the Tuesday of the second week in September. One delegation expressed the need to carefully examine any alternative options and was unprepared to take any decision at the current session. Another delegation regretted that the only realistic option suggested in the report was option C, which was under discussion in the Ad Hoc Working Group for the past two years. Another speaker supported the idea to consider alternative dates for the opening of the session by bringing the high-level week to the very end of each session.
- 17. Several speakers welcomed the steps taken regarding the provision of the *Journal of the United Nations* in digital format in all six languages. Many delegations encouraged the taking of additional steps to improve its accessibility even further. The need for full implementation of rule 55 of the rules of procedure of the General Assembly was reiterated. One delegation expressed the specific wish that the information regarding the informal consultations be provided in all six languages. Another expressed concern about a long time for the digital Journal to load on all devices. Moreover, delegations looked forward to the continuation during the seventy-third session of the comprehensive dialogue established between permanent missions and the Secretariat. A group of States strongly objected to the use of United Nations premises by some Member States to campaign against other Member States and underlined that the facilities of the United Nations must be used in line with the purposes and principles of the Organization.
- 18. Attention was given to the selection process of the Secretary-General and other executive heads. Delegations referred to the conclusions from the most recent selection process (A/72/514-S/2017/846) and argued for the consolidation of the historic achievement attained. Other delegations stated that it would be premature to focus on the selection process of the Secretary-General at this session. Improved interaction between the Security Council and the General Assembly was highlighted as a topic for further discussion. One group underlined that, at whatever stage a candidature was presented, the new procedure would always be followed in the future, and encouraged a deadline for the presentation of candidates. This group also wished

- to further consider the possibility of submitting multiple candidates to the General Assembly; the application of practices used in the selection of other executive heads; and updating the oath of office. The same group wished to see extensive consultations on the draft resolution on the appointment of the Secretary-General and the conduct of a secret ballot in the Assembly. It was stressed that any new proposals must be studied very carefully to ensure their conformity with the Charter of the United Nations and that the viability of innovative ideas ought to be borne in mind before they were tabled.
- 19. Regarding the appointment of other executive heads and senior officials in the Organization, one group advocated that the Secretary-General should exercise independence in appointing senior officials, while securing the highest standards of efficiency, competence and integrity, as well as equal and fair distribution based on gender and geographical balance. While commending the Secretary-General for the steps already taken, many delegations wished to receive a clearer overview from the Secretariat regarding vacancies for all senior posts and a broader and timely dissemination to the wider membership of positions available at the level of Under-Secretary-General and other senior posts. It was emphasized that, in line with past resolutions, no country or group of countries should hold any type of monopoly on senior positions in the Secretariat.
- 20. With regard to the strengthening of the Office of the President of the General Assembly, several delegations welcomed the steps taken to ensure greater transparency and accountability. A group of States wished to see additional posts in the Office of the President of the General Assembly on a permanent basis, as well as sufficient human and financial resources from the United Nations regular budget. It also highlighted the need for successful transition from one presidency to the next. One delegation proposed holding the election of the President earlier than June in order to afford the President-elect sufficient time to assemble a team and adequately prepare for the handover. Another delegation drew attention to the current support received by the President of the General Assembly from the Secretariat, and the need to strengthen it, in accordance with the role of the President under the Charter and the resolutions adopted. The informal dialogue with candidates for the post was cited as an important innovation that would serve to ensure that the best candidate was elected.
- 21. Member States welcomed the appointment by the President of the General Assembly of the Permanent Representative of Singapore, His Excellency Mr. Burhan Gafoor, and the Permanent Representative of Iceland, Her Excellency Ms. Bergdis Ellertsdottir, as the co-facilitators on the theme, dates and modalities for the commemoration of the seventy-fifth anniversary of the United Nations in 2020. Delegations referred to the anniversary as an opportunity to take stock of achievements as well as to critically look at the challenges for the United Nations and multilateralism. Many speakers suggested to refer to the seventy-fifth anniversary in the resolution of the ad hoc working group. In addition, delegations supported the intention by the Co-Chairs to streamline the zero draft.
- 22. In concluding remarks, the Co-Chairs noted the wide range of substantive issues raised and emphasized that their main objective would continue to be to listen to Member States' interventions during the forthcoming thematic debates. The views and positions would form the basis for the zero draft of the resolution to be circulated before the commencement of the negotiations.

B. Thematic meetings

First thematic meeting: the role and authority of the General Assembly

- 23. In the course of the first thematic meeting, held on 19 March 2019, 15 delegations made statements, including on behalf of groups of States. Following opening remarks by the Co-Chairs a briefing was provided by Under-Secretary-General for Global Communications on efforts by the Department of Global Communications to enhance the visibility of the work of the General Assembly.
- The Under-Secretary-General for Global Communications affirmed that the General Assembly continued to be at the centre of the efforts of the Department of Global Communications to tell the United Nations story to the global public every day, in as many languages and via as many platforms as possible. The Under-Secretary-General highlighted increased communications on the Sustainable Development Goals by engaging more partners, including civil society, academia and private sector. She further cited production and dissemination of multimedia and social media content on the Assembly in the six official languages as well as Kiswahili and Portuguese, the live and archived webcast coverage of the meetings of the plenary and the Main Committees as well as same-day press releases in English and French summarizing the proceedings. She also referred to the practical support provided by the Department to the Office of the President of the General Assembly, which included the secondment of a staff member to support the communications team of the Office, producing and disseminating the annual General Assembly press kit and providing year-round media support to the President, for example, assisting in the placement of op-eds, amplifying social media content, arranging media interviews and providing media monitoring when the President was travelling. Finally, she underscored the services of the Department for Member States, such as having a dedicated team on social media to guide digital diplomacy efforts, the social media studio during the high-level week in September, and the "one-stop" website to streamline events at the United Nations Headquarters.
- 25. In the subsequent interactive segment, three delegations posed questions. Responding to a question how the Department for Global Communications attempts to improve media coverage of the visits by the President of the General Assembly to various countries, the Under-Secretary-General assured that the Department was working closely with the Office of the President and utilizing the network of Information Centers to ensure media coverage of the movements of the President. Answering about key elements during the ongoing United Nations reform process, especially in relation to the Main Committees of the General Assembly, the Under-Secretary-General explained that emphasis was placed on social media and the revamping of the United Nations' website to modernize the communications. Lastly, she highlighted that the Department was striving to provide high-quality communication products in all six official languages in response to a question how digital media has influenced the traditional media such as radio and multilingualism section.
- 26. In the course of the subsequent debate, delegations focused on the role and authority of the General Assembly, especially from the perspective of the Assembly's relationship with the other principal organs, in particular the Security Council.
- 27. Many Member States reaffirmed the importance of strengthening the authority of the General Assembly, including in matters of peace and security. For example, one group of States stressed the necessity of complete observance by the Security Council of all Charter provisions, as well as of General Assembly resolutions, and urged the Council to submit a more comprehensive and analytical annual report to the General Assembly. Other speakers stressed that the best way to enhance the role and

- authority of the Assembly was to improve its efficiency and effectiveness, pointing to, among other elements, the respective and complementary functions of the General Assembly and the Security Council.
- 28. On election-related matters, one delegation welcomed the practice of interactive dialogues with candidates for the Secretary-General and the President of the Assembly, while advocating that this practice should be extended to other election forums. Another delegation suggested the introduction of a single non-renewable term and independence of elected United Nations Officials. Regarding election campaigns by Member States, some delegations called for more transparency and equity and reducing financial costs for small countries. In this regard, one delegation suggested to use a platform to support election decisions on the basis of track records and commitments by the candidates.
- 29. Many delegations called for greater coherence in the work of the various principal organs, including the rationalization of agenda, and greater coordination among them through regular meetings of their Presidents. One delegation welcomed the circulation by the President of the General Assembly of summaries of the meetings between the Presidents of the principal organs. Speakers also stressed the importance of implementing 2030 Agenda. More generally, some argued that the voluminous agenda of the Assembly was a burden for Member States and advocated the streamlining of agenda, resolutions and other outcome documents. One delegation reiterated that all proposals to remove or change the frequency of consideration of agenda items would require consultations with the concerned Member States. Some delegations emphasized the importance of including other stakeholders in the work of the General Assembly.
- 30. With regard to the interactive and comprehensive dialogue between permanent missions and the Secretariat, which was established under the cluster of this thematic debate, many delegations welcomed the dialogue as a "standing mechanism". One speaker suggested to expand this practice to other intergovernmental organs, while a group of States reiterated the need to follow up on all issues raised during the dialogues.
- 31. Many speakers reiterated their concerns about the increasing number of side events scheduled in parallel with the general debate in September. Some called on Member States to reconsider the scheduling of such events to ensure appropriate level of attention to the general debate. A group of States reiterated a need to develop guidelines to manage these events.
- 32. In concluding remarks, the Co-Chairs noted the wide range of substantive issues raised, which they intended to take into account when preparing the zero draft of the draft resolution.

Second thematic meeting: the working methods of the General Assembly

- 33. The second thematic meeting was convened by the Co-Chairs on 27 March 2019. In accordance with paragraph 22 of resolution 72/313, the meeting participants heard briefings from the Chairs and representatives of the six Main Committees. In addition, at the invitation of the Co-Chairs, the Chef de Cabinet of the President of the General Assembly briefed on behalf of President of the General Assembly in her capacity as the Chair of the General Committee. During the interactive question-and-answer segments that followed, delegations had an opportunity to pose questions.
- 34. The Co-Chairs, in their opening remarks, emphasized the importance of the working methods for the revitalization of the GA, since they had a direct and comprehensive impact on efficiency, effectiveness and transparency. They highlighted that Member States had already advanced important initiatives to

streamline the agenda, consolidate documents and improve various procedural matters, including planning of meetings and voting. However, discussions during the current session reflected that Member States saw potential and need for further improvement.

Briefings by the Chairs of the Main Committees

- 35. The Chair of the First Committee noted that, as in previous years, the Committee was able to complete its work well within the provided timeframe. Despite "this session being one of the most contentious in the Committee's history", the Committee was able to complete its work one day ahead of schedule by adding meetings within the session. The use of the e-Speakers and e-Sponsors modules of the e-deleGATE portal had added convenience for delegations and increased transparency of the proceedings. The Chair noted delegations' efforts to deliver their statements within the time limits set, which was facilitated by a buzzer system. In February 2019, the Chair started discussions on improving the working methods of the Committee regarding the modalities for participation of intergovernmental organizations in the Committee's panel discussions, through an open and transparent consultative process, based on a "non-paper" containing options for consideration by Member States that he circulated in 2018. In conclusion, he welcomed the efforts by the Office of the PGA to promote coherence among the Main Committees, to which the discussions within the AHWG greatly contributed.
- 36. The Chair of the Fourth Committee informed that the Committee continued its practice of considering the five decolonization items in a clustered manner and holding interactive dialogues with high-level representatives of the Secretariat and agencies, in accordance with General Assembly resolution 58/316. Pursuant to General Assembly resolution 51/241, the First and Fourth Committees had closely coordinated their meetings at the current session furthering active coverage of the two Committees by smaller delegations. He also pointed out that the methods of work of the Committee, especially those relating to established time limits for statements, might require further review if the number of petitioners and delegations requesting to address the Committee continued to increase. Time management, aided by the use of a flashing light on microphones when one minute remained and deactivating the microphone during the statements by the petitioners when time allocation elapsed, proved crucial for the successful and timely conduct of work. The Chair further highlighted the benefits from the use of e-deleGATE, as a single consolidated platform to circulate information, which helped delegations to prepare for the meetings. In addition, the website launched at the seventy-second session for the submission of requests by petitioners (epetition.un.org) had continued to prove extremely useful and efficient.
- 37. The Rapporteur of the Second Committee highlighted the number of improvements made since the seventieth session: early preparations for the session, including agreement on a programme of work; reduction of the number of side events to two in addition to a joint meeting with the Economic and Social Council; compression of the general discussions of all items into the first three weeks of the session; strict implementation of time limits for interventions by deactivating the microphone one minute after the agreed speaking time had elapsed; establishing realistic deadlines for submission of draft resolutions; continued use of e-deleGATE to facilitate the work of the Committee and timely identification of facilitators. Highlighting the traditional practice of adopting the large majority of proposals by consensus, the Rapporteur regretted that it was not possible to find a formulation acceptable to all delegations of the paragraphs occurring in many resolutions referring to the inclusive nature of the 2030 Agenda. Discussions on the methods of work of the Committee pursuant to General Assembly resolution 72/313 were held in the

context of the Bureau meetings since no delegation intervened under the item during the plenary meeting on 30 November 2018. Subsequently, in response to an invitation by the bureau, many delegations had sent written inputs containing suggestions to improve the working methods of the Committee. In concluding, the Rapporteur emphasized that any discussions on the revitalization of the work of the Second Committee needed to be conducted taking into account other ongoing intergovernmental processes linked to the issues considered by the Committee.

- 38. The Vice-Chair of the Third Committee (Slovakia) informed about its rigorous workload and a continuous challenge with the scarcity of rooms for the numerous informal meetings. He highlighted that the number of special procedure mandate holders interacting with the Committee more than doubled in the last ten years, while the number of meetings remained the same. Therefore, time management was of great importance, furthered by progressive biennialization of some reports and resolutions, clustering of agenda items, discouragement of introductions of recurring draft proposals, the display of the digital count-down speech timer and automatic deactivation of the microphones when allotted speaking times elapsed. Reflecting on the Committee's experience with the consolidation of draft resolutions, he cautioned that any potential efficiency gains from omnibus resolutions should be weighed against possible complications resulting from contentious issues preventing an agreement on the wider proposal and increasing the possibility of voting. The use of e-deleGATE continued to facilitate information sharing by the bureau and the Secretariat but could be further expanded. Moreover, the election of the bureau three months in advance as well as the customary meeting of the incoming with the outgoing bureau had proven useful. Finally, the Vice-Chair encouraged the bureau to continue its practice of dividing the responsibilities to monitor draft resolutions emanating from their respective regional groups.
- 39. The Chair of the Fifth Committee highlighted the Committee's special nature owing to its consensual decision-making practice. She mentioned that the conclusion by the Fifth Committee of the main part of the session on 22 December 2018 was achieved by changing the standard procedure, enforcing the punctual start of meetings and instituting the time limits for statements (without cutting off speakers' microphones). The Chair further highlighted the importance of timely availability of documentation and stated that the Secretariat and the Advisory Committee on Administrative and Budgetary Questions should be held accountable to the General Assembly for the timely provision of reports, while recognizing the responsiveness of the Department for General Assembly and Conference Management to the needs of the Committee with the editing and translation of documentation. In addition, while welcoming transparency, the Chair pointed out that the Secretariat submits many reports to the Fifth Committee that do not seem to need the approval of the Assembly, thus resulting in extra spending because of the processing costs and longer proceedings to discuss them. Finally, the Chair proposed to ensure that there is at least a week break between the end of the session of the Committee on Administrative and Budgetary Questions and that of the Fifth Committee so as to allow time for preparation and consideration of the reports by the Fifth Committee.
- 40. The Chair of the Sixth Committee informed that the Committee continued the practice to discuss its working methods and the provisional work programme for the following session. The bureau also continued to proactively and successfully address the overlap with the schedule of plenary meetings, especially regarding consideration of the reports of the International Criminal Court and the International Residual Mechanism for Criminal Tribunals. Member States benefitted from informal briefings and side events, which encouraged dialogue between them and other stakeholders. While acknowledging the positive impact on information sharing through e-deleGATE, PaperSmart and the Committee's website, the Chair encouraged the

Secretariat to continue expanding its electronic information resources. The current bureau intended to continue the practice of holding a "hand-over" meeting with its successor. In concluding, the Chair mentioned the quality of the debate and interaction between delegations during the session as one area in need of improvement. He proposed to encourage delegations to reduce statements to the main points and share the detailed statements through PaperSmart.

- The Chef de Cabinet of the President of the General Assembly, speaking on behalf of the President, informed that on 5 December 2018, the General Committee held a meeting to exchange views on the important process to address gaps and duplication in the agenda of the General Assembly as they relate to the 2030 Agenda for Sustainable Development in accordance with GA resolution 72/313, in particular its paragraphs 29, 30 and 31. Reiterating the President's preoccupation regarding the general debate of the General Assembly, which risked losing its importance and primacy due to the increasing number of parallel activities, the President concurred with proposal by Member States to consider a set of guidelines on the initiation of high-level meetings and side-events held in parallel to the general debate to be applicable to the Member States, Secretariat and the entire United Nations system. Turning to the possible options to streamline the agenda as well as the number and the length of resolutions, the President suggested four levels of action: (a) to identify a comprehensive methodology that defines possible gaps and duplications and establish a realistic timeline within the framework of the ongoing process to enhance synergies and coherence and reducing overlap in the agendas of the General Assembly, Economic and Social Council and their subsidiary bodies, as well as the high-level political forum on sustainable development and other related forums in view of the 2030 Agenda for Sustainable Development; (b) to consider issues related to time management, programme of work, format of meetings, frequency and clustering of agenda items and resolutions, as part of the work to be undertaken by the Chairs of the Main Committees of the General Assembly; (c) to discuss streamlining the agenda in the General Committee; and (d) to strictly restrain submissions of new proposals and agenda items, reconsider frequency of recurring proposals and items and possibly cease those that are no longer relevant by the respective individual and groups of Member States. In conclusion, the President appealed to Member States to change the opening date of the regular session of the General Assembly so as to allow sufficient time for the Office of the President of the General Assembly to prepare for the session.
- 42. In the subsequent question-and-answer segment, five delegations engaged the Main Committee representatives and Chef de Cabinet of the Office of the President of the General Assembly on the issues that they had raised or on specific proposals of their own as to how to further enhance efficiencies, including through better coordination. One delegation suggested that the Main Committees could utilize the agenda item entitled "Revitalization of the work of the General Assembly", allocated to each Main Committee annually, to consider biennialization, triennialization, elimination of items as well as a possible impact of such changes on the future consideration of these items by the respective Committees. Another delegation proposed for the Third Committee to follow the practice of the Human Rights Council in hearing a cluster of special procedures at the same meeting instead of convening individual dialogues. One delegation noted with concern the continuous proliferation of the high-level events in the last several years and regretted the short time allotted to Member States to react to statements by experts and presenters during the interactive debates, presenting a challenge in attracting high-level officials from capitals. Responding to a question about the rational and the most preferred alternative date for the opening of the session by the Office of the President, the Chef de Cabinet expressed a preference for starting the session in January so as to facilitate the transition between the presidencies. Speaking in her individual capacity, the Chair

of the Fifth Committee remarked that the Chair of the Fifth Committee would benefit from commencing office in January for a calendar year to enable the incumbent to gain experience with the operation on smaller and less complex agenda items during the two parts of the resumed session, culminating in the main session. She added that the General Assembly and especially the President would also benefit from such annual cycle. Responding about a high number of meetings and non-negotiated outcomes, the Chef de Cabinet highlighted the need to experiment with the format of the meetings so as to create space for relevant action-oriented outcomes while fully taking into account the sovereign rights of the Member States.

Statements/debate

- 43. During the debate, 11 delegations made statements, including on behalf of groups. Speakers reviewed the implementation of the provisions adopted by the General Assembly under this thematic cluster during the seventy-second session, noting and highlighting various achievements. A group of States stressed the urgent need for steps to be taken towards rationalizing the agenda in order to reprioritize, eliminate duplication and overlap and promote complementarity in the consideration and negotiations of similar and related issues, including in the light of the 2030 Agenda. A group of States proposed to include a placeholder paragraph in the draft resolution on the revitalization of the work of the General Assembly for the subsequent inclusion of the outcome of the agenda alignment process and stressed the need to synchronize these processes so that they are mutually-reinforcing. One delegation called the ad hoc working group to be mindful of the impact of the ongoing reforms by the Secretary-General, including of the peace and security pillar and repositioning of the United Nations development system, on the working methods of the Committees, while keeping in mind that the main rational behind these reforms was to do away with fragmentation and strengthen coherence, leadership and enhanced results. A group of States recognized that some resolutions could be biennialized or triennialized, while expressing its strong belief that considerations by Member States, particularly the sponsors of resolutions, should be duly taken into account. Another group stressed that increased focus on implementation of draft resolutions would create public visibility and generate awareness on the ability of the Assembly to fulfil its mandates. One delegation specifically encouraged the Main Committees to identify resolutions suitable for biennial or triennial review. One speaker suggested biennializing the revitalization item itself, which would allow for greater focus on implementing previous resolutions rather than negotiating a new resolution every year. Another delegation suggested that sponsors of draft proposals should assess the practical feasibility of their recommendations prior to tabling draft proposals to improve implementation of the agreed resolutions. Another speaker pointed out that a comprehensive report by the Secretary-General on the implementation of General Assembly resolutions would greatly facilitate Member States' assessment on the necessity of annual review of resolutions.
- 44. The scheduling of meetings was identified as another important area for possible improvement in the working methods of the General Assembly, with many speakers stressing that meetings organized in parallel with the general debate should be kept to the absolutely critical minimum in order to preserve the integrity of the debate. A group of States recalled that high-level thematic debates organized by the President of the General Assembly should be limited to current issues of critical importance to the international community. Another group looked forward to the implementation of existing provisions aimed at enhancing the coordination of high-level meetings to optimize their number and relevance, and stressed the role of the Secretary-General, the President of the General Assembly, including in his capacity as Chair of the General Committee, and of the Chairs of the Main Committee in that regard. The same group strongly encouraged the ad hoc working group to consider guidelines to

- minimize the number of side events during the general debate with the aim reducing the current overload, while acknowledging that concentrating high-level events in a specific period of time increases political magnitude of the meetings and encourages more intense high-level participation from capitals. Another delegation supported spreading out high-level meetings across the year.
- 45. Acknowledging improvements from previous years, several speakers noted room for improvement regarding the coordination among the Main Committees during the session and the transition from one session to the next.
- 46. With regard to the possible modification of the opening date of the sessions of the General Assembly, one delegation observed that the report of the Secretary-General (A/73/723) provided a preliminary overview on the implications of each option outlined therein. However, in view of the implications not only for the Organization, but also for Governments, a more comprehensive analysis was needed before a decision could be taken. Another delegation reiterated its suggestion to bring the high-level week to the very end of each regular session and added that Option A seemed acceptable. One delegation expressed its openness to all three options presented in the report, noting that Options A and B would require further study, while Option C could be accepted as an interim solution.
- 47. A group of States mentioned that elections for the bureau of the Main Committees should be based on fair geographical representation and held at least three months before the opening of each session, preferably up to six months, to guarantee adequate preparation. Some speakers encouraged the Working Group to focus on the development of a code of conduct for election campaigns with a view to improving standards of transparency, accountability and equity. One delegation saw room for improvement in the conduct of elections of the Assembly and stated that it would be useful to task the Secretariat with an analysis of the current electoral practices to explore other solutions, including technologically advanced electronic voting systems.
- 48. One group of States proposed to elect the non-permanent members of the Security Council a full year before their term of office, instead of six months before, as provided for in resolution 68/307, and advocated expanding the membership of the Advisory Committee on Administrative and Budgetary Questions.
- 49. Many delegations welcomed the improved format of the *Journal*. One group, noting that the renewed *Journal* reflected the Organizations' commitment to multilingualism, called for further improving the ease of access to the *Journal* on electronic devices. One group looked forward to steps to be taken to ensure the full implementation of rule 55, namely, publication of the *Journal* in the six official languages.
- 50. A group of States called on the Secretariat to come up with ideas for a workable solution to ensure that General Assembly meetings were provided with interpretation services, irrespective of whether they ran overtime. The group also requested the timely issuance of documentation. Regarding the e-services provided by the Secretariat, such as the webcasting of meetings and the PaperSmart portal, the group stressed that their use should not be interpreted as an alternative to the provision of hard copies. One group of States said that the Secretariat should continue improving and harmonizing e-services provided to Member States under e-deleGATE so as it could serve as a full-fledged on-line workplace for delegates. One delegation mentioned that the Secretariat should inform Permanent Missions in advance about any innovations or administrative changes that may impact the work of delegates.

51. In concluding remarks, the Co-Chairs expressed gratitude for the rich debate and assured delegations that they had taken careful note of the views expressed, which would be duly taken into account.

Third thematic meeting: selection and appointment of the Secretary-General and other executive heads of the United Nations system

- 52. The Co-Chairs convened the third thematic meeting of the Working Group on 16 April 2019 and heard statements from 16 delegations, including on behalf of groups of States. Before the debate, the Working Group received a briefing from the Assistant Secretary-General for Human Resources Management on the gender balance and regional origin of the executive heads of the United Nations system and the Senior Management Group of the Organization, as well as on the issue of candidacies of senior United Nations officials currently holding office, in accordance with paragraphs 80 and 82 of resolution 72/313.
- 53. The Assistant Secretary-General for Human Resources Management informed the Working Group that the Secretariat consisted of 37,505 staff members. Of those, 63.2 per cent were men and 36.8 per cent were women. Of the latter, 6,680 were from landlocked least developed countries and 1,060 from the small island developing States. Of the 45 members of the Senior Management Group, 28 members or 62.3 per cent were women (the presentation was subsequently circulated in a letter dated 18 April 2019 by the President of the General Assembly to all Member States). The Assistant Secretary-General for Human Resources Management reported that there have been concerted efforts to raise gender parity and make the United Nations more geographically and regionally diverse. For example, as of March 2019, all heads of entities have access to a dashboard providing them with live data on geographical representation for all posts. Additionally, hiring managers received information on candidates' nationalities and regional groups, including whether the nationality/group is over- or under-represented at the United Nations.
- 54. In an interactive question-and-answer segment, three delegations intervened. One group appreciated the Secretariat's efforts to achieve gender parity among the Secretariat staff but expressed concern about the lack of parity between the regional groups, particularly with regards to the senior posts. Two delegations stressed the need to take measures to achieve geographical parity and take further steps in enhancing transparency in appointments. One speaker expressed concern regarding the underrepresentation of the nationals of the Eastern European States in the Secretariat and suggested to present future statistics separating from the data the nationals of the five permanent members of the Security Council.
- 55. In the subsequent debate, speakers reiterated as success the selection process that had led to the appointment of the ninth Secretary-General, citing the various innovative steps taken as a result of resolution 69/321 and 70/305. Many delegations emphasized their expectation that the innovative procedure used in the most recent appointment process pursuant to resolution 69/321 (including the sending of a joint letter from the Presidents of the General Assembly and of the Security Council inviting candidates to come forward; the circulation of candidacies received as official documents; and the convening of informal dialogues) should be applied in all future selection processes. On the other hand, a number of delegations stated that it was premature to adopt any additional measures regarding the selection process of the Secretary-General during the current session. To safeguard the institutional memory and lessons learned from the most recent process, delegations requested the Working Group to give priority to the consolidation of the appointment process. References were made to the notes containing lessons learned from the selection process (A/71/774-S/2017/93 and A/72/514-S/2017/846), both of which, it was argued, could serve as an input to the discussion.

- 56. A group of States called upon the President of the General Assembly at future sessions to play a proactive role and the Security Council to recommend more than one candidate for the Assembly's consideration. The same group encouraged the introduction of a deadline for the presentation of candidacies; the tabling of a draft resolution in the General Assembly, preceded by wide and extensive consultations with all Member States; and action on the recommendation by secret ballot. It also advocated the updating of the Secretary-General's oath of office. In general, the group was of the view that resolution 11 (I) of 1946 had been amended by relevant provisions from subsequent resolutions on the revitalization of the work of the General Assembly.
- 57. The possibility of considering the establishment of a single, non-renewable term for future Secretary-Generals was raised. One delegation argued that the proposed change would improve regional rotation and gender balance, noting that no woman or a national of the Eastern Europe had yet been selected. Other delegations, on the other hand, opposed a single term, arguing that while the renewal of that term ought not to be taken for granted, neither should the possibility of reappointment be automatically precluded.
- 58. Various speakers touched upon the informal hearings with candidates, which they welcomed as a tangible improvement or, in the words of one group, as an essential component of the appointment process. Nevertheless, opportunities for further improving the format of those hearings were noted.
- One group recalled that in resolution 72/313, delegations agreed to consider notional timelines for the process of selection and appointment of the Secretary General, which constituted a significant step forward. In order to guarantee a more inclusive and transparent selection process, it further argued that a deadline for presentation of candidatures, as well as a timeline for the overall process should be followed for all future processes, while bearing in mind that ultimately the best possible candidate should be appointed. Some delegations opposed establishing timelines for the Security Council by the General Assembly. One speaker expressed concern that strict deadlines may preclude consideration of well-qualified candidates. One group appreciated the value added by various stakeholders, including civil society, in searching for suitable candidates at their own initiative as an input for consideration by Member States.
- 60. Other delegations underscored the need for full implementation of Article 97 of the Charter and stressed the role of the Security Council in the selection process of the Secretary-General, which had served the Organization well since its inception. Noting the innovative changes introduced during the most recent process, the delegations emphasized that any new proposals required in-depth examination, including with a view to ensuring their full compliance with the Charter. These delegations highlighted the importance of flexibility to ensure that the best person, regardless of gender and geographical origin, would be selected for the post of Secretary-General. One speaker opposed any automatic favouring of women candidates and argued against the excessive codification of the process, rejecting the request for the Council to publish straw poll results, which, it argued, could harm the prestige of the candidates and the Member States nominating them. Furthermore, there should be no duplication of informal meetings with candidates between the Council and the General Assembly. Lastly, the suggestion of a single term could be perceived as an attempt to separate the Secretary-General from the work of the Organization.
- 61. Turning to senior appointments and the selection of executive heads, delegations welcomed the attainment by the Secretary-General of gender parity in the Senior Management Group. One group of States strongly encouraged the Secretary-General

to continue along that path with a view to achieving gender parity within the Organization as a whole. One group suggested that the Joint Inspection Unit includes in its programme of work the preparation of analysis and recommendations on the selection and appointment of executive heads and senior officials in the United Nations.

- 62. Several delegations reiterated that there should be no monopoly on senior posts and stressed the importance that recruitments be made on as wide a geographical basis as possible. One group called upon the Secretariat to provide a clearer overview of vacancies and timelines for all senior appointments. The same group underlined that the Secretary-General should exercise complete independence in the selection of senior officials with due regard to geographical and gender balance and proposed that the principles, which should govern the appointment of Executive Heads and the Senior Management Group of the Organization, be formally established.
- 63. In concluding, the Co-Chairs stated that they would duly take the discussion into account.

Fourth thematic meeting: strengthening the institutional memory of the Office of the President of the General Assembly

- 64. The Co-Chairs convened the fourth thematic meeting on 30 April 2019. It included briefings by the President of the General Assembly and the Under-Secretary-General for General Assembly and Conference Management. The briefings were followed by an interactive question-and-answer session and, subsequently, by remarks from 18 delegations, including on behalf of groups.
- 65. The Co-Chair (Slovakia), in his opening remarks, recalled that the ad hoc working group had been discussing a wide range of issues related to the Office of the President of the General Assembly and the perceived need to further enhance support for the Office in the light of the steady increase in the workload of the Assembly and the expansion of the role played by its Presidents in the recent past. Member States universally supported the recent achievements in terms of the adoption of an oath of office and a code of conduct. In his view, it was important to discuss the following two main questions: (1) whether the presidency of the General Assembly was more of a protocol function, or rather a position of leadership and political responsibility and (2) whether the role of the President and the size and composition of the Office had reached their full potential or not yet. The Co-Chair hoped to make further practical progress on this cluster in the upcoming negotiations on the draft resolution.
- 66. The President of the General Assembly briefed the Working Group on the implementation of the mandates addressed to her by resolution 72/313 and on recent trends concerning the workload of the Office of the President of the General Assembly, highlighting the increasing demands on the President as a result of the Assembly's enhanced agenda. The President urged the Member States to discuss measures to close the gap between the number of tasks they request from the Presidents and the resources allocated to the Office. For example, the number of mandates addressed to the President increased from 24 during the seventieth session and 22 during the seventy-first session to 37 during the seventy-second session and 38 during the seventy-third session. The following seven areas were highlighted in which the Member States could make further progress under this cluster: staffing of the Office of the President, funding its activities, institutional memory, transparency and accountability, the workload of the Office, communications and the alternative opening dates for the regular sessions of the Assembly.
- 67. On staffing, the President reported that her team was comprised of 38 individuals, nationals of 28 countries, over 60 percent of whom were women. Stressing the challenge of the limited time for handover and limited institutional

- support, she concluded that there was a need to have a transition team in place, to start preparations well in advance of the transition period; and the importance of continuity. The turnover of staff between sessions, although expected, was a challenge for the institutional memory and capacity. The Office was allocated 2 staff from the Secretariat and 5 paid positions. A similar structure to the previous Office was maintained, by keeping 7 advisers and 2 administrative staff. The President sought support from Member States to consider establishing a P-5 position in the Office to support the required continuity, a new position, which would again be requested by the Secretary-General in 2020, with her full support.
- 68. Turning to the funding of the activities of the office, the President reported that only 13% of the Office's resources were from the regular budget, while the remaining 87 per cent were raised through voluntary contributions. One of the biggest burdens on the Trust Fund was the result of unfunded mandates established by Assembly resolutions, resulting in a continuous need to fundraise since assuming the office. The President hoped that delegations could discuss the regular budget support to enable presidents to deliver what is requested of them by the Member States.
- 69. On the institutional memory, the PGA highlighted the following three beneficial handover practices: the annual retreat between presidencies; the "handover report", which sought to capture good practices and lessons learned and was made available on the websites of the Presidents; and the induction programme organized by the Department for General Assembly and Conference Management. Turning to the issue of transparency and accountability, the President recalled her points made in relation to the regular budget support and reiterated her commitment to positive practices established by her predecessors, such as disclosing relevant information on the Office's activities and holding dialogues with candidates for the positions of the Presidents of the General Assembly in line with paragraph 73 of resolution 71/323.
- 70. In terms of the workload of the Office, over 20 mandated high-level and other events remained to be prepared. The Office was also supporting preparations for the high-level meetings in September 2019 and 32 co-facilitators and co-chairs. Moreover, the established practice of coordination with other principal organs was maintained by holding monthly meetings with the Presidents of the Economic and Social Council and Security Council, and with the Secretary-General. She also convened meetings of the General Committee and the "morning mingas" to promote dialogue on issues of interest to the Assembly. In the area of communications, she outlined the efforts of the Office in increasing transparency and public awareness.
- 71. Finally, the President appealed to the Member States to consider changing the opening dates for the regular sessions of the General Assembly, which in her view would have a transformative impact on the ability of the future Presidents to deliver as they would have more time to build their team, get acquainted with the working methods and plan the delivery of mandates, processes and priorities for that session.
- 72. The Under-Secretary-General for General Assembly and Conference Management briefed the Working Group on the support provided by the Secretariat to the Office of the President of the General Assembly, which covered the staffing, sources of funding and the regular Secretariat support available to the Office, while highlighting the wide range of support provided from within the Secretariat, which transcended any one Department. As to staffing, the Department covered the expenses of five staff members (2 D-2, 1 D-1, 1 P-5 and 1 General Service) in the Office and provided direct support by means of three Professional posts from within the Department. In addition, and also from within its own resources, the Department made available two General Service staff members, who were located in the Office, as well as translators and text processors, as needed. The Department also provides protocol services, as required, and correspondence services. The Department of

Operational Support provided a car and driver for official purposes, as well as office space, including transitional office space during the three-month transition period. The Department of Safety and Security provided a detail of two security officers, including during travel. The President is entitled to select a spokesperson for the term of office from the Department of Global Communications, while legal guidance was provided by the Office of Legal Affairs on an as-needed basis. Other substantive departments and offices were ready to accommodate the needs of the President, as required, for the work of the General Assembly. The Department for General Assembly and Conference Management also provides administrative support for the President's official travels when financed by the United Nations and the Trust Fund of the Office of the President.

- 73. With regard to funding, the regular budget allocation amounted to approximately \$327,100 per session. In the light of the static nature of the funding, a trust fund had been created in 2010, the importance of which had been stressed by Member States in General Assembly resolutions. Contributions were usually earmarked either for specific purposes, that is, in support of particular meetings, or for general administrative, logistical and management support, and were associated with a specific session. Since November 2015, the Department of Management, which had since been renamed the Department of Management Strategy, Policy and Compliance, approved a reduction of the programme support cost for the trust fund from 13 to 7 per cent. Noting that the activities of the President have increased markedly in recent years, the General Assembly has expressed continued interest in seeking ways to further support the Office in accordance with existing procedures, as well as to continue discussions in the Ad Hoc Working Group on further steps to strengthen the Office. In response to a request from the General Assembly, the Secretary-General had included relevant proposals in the proposed programme budget 2018-2019 for the establishment of one additional P-5 position in the Office of the President to ensure continuity and manage the transfer of knowledge between sessions, including to assist in the preparation of the President's end-of-presidency report and in the handover briefing, as well as for the additional general temporary assistance resources corresponding to an overlap period for one month for four positions in the Office to maximize the use of the transition period for incoming Presidents. At the end of the main part of its seventy-second session, the General Assembly decided against the establishment of the requested additional P-5 position in the OPGA but approved the additional general temporary assistance resources corresponding to an overlap period for one month for four positions in the Office of the President to maximize the use of the transition period for incoming Presidents. By resolution 72/313, the General Assembly requested the Secretary-General to submit proposals to review the budget allocation to the Office of the President in the context of the proposed programme budget for 2020. In response to this request, and in accordance with the recommendation in the report of the Task Force on the functioning of the Office of the President of the General Assembly, the Secretary-General again included in the proposed programme budget for 2020 the establishment of an additional P-5 position in the OPGA to ensure continuity and knowledge transfer. To this end, the proposed budget for Office of the President for 2020 will reflect an increase of \$218,100.
- 74. In terms of other support, the Department for General Assembly and Conference Management fulfilled the role of focal point and assisted the Office throughout the year through conference management support, protocol and institutional memory. The Department would also continue the practice of organizing an induction programme for incoming Presidents.
- 75. In an interactive exchange, 8 delegations intervened. One delegation commended the President for her outreach to the regional groups, reactivation of

General Committee, and addressing gender balance. Regarding the issue of the limited time for handover, the same delegation recalled that the election of the President had been mandated to occur four months in advance of the start of the session so as to allow sufficient time for transition but that apparently this change did not help. Reiterating previous calls by a group of States to strengthen the Office, including by increasing resources from the regular budget, one speaker asked to further clarify the objectives of changing the starting date of the session. Regarding the change in the opening date, another sought to clarify which activities the Office could not undertake after being elected and before taking the oath, recognizing that it was the fourth PGA who presented similar difficulties to the ad hoc working group. One delegation asked what help Member States could offer in streamlining the work of the Office while another enquired about the challenges with the implementation of the high-level meetings mandated by the Member States. The President responded that a longer period before taking office was necessary to prepare for the session. For example, the location of the temporary office was outside of the Secretariat building, which made the transition more difficult. Moreover, the length of the recruitment process of staff lasted beyond the transitional period. As a result, staff members joined long after the President had been sworn in. In addition, fundraising required serious efforts and also lasted beyond the transitional month. Responding to a delegation who asked about the status of the President's archives, the President acknowledged that archiving remained a challenge and that the Office continued discussions with the Department for General Assembly and Conference Management on further steps to improve this. Two delegations emphasized that the position of the President had become political and influential and was no longer ceremonial. Thus, the President required adequate support. Two delegations welcomed the practice of disclosing all travels undertaken by President on the website, including information on the purpose of travel, financing and the composition of delegation.

- 76. In the subsequent debate, delegations touched upon a wide range of issues related to the Office, focusing on the perceived need to further enhance support for the Office in the light of the steady increase in the workload of the General Assembly over the years and the expansion of the role played by its Presidents in the recent past. The recent achievements in terms of the adoption of an oath of office and a code of conduct were universally welcomed.
- 77. With regard to the budgetary provisions, many delegations supported adequate funding of the Office in the light of the increased workload of the President over the years. One group of States pointed out that a considerable amount of the expenses was covered by the country of origin of the President, which created a risk of inequality, in particular for developing countries. One speaker favoured the allocation of appropriate resources while highlighting the need to maintain budgetary discipline. Another supported "realistic proposals" for strengthening the Office, which needed to be considered in accordance with the relevant rules of procedure and resolutions 41/213 and 42/211, that is, through the Advisory Committee on Administrative and Budgetary Questions in the Fifth Committee. Furthermore, support for the Office should be provided by the Secretariat within existing budgetary resources. Another delegation expressed reservations on any proposals that could have budgetary implications, noting that United Nations reform was best served when it brought cost savings or was cost-neutral.
- 78. Concerning human resources, one group underlined the need for the assignment of additional posts to the Office on a permanent basis. Many delegations welcomed the secondments by Member States of staff from their respective Permanent Missions to the Office of the President and encouraged the continuation of this good practice. Efforts undertaken to reflect gender parity within the Office were welcomed. At the same time, it was pointed out that the Presidents-elect should continue to strive for

both gender and geographic balance within the Office. Many delegations mentioned their support of the work of the Office either through contributions to the trust fund or secondments.

- 79. To safeguard the Office's institutional memory and ensure a smooth transition between presidencies, several delegations welcomed recent innovations, such as the introduction of a handover report. They also called for improvements in the Office's archiving system. One group encouraged the President to continue efforts to make communication tools even more accessible. The need to continue improving the digital documents published by the President was stressed. One group of States encouraged early contact between the President-elect and the Working Group in order to determine the areas that needed to be addressed by the Group, including through the next resolution on revitalization.
- 80. While recognizing that the issue of the alternative opening date for the sessions of the GA had been under discussion for years, one delegation stressed the need to find innovative solutions to help the incoming Presidents with the difficulties that they face during the short transition period. Another delegation suggested to move the election of the President to an earlier date to give more time to the President-elect to assemble the team and enable a smooth transition.
- 81. Other matters raised in the debate included adoption of a code of conduct governing elections at the General Assembly to improve transparency, accountability and equity for Member States in election campaigns; continuation of the morning dialogues ("Morning mingas") with the Permanent Missions; continuation of the practice of convening interactive dialogues with the candidates for the position of the President of the General Assembly and creating guidelines for these dialogues.
- 82. In closing, the Co-Chair (Jordan) thanked the Member States for their contributions to all thematic discussions as well as the Secretariat for the continuous engagement and support. Highlighting the main points covered during the thematic discussions, the Co-Chair underlined the need to further enhance the role, authority, effectiveness and efficiency of the General Assembly, highlighting topics such as increasing the synergy between United Nations principal organs and reducing redundancies, streamlining the agenda of the General Assembly, strengthening the Office of the President, reducing the number of high-level meetings and side-events, and creating a code of conduct for elections. She recalled suggestions for improved coordination between the Chairs of the Main Committees, including by sharing the lessons learned and best practices to improve working methods. In addition, improving language parity of the e-services and further raising the visibility and media awareness of the Assembly. The change in the opening of the regular session was strongly suggested by the President and supported by many Member States.
- 83. Furthermore, a greater push for gender and regional parity in all aspects of the UN was stressed, including in the appointment of the executive heads. As for the selection and appointment of the Secretary-General, the view was expressed that there is more work to be done. Opinions differed as to what further changes were needed to the process of the selection of the Secretary-General and whether this session is the correct time to discuss them.
- 84. The Co-Chair also welcomed the holding of the fourth interactive dialogue between representatives of the Secretariat and Permanent Missions to further facilitate an equal access to the United Nations resources and services for all Permanent Missions. The rental prices for holding diplomatic events at the United Nations were identified as an overarching concern for many delegations. Delegations were presented by three options the Department of Operational Support that might serve as a basis for deciding on an appropriate solution for the existing situation.

- 85. The Co-Chair further recalled that the delegations mentioned the upcoming seventy-fifth anniversary of the United Nations in 2020, and the opportunity to use it for stocktaking and reform efforts, in order to increase the role of multilateralism with a reformed Organization at its core.
- 86. Finally, the Co-Chair informed that all contributions will be reflected in a fair and balanced manner in the zero draft to be presented for the discussion in the drafting sessions. She further reiterated that the Co-Chairs intended to streamline the draft resolution by producing a shorter, more concise version, while keeping in mind that all mandates will remain in place unless decided otherwise by the Assembly.

III. Conclusion

- 87. In accordance with its mandate, the Working Group endeavoured to identify key issues of concern and possible consensus, to examine the current status of implementation of those issues, and either to take action or to indicate possible further action to be taken.
- 88. Some Member States or groups of States made several proposals for the draft resolution that deserved further reflection, and in this regard called for the continuation of discussions on the issues concerned, including on a possible review of the selection and appointment processes of executive heads and senior managers in the United Nations system by the Joint Inspection Unit, the appropriate precedence of the President of the General Assembly and ways to strengthen the participation of civil society in the work of the General Assembly, at the subsequent session of the Working Group.
- 89. At its final meeting, held on 11 September 2019, the Working Group considered and adopted the present report, including the draft resolution contained in section IV below (see para. 91).

IV. Recommendation

- 90. On the basis of a draft resolution circulated by the Co-Chairs, the Working Group formulated the resolution set out below.
- 91. At its final meeting, on 11 September 2019, the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly concluded its work for the seventy-third session. The Working Group recommended that the Assembly adopt the following draft resolution:

Revitalization of the work of the General Assembly

The General Assembly,

Bearing in mind the role and authority of the General Assembly as a principal organ of the United Nations and the importance of its effectiveness and efficiency in fulfilling its functions under the Charter of the United Nations,

Acknowledging that all resolutions of the General Assembly relating to the revitalization of its work constitute an equally important contribution to the strengthening of the role, authority, effectiveness and efficiency of the Assembly as established by the Charter,

Reiterating that the revitalization of the work of the General Assembly is a critical component of the overall reform of the United Nations,

Welcoming the calls to increase the efficiency of the work of the General Assembly through streamlining its agenda, including by elimination of duplication and overlap of agenda items,

Welcoming also the efforts of the President of the General Assembly to provide impetus to and promote the process of revitalization of the work of the Assembly during its seventy-third session in favour of strengthening multilateralism,

Recalling that the seventy-fifth anniversary of the United Nations will be commemorated in 2020 under the theme "The future we want, the United Nations we need: reaffirming our collective commitment to multilateralism",

Underlining the need to further enhance the role, authority, effectiveness and efficiency of the General Assembly to address the evolving global challenges,

- 1. Reaffirms its resolution 72/313 of 17 September 2018 and all other previous resolutions adopted by consensus relating to the revitalization of the work of the General Assembly;
- 2. Welcomes the report of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly and the updated inventory of Assembly resolutions on revitalization annexed thereto;¹
- 3. Requests the Secretariat to continue updating regularly and equally the multilingual web page devoted to the revitalization of the work of the General Assembly in all six official languages and its substantive content within existing resources in a cost-effective manner, including through the use of existing capabilities such as automation of translation, while ensuring the accuracy of translation;
- 4. *Decides* to establish, at its seventy-fourth session, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:
- (a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on the progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation;
 - (b) To submit a report thereon to the Assembly at its seventy-fourth session;
- 5. Also decides that the Ad Hoc Working Group shall continue its review of the inventory of General Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted at the seventy-third session and, as a result, continue to update the inventory to be attached to the report to be submitted at the

seventy-fourth session of the Assembly, including the separate indication of relevant provisions that were not implemented, with reasons therefor;

6. Takes note of the report of the Secretary-General, ² and requests the Secretary-General to submit an update on the provisions of the General Assembly resolutions on revitalization addressed to the Secretariat for implementation that have not been implemented, with an indication of the constraints and reasons behind any lack of implementation, for further consideration by the Ad Hoc Working Group at the seventy-fourth session;

Role and authority of the General Assembly

- 7. Reaffirms the role and authority of the General Assembly and the strict respect of the Charter-based prerogatives and division of work among the principal organs of the United Nations;
- 8. Welcomes the decision of the President of the General Assembly at its seventy-third session to select "Making the United Nations relevant to all people: global leadership and shared responsibilities for peaceful, equitable and sustainable societies" as the theme of the general debate, and also welcomes the decision of the President-elect of the General Assembly to select "Galvanizing multilateral efforts for poverty eradication, quality education, climate action and inclusion" as the theme of the general debate of the seventy-fourth session of the General Assembly;
- 9. Stresses the importance of implementing the resolutions of the General Assembly on a non-selective basis, including those related to the revitalization of its work that require a follow-up or further actions, as shown in the updated inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group;
- 10. Welcomes the efforts of the President of the General Assembly to reinforce synergy, coherence and complementarity between the agendas of the Assembly and its Committees, and the Economic and Social Council and its subsidiary bodies, and encourages regular interaction between the Presidents of the General Assembly, the Security Council and the Economic and Social Council in this regard;
- 11. Recalls the Guidelines on the Rationalization of the Agenda of the General Assembly, as adopted in its resolution 48/264 of 29 July 1994;
- 12. Also recalls the need to enhance synergies and coherence by addressing gaps, overlaps and duplication where they are found to exist in the agendas of the General Assembly, especially of its Second and Third Committees, and the Economic and Social Council and its subsidiary bodies, in accordance with relevant rules of procedure and in the light of the adoption of the 2030 Agenda for Sustainable Development;³
- 13. Requests the General Committee, while exercising its functions under rule 40 of the rules of procedure of the General Assembly, to pay special attention to reduction of such overlap;
- 14. *Stresses* the need to limit the number of high-level events in the margins of the general debate;
- 15. *Underlines* the urgent need to preserve the primacy of the general debate of the General Assembly and for Member States and the United Nations system to

singly and collectively limit the number of side events held in parallel with or in the margins of the general debate;

- 16. Recognizes the value of holding interactive inclusive thematic debates on current issues of critical importance to the international community, calls for the rationalizing of such debates to ensure high-level attendance, and calls upon the President of the General Assembly to be mindful of the regular agenda of the Assembly when organizing such debates;
- 17. Requests the President of the General Assembly to reconsider the timing of the plenary meetings of the General Assembly on the report of the Secretary-General on the work of the Organization and on the report of the Security Council, in close coordination with the Secretary-General and the President of the Security Council, so that discussions of these important reports are not conducted in a perfunctory manner;
- 18. Reiterates its decision to hold an interactive and comprehensive dialogue between the Permanent Missions and the Secretariat as mandated in resolution 71/323 of 8 September 2017, during the work of the Ad Hoc Working Group, and strongly emphasizes the importance of the follow-up on issues raised during the dialogue aimed at improving the work of the Secretariat in its interaction with Permanent Missions, including the circulation of these follow-up measures to Permanent Missions:
- 19. Requests the Secretariat to circulate in advance to the Permanent Missions all new or updated administrative instructions and other documents that have an impact on Member States with respect to the delivery of standard administrative services;
- 20. Notes the progress aimed at increasing the visibility of the General Assembly in the media and in bringing the priorities of the Assembly to a wider audience, and requests the Department of Global Communications of the Secretariat to continue to take appropriate measures to further enhance public awareness of the role and activities of the Assembly, including in as many platforms as possible;
- 21. Takes note of the proposals provided by the Secretariat for addressing the cost of the use of the Delegates' Dining Room and other venues at United Nations Headquarters in New York by delegations, and decides to continue the consideration of this issue during its seventy-fourth session;
- 22. Commends the President of the General Assembly and the Secretary-General for their efforts to phase out single-use plastic food containers and disposable cutlery at United Nations catering venues in New York, and notes the desirability that these measures would not lead to any additional increase in the prices of goods and services provided by vendors;

Working methods

- 23. *Stresses* the desirability of the General Assembly further streamlining its agenda and dedicating more time for dialogue as well as the review of the implementation of the resolutions it adopts;
- 24. Reaffirms existing relevant mandates related to the improvement of the working methods of the Main Committees;
- 25. Requests the Secretariat to brief the Ad Hoc Working Group at the seventy-fourth session of the General Assembly on past decisions regarding the streamlining of the agenda of the Assembly to further address the issue of the increasingly overloaded agenda of the Assembly;

- 26. Requests each Main Committee to further discuss its working methods, and in this regard invites the Chairs of the Main Committees to continue briefing the Ad Hoc Working Group during the seventy-fourth session on any best practices and lessons learned with a view to improving working methods, and to coordinate their briefings through, inter alia, possible identification of commonalities in the working methods and the lessons learned;
- 27. Reiterates its request to the President of the General Assembly at its seventy-fourth session to identify proposals, in a timely manner, through consultations with all Member States, the President of the Economic and Social Council and the General Committee, within their respective mandates, aimed at addressing gaps, overlaps and duplication where they are found to exist in the agenda of the Assembly as they relate to the 2030 Agenda for Sustainable Development as a whole, and reaffirms the respective mandates of the Main Committees of the Assembly, and on that basis, calls upon all of them to continue their consideration of addressing gaps, overlaps and duplication in their respective agendas as they relate to the 2030 Agenda as a whole, and in this regard requests them to make proposals available for discussion during the seventy-fourth session of the Assembly;
- 28. Takes note with appreciation of the updated mapping assessment of the Sustainable Development Goals coverage developed during the seventy-third session of the General Assembly as an evolving reference document for the consideration of Member States during the seventy-fourth session of the Assembly, and also takes note of the initial efforts made during the seventy-third session of the Assembly to develop possible criteria to identify overlaps and duplication where they are found to exist, with a view to continuing the work on agenda alignment with the aim of focusing the work of the Assembly more effectively and efficiently on the timely implementation of the 2030 Agenda for Sustainable Development;
- 29. Emphasizes that the General Assembly and its Main Committees, at the seventy-fourth session, in consultation with Member States, should continue their consideration of and make concrete proposals for the further biennialization, triennialization, clustering and elimination of items on the agenda of the Assembly, including through the introduction of a sunset clause, with the clear consent of the sponsoring State or States, taking into account the relevant recommendations of the Ad Hoc Working Group, during the seventy-fourth session of the Assembly;
- 30. Welcomes the increasing number of women candidates nominated for the subsidiary organs of the General Assembly in seeking to promote gender balance, and encourages Member States to continue to do so;
- 31. Reiterates the need to produce the Journal of the United Nations in all six official languages in strict compliance with rule 55 of the rules of procedure of the General Assembly, and in that regard emphasizes the importance of the extension of the information in the Journal published in the six official languages, reiterates its request to the Secretary-General to brief the Ad Hoc Working Group, on a yearly basis, on the progress achieved in this regard, and requests the Secretariat to continue to explore cost-neutral options to that effect;
- 32. Requests the Secretariat to continue to improve, harmonize and unify e-services provided to Member States under e-deleGATE with a view to creating a full-fledged delegates' online workplace in order to save costs, reduce the environmental impact and improve the distribution of documents;
- 33. *Decides* that all meetings of the General Assembly and its subsidiary organs should make provisions for accessible seating for representatives with disabilities through the following process:

- (a) Upon a request by a delegation for accessible seating, the seating order in a given meeting room is changed in such a way as to allow the requesting delegation to move to the closest accessible seat from the one it occupies in accordance with the order established for each session of the General Assembly, and the seating order for the rest of the delegations is moved by one seat;
- (b) Should there be more than one request for accessible seating, the delegations requesting such seats will move to the accessible seats which are closest to their respective seats, which they occupy in accordance with the order established for each session of the General Assembly, and the seating order for the rest of the delegations is moved by the corresponding number of seats, omitting the ones newly occupied by the requesting delegations;
- 34. *Requests*, in this regard, the Secretariat to inform the Member States as soon as possible of any changes to the seating plans of the conference rooms;
- 35. Requests the Secretary-General to submit a comprehensive report during the seventy-fourth session of the General Assembly on the ways to improve the accessibility of the United Nations Headquarters premises for persons with disabilities;
- 36. *Invites* other principal organs of the United Nations and their subsidiary organs to make similar accommodations, as provided in paragraphs 33 and 34 above, for their meetings;
- 37. Requests the Secretariat to bring this decision to the attention of any State, organization or entity that seeks to organize a meeting to be held at the United Nations, and encourages such State, organization or entity to make arrangements for accessible seating in the manner mentioned in paragraphs 33 and 34;
- 38. Takes note of the report of the Secretary-General entitled "Opening of the regular sessions of the General Assembly", submitted pursuant to resolution 72/313;⁴

Selection and appointment of the Secretary-General and other executive heads

- 39. *Reaffirms* the important role played by the Secretary-General in the context of the current global challenges, and in the implementation of the three pillars of the United Nations, namely, peace and security, human rights and sustainable development;
- 40. Reaffirms its commitment to continue, in the Ad Hoc Working Group, in accordance with the provisions of Article 97 of the Charter, its thorough consideration of the issues under the third thematic cluster of the Working Group, on the revitalization of the work of the General Assembly, including the examination of innovative ways to improve the process of selecting and appointing the Secretary-General and other executive heads in all its aspects, and recalls all relevant resolutions, including resolutions 11 (I) of 24 January 1946, 46/77 of 12 December 1991, 47/233 of 17 August 1993, 48/264, 51/241 of 31 July 1997, 52/163 of 15 December 1997, 55/14 of 3 November 2000, 55/285 of 7 September 2001, 56/509 of 8 July 2002, 57/300 of 20 December 2002, 57/301 of 13 March 2003, 58/126 of 19 December 2003, 58/316 of 1 July 2004, 59/313 of 12 September 2005, 60/286 of 8 September 2006, 61/292 of 2 August 2007, 62/276 of 15 September 2008, 63/309 of 14 September 2009, 64/301 of 13 September 2010, 65/315 of 12 September 2011, 66/294 of 17 September 2012, 67/297 of 20 August 2013, 68/307 10 September 2014, 69/321 of 11 September 2015, 70/305 of 13 September 2016, 71/323 and 72/313, reaffirming the applicable procedures set out in the rules of procedure of the

Assembly, in particular rule 141, and acknowledging existing relevant practices of the Assembly;

- 41. Encourages future Presidents of the General Assembly to actively contribute to the implementation of provisions guiding the selection and appointment of the ninth Secretary-General, as contained in all relevant resolutions, in particular resolutions 69/321 and 70/305, and stresses the need for the selection and appointment process of the Secretary-General and other executive heads to be guided by the principles of transparency and inclusiveness;
- 42. Welcomes the progress achieved in the selection and appointment process of the Secretary-General in the consensual resolutions 69/321, 70/305, 71/323 and 72/313, in full compliance with the General Assembly mandate under Article 97 of the Charter, and reaffirms previous resolutions referring to gender balance and regional rotation in the course of the identification and appointment of the best candidate for the post of the Secretary-General;
- 43. Decides to further assess during the seventy-fourth session of the General Assembly the selection and appointment process of the Secretary-General, consolidate the advances gained in the relevant General Assembly resolutions and explore possible steps to further improve the process, including the collaboration between the General Assembly and the Security Council, consistent with Article 97 of the Charter, as well as to explore the possibility for the incumbent Secretary-General to present a vision statement for the next term and to brief the Member States on its content;
- 44. Reiterates the possibility of providing the process of selection and appointment of the Secretary-General with notional timelines in accordance with paragraph 72 of its resolution 72/313, and decides to further discuss this issue during its seventy-fourth session in the Ad Hoc Working Group;
- 45. *Decides* that the Secretary-General-designate shall take an oath of office before the General Assembly during a swearing-in ceremony, as detailed in the annex to the present resolution;
- 46. Welcomes again the ongoing efforts of the Secretary-General towards achieving equal and fair distribution in terms of the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, while securing the highest standards of efficiency, competence and integrity, in accordance with Article 101 of the Charter and its resolutions 46/232 of 2 March 1992, 51/241, and 71/263 of 23 December 2016, commends in particular the fact that gender parity was achieved in the Senior Management Group, and requests that further effective measures be taken in this regard;
- 47. Supports the request of the Secretary-General for Member States to submit names and résumés of nationals who may be considered for positions of executive heads and senior management of the Secretariat;
- 48. Welcomes the fact that gender parity has already been reached in the Senior Management Group, and commends the Secretary-General's commitment to reach gender parity and to recruit staff on as wide a geographical basis as possible across the United Nations Organization;
- 49. Reiterates the need to ensure equal and fair distribution based on gender balance and as wide a geographical basis as possible, and in this regard recalls its resolutions 46/232 and 51/241, adopted without a vote, which contain the principles that the highest standards of efficiency, competence and integrity are the paramount considerations in the recruitment and performance of international civil servants and

that, as a general rule, there should be no monopoly on senior posts in the United Nations system by nationals of any State or group of States;

50. Requests the Office of Human Resources of the Secretariat to continue with the practice of providing a briefing to the Ad Hoc Working Group on the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, as well as with a breakdown showing those originating from the States that are permanent members of the Security Council:

Strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly

- 51. *Emphasizes* the important role of the President of the General Assembly within the United Nations Organization, as well as in the overall success of the work of the General Assembly;
- 52. *Invites* Member States to equally consider women as candidates for the position of President of the General Assembly, and encourages Presidents-elect to continue to strive for both gender and geographical balance within the Office of the President of the General Assembly;
- 53. *Notes with appreciation* the decision of Member States to fund the transition period, the trust fund in support of the Office of the President of the General Assembly, seconding national staff as well as the convening of annual retreats;
- 54. *Welcomes* the induction programme delivered to the Office of the President of the General Assembly, and calls upon the Secretariat to strengthen the programme through enhanced content and increased delivery time;
- 55. Recognizes the heavy reliance of the Office of the President of the General Assembly on voluntary contributions to deliver on a growing number of mandates entrusted to it by the Assembly;
- 56. Requests the Secretary-General to continue to provide to the President of the General Assembly, within existing resources, adequate administrative, technical, logistical and protocol-related support necessary to effectively execute his or her mandates as president of a principal organ of the United Nations;
- 57. Recalls that the activities of the President of the General Assembly have increased continuously and markedly in recent years, also recalls the provisions regarding the support for the Office of the President of the General Assembly in previous resolutions, and expresses continued interest in seeking ways to further support and strengthen the Office in accordance with existing procedures, in particular rule 153 of the rules of procedure of the Assembly;
- 58. Requests the Secretary-General to take the measures necessary to preserve and further strengthen the institutional memory of the Office of the President of the General Assembly, through utilizing existing United Nations record-keeping and archiving facilities;
- 59. Requests the Secretariat to issue, within existing resources, in coordination with the Office of the President of the General Assembly, a compendium of best practices of past Presidents that could serve to contribute to strengthening the institutional memory of the Office;
- 60. *Emphasizes* the importance of a handover report for the institutional memory of the Office of the President of the General Assembly in accordance with resolution 69/321 and other relevant mandates contained in resolutions on the revitalization of the work of the Assembly;

- 61. - 62. *Encourages* the Office of the President of the General Assembly to expedite the posting of all relevant documents, including the President's speeches, letters, travels, activities, decisions and press releases, on the relevant websites of the United Nations.

- 1. In accordance with paragraph 4 of General Assembly resolution 72/313, in which the Assembly decided that the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-second session (A/72/896) and, as a result, continue to update the inventory to be attached to the report of the Ad Hoc Working Group at the seventy-second session, the Co-Chairs, assisted by the Secretariat, have prepared the updated inventory chart for consideration by Member States.
- 2. The present inventory chart has been updated to reflect the progress achieved since the adoption of resolution $\frac{72}{313}$.
- 3. The Co-Chairs, assisted by the Secretariat, obtained updated information, where possible, from relevant entities responsible for implementation.
- 4. The updated inventory chart retains the following two-part structure, which was also utilized in the report submitted at the seventy-second session:
- (a) The first part contains unimplemented provisions, in order to focus on their follow-up;
- (b) The second part contains implemented provisions, both those that required one-time action and those to be implemented on an ongoing basis, in order to keep track of previous achievements and provide the means to compare with and learn from past experience.
- 5. The inventory chart does not have a definite character and may be amended at any time by Member States through the Ad Hoc Working Group. Furthermore, it is not intended to, and does not, have any legal effect. It should serve only as a tool to facilitate discussions on the follow-up to the implementation of the previous related resolutions.
