

# Revitalization of the work of the General Assembly

## Report of the Sixth Committee

#### I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the seventy-fourth session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 20 September 2019, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the purpose of discussing their working methods and considering and taking action on their respective tentative programmes of work for the seventy-fifth session of the Assembly.
- 3. The Sixth Committee considered the item at its 34th and 35th meetings, on 11 and 20 November 2019. The views of the representatives who spoke during the Committee's consideration of the item are reflected in the relevant summary records. <sup>1</sup>

### II. Consideration of draft decision A/C.6/74/L.22

- 4. At the 35th meeting, on 20 November, the Chair introduced a draft decision containing the provisional programme of work of the Committee for the seventy-fifth session of the General Assembly, as proposed by the Bureau (A/C.6/74/L.22).
