Land violations committed in April 2020

| | 1030 | In occupied Palestinian territory, opposite the town of Mays al-Jabal, between points B64 and B65, Israeli enemy soldiers pointed their weapons at a Lebanese Army patrol. |
| | 1118 | In occupied Palestinian territory, opposite the town of Mays al-Jabal, near point B65, an Israeli enemy soldier directed obscenities at a United Nations Interim Force in Lebanon (UNIFIL) patrol. |
| | 1740 | In occupied Palestinian territory, opposite the town of Mays al-Jabal, near point B64, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory and at a Lebanese Army patrol. The enemy soldiers left in the direction of occupied territory at 1930 hours. |
| 5 April | 0900 | In occupied Palestinian territory, in the locality of Wadi Sa'sa', opposite the town of Rumaysh, enemy soldiers redirected water towards Lebanese territory because of a malfunction in an agricultural pipe. The onrushing water carried away soil and caused material damage to approximately 300 m ² of agricultural land. |
| | 1245–1330 | Several explosions were heard from inside the occupied Shab'a Farms, in the area behind the Ramta position and Ruwaysat al-Alam. |
| 6 April | 1015 | In occupied Palestinian territory, opposite the town of Udaysah, at point TP37, Israeli enemy soldiers pointed a vehicle-mounted machine gun towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1530 hours. |
| 7 April | 1355 | In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a vehicle-mounted machine gun towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1545 hours. |

| 15 April | 1038 | In occupied Palestinian territory, opposite the town of Aytarun, the Israeli enemy pointed the cannon of a Merkava tank towards UNIFIL soldiers and a team of international observers. At 1117 hours, enemy soldiers pointed their weapons at a UNIFIL patrol that was on the opposite side, in Lebanese territory. |
| | 1100 | In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1250 hours. |
