Repertory of Practice of United Nations Organs and *Repertoire of the Practice of the Security Council*

Report of the Secretary-General

Summary

In conformity with General Assembly resolution 74/190, the present report provides an outline of the progress made by the Secretariat between 1 July 2019 and 30 June 2020 in updating the *Repertory of Practice of United Nations Organs* and the *Repertoire of the Practice of the Security Council*. The Assembly is invited to take action in the light of the conclusions drawn in paragraphs 18 and 32.







I. Introduction

1. The present report has been prepared pursuant to General Assembly resolution 74/190. It provides information on the progress made by the Secretariat between 1 July 2019 and 30 June 2020^{1} in updating the *Repertory of Practice of United Nations Organs* and the *Repertoire of the Practice of the Security Council*. It examines the respective mandates and workflow in the preparation of these publications, in printed and electronic forms, and gives an overview of the available resources and existing modalities of cooperation with academic institutions, associate experts, temporary staff and consultants, as appropriate. The Assembly is invited to take action in the light of the conclusions drawn in paragraphs 18 and 32.

II. Repertory of Practice of United Nations Organs

A. Mandate and preparation of supplements to the Repertory

2. The *Repertory of Practice of United Nations Organs* was originally mandated by the General Assembly in its resolution 796 (VIII) of 27 November 1953. Its purpose is to document the Organization's application and interpretation of each individual Article of the Charter of the United Nations, to form a legislative history contributing to the knowledge and understanding of the Charter as applied in the practice of the organs of the United Nations.

3. Bearing in mind the call made upon the Secretary-General, in paragraph 17 of General Assembly resolution 74/190, to address, effectively and on a priority basis, the backlog in the preparation of volume III of the *Repertory*, the Codification Division of the Office of Legal Affairs, acting as coordinator for the preparation of the *Repertory*, maintained regular contact with Peking University, where research and drafting of three studies on Article 23 of the Charter of the United Nations for volume III of Supplements Nos. 7 to 9 (1985–1999) were completed.

4. With regard to the preparation of studies for volumes III and IV of Supplement No. 10 (2000–2009), a study on Article 49 of the Charter for volume III, prepared with the assistance of a consultant, continues to be under review. Two studies, on Articles 55 (c) and 56 for volume IV, also continue to be under review by the responsible author department, the Office of the United Nations High Commissioner for Human Rights. In addition, the Department of Economic and Social Affairs, with the assistance of a consultant, has finalized the preparation of a study on Article 58 for volume IV, in consultation with relevant units and entities of the United Nations system, including the secretariat of the United Nations System Chief Executives Board for Coordination, the Joint Inspection Unit, the International Civil Service Commission, the Food and Agriculture Organization of the United Nations, the United Nations Office for Disaster Risk Reduction, the United Nations Environment Programme, the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) and the Department of Political and Peacebuilding Affairs. The Department of Economic and Social Affairs has also conducted consultations with the relevant Secretariat units, namely, the Department for General Assembly and Conference Management and the Department of Political and Peacebuilding Affairs, with a view to undertaking the preparation of a study on Article 65 for volume IV, with the assistance of a consultant. Work also continues in relation to studies on Articles 104 and 105 for volume VI, in preparation by the Office of the Legal Counsel in the Office of Legal Affairs.

5. Substantial progress has been made in relation to Supplement No. 11 (2010–2015) with the assistance of the Faculty of Law at the University of Ottawa, where

research and drafting were completed in relation to five studies: on Article 8 for volume I, on Articles 36 and 54 for volume III and on Articles 94, 104 and 105 for volume VI. The study on Articles 104 and 105 is currently under review by the Office of the Legal Counsel in the Office of Legal Affairs. Two studies for volume IV, on Articles 55 (c) and 56, are still under preparation by the responsible author department, the Office of the United Nations High Commissioner for Human Rights. In April 2020, the Department of Economic and Social Affairs selected a consultant, to be financed from the trust fund for the elimination of the backlog in the *Repertory*, to undertake the research and drafting of a study on Article 58 for volume IV. In June 2020, the United Nations Office for Disarmament Affairs also took preliminary steps towards selecting a consultant to prepare a study on Article 11 for volume II.

6. As is customary, the Department of Global Communications and the Dag Hammarskjöld Library played an important role in supporting the research phase for the *Repertory* studies.

7. During the period under review, the Codification Division, in its capacity as coordinator of the *Repertory*, was in regular contact with the various units involved in its preparation. In particular, a meeting was held with representatives of the United Nations Office for Disarmament Affairs in September 2019 for the purpose of presenting the publication and providing guidance and information on the preparation of studies. Information in that regard was also conveyed to representatives of the Department for General Assembly and Conference Management in June 2020. Furthermore, a consultation process with all units bearing primary responsibility for the preparation of studies took place in June 2020 regarding the time frame for the next *Repertory* Supplement, namely, Supplement 12. In the light of the experience acquired and lessons learned from the preparation of previous Supplements, it was decided that Supplement No. 12 would cover a five-year period (2016–2020). That period appears reasonable to highlight significant trends that are relevant for the interpretation and application of the various provisions of the Charter of the United Nations.

8. Also during the period under review, the Department for General Assembly and Conference Management published a total of six volumes in electronic format, as follows: volume I in English and volumes II and IV in Spanish for Supplement No. 7 (1985–1988); volume II in Spanish for Supplement No. 8 (1989–1994); and volumes II and V in Spanish for Supplement No. 9 (1995–1999). All studies included in these volumes were accordingly posted on the *Repertory* website. The current status of the publication is thus as follows: 36 volumes have been published² and 8 have been finalized and submitted for translation and editing.³ Consequently, from among the 57 volumes of which the publication as a whole (original *Repertory* and Supplements Nos. 1 to 11 thereto) should consist, as at 30 June 2020, work remains to be completed on 13 volumes, 6 of which pertain to Supplement No. 11 (2010–2015) and 4 to Supplement No. 10 (2000–2009), which are at different stages of preparation (see para. 4 above). The other three volumes on which work remains to be completed correspond to volume III of Supplements Nos. 7 to 9.

9. Annex I to the present report identifies which Secretariat units are responsible for preparing *Repertory* studies on each of the individual Articles of the Charter. Annex II provides information on the status of the *Repertory*.

B. Availability of Repertory studies on the Repertory website

10. Studies from 44 complete volumes, including the 8 volumes at the translation and editing stages, are available on the United Nations website for the *Repertory* (http://legal.un.org/repertory). Advance versions of several studies on individual Articles for volume III of Supplements Nos. 7 to 9, as well as a considerable number of studies for Supplement No. 10 that have been finalized and are awaiting completion of the respective volumes, continue to be made accessible on the website. This is indeed also done for newly completed studies for Supplement No. 11. The electronic version of the *Repertory* includes a full-text search feature, providing users with the opportunity to search all the studies instantaneously for any word or combination of words in the three languages of the publication (English, French and Spanish).

11. Currently, all studies available in English are on the *Repertory* website, and most of them are also available in French and Spanish, while a few are available in only one of these languages. Finalized studies awaiting translation and editing are placed on the *Repertory* website in the language in which they have been prepared (English for most of them and French for some of them). The Secretariat will continue to make available electronically all three language versions of the finalized *Repertory* studies.

C. Cooperation with academic institutions and sponsoring of associate experts

12. The well-established cooperation with the Faculty of Law at the University of Ottawa continued for the tenth consecutive year. During the period under review, the Faculty of Law contributed to the preparation of five studies, on Article 8 for volume I, Articles 36 and 54 for volume III and Articles 94, 104 and 105 for volume VI of Supplement No. 11 (see para. 5 above). The cooperation with Peking University initiated in 2018 also led to the drafting of three studies on Article 23 for volume III of Supplements 7, 8 and 9 (see para. 3 above).

13. With a view to revitalizing cooperation with academic institutions and pursuing a diverse geographical spread, the Codification Division, acting as coordinator for the preparation of the *Repertory*, continued to call upon permanent missions to the United Nations to identify academic institutions that may be interested in contributing to the preparation of studies. In the past three years, the Codification Division has had preliminary contact with four universities: two in the South Pacific region, one in the Latin American and Caribbean region and one in the Western European and other States region. The Codification Division continued to invite academic institutions to which members of the International Law Commission are affiliated to consider contributing to the preparation of studies.

14. Furthermore, consistent with paragraph 15 of resolution 74/190, in which the General Assembly reiterated its call for the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the *Repertory*, the Codification Division made an appeal to all permanent missions to the United Nations by a note verbale dated 7 January 2020.

D. Trust fund

15. In its resolution 74/190, the General Assembly reiterated its call for voluntary contributions to the trust fund established pursuant to its resolution 59/44, in order to eliminate the backlog in the *Repertory*. Accordingly, a note verbale was sent on 7 January 2020 to all permanent missions to the United Nations, reminding them of the possibility of making voluntary contributions to the trust fund and inviting them

to bring the question of funding for the *Repertory* to the attention of private institutions and individuals that might wish to assist in that regard. The Secretary-General welcomes with appreciation the contributions to the trust fund received during the period under review (1 July 2019 to 30 June 2020) from Cyprus (\$2,220) and Qatar (\$10,000). The fund balance, as at 30 June 2020, was \$79,037.

16. As mentioned above (see para. 5), during the period under review, a consultant, to be financed through the trust fund, was hired to undertake the research and drafting of a study on Article 58 for volume IV of Supplement No. 11 (2010–2015) and preliminary steps were taken towards hiring a consultant to prepare a study on Article 11 of volume II of Supplement No. 11. The further use of consultants for the preparation of studies pertaining to volumes that are nearing completion is envisaged. Additional contributions to the trust fund are therefore strongly encouraged, so as to allow the Secretariat to continue to eliminate the backlog in the *Repertory*.

E. Recommendations of the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization

17. The Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization considered the question of the Repertory and the Repertoire at its session held from 18 to 26 February 2020. In paragraph 75 of its report (A/75/33), the Special Committee recommended, with regard to the *Repertory*, that the General Assembly should commend the Secretary-General for the progress made in the preparation of studies, including the use of the internship programme of the United Nations and cooperation with academic institutions for that purpose; encourage Member States to identify academic institutions that have the capacity to contribute to the preparation of studies for the *Repertory* and to provide the contact details of such institutions, and in this regard welcome the initiative of the Secretariat to invite members of the International Law Commission to recommend academic institutions that the Secretariat could contact for this purpose; note with appreciation the contributions made by Member States to the trust fund for the elimination of the backlog in the Repertory; reiterate its call for voluntary contributions to the trust fund for the elimination of the backlog in the Repertory, as well as the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication; call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions, and encourage the continued updating of the website for the Repertory; note with concern that the backlog in the preparation of volume III of the *Repertory*, although slightly reduced, had not been eliminated, and call upon the Secretary-General to address that issue effectively and on a priority basis, while commending the Secretary-General for progress made in reducing the backlog; and reiterate the responsibility of the Secretary-General for the quality of the Repertory.

F. Conclusions

18. With regard to the *Repertory*, in the light of the foregoing, the General Assembly may wish:

(a) To note the current status of the publication, including the progress made in the preparation of *Repertory* studies and in their posting on the Internet in three languages (English, French and Spanish);

To consider the recommendations of the Special Committee (see (b) para. 17 above) concerning the use of the internship programme of the United Nations and the cooperation with academic institutions for the preparation of studies; the identification of academic institutions having the capacity to contribute to the preparation of studies for the *Repertory*; the initiative of the Secretariat to invite members of the International Law Commission to recommend academic institutions that the Secretariat could contact for this purpose; the voluntary contributions to the trust fund for the elimination of the backlog in the *Repertory* so as to further support the Secretariat in carrying out the effective elimination of that backlog; the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication; the call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions, the continued updating of the website for the Repertory and the call to continue to address effectively and on a priority basis the elimination of the backlog in volume III of the *Repertory*; and the reiteration of the responsibility of the Secretary-General for the quality of the *Repertory*;

(c) To note the progress made towards the elimination of the backlog through the utilization of the trust fund; and to strongly encourage States to make additional contributions to the trust fund.

III. Repertoire of the Practice of the Security Council

A. Mandate and preparation

19. The *Repertoire of the Practice of the Security Council*, originally mandated by the General Assembly in its resolution 686 (VII) of 5 December 1952, provides a record of the evolving practice and procedure of the Security Council in the framework of the Charter of the United Nations and the provisional rules of procedure of the Security Council. Most recently, by its resolution 74/190, the General Assembly called upon the Secretary-General to continue to follow the modalities outlined in paragraphs 102 to 106 of his report dated 18 September 1952 (A/2170).

20. In paragraph 12 of resolution 74/190, the General Assembly commended the Secretary-General for the progress made towards updating the *Repertoire*. In paragraph 16, the Assembly called upon the Secretary-General to continue his efforts towards updating the *Repertoire* and making it available electronically in all its language versions.

21. During the reporting period, pursuant to the mandate provided by the General Assembly, the Secretariat continued to make significant progress in the preparation of the Supplements to the *Repertoire*. The Secretariat adapted its working methods to enable the contemporaneous coverage of the practice of the Security Council, a milestone in the 68-year history of the *Repertoire*. The focus of the work of the Secretariat over the past year was the preparation of the first single-year editions of the publication, the twenty-first and twenty-second Supplements to the *Repertoire*, covering the years 2018 and 2019, respectively.

22. The Secretariat completed the twenty-first Supplement to the *Repertoire* in the third quarter of 2019. The advance version of the Supplement has been posted on the website of the Security Council, while the published version is expected to be made available online and in hard copy in the last quarter of 2020. Parts of the twenty-second Supplement have already been posted in their advance form on the website of the Security Council and the remaining ones will be made available gradually in the coming months as they are completed. The entire twenty-second Supplement is expected to be

made available in its advance form by October 2020, as newly elected members of the Council commence observing proceedings. In line with the new contemporaneous coverage of the practice of the Council, the Secretariat has commenced research and drafting work for the twenty-third Supplement covering the year 2020.

23. The aim of this ambitious schedule for the preparation of the *Repertoire* is to ensure that the invaluable information on the practice of the Council is made available to States Members of the United Nations and the public as soon as possible. In order to ensure the sustainability of the new contemporaneous coverage of the practice of the Council, the Secretariat has continued to optimize the limited resources available through efficiency-enhancing initiatives, such as the introduction of new technologies. In this regard, the Secretariat has continued to work on the phased development, subject to the availability of resources, of a modern, secure, webenabled database, which would significantly facilitate the research and drafting of the Repertoire. Furthermore, the recruitment and training of staff, the availability of associate experts and the increased use of the internship programme have also enhanced the capacity of the Secretariat to expedite these efforts, while maintaining the highest standards of accuracy and quality control. The various offices within the Secretariat vested with the complex tasks of editing, translating, indexing, and publishing the Supplements to the *Repertoire* have also achieved progress on ensuring the most efficient coordination and division of labour as part of this process.

24. Following the transition to remote working arrangements in March 2020 in the light of the coronavirus disease (COVID-19) pandemic, the Secretariat successfully implemented business continuity plans in order to ensure uninterrupted work on the *Repertoire*. The Secretariat further adapted its methodology for contemporaneous coverage to the new remote working methods of the Security Council. As at the date of the present report, no significant impact on the previously defined schedule for the preparation of the *Repertoire* is anticipated as a result of the new working arrangements.

B. Availability of Repertoire studies on the Security Council website

25. The Secretariat continued to make available advance and published versions of the Supplements to the *Repertoire* on the website of the Security Council (www.un.org/securitycouncil/content/repertoire/structure) immediately upon their completion. The Supplements are searchable and systematized both chronologically and by topic. The website also offers a broad range of information resources such as tables, graphs and statistical information providing an overview of the practice of the Council. The website is constantly reviewed and enhanced with new content and visualizations, and further improvements continue to be explored.

26. In the past year, the Secretariat continued to explore the use of modern technologies with a view to enhancing these resource tools. In August 2019, the Secretariat launched the Field Missions Dashboard, a new information platform that provides a comprehensive and user-friendly overview of the mandates of United Nations peacekeeping operations and special political missions. It uses maps and infographics to present mandate information and allows for comparisons of mandates across regions and types of field missions. The Dashboard project is the outcome of over 10 years of work on systematically tracking the mandates of peacekeeping operations and special political missions. Updated quarterly, it is made available on the website of the Security Council, together with other information resources.

27. In early January 2020, building on its work in previous years, the Secretariat made available on the website of the Security Council a revamped edition of the *Highlights of Security Council Practice* covering 2019, utilizing a new design and technological platform. The new platform includes a user-friendly navigation bar and

offers multiple visual representations of the data, new maps of peacekeeping operations, special political missions and visiting missions of the Council, and enhanced interactivity with underlying data available for download directly from the website. The editions of the *Highlights of Security Council Practice* provide an annual review of the activities of the practice of the Council as it relates to its agenda, meetings, missions, decisions, voting patterns, and the work of subsidiary bodies.

28. The Secretariat has continued to fulfil and enhance its advisory role through the provision of information in response to questions relating to the procedural and constitutional practice of the Security Council and its subsidiary organs. During the reporting period, the Secretariat received a substantial number of such queries from Member States, officials of the United Nations system and representatives of other international organizations, non-governmental organizations, academic institutions, scholars and researchers, and the private sector. In addition, the Secretariat provided complex and in-depth research and analysis for internal policy development and engaged in several outreach programmes aimed at familiarizing new Council members with the evolving procedure, practice and working methods of the Council.

C. Publication in language versions (print and electronic)

29. Pursuant to General Assembly resolution 55/222, the published versions of the eleventh to the twentieth Supplements to the *Repertoire*, covering the period from 1989 to 2017, have been made available online in all six official languages. The twenty-first Supplement, covering the year 2018, is expected to be made available by the first quarter of 2021. The Department for General Assembly and Conference Management continues to make every effort to ensure that the Secretariat is able to post the latest Supplements in the six official languages as soon as they are available.

D. Resources

30. The progress made in the preparation and publication of the *Repertoire* and the maintenance of its website in all official languages would not have been possible without the continuing support of Member States. Voluntary contributions to the trust fund for the updating of the *Repertoire* remain a critical element for sustaining the progress made thus far and improving accessibility to the practice of the Security Council.

31. Extrabudgetary resources have enabled the Secretariat to retain the services of temporary staff assisting in the preparation of the *Repertoire*. Since the previous report, contributions to the trust fund have been received from China, Ireland and Singapore. In addition, the Republic of Korea has contributed by sponsoring one associate expert in the Security Council Practices and Charter Research Branch, who has made a substantial contribution to advancing the work on the *Repertoire*. Denmark and Sweden have also made commitments in this regard and two additional associate experts will be joining the Branch in the second half of 2020. In order to sustain the progress achieved to date, the Secretary-General calls upon Member States to further support the work of the Secretariat in updating the *Repertoire* through voluntary contributions to the trust fund and the sponsoring of associate experts.

E. Conclusions

32. With respect to the *Repertoire of the Practice of the Security Council*, in the light of the foregoing, and the recommendations made by the Special Committee at its session held from 18 to 26 February 2020 (A/75/33), the General Assembly may wish:

(a) To note the progress made towards updating the *Repertoire*;

(b) To note with appreciation the contributions made by Member States to the trust fund for the updating of the *Repertoire*;

(c) To reiterate its call for voluntary contributions to the trust fund for the updating of the *Repertoire* and the sponsoring, on a voluntary basis and with no cost to the United Nations, of associate experts to assist in the updating of the publication;

(d) To call upon the Secretary-General to continue his efforts towards updating the publication and making it available electronically in all its language versions;

(c) To reiterate the responsibility of the Secretary-General for the quality of the *Repertoire*, and call upon the Secretary-General to continue to follow the modalities outlined in paragraphs 102 to 106 of his report dated 18 September 1952 (A/2170).
