#### **Chapter I**

#### Matters calling for action by or brought to the attention of the General Assembly

#### United Nations High Commissioner for Refugees (item 19 (e))

### **Enlargement of the Executive Committee of the Programme of the United Nations High Commissioner for Refugees**

- 1. By its decision 2020/204, the Council, recalling General Assembly resolution 1166 (XII) of 26 November 1957, in which the Assembly requested the Council to establish the Executive Committee of the Programme of the United Nations High Commissioner for Refugees, as well as subsequent Assembly resolutions by which the membership of the Executive Committee was increased:
- (a) Took note of the request to enlarge the membership of the Executive Committee, contained in the note verbale dated 26 July 2019 from the Permanent Mission of Mali to the United Nations addressed to the Secretary-General (E/2020/3);
- (b) Recommended that the General Assembly, at its seventy-fourth session, decide on the question of enlarging the membership of the Executive Committee from 105 to 106 States.

#### **Chapter II**

### Special meetings of the Economic and Social Council at the seventy-fourth session of the General Assembly

#### Ecosystem approaches for shifting the world onto a sustainable pathway

- 1. The Council held its 3rd plenary meeting, on 15 October 2019, jointly with the Second Committee of the seventy-fourth session of the General Assembly, on the theme "Ecosystem approaches for shifting the world onto a sustainable pathway". An account of the proceedings is contained in the relevant summary record (A/C.2/74/SR.13-E/2020/SR.3).
- 2. The joint meeting was co-chaired by the President of the Economic and Social Council, Mona Juul (Norway), and the Chair of the Second Committee, Cheikh Niang (Senegal) who made opening statements.
- 3. Presentations were made by the following panellists: Global Coordinator, Climate Change Portfolio, International Union for Conservation of Nature, Sandeep Sengupta; Innovation Catalyst, Centre for Social Innovation at Trinity College Dublin, Siobhan McQuaid; and Founder and Chief Executive Officer of Conservation Investment Management, Ben Guillon.
- 4. In the ensuing discussion, the panellists responded to comments made and questions posed by the representatives of Norway, the Russian Federation, the United Kingdom of Great Britain and Northern Ireland, the United States of America, Armenia, Ethiopia and China.
- 5. The observers for the European Union and the International Renewable Energy Agency also participated in the discussion.
- 6. The President of the Economic and Social Council and the Chair of the Second Committee made closing statements.

### Joining forces: effective policy solutions for the coronavirus disease (COVID-19) response

7. The Council held an online informal meeting on 11 May 2020 on the theme "Joining forces: effective policy solutions for the coronavirus disease (COVID-19) response". The proceedings of the meeting are reflected in annex IV to the present document.

#### **Chapter III**

### Special meeting of the Economic and Social Council on international cooperation in tax matters

- 1. The Council, in its resolution 2017/2, decided, in accordance with General Assembly resolutions 68/1 and 69/313, in which the Assembly adopted the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, that, starting in 2017, one session of the Committee of Experts on International Cooperation in Tax Matters would be held in New York in the spring and one in Geneva in the autumn, with the session in New York held back-to-back with the special meeting of the Council on international cooperation in tax matters, in order to increase the Committee's engagement with the Council, with a view to enhancing intergovernmental consideration of tax issues.
- 2. The Council, in its resolution 2020/1, decided that the one-day special meeting of the Council on international cooperation in tax matters would be held on 1 May 2020, following the twentieth session of the Committee.
- 3. The Council, taking into account the impact of COVID-19 on the working arrangements for its 2020 session, decided in its resolution 2020/3, to defer the one-day special meeting to its 2021 session.

#### **Chapter IV**

### **Economic and Social Council forum on financing for development follow-up**

- Pursuant to the commitment made in the Addis Ababa Action Agenda of the Third International Conference on Financing for Development (General Assembly resolution 69/313, annex, para. 132), the financing for development follow-up process would include an annual Economic and Social Council forum on financing for development follow-up with universal, intergovernmental participation, and the modalities of participation in the forum would be those utilized at the international conferences on financing for development. The forum would be held for up to five days, up to four days of which would be dedicated to discussing the follow-up and review of the financing for development outcomes and the means of implementation of the post-2015 development agenda, and one of which would be devoted to the special high-level meeting of the Council with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development, as well as additional institutional and other stakeholders, depending on the priorities and scope of the meeting. The intergovernmentally agreed conclusions and recommendations of the forum would be fed into the overall follow-up and review of the implementation of the post-2015 development agenda in the high-level political forum on sustainable development convened under the auspices of the Council.
- 2. The General Assembly, in its resolution 70/192, reaffirmed that the forum on financing for development follow-up would hold its meetings at United Nations Headquarters in New York in the second quarter of the year and would be chaired by the President of the Council. The Council, in its resolution 2020/1, recalled that it had been decided at the 2019 forum on financing for development follow-up that the fifth forum would be held from 20 to 23 April 2020.
- 3. The Council, taking into account the impact of COVID-19 on the working arrangements for its 2020 session, decided in its resolution 2020/3, to hold the forum in a scaled-down and abbreviated format, with modalities decided by the Bureau of the Council following consultations with Member States.
- 4. The proceedings of the Economic and Social Council forum on financing for development follow-up in 2020 are contained in the report of the forum (E/FFDF/2020/3).
- 5. The summary by the President of the Council of the proceedings of the forum on financing for development follow-up is contained in document A/75/93-E/2020/64.

#### Intergovernmentally agreed conclusions and recommendations

- 6. On 27 April 2020, the forum adopted the revised draft intergovernmentally agreed conclusions and recommendations of the forum (E/FFDF/2020/L.1/Rev.1) pursuant to Council decision 2020/205 on the procedure for taking decisions of the Council during the COVID-19 pandemic (see E/FFDF/2020/3, sect. III).
- 7. Statements in connection with the draft intergovernmentally agreed conclusions and recommendations of the forum were submitted by the representatives of Belize (on behalf of the Alliance of Small Island States), the European Union, Guyana (on behalf of the Group of 77 and China), Hungary, Malawi (on behalf of the Group of Least Developed Countries), the Philippines (on behalf of the Like-minded Group of Supporters of Middle-Income Countries (Armenia, Belarus, Chile, Colombia, Costa Rica, the Dominican Republic, Ecuador, El Salvador, Honduras, Guatemala, Jamaica, Mexico, Panama and the Philippines)), the Russian Federation and the United States of America.

#### Chapter V

### Multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals

- 1. Pursuant to General Assembly resolutions 69/313 and 70/1, the President of the Council would convene the annual multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals for a period of two days to discuss science, technology and innovation cooperation around thematic areas for the implementation of the Goals, congregating all relevant stakeholders to actively contribute in their area of expertise. The forum would provide a venue for facilitating interaction, matchmaking and the establishment of networks between relevant stakeholders and multi-stakeholder partnerships to identify and examine technology needs and gaps, including on scientific cooperation, innovation and capacity-building and to help to facilitate the development, transfer and dissemination of relevant technologies for the implementation of the Goals.
- 2. The Council, by its resolution 2020/1, decided that the multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals would be held on 12 and 13 May 2020. The President of the Council appointed the Permanent Representative of Ghana to the United Nations, Martha Pobee, and the Permanent Representative of Israel to the United Nations, Danny Danon, as Co-Chairs of the forum.
- 3. The Council, taking into account the impact of COVID-19 on the working arrangements for its 2020 session, decided in its resolution 2020/3, to defer the multi-stakeholder forum to its 2021 session.

#### **Chapter VI**

#### **High-level segment**

- 1. The high-level segment (agenda item 5) of the 2020 session of the Council, including the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council (agenda item 5 (a)), was convened pursuant to the provisions of General Assembly resolutions 67/290 and 68/1 and Council resolution 2020/1.
- 2. Pursuant to Council resolution 2020/4, in which the Council further revised the working arrangements for its 2020 session and the sessions of its subsidiary bodies, and decisions 2020/205, 2020/206 and 2020/219 on the procedure for taking decisions during the COVID-19 pandemic, and taking into account the prevailing conditions relating to COVID-19 affecting the working arrangements and the available technological and procedural solutions, the high-level segment held online informal meetings from 14 to 17 July 2020.
- 3. The General Assembly, in its decision 74/508, decided that the theme for the 2020 high-level political forum on sustainable development convened under the auspices of the Council would be "Accelerated action and transformative pathways: realizing the decade of action and delivery for sustainable development".
- 4. The Council considered the following documents at its high-level segment:
- (a) Report of the Secretary-General on accelerated action and transformative pathways: realizing the decade of action and delivery for sustainable development (E/2020/59);
- (b) Report of the Secretary-General on progress towards the Sustainable Development Goals (E/2020/57);

  - (e) World economic situation and prospects as of mid-2020 (E/2020/58);
- (f) Report of the Committee for Development Policy on its twenty-second session (E/2020/33);
- (g) Summary by the President of the Economic and Social Council of the forum on financing for development follow-up (New York, 23 April 2020 and 2 June 2020) (E/2020/64);
- (h) Report of the Economic and Social Council forum on financing for development follow-up (E/FFDF/2020/3);
- (i) Statements submitted by non-governmental organizations in consultative status with the Council (E/2020/NGO/1 and E/2020/NGO/2).
- 5. The proceedings of the online informal meetings of the high-level segment are reflected in annex IV to the present document.

## A. Ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

- 6. The General Assembly, in its resolution 67/290, decided that meetings of the high-level political forum on sustainable development under the auspices of the Council would be convened annually by the President of the Council for a period of eight days, including a three-day ministerial segment.
- 7. Pursuant to paragraph 11 (c) of the annex to General Assembly resolution 68/1, the three-day ministerial meeting of the forum (agenda item 5 (a)) would be held during the high-level segment of the Council. In its resolution 2020/1, the Council decided that the high-level segment of its 2020 session, including the three-day ministerial meeting of the forum, would be held from 14 to 17 July 2020.
- 8. During the three-day ministerial meeting of the forum, held from 14 to 16 July 2020, as well as at the meeting of the forum on 10 and 13 July, a total of 47 voluntary national reviews were held. An account of the proceedings is set out in the report of the forum (E/HLPF/2020/6).

## B. High-level policy dialogue on future trends and scenarios and the long-term impact of current trends on the realization of the 2030 Agenda for Sustainable Development

9. Pursuant to the mandate for the high-level policy dialogue on future trends and scenarios and the long-term impact of current trends on the realization of the 2030 Agenda for Sustainable Development (agenda item 5 (b)), the Council held two dialogues on 17 July 2020. The proceedings of the dialogues are reflected in annex IV to the present document.

#### C. Development Cooperation Forum

- 10. The Council, in its resolution 2020/1, decided that the biennial Development Cooperation Forum would be held on 14 and 15 May 2020.
- 11. The Council, taking into account the impact of COVID-19 on the working arrangements for its 2020 session, decided in its resolution 2020/3, to defer the Development Cooperation Forum to its 2021 session.

#### D. General debate of the high-level segment

12. In accordance with the invitation of the President of the Council to submit official statements for the general debate in writing or via video recordings, communicated in her letter dated 22 June 2020, general statements and videos received by the secretariat for posting can be accessed on the web page of the high-level political forum on sustainable development (https://sustainabledevelopment.un.org/hlpf/2020#debate).

#### E. Ministerial declaration of the high-level segment

13. The Council had before it the draft ministerial declaration of the high-level segment of its 2020 session, on the theme "Accelerated action and transformative pathways: realizing the decade of action and delivery for sustainable development" (E/2020/L.20).

- 14. In a letter dated 17 July 2020, the President of the Council informed that the draft ministerial declaration contained no programme budget implications. In the same letter, the President of the Council placed the draft ministerial declaration under silence procedure until Wednesday, 22 July 2020, at 5 p.m., pursuant to Council decisions 2020/205, 2020/206 and 2020/219.
- 15. In a letter dated 22 July 2020, the President of the Council informed that the silence procedure had been broken on the draft ministerial declaration.

#### **Chapter VII**

# High-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

- 1. The General Assembly, in its resolution 67/290, decided that the meetings of the high-level political forum on sustainable development under the auspices of the Council (agenda item 6) should be convened annually by the President of the Council for a period of eight days, including a three-day ministerial segment. The Assembly also decided, in reviewing the implementation of its resolution 61/16, contained in the annex to its resolution 68/1, that the three-day ministerial meeting of the forum would be included in the high-level segment of the Council.
- 2. The General Assembly, in its decision 74/508, decided that the theme for the 2020 high-level political forum convened under the auspices of the Council would be "Accelerated action and transformative pathways: realizing the decade of action and delivery for sustainable development".
- 3. The Council, in its resolution 2020/1, decided that the forum would be held from 7 to 13 July 2020. The Council also decided that the three-day ministerial meeting of the forum would be held from 14 to 17 July 2020.
- 4. The proceedings of the high-level political forum on sustainable development, convened under the auspices of the Council at its 2020 session, including the three-day ministerial meeting of the forum, are contained in the report of the forum (E/HLPF/2020/6).

#### **Chapter VIII**

#### Operational activities for development segment

### Operational activities of the United Nations for international development cooperation

- 1. Pursuant to the provisions of General Assembly resolution 68/1 and Economic and Social Council resolution 2020/1, the operational activities for development segment of the 2020 session of the Council was scheduled from 19 to 21 May 2020.
- 2. Pursuant to Council resolution 2020/3, and taking into account the prevailing conditions relating to COVID-19 on the working arrangements for its 2020 session and the available technological and procedural solutions in the interim period, the Council convened the operational activities for development segment (agenda item 7) from 19 to 22 and on 27 May 2020, in the course of which it held five online informal meetings.
- 3. The proceedings of the online informal meetings of the operational activities for development segment are reflected in annex IV to the present document.

### A. Follow-up to policy recommendations of the General Assembly and the Council

- 4. Under agenda item 7 (a), the Council considered the following reports:

6. There was no advance documentation and no proposal submitted under agenda item 7 (c) (South-South cooperation for development).

#### Action taken by the Council

7. Under agenda item 7 as a whole, the Council adopted resolution 2020/23.

## Progress in the implementation of General Assembly resolution 71/243 on the quadrennial comprehensive policy review of operational activities for development of the United Nations system

- 8. On 1 July 2020, the observer for Guyana (on behalf of the Group of 77 and China) submitted a draft resolution entitled "Progress in the implementation of General Assembly resolution 71/243 on the quadrennial comprehensive policy review of operational activities for development of the United Nations system" (E/2020/L.18).
- 9. In her letter dated 19 July 2020, pursuant to Council decisions 2020/205 and 2020/219 on the procedure for taking decisions of the Council during the COVID-19 pandemic, the President of the Council circulated under silence procedure until 22 July 2020, a draft resolution entitled "Progress in the implementation of General Assembly resolution 71/243 on the quadrennial comprehensive policy review of operational activities for development of the United Nations system" (E/2020/L.28), as submitted by her on the basis of informal consultations on draft resolution E/2020/L.18.
- 10. In her letter dated 22 July 2020, the President of the Council announced the adoption of draft resolution E/2020/L.28 following the expiration of the silence procedure without objection (see Council resolution 2020/23).
- 11. Statements in in connection with the draft resolution were submitted by the observers for Fiji (on behalf of the Pacific Small Island Developing States (Fiji, Kiribati, Marshall Islands, Micronesia (Federated States of), Nauru, Palau, Papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu and Vanuatu)), Guyana (on behalf of the Group of 77 and China) and Turkey.

#### **Chapter IX**

#### **Integration segment**

- 1. Pursuant to the provisions of General Assembly resolutions 68/1 and 72/305 and Council resolution 2020/1, the Council held the integration segment (item 8) of its 2020 session on 6 July 2020.
- 2. Pursuant to Council resolution 2020/4 and taking into account the prevailing conditions relating to COVID-19 on the working arrangements for its 2020 session and the available technological and procedural solutions in the interim period, the Council held a half-day online informal meeting of the integration segment.
- 3. Under agenda item 8, the Council considered the annual overview report of the United Nations System Chief Executives Board for Coordination for 2019 (E/2020/5).
- 4. The proceedings of the online informal meetings of the integration segment are reflected in annex IV to the present document.

#### Chapter X

#### Humanitarian affairs segment

#### Special economic, humanitarian and disaster relief assistance

- 1. Pursuant to the provisions of General Assembly resolution 68/1 and Council resolution 2020/1, the Council held the humanitarian affairs segment of its 2020 session from 9 to 11 June 2020.
- 2. Pursuant to Council resolution 2020/4 and taking into account the prevailing conditions relating to COVID-19 on the working arrangements for its 2020 session and the available technological and procedural solutions in the interim period, the Council convened the humanitarian affairs segment (agenda item 9) from 9 to 11 June 2020, in the course of which it held four online informal meetings.
- 3. Under agenda item 9, the Council considered the report of the Secretary-General on the strengthening of the coordination of emergency humanitarian assistance of the United Nations (A/75/75-E/2020/48).
- 4. The proceedings of the online informal meetings of the humanitarian affairs segment are reflected in annex IV to the present document.

#### Action taken by the Council

- 5. On 4 June 2020, the Vice-President of the Council submitted a draft resolution entitled "Strengthening of the coordination of emergency humanitarian assistance of the United Nations" (E/2020/L.13) on the basis of informal consultations.
- 6. Subsequently, action on the draft resolution was postponed. 1

#### **Chapter XI**

#### Management segment

- 5. The Council also held a special meeting jointly with the Second Committee of the seventy-fourth session of the General Assembly (see chap. II) on 15 October 2019 (3rd meeting).
- 6. The Council also held the 2020 forum on financing for development follow-up (see chap. IV) on 23 April and 2 June 2020 (two online meetings), the high-level political forum on sustainable development convened under the auspices of the Council (see chap. VII) from 7 to 13 July 2020 (ten online meetings) and the three-day ministerial meeting of the forum (see chap. VI, sect. A) from 14 to 16 July 2020 (six online meetings).
