

I. Introduction

- 1. The item entitled "Revitalization of the work of the General Assembly" was included in the provisional agenda of the seventy-fifth session of the General Assembly pursuant to Assembly resolution 58/316 of 1 July 2004.
- 2. At its 2nd plenary meeting, on 18 September 2020, the General Assembly, on the recommendation of the General Committee, decided to allocate the item to all the Main Committees for the purpose of discussing their working methods and considering and taking action on their respective tentative programmes of work for the seventy-sixth session of the Assembly.
- 3. The Sixth Committee considered the item at its 19th meeting, on 19 November 2020. The views of the representatives who spoke during the Committee's consideration of the item are reflected in the relevant summary record. ¹
