I. Introduction

1. By its resolution 74/303, the General Assembly decided to establish, at its seventy-fifth session, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:

(a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation;

(b) To submit a report thereon to the Assembly at its seventy-fifth session.

2. The General Assembly also decided that the Ad Hoc Working Group should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted at the seventy-third session (A/73/956) and, as a result, continue to update the inventory to be attached to the report to be submitted at the seventy-fifth session of the Assembly. The present report and the recommendations contained herein are submitted pursuant to the provisions of that resolution.

3. During the seventy-fifth session of the General Assembly, the President of the General Assembly appointed the Permanent Representative of El Salvador to the United Nations, Egriselda López, and the Permanent Representative of Slovakia to the United Nations, Michal Mlynár, as Co-Chairs of the Ad Hoc Working Group.

II. Proceedings

4. The Working Group held a total of three formal meetings, on 11 February and 27 July 2021, and four virtual thematic meetings on 25 February, 11 March and 14 and 23 April 2021. At its first meeting, on 11 February, the Working Group approved its working arrangements for the seventy-fifth session as set out in the letter of the Co-Chairs dated 2 February 2021. The proceedings of the four virtual thematic meetings are reflected in annex I to the present report.

5. The programme of work consisted of a general discussion and four virtual thematic meetings on the following themes identified by the Co-Chairs:

- (a) The role and authority of the General Assembly;
- (b) The working methods of the Assembly;

(c) The selection and appointment of the Secretary-General and other executive heads of the United Nations system;

(d) The strengthening of the accountability, transparency and institutional memory of the Office of the President of the General Assembly.

6. In addition, one meeting was held on 25 March 2021 as part of the interactive dialogue between permanent missions and the Secretariat. On 10 June 2021, the Co-Chairs presented virtually the zero draft of the resolution.

General discussion

7. The first and second meetings of the Working Group were convened by its Co-Chairs on 11 February 2021. Following introductory remarks by the President of the General Assembly, participants heard interventions from 31 delegations, including on behalf of four groups of States. The Working Group also had before it a tentative

timetable for the thematic discussions to be held virtually and a draft updated inventory chart of all revitalization mandates, which was uploaded on the dedicated web page accessible from the website of the General Assembly (www.un.org/en/ga/revitalization/).

In his opening remarks, the President of the General Assembly commended 8. Member States for their support in keeping the General Assembly functioning during the coronavirus disease (COVID-19) pandemic, which continued to present the greatest challenge to its operations. He noted that the past months had demonstrated that the Assembly could adapt to new challenges when there was strong political will. The President called upon Member States to continue to find new and improved wavs of doing business and to strengthen the role of the Assembly. He indicated that, to be effective, the Assembly must remain relevant and respond to the rapid changes taking place in the world. Despite pandemic-related limitations, as a candidate, the President had met with representatives of Member States in an informal interactive dialogue, successfully held in a virtual format. In addition, elections had concluded in June, three months in advance of the opening of the session, thus allowing sufficient time for preparations. The President had also taken his oath of office and agreed to abide by the code of ethics. With regard to the selection and appointment of the Secretary-General, the President informed the Working Group that he and the President of the Security Council had launched the selection process by a joint letter dated 5 February 2021 (A/75/780-S/2021/179), in accordance with the landmark resolution 69/321 negotiated by the Working Group, a resolution that established a new era of transparency and inclusivity in the appointment process. In closing, the President invited delegations to reflect on the Assembly's effectiveness at adapting its working methods, which had enabled it to continue to address evolving global challenges despite the ongoing health crisis.

9. In the subsequent debate, delegations noted the importance of the revitalization process and highlighted the achievements realized during previous sessions, citing, in particular, the adoption of resolutions 69/321, 70/305, 71/323, 72/313 and 73/341. Many called for sustaining momentum around the revitalization of the Assembly and the reinvigoration of multilateralism that was generated during the seventy-fifth anniversary of the United Nations. Given that only a technical rollover resolution (resolution 74/303) was adopted at the seventy-fourth session, many expected the Working Group to make tangible progress at the seventy-fifth session. One group emphasized the importance of preserving the intergovernmental, inclusive and democratic nature of the United Nations and the need to ensure the proper implementation of the Charter of the United Nations with respect to the functional relationship between its principal organs, while also fully respecting their respective mandates.

10. Among the many interrelated global challenges, the COVID-19 pandemic remained the most immediate one. Delegations recognized the unprecedented challenges for the operations and working conditions caused by the pandemic but nevertheless welcomed the Organization's capacity to change and adapt during a crisis, when all activities had to be prioritized more than ever before and with many processes being either cancelled or limited to technical rollover outcomes under such exceptional circumstances. Delegations praised the efforts of the Presidents of the General Assembly at its seventy-fourth and seventy-fifth sessions to ensure business continuity. In this regard, some delegations, in keeping with the spirit of pragmatism and prioritization that had recently prevailed, suggested continuing the discussion to biennialize or sunset resolutions and to align the work of the Assembly with the priorities outlined in the declaration on the commemoration of the seventy-fifth anniversary of the United Nations (resolution 75/1) and the 2030 Agenda for Sustainable Development. On the other hand, a group of States underscored the

exceptional nature of the current working methods and reiterated the importance of maintaining strict compliance with and adherence to the rules of procedure of the Assembly. That group of States emphasized that the rationalization measures must be analysed on a case-by-case basis, in consultation with the Member States. Speakers called upon the Assembly and its Main Committees to streamline, rationalize and bring an action-oriented focus to their decisions and resolutions. In the light of the rapidly evolving developments related to COVID-19, the Assembly had been carrying out its work through novel means to guarantee business continuity and mitigate the spread of the disease. Delegations welcomed the adoption of decision 75/510, entitled "Procedure for decision-making in the General Assembly when an in-person meeting is not possible", which equipped the Assembly and its Main Committees with tools and methods to ensure business continuity under any circumstances. Speakers also recalled the procedure established by the Assembly at the seventy-fourth session on the proposal of its President that had enabled it and its Main Committees to take essential decisions through a silence procedure from March to August 2020, when a plenary meeting was not practicable as a result of the COVID-19 pandemic (see decisions 74/544, 74/555, 74/558 and 74/561).

11. The majority of speakers called for greater support for multilingualism in the working methods, recalling the most severe impact that the pandemic had had on the ability of delegations at Headquarters to meet, consult or negotiate with interpretation in the official languages of the United Nations. One group specifically referred to the need to remove language barriers for briefers from the field, including civil society and humanitarian briefers. On another note, speakers also underlined that the pandemic should not jeopardize the engagement of civil society and other stakeholders in the work of the United Nations.

12. Many delegations reiterated that the number of high-level and side events organized in parallel with the general debate of the General Assembly should be kept to a minimum in order to preserve the sanctity of the general debate. Delegations suggested that capping the number of events, in particular during the high-level week, would contribute to the Assembly focusing on main priorities.

13. Many speakers reiterated the importance of enhancing the efficiency and effectiveness of the Office of the President of the General Assembly, especially in the context of the pandemic, when the Office had played an important role in allowing the Assembly to adapt its programme of work and continue to perform essential functions. One group further reiterated the need to strengthen the Office by allocating to it adequate resources from the regular budget.

14. The need to further streamline and rationalize the agenda of the Assembly was also mentioned. One group reiterated the importance of achieving greater coherence and coordination in the work of the Main Committees, including better use of lessons learned, as well as achieving better synergies and alignment in the work of the Assembly and the Economic and Social Council. Another group recalled that the Assembly had encouraged the Main Committees to continue to consider and make proposals on their working methods and, in that connection, reiterated the intergovernmental and inclusive nature of such discussions, which should engage all delegations.

15. Promoting the interactive nature of discussions to generate real dialogue was another proposal to consider. Some delegations welcomed the move to a virtual format on a remote simultaneous interpretation platform for the four thematic debates, which would allow a more informal discussion and a frank exchange of views.

16. Attention was given to the selection process for the Secretary-General and other executive heads, in particular the requirement to appoint the Secretary-General for a term beginning in 2022. Speakers said that the process of selection and appointment

of the Secretary-General should be carried out in full compliance with Article 97 of the Charter and relevant General Assembly resolutions, in particular resolutions 69/321 and 70/305. It was important to keep the best practices and lessons learned from the previous selection and appointment process (see A/71/774-S/2017/93 and A/72/514-S/2017/846) in view, while underscoring that the achievements in terms of transparency, democracy and inclusivity of all Member States in connection with the election of the incumbent Secretary-General should inform the current year's selection and appointment process. Delegations also welcomed the leadership shown by the President of the General Assembly in initiating this important process in line with positive standards and the principles of transparency, inclusivity and accountability.

17. Speakers also welcomed the cooperation between the President of the General Assembly and the President of the Security Council, which resulted in the joint letter dated 5 February 2021 (A/75/780-S/2021/179) and the intent to continue the practice of vision statements and dialogues with the candidates. Appreciation was expressed for the collaboration between the Assembly and the Council, and delegations encouraged interaction between both organs in all stages of the process.

18. One group encouraged the early presentation of highly qualified candidates, especially women candidates. The identification and appointment of the most qualified candidate for the post should be guided by best practices in high-level appointments.

19. Delegations encouraged the President of the General Assembly to optimize the informal dialogue format by minimizing duplication of questions and ensuring ample time for responses. Regarding the incumbent candidate, speakers welcomed his commitment to transparency and his willingness to produce a vision statement and participate in a dialogue with the membership.

20. One group highlighted the contribution of civil society during the previous process and underlined the high and legitimate expectations of global civil society to be more closely included in the work of the United Nations after the successful global outreach for the commemoration of the seventy-fifth anniversary of the United Nations. The group called for various elements of the 2016 process to be replicated and, where possible, strengthened by allowing for greater participation, including through virtual modalities. The current COVID-19 situation represented an opportunity for innovation and for strengthening interaction with civil society. The group called upon the President of the General Assembly to facilitate these interactions and looked forward to discussing more concrete proposals at the thematic debate in April.

21. With regard to the draft resolution of the Working Group, delegations suggested that the Working Group should lead by example and streamline both its programme of work and its resolution. In addition, biennializing the resolution on the revitalization of the work of the General Assembly was suggested, so that substantive changes would be made every two years, while implementation would be monitored in the intervening year.

22. In their concluding remarks, the Co-Chairs noted the wide range of substantive issues raised and emphasized that their main objective would continue to be to listen to Member States' interventions during the forthcoming thematic debates. The views and positions expressed would form the basis for the zero draft of the resolution to be circulated before the commencement of the negotiations.

III. Conclusion

23. In accordance with its mandate, the Working Group endeavoured to identify key issues of concern and possible consensus, to examine the current status of implementation of those issues, and either to take action or to indicate possible further action to be taken.

24. At its final meeting, held on 27 July 2021, the Working Group considered and adopted the present report, including the draft resolution contained in section III below (see para. 27).

25. At the same meeting, the Secretary read out a statement of the programme budget implications of the draft resolution. Statements were made by several delegations, including on behalf of three groups of States.

IV. Recommendation

26. On the basis of a draft resolution circulated by the Co-Chairs, the Working Group formulated the resolution set out below.

27. At its final meeting, on 27 July 2021, the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly concluded its work for the seventy-fifth session. The Working Group recommended that the Assembly adopt the following draft resolution:

Revitalization of the work of the General Assembly

The General Assembly,

Bearing in mind the role and authority of the General Assembly as a principal organ of the United Nations and the importance of its effectiveness and efficiency in fulfilling its functions under the Charter of the United Nations,

Reiterating that the revitalization of the work of the General Assembly is a critical component of the overall reform of the United Nations,

Welcoming the calls to increase the efficiency of the work of the General Assembly through streamlining its agenda, including by elimination of duplication and overlap of agenda items,

Welcoming also the efforts of the President of the General Assembly to provide impetus to and promote the process of revitalization of the work of the Assembly during its seventy-fifth session in favour of strengthening multilateralism and international cooperation,

Recalling the declaration on the commemoration of the seventy-fifth anniversary of the United Nations, adopted as resolution 75/1 of 21 September 2020, which reaffirms overarching priorities for the work of the General Assembly, including the commitment to multilateralism and to continue to work to revitalize the Assembly,

Recognizing the impact of the coronavirus disease (COVID-19) pandemic on the work of the General Assembly during its seventy-fourth and seventy-fifth sessions, and welcoming the efforts of the Presidents of the General Assembly at its seventy-fourth and seventy-fifth sessions to ensure the continued functioning of the Assembly despite the limitations as a consequence of the pandemic, *Mindful* of the importance of the rules of procedure of the General Assembly, which continue to guide its work,

Recognizing the temporary adjustments that were carried out by the Secretariat without setting a precedent due to the COVID-19 pandemic, which demonstrated its adaptability and resilience under exceptional circumstances, and taking note of the analysis of the Secretary-General on the impact of the COVID-19 pandemic on the work of the General Assembly and the briefing thereon provided to the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly during the seventy-fifth session,

Recognizing also that multilingualism, as a core value of the Organization, contributes to the achievement of the goals of the United Nations, as set out in Article 1 of the Charter,

Underlining the need to further enhance the role, authority, effectiveness and efficiency of the General Assembly to address the evolving global challenges,

1. *Reaffirms* its resolutions 73/341 of 12 September 2019 and 74/303 of 4 September 2020 and all other previous resolutions adopted by consensus relating to the revitalization of the work of the General Assembly;

2. *Welcomes* the report of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly issued during the seventy-fifth session and the updated inventory of Assembly resolutions on revitalization annexed thereto,¹ which continues to form a basis for the deliberations of Member States under the item on the revitalization of the work of the General Assembly;

3. *Requests* the Secretariat to continue updating regularly and equally the multilingual web page devoted to the revitalization of the work of the General Assembly in all six official languages and its substantive content within existing resources in a cost-effective manner, including through the use of existing capabilities such as automation of translation, while ensuring the accuracy of translation;

4. *Decides* to establish, at its seventy-sixth and seventy-seventh sessions, an ad hoc working group on the revitalization of the work of the General Assembly, open to all Member States:

(a) To identify further ways to enhance the role, authority, effectiveness and efficiency of the Assembly, inter alia, by building on the progress achieved in past sessions as well as on previous resolutions, including evaluating the status of their implementation, with the primary focus on:

(i) During the seventy-sixth session: role and authority of the General Assembly, and working methods;

(ii) During the seventy-seventh session: strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly and selection and appointment of the Secretary-General and other executive heads;

(b) To also place the primary focus on implementation of the present resolution during the seventy-sixth session, and to submit a report thereon to the Assembly at its seventy-seventh session;

5. *Also decides* that the next resolution shall be considered during the seventy-seventh session and biennially thereafter;

6. *Further decides* that the Ad Hoc Working Group shall continue its review of the inventory of General Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted at the seventy-fifth session and, as a result, continue to update the inventory to be attached to the reports to be submitted at the seventy-sixth and seventy-seventh sessions of the Assembly, including the separate indication of relevant provisions that were not implemented, with reasons therefor;

7. *Requests* the Secretary-General to submit an update on the provisions of the General Assembly resolutions on revitalization addressed to the Secretariat for implementation that have not been implemented, with an indication of the constraints and reasons behind any lack of implementation, for further consideration by the Ad Hoc Working Group at the seventy-sixth and seventy-seventh sessions;

8. *Reiterates* its decision to hold annually an interactive and comprehensive dialogue between the Permanent Missions and the Secretariat as mandated in resolution 71/323 of 8 September 2017, during the work of the Ad Hoc Working Group, and strongly emphasizes the importance of the follow-up on issues raised during the dialogue aimed at improving the work of the Secretariat in its interaction with Permanent Missions, including the circulation of these follow-up measures to Permanent Missions;

Role and authority of the General Assembly

9. *Reaffirms* the role and authority of the General Assembly and the strict respect of the Charter-based prerogatives and division of work among the principal organs of the United Nations;

10. Welcomes the decision of the President of the General Assembly at its seventy-fifth session to select "The future we want, the United Nations we need: reaffirming our collective commitment to multilateralism – confronting COVID-19 through effective multilateral action" as the theme of the general debate, and also welcomes the decision of the President-elect of the General Assembly to select "Building resilience through hope – to recover from COVID-19, rebuild sustainably, respond to the needs of the planet, respect the rights of people, and revitalize the United Nations" as the theme of the general debate of the seventy-sixth session of the Assembly;

11. *Stresses* the importance of implementing the resolutions of the General Assembly on a non-selective basis, including those related to the revitalization of its work that require a follow-up or further actions, as shown in the updated inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group;

12. *Welcomes* the efforts of the President of the General Assembly to reinforce synergy, coherence and complementarity between the agendas of the Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies, and encourages regular interaction and continued coordination between the Presidents of the General Assembly, the Security Council and the Economic and Social Council in this regard;

13. *Stresses* the need for United Nations intergovernmental bodies to effectively address the 2030 Agenda for Sustainable Development² as a whole, including its Sustainable Development Goals, in order to effectively and efficiently support its accelerated implementation during the decade of action and delivery for sustainable development;

14. *Takes into account* the respective mandates and distinct functions of each intergovernmental body, recognizes that it is necessary to further align the agendas of the General Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies with the 2030 Agenda, considering a comprehensive and holistic view of the agendas, and also recognizes the need for the Assembly process on alignment to identify and simultaneously address gaps, overlaps and duplication in a balanced manner and on a case-by-case basis;

15. Underlines that the work of the General Assembly on the alignment of agendas does not undermine the sovereign right of any Member State to introduce a new agenda item or resolution, taking into account the alignment-related principles and objectives of the present resolution;

16. *Invites* delegations proposing draft resolutions, where possible, to consider including provisions to accelerate the implementation of the 2030 Agenda in the resolutions, and also invites them to take into consideration the principles and objectives agreed during the alignment process;

17. *Invites* the General Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies to consider ways to address those Sustainable Development Goals that have limited or no coverage, and ways to avoid overlaps and duplication, bearing in mind their respective mandates, and to make recommendations to Member States for their consideration;

18. *Invites* the main sponsors of draft resolutions that are submitted for the consideration of delegations to consider the procedural practices applied during previous sessions with the aim of enhancing the efficiency of the work of the General Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies;

19. Underlines the urgent need to preserve the primacy, significance and established practice of the general debate of the General Assembly, and:

(a) Stresses the need to limit the number of high-level events held in the margins of the general debate to those of key significance that require immediate attention from Heads of State and Government, and calls upon the President of the General Assembly, Member States, in close coordination with the Secretary-General and heads of other relevant United Nations bodies, to be very mindful of these aspects when planning the events of the high-level week in September and to be guided by the existing mandates agreed upon by Member States;

(b) Encourages Member States and the United Nations system to singly and collectively limit the number of side events held in parallel with or in the margins of the general debate, as well as other high-level sessions, including by consulting one another to identify side events on similar topics in an effort to minimize overlap and informing the Secretariat of the details of planned side events;

(c) Requests the Secretariat to upload information on the side events, when indicated by the organizers, in the *Journal of the United Nations*;

(d) Invites Member States to continue discussions on efforts to limit the number of side events held in parallel with or in the margins of the general debate and other high-level sessions, with a view to taking stock and exploring further improvements, as necessary, during the seventy-eighth session of the General Assembly;

20. *Recognizes* the value of holding interactive inclusive thematic debates on current issues of critical importance to the international community, calls for the rationalizing of such debates to ensure high-level attendance, calls upon the President of the General Assembly to be mindful of the regular agenda of the Assembly when

organizing such debates, and urges Member States to be mindful of existing mandates when considering new mandates for meetings of the Assembly and, in this regard, to refrain from mandating recurring high-level and commemorative meetings where possible;

21. *Encourages* the President of the General Assembly, supported by the membership, to achieve gender parity among invited speakers and panellists for high-level and other relevant meetings of the General Assembly;

22. *Requests* the President of the General Assembly to continue scheduling the plenary meetings of the Assembly on the report of the Secretary-General on the work of the Organization and on the report of the Security Council in close coordination with the Secretary-General and the President of the Security Council, so that discussions of these important reports are not conducted in a perfunctory manner;

23. *Recognizes* the timely submission of the report of the Security Council to the General Assembly in accordance with Article 24, paragraph 3, of the Charter of the United Nations, recalls resolution 69/321 of 11 September 2015 and other relevant resolutions of the Assembly, and reiterates the importance of the Security Council continuing its efforts to provide its annual report to the Assembly in accordance with resolutions 51/193 of 17 December 1996 and 58/126 of 19 December 2003;

24. Notes the progress aimed at increasing the visibility of the General Assembly in the media and in bringing the priorities of the Assembly to a wider audience, including during the COVID-19 pandemic with a view to ensuring relevance and providing accurate and reliable information to the global public in a timely manner, requests the Department of Global Communications of the Secretariat to continue to take appropriate measures to further enhance public awareness of the role and activities of the Assembly throughout its session in all six official languages, including on as many platforms as possible, requests the Secretary-General and the President of the General Assembly to continue to make efforts to ensure that multilingualism is not undermined by the measures taken in response to the liquidity situation and the COVID-19 pandemic, and requests the Secretariat to continue to explore cost-neutral options to that effect;

Working methods

25. *Stresses* the desirability of the General Assembly further streamlining its agenda and dedicating more time for dialogue as well as the review of the implementation of the resolutions it adopts;

26. *Reaffirms* existing relevant mandates related to the improvement of the working methods of the Main Committees;

27. *Notes* the important role of information and communications technologies in carrying out the work of the United Nations, including the General Assembly, on an exceptional basis, during the COVID-19 pandemic, and:

(a) Recognizes the use of information and communications technologies in holding interactive inclusive thematic debates during the COVID-19 pandemic, and encourages the President of the General Assembly to be mindful of the proper use of such technologies to ensure full and equal participation of Member States when organizing such events;

(b) Requests the Secretariat to brief the Ad Hoc Working Group at the seventysixth session of the General Assembly on lessons learned from the COVID-19 pandemic, including the use of information and communications technologies, with a view to ensuring better preparedness in exceptional circumstances; 28. *Requests* the Secretariat to brief the Ad Hoc Working Group at the seventysixth session of the General Assembly on the implementation of past decisions regarding the streamlining of the agenda of the Assembly to further address the issue of the increasingly overloaded agenda of the Assembly;

29. *Requests* each Main Committee to further discuss its working methods, and in this regard invites the Chairs of the Main Committees to continue briefing the Ad Hoc Working Group during the seventy-sixth session on any best practices and lessons learned with a view to improving working methods, and to coordinate their briefings through, inter alia, possible identification of commonalities in the working methods and the lessons learned;

30. *Emphasizes* that the General Assembly and its Main Committees, at the seventy-sixth session, in consultation with Member States, should continue their consideration of and make concrete proposals for the further biennialization, triennialization, clustering and elimination of items on the agenda of the Assembly, including through the introduction of a sunset clause, with the clear consent of the sponsoring State or States, taking into account the relevant recommendations of the Ad Hoc Working Group, during the seventy-sixth session of the Assembly, and encourages the General Committee to play a more active role in this regard, in line with the rules of procedure of the Assembly;

31. *Requests* each Main Committee to submit to the Ad Hoc Working Group during the seventy-sixth session a written update on progress achieved so far in the efforts aimed at improving the working methods of the Committees, taking into account recommendations of the Ad Hoc Working Group as appropriate, and encourages the Ad Hoc Working Group during the seventy-sixth session to appoint two focal points who would work closely with the Chairs and Bureaux of the Main Committees, the President of the General Assembly and the Secretariat to assist the Co-Chairs of the Ad Hoc Working Group in elaborating practical proposals for consideration by the Working Group for the implementation of paragraphs 29 and 30 of the present resolution and of reports submitted by the Main Committees;

32. Notes the pilot analysis on Sustainable Development Goal 2 carried out during the seventy-fifth session to examine in depth the coverage of Goal 2 (zero hunger) and the mapping developed during the seventy-third session of the Assembly, along with the pilot analysis, which remain relevant reference documents for the consideration of Member States during the seventy-eighth session of the Assembly;

33. *Recognizes* that, when considering Sustainable Development Goals that are not fully covered by intergovernmental bodies, due consideration should be given to addressing these through an integrated approach across the intergovernmental bodies, and not in silos;

34. *Highlights* that the COVID-19 pandemic is impacting all Sustainable Development Goals and that dedicated attention by intergovernmental bodies is required to address these impacts, notably on the most affected Goals and resulting gaps, and that it will be important to closely monitor various aspects of the 2030 Agenda to enable governments to respond to the pandemic and its impacts and establish the way forward to build back better and to strengthen international cooperation;

35. *Invites* the General Committee, within its mandate, to consider the best possible way to conduct the discussions on the impacts of the COVID-19 pandemic within the agenda of the General Assembly and make recommendations to Member States for their consideration;

36. *Emphasizes* that addressing overlaps and duplication in the agendas of the General Assembly and its Main Committees and the Economic and Social Council

and its subsidiary bodies will free up time and create space in the agendas and allow resources to be applied effectively, and that this will also allow these bodies to better and more comprehensively address the 2030 Agenda as a whole as well as emerging global issues of an important and urgent nature;

37. Notes that identifying duplication and overlaps in the agendas of the intergovernmental bodies should entail encouraging the General Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies to examine, on a case-by-case basis, all the resolutions and agenda items that focus on the same area, based on their purpose, relevance and content;

38. *Recognizes*, at the same time, that some issues may need to be addressed by different intergovernmental bodies from their own specific perspective and based on their respective mandates, which should be reflected in setting agendas and in the reporting of the Secretary-General, taking due consideration of synergies and mandates of respective resolutions;

39. *Invites* the General Assembly and its Main Committees and the Economic and Social Council and its subsidiary bodies to strengthen synergies and complementarities in their respective work and outcomes, in line with resolution 73/341, when covering interrelated issues, as appropriate;

40. *Reaffirms* the respective mandates of the Main Committees of the General Assembly, and on that basis, calls upon those Committees to continue their consideration, in consultation with all relevant bodies, of addressing gaps, overlaps and duplication in their respective agendas as they relate to the 2030 Agenda as a whole and, in this regard, invites the Bureaux of the relevant Main Committees of the Assembly and the Economic and Social Council and its subsidiary bodies to facilitate the consideration of the alignment principles by their respective intergovernmental bodies and to present concrete proposals for the consideration of Member States;

41. *Requests* the General Committee, while exercising its functions under rule 40 of the rules of procedure of the General Assembly, and within its mandate, to also consider discussing gaps, overlaps and duplication and make recommendations to Member States for consideration;

42. *Encourages* the President of the General Assembly and the President of the Economic and Social Council to continue to convene an annual joint briefing, highlighting the connection between agenda items and their interlinkages across the 2030 Agenda;

43. Also encourages the President of the General Assembly and the President of the Economic and Social Council to facilitate informal joint meetings of the Bureaux of the Main Committees of the Assembly and the Bureau of the Economic and Social Council to discuss how their respective work relates to the implementation of the 2030 Agenda and to ensure synergies among their work and outcomes, as stipulated in resolution 73/341 and the present resolution, on an ongoing basis and in full transparency, including regular reporting on those meetings to the entire membership;

44. *Requests* the President of the General Assembly at its seventy-eighth session to draw lessons learned from the implementation of the provisions contained in paragraphs 13 to 18 and 32 to 44 of the present resolution on the revitalization of the work of the Assembly and identify further proposals on alignment, and, in the interim, requests the Ad Hoc Working Group, during both the seventy-sixth and the seventy-seventh sessions, to hold one or two dedicated meetings, as required, on the progress of the implementation of the aforementioned provisions;

45. *Welcomes* the increasing number of women candidates nominated for the subsidiary organs of the General Assembly in seeking to promote gender balance, and encourages Member States to continue to do so;

46. *Reiterates* the need to continue to produce the *Journal of the United Nations* in all six official languages in strict compliance with rule 55 of the rules of procedure of the General Assembly, and in that regard emphasizes the importance of the extension of the information in the *Journal* published in the six official languages, reiterates its request to the Secretary-General to brief the Ad Hoc Working Group, on a yearly basis, on the progress achieved in this regard, and requests the Secretariat to continue to explore cost-neutral options to that effect;

47. *Requests* the Secretariat to continue to improve, harmonize and unify e-services provided to Member States under e-deleGATE with a view to creating a full-fledged delegates' online workplace in all six official languages in order to save costs, reduce the environmental impact and improve the distribution of documents;

48. *Recognizes* the need to have open access to the archive of past statements, and requests the Secretariat to ensure open access, by the end of the seventy-sixth session, to all documents uploaded to PaperSmart and, further, to ensure its replacement with the eStatements module of the *Journal of the United Nations*;

49. *Reaffirms* paragraphs 33 to 37 of resolution 73/341, and requests the Secretariat to brief the Ad Hoc Working Group during the seventy-sixth session of the General Assembly on the progress reached so far and on ways to improve the accessibility of the United Nations Headquarters premises for persons with disabilities;

50. *Recalls* the report of the Secretary-General entitled "Opening of the regular sessions of the General Assembly", submitted pursuant to resolution 72/313 of 17 September 2018,³ and decides, in order to allow more time for the incoming President of the General Assembly and his/her Office to prepare for the general debate, to amend rule 1 of the rules of procedure of the General Assembly to read, effective from the opening of the seventy-eighth session:

The General Assembly shall meet every year in regular session commencing on the Tuesday of the second week in September, counting from the first week that contains at least one working day.

The general debate in the General Assembly shall open on the Tuesday of the fourth week in September, counting from the first week that contains at least one working day, and shall be held without interruption over a period of nine working days;

Selection and appointment of the Secretary-General and other executive heads

51. *Reaffirms* the important role played by the Secretary-General in the context of current global challenges and in the implementation of the three pillars of the United Nations, namely, peace and security, human rights and sustainable development;

52. *Reaffirms its commitment* to continue, in the Ad Hoc Working Group, in accordance with the provisions of Article 97 of the Charter, its thorough consideration of the issues under the third thematic cluster of the Working Group, on the revitalization of the work of the General Assembly, including the examination of innovative ways to improve the process of selecting and appointing the Secretary-General and other executive heads in all its aspects, and recalls all relevant

resolutions, including resolutions 11 (I) of 24 January 1946, 46/77 of 12 December 1991, 47/233 of 17 August 1993, 48/264 of 29 July 1994, 51/241 of 31 July 1997, 52/163 of 15 December 1997, 55/14 of 3 November 2000, 55/285 of 7 September 2001, 56/509 of 8 July 2002, 57/300 of 20 December 2002, 57/301 of 13 March 2003, 58/126 of 19 December 2003, 58/316 of 1 July 2004, 59/313 of 12 September 2005, 60/286 of 8 September 2006, 61/292 of 2 August 2007, 62/276 of 15 September 2008, 63/309 of 14 September 2009, 64/301 of 13 September 2010, 65/315 of 12 September 2011, 66/294 of 17 September 2012, 67/297 of 29 August 2013, 68/307 of 10 September 2014, 69/321 of 11 September 2015, 70/305 of 13 September 2016, 71/323 of 8 September 2017, 72/313 of 17 September 2018 and 73/341 of 12 September 2019, reaffirming the applicable procedures set out in the rules of procedure of the Assembly, in particular rule 141, and acknowledging existing relevant practices of the Assembly;

53. *Encourages* future Presidents of the General Assembly to actively contribute to the implementation of provisions guiding the selection and appointment of the next Secretary-General, as contained in all relevant resolutions, in particular resolutions 69/321 and 70/305, and stresses the need for the selection and appointment process of the Secretary-General and other executive heads to be guided by the principles of transparency and inclusiveness;

54. *Welcomes* the progress achieved in the selection and appointment process of the Secretary-General in the consensual resolutions 69/321, 70/305, 71/323 and 72/313, in full compliance with the General Assembly mandate under Article 97 of the Charter, and reaffirms previous resolutions referring to gender balance and regional rotation in the course of the identification and appointment of the best well-qualified and experienced candidate for the post of Secretary-General;

55. *Recommends* that the President of the General Assembly and the President of the Security Council, in future joint letters on the selection and appointment process of the Secretary-General, encourage Member States to publicize the call for nominations, including with civil society and other stakeholders with the aim of identifying potential candidates;

56. Decides that, in order to be circulated in a joint letter by the President of the General Assembly and the President of the Security Council pursuant to the process established in resolution 69/321, nominations of candidates must be submitted by at least one Member State, in accordance with the ongoing practice;

57. Also decides to further assess during the seventy-seventh session of the General Assembly the selection and appointment process of the Secretary-General, to consolidate the advances gained in the relevant Assembly resolutions and to explore possible steps to improve future processes, including the collaboration between the Assembly and the Security Council, consistent with Article 97 of the Charter;

58. *Notes with appreciation* the presentation of a vision statement by the incumbent Secretary-General, and the informal dialogue with Member States and observers⁴ of the General Assembly on its content, including the engagement of civil society in line with the letter dated 26 April 2021 from the President of the General Assembly, and encourages the continuation of such practices;

59. *Reiterates* the possibility of providing the process of selection and appointment of the Secretary-General with provisional timelines in accordance with paragraph 72 of its resolution 72/313, and decides to further discuss this issue during its seventy-seventh session in the Ad Hoc Working Group;

60. *Notes* that the Secretary-General-designate shall take an oath of office before the General Assembly during a swearing-in ceremony, as detailed in the annex to the present resolution;

61. Welcomes again the ongoing efforts of the Secretary-General towards achieving equal and fair distribution in terms of the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, while securing the highest standards of efficiency, competence and integrity, in accordance with Article 101 of the Charter and its resolutions 46/232 of 2 March 1992, 51/241, and 71/263 of 23 December 2016, commends in particular the fact that gender parity was achieved in the Senior Management Group, and requests that further effective measures be taken in this regard;

62. *Supports* the request of the Secretary-General for Member States to submit the names and résumés of nationals who may be considered for positions of executive heads and senior management of the Secretariat;

63. *Reiterates* the need to follow best practices in all senior appointments, including a public call for candidates, including women;

64. *Reaffirms* that no post should be considered the exclusive preserve of any Member State or group of States and that the Secretary-General should ensure that this principle is applied faithfully in accordance with the principle of equitable geographical distribution;

65. *Welcomes* the fact that gender parity has already been reached in the Senior Management Group, and commends the Secretary-General's commitment to reach gender parity and to recruit staff on as wide a geographical basis as possible across the United Nations Organization;

66. *Reiterates its request* to the Secretary-General that he continue his ongoing efforts to ensure the attainment of equitable geographical distribution in the Secretariat and to ensure as wide a geographical distribution of staff as possible in all departments and offices and at all levels, including at the Director and higher levels, of the Secretariat;

67. Reiterates the need to ensure equal and fair distribution based on gender balance and as wide a geographical basis as possible, while also being diverse from a multilingual perspective, and in this regard recalls its resolutions 46/232 and 51/241, adopted without a vote, which contain the principles that the highest standards of efficiency, competence and integrity are the paramount considerations in the recruitment and performance of international civil servants, and that candidates' independence should be considered;

68. *Notes* that there is yet to be a woman Secretary-General, and invites Member States to bear this in mind in the future, when nominating candidates for the position of Secretary-General;

69. *Requests* the Office of Human Resources of the Secretariat to continue with the practice of providing a briefing to the Ad Hoc Working Group, during the seventy-seventh session of the General Assembly, on the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, as well as with a breakdown showing those originating from the States that are permanent members of the Security Council;

Strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly

70. *Emphasizes* the important role of the President of the General Assembly within the United Nations Organization, as well as in the overall success of the work of the Assembly;

71. *Invites* Member States to equally consider women as candidates for the position of President of the General Assembly, and encourages Presidents-elect to continue to strive for both gender and geographical balance within the Office of the President of the General Assembly;

72. *Recalls with appreciation* the decision of Member States to fund the transition period, the trust fund in support of the Office of the President of the General Assembly, seconding national staff as well as the convening of annual retreats;

73. *Welcomes* the induction programme delivered to the Office of the President of the General Assembly, and calls upon the Secretariat to strengthen the programme through enhanced content and increased delivery time;

74. *Also welcomes* the initiatives by Member States to support the strengthening of the efficiency and effectiveness of the Office of the President of the General Assembly, including through the annual General Assembly retreat and a transition workshop that includes the revitalization of the work of the Assembly among its central components;

75. *Recognizes* the heavy reliance of the Office of the President of the General Assembly on voluntary contributions to deliver on a growing number of mandates entrusted to it by the Assembly;

76. *Requests* the Secretary-General to continue to provide to the President of the General Assembly, within existing resources, adequate administrative, technical, logistical and protocol-related support necessary to effectively execute his or her mandates as president of a principal organ of the United Nations;

77. *Recalls* that the activities of the President of the General Assembly have increased continuously and markedly in recent years, also recalls the provisions regarding the support for the Office of the President of the General Assembly in previous resolutions, and expresses continued interest in seeking ways to further support and strengthen the Office in accordance with existing procedures, in particular rule 153 of the rules of procedure of the Assembly;

78. *Requests* the Secretariat to provide to the Ad Hoc Working Group during the seventy-seventh session of the General Assembly a written update with recommendations, and a briefing on the functioning of the Office of the President of the General Assembly, as a follow-up to the report of the Task Force convened by the Secretary-General in November 2015 and circulated in the annex to the letter dated 11 March 2016 from the Secretary-General addressed to the President of the General Assembly,⁵ taking into consideration its previous relevant resolutions;

79. *Requests* the Secretary-General to take the measures necessary to preserve and further strengthen the institutional memory of the Office of the President of the General Assembly and the General Assembly revitalization process, through utilizing existing United Nations record-keeping and archiving facilities, in particular in the Dag Hammarskjöld Library and the Department of General Assembly and Conference Management and the Department of Global Communications of the Secretariat;

80. *Requests* the Secretariat to issue, during the seventy-seventh session, within existing resources, in coordination with the Office of the President of the General Assembly, a compendium of best practices of past Presidents that could serve to contribute to strengthening the institutional memory of the Office;

81. *Emphasizes* the importance of a handover report for the institutional memory of the Office of the President of the General Assembly in accordance with resolution 69/321 and other relevant mandates contained in resolutions on the revitalization of the work of the Assembly;

82. *Welcomes* the good practice of the organization by the President of the General Assembly of informal interactive dialogues of the Member States, with the engagement of civil society, with the candidate(s) for the position of President of the General Assembly based on his or her vision statement.

Annex

Oath of office of the Secretary-General

I, [name], solemnly swear to exercise in all loyalty, discretion and conscience the functions entrusted to me as Secretary-General of the United Nations, to discharge these functions and regulate my conduct with the interests of the United Nations only in view and in accordance with the Charter of the United Nations, without seeking or accepting any instructions in regard to the performance of my duties from any Government or other authority external to the Organization.

Annex I

Thematic meetings held virtually

Thematic meeting: the role and authority of the General Assembly

1. The Co-Chairs convened the thematic meeting on the role and authority of the General Assembly on 25 February virtually. Nineteen delegations made statements, including on behalf of two groups. A briefing was provided by the Under-Secretary-General for Global Communications on the efforts of the Department of Global Communications to enhance the visibility of the work of the Assembly. The Under-Secretary-General focused on the efforts undertaken during the coronavirus disease (COVID-19) pandemic, which required careful rethinking of how to reach and engage with the global public. In 2020, in response to the flood of misinformation on the Internet and other digital platforms, the Department had launched the Verified initiative. There was a dramatic increase in viewership of the website and social media channels of the United Nations amid the global health crisis. The number of visits to the multilingual web pages of United Nations News soared by more than 250 per cent to over 70 million in 2020. Much of the content featured on those pages focused on the work of the Assembly, including the thirty-first special session, held in December 2020 in response to the COVID-19 pandemic. Social media continued to generate interest in the Assembly's goals and activities, especially during the high-level period in September, when most meetings and events had to be conducted virtually. With regard to the Department's efforts to support the Office of the President of the General Assembly, the Department continued to provide a spokesperson, arrange media interviews, monitor media coverage of the President's activities and facilitate connections with civil society, academia and celebrities. The Department also worked with the Office of the President to create a dedicated COVID-19 web page to meet Member States' needs by consolidating information related to the Assembly's novel working arrangements during the pandemic. In an interactive segment, five delegations, including on behalf of one group, asked questions about the briefing, particularly on multilingualism, efforts to reduce and prevent misinformation and ways in which the Assembly could contribute to the implementation of the mandate of the Department. The Under-Secretary-General responded by reiterating that the use of all six official languages of the United Nations was a priority, especially to convey information related to the COVID-19 pandemic.

2. In a subsequent debate, delegations focused on the role and authority of the Assembly, especially from the perspective of its relationship with the other principal organs. The ongoing global health crisis amplified the need to strengthen the central role and authority of the Assembly in addressing global challenges, as well as the critical importance of a reinvigorated multilateralism and international cooperation. One group stressed the necessity of complete observance by the Security Council of all relevant Charter provisions, as well as of Assembly resolutions, and reiterated the importance of the Council reporting to the Assembly, as well as the need for more analytical annual reports and special subject-oriented reports on issues of current international concern. Others stated that the best way to enhance the role and authority of the Assembly was to improve its efficiency and effectiveness by focusing on current priorities and suggested reducing the length and number of resolutions and other outcome documents and focusing on their operational aspects. They urged that concrete steps be taken collectively towards more effective mandate delivery, while making better use of the resources available. Many delegations called for greater coherence in the work of the various principal organs, including the rationalization of agendas. The importance of implementing the 2030 Agenda for Sustainable Development was also highlighted. Speakers stressed the importance of

multilingualism as a fundamental value of the United Nations and called for the equal treatment of all official languages in all activities of the Organization, while expressing regret at the severe negative effect of the pandemic on multilingualism. Some delegations emphasized the importance of including other stakeholders in the work of the Assembly and its Main Committees, as well as improving the possibility of such participation, including by virtual means. Delegations looked forward to the analysis and lessons learned by the Secretary-General pertaining to the impact of COVID-19 on the work of the Assembly, scheduled in March. Delegations noted the progress made in increasing the visibility of the Assembly and requested further measures to enhance public awareness of its role and activities. One group suggested communicating in a citizen-friendly way.

Thematic meeting: the working methods of the General Assembly

3. The Co-Chairs convened the thematic debate on the working methods of the General Assembly virtually on 14 April 2021. In their opening remarks, the Co-Chairs invited the Working Group to reflect deeply on the working methods of the Assembly and its Main Committees and to consider lessons learned from operating under COVID-19 restrictions in 2020. The representatives of the Bureaux of the Main Committees and the Chef de Cabinet of the Office of the President of the General Assembly, on behalf of the President in his capacity as Chair of the General Committee, reflected on experiences in their respective Committees. All briefers noted that, owing to the constrained working arrangements at United Nations Headquarters, and as a consequence of the COVID-19 pandemic, the programmes of work of the Main Committees had to be condensed into fewer meetings. This led to the emergence of a number of innovative working arrangements that enabled the Assembly and its Main Committees to successfully complete their work in an efficient and timely manner.

4. In general, action was taken during in-person meetings, whereas most interactive dialogues, debates and meetings of the working groups of the Main Committees were held virtually with remote simultaneous interpretation. Informal consultations on draft resolutions were also held virtually, without interpretation. Despite the challenges, briefers noted that all Committees broadly succeeded at collaboration and coordination internally in each Main Committee, among Committees and among the different branches of the Secretariat. The President of the General Assembly provided the necessary leadership and was a key partner in the process. In addition, briefers acknowledged helpful use of various tools and platforms, including e-deleGATE, United Nations webcast and virtual meeting and remote simultaneous interpretation platforms.

Briefings by the Chairs of the Main Committees

5. The Chair of the First Committee reported that the organization of work, including any novel methods of work due to the pandemic, had been prepared in consultation with the full membership through the respective regional groups in advance of the session. At its organizational meeting, the Committee considered a logistical note that described these arrangements. One novelty was to compile a 500-page compendium of all statements made in addition to verbatim records so that all members of delegations could have access to all positions expressed. The Committee proceeded in two phases: first, a debate that included an in-person component and three virtual informal meetings; and, second, in-person action on draft proposals. Consideration of proposals took place over the course of five days of in-person meetings and included 80 separate recorded votes. As a recommendation for the future, the Chair stressed the need to

consult the members in advance of the session before applying any innovative working methods to ensure broad agreement and transparency.

The Vice-Chair (Malta) of the Special Political and Decolonization Committee 6. (Fourth Committee) highlighted some of the innovative organizational arrangements adopted at the seventy-fifth session to facilitate the Committee's work in the midst of the pandemic. The organization of work of the Committee during this extraordinary session was the result of extensive consultations and coordination between the incoming Chair, Bureau members-designate, Member States, observers and the Committee secretariat. The balance between in-person meetings for decision-making and the joint general debate and virtual ones for introductory statements was agreed by the Bureau on the basis of the comments on a non-paper on possible options for the working arrangements for the session and subsequent consultations with Member States. Owing to restrictions, the Committee held a consolidated joint general debate on all 12 substantive agenda items before it, on an exceptional basis. A number of written statements under individual agenda items were also submitted to the Committee secretariat and uploaded to the First Committee Place on e-deleGATE and the Committee website. Another novel working arrangement was the convening of two virtual informal meetings on a remote simultaneous interpretation platform to hear introductory statements by the officers of subsidiary bodies and senior Secretariat officials prior to the start of the joint general debate and to engage in an interactive dialogue in a consolidated manner. Informal consultations on draft proposals submitted by Member States were held virtually without interpretation, and main sponsors were encouraged by the Bureau to consider submitting drafts with mostly technical and procedural updates. In addition, the Committee decided, on an exceptional basis, not to have its annual interaction with the representatives of and petitioners on the 17 Non-Self-Governing Territories on its agenda under the decolonization cluster owing to logistical and technical challenges.

7. The Chair of the Second Committee stated that the review of the Committee's working methods was an ongoing process, building on decision 74/537 B. Most of the measures recommended in the decision had been implemented at the seventy-fifth session, in addition to other adjustments to the working methods imposed by restrictions. These measures to revitalize the work of the Committee included: adoption of a theme for the general debate of the Committee; wider use of joint consideration of items in the general discussions; restriction of side events to a maximum of three; a request to focus reports of the Secretary-General, inter alia, on the implementation of the 2030 Agenda and the Addis Ababa Action Agenda and their interlinkages and to include recommendations; and a number of practical measures related to draft resolutions, including the periodicity of some of them. In addition to limiting the number of meetings, reducing time limits and holding virtual meetings, the Committee exceptionally agreed that changes to the draft resolutions should be limited and should comprise one cross-cutting preambular paragraph on the general impact of COVID-19 on economic and development aspects; no more than one preambular paragraph for substantive COVID-19-related aspects; and no more than one operative paragraph related to COVID-19. Technical updates critical to the resolution were also introduced. With regard to further discussions on revitalization, in decision 75/548 A, it was decided that the Bureau of the Committee would convene informal dialogues to discuss the revitalization of the Committee's work in the first months of 2021 and would convene a plenary meeting following those dialogues to take stock of the deliberations and, as appropriate, take action on any recommendations, for subsequent approval by the Assembly. In conclusion, the Chair emphasized that any discussions on the revitalization of the work of the Committee would be conducted while taking into account other ongoing intergovernmental processes linked to its work.

The Rapporteur of the Third Committee (Liechtenstein) noted that, considering 8. the unprecedented situation, the Bureau, in consultation with the members, proposed revised modalities for the work of the Committee during the session, taking into account physical distancing guidelines and constraints related to the pandemic. The lessons learned from the revised modalities could be considered in further rationalizing the work of the Committee. Some resolutions were considered as "technical rollovers" on the recommendation of the Bureau. A single general debate of the Committee was held through six in-person formal meetings, in lieu of separate general discussions on each agenda item or cluster of items. The general debate provided an opportunity for delegations to deliver their statements, in person, virtually, through pre-recorded video statements or in writing, on any or all of the agenda items before the Committee at the session. This resulted in a significantly lower number of formal meetings overall. The interactive dialogues with 64 special procedures mandate holders and other experts and United Nations officials took place through virtual informal meetings using a remote simultaneous interpretation platform. Increasing the periodicity of reports and draft resolutions was one of the key recommendations of the Bureau at the seventy-fourth session. The current Bureau had strongly discouraged the introduction of draft proposals, unless it was in respect of a new draft resolution, and encouraged main sponsors to make only a single short statement prior to action on the draft. None of the 50 draft resolutions were formally introduced. Time management in the Committee remained strong with strict adherence to the agreed time limits and to the timely opening of meetings as well as automatic microphone cut-offs. The Bureau was working on updating the content of the conference room paper describing the methods of work of the Committee, originally prepared by the Bureau of the Committee at the sixty-fifth session.

9. The Chair of the Fifth Committee commented on the current session, drawing on the views expressed by delegations during the negotiations, as well as on the advice and experience of previous Chairs. The working methods of the Committee were unique and had been seriously affected by the pandemic. The Chair said that the Assembly should consider ensuring that the innovative working methods that had been used so far would remain available for use when required. Given the longstanding practice of the Committee to make decisions by consensus, negotiations were often long and difficult. Under current restrictions, long hours of in-person negotiations were not possible, and yet owing to the commitment of delegations to overcoming the challenges, the necessary budgetary and fiscal deadlines were met. The timely availability of documentation was critical for decision-making. The reports of the Secretary-General on administrative and budgetary matters should be considered in conjunction with the reports of the Advisory Committee on Administrative and Budgetary Questions. This required proper planning and timely action to allow for the required revisions so that documentation was available in the official languages. Another continued challenge related to the volume of questions posed in the context of the work. The Committee had taken specific steps to request that written replies provided by the Secretariat to the Advisory Committee also be made available to the Fifth Committee to avoid duplication of questions that required written answers. Another concrete step was to ensure that the Committee had access to useful data on an ongoing basis and in a more user-friendly format. In response to requests from the Committee, the Secretariat established a new portal that provided budget-related information, including expenditures for both the Advisory Committee and the Fifth Committee. The Chair intended to continue to advocate the improvement and expansion of the scope of such information, which was necessary to address the growing demand for data by delegations. In conclusion, he suggested improving synergies among all the Main Committees, especially in the context of programme budget implications.

10. The Chair of the Sixth Committee reported that, after consultations with delegations and given the difference of views as to the holding of meetings in person or virtually and the long-standing practice of consensus, the Committee, on the basis of a recommendation by the Bureau, held its meetings in the following format: plenary meetings were held in person only, whereas Working Group meetings were held online only with remote simultaneous interpretation. Informal consultations on draft resolutions were held online only, without interpretation. Given the constraints, most resolutions and decisions were "technical rollovers". In terms of innovations on working methods introduced to face the unprecedented COVID-19 situation in the Committee, the Chair highlighted: (a) introducing a series of deadlines for the closing of inscription to the list of speakers; (b) agreeing on time limits for the statements, for the first time, a measure that helped to stay on track with the schedule, even in the face of last-minute cancellations of meetings due to the temporary closure of the building; and (c) cancellation of the traditional International Law Week, which is one of the most important and substantive activities of the Committee, and which led to the preparation of a shorter but meaningful activity aimed at partly maintaining the usual environment, to continue to stress the significant role in the codification and progressive development of international law during the seventy-fifth anniversary of the Organization. Expressing regret at the discontinuation of the PaperSmart portal, the Chair reported that the Committee secretariat, at the request of the Bureau and delegations, had been progressively transferring statements previously posted on PaperSmart to the website of the Committee. On a more specific revitalization-related matter, the Bureau of the Committee recommended, from the seventy-sixth session onward, aligning its practice on the election of its Rapporteur with that followed by the majority of the other Main Committees, in accordance with resolution 68/307, whereby the Rapporteur should be selected from the regional group that chaired the previous session.

11. The Chef de Cabinet of the President of the General Assembly, speaking on behalf of the President, expressed hope that some of the innovations, streamlining and pragmatism could help to continue to revitalize the working methods of the Assembly while building back from the pandemic. As an example of the utility of regular General Committee meetings, she recalled the informal meeting held on 30 March, during which the President gave a briefing on forthcoming events, including on the format of and participation at high-level events. At the same meeting, the issue of the ever-increasing number of mandates being assigned to the Assembly was also mentioned by the President. In this regard, the Chef de Cabinet appealed to delegations to continue to look for ways to improve the efficiency of the work and focus on the most critical issues.

12. During the formal debate, many delegations expressed appreciation for the continued dedication and commendable work undertaken by the Office of the President and the Secretariat to ensure business continuity under challenging circumstances. They also welcomed the flexibility and commitment of the Member States, which allowed the Assembly and its Main Committees to conclude the main part of the session efficiently. One group of States reiterated the exceptional nature of the current working methods in the context of the pandemic, as well as the importance of maintaining strict compliance with and adherence to the existing rules of procedure of the Assembly, while welcoming the fact that the Assembly had managed to adapt its working methods to ensure continuous functioning, including through the use of virtual platforms. Many delegations expressed a preference for in-person meetings and intergovernmental negotiations, if the situation allowed and the precautionary measures to mitigate the spread of COVID-19 were fully respected.

13. One group of States reiterated the need to focus on agreed priorities as set out in the 2030 Agenda and the declaration on the commemoration of the seventy-fifth

anniversary of the United Nations (resolution 75/1). In its view, the endless flow of new mandates and initiatives, often lacking a clear added value, distracted from the implementation of the already agreed mandates and from dealing with new global challenges, such as the current pandemic. Many speakers reiterated the need to address the periodicity of the agenda items and resolutions, in consultation with Member States. Some delegations emphasized the need to seek the broadest possible consensus on all decisions and avoid forcing a vote in the Assembly, arguing that it would help with better implementation of the adopted mandates. A group of States proposed considering agreement, as part of the resolution on revitalization, on a list of agenda items that could be addressed every other year and biennializing the resolution on revitalization itself. Delegations reiterated proposals concerning agenda streamlining, including moving away from annual resolutions; covering any new initiatives dealing with an emerging or new challenge by default with a one-off resolution; equipping all recurring existing and new resolutions with a sunset clause; and consolidating agenda items and clustering topics at longer intervals.

14. Some delegations also suggested extending certain innovations required by the COVID-19 pandemic to improve operations into the future, such as holding virtual and hybrid meetings, which would cut down on the cost of travel and reduce the environmental impact. Many speakers welcomed the use of virtual platforms for the negotiation of resolutions, the creative implementation of hybrid meetings and the adoption of decision 75/510, entitled "Procedure for decision-making in the General Assembly when an in-person meeting is not possible", to be used in exceptional circumstances. One delegation welcomed the successful use of the e-voting platform in Geneva by the Human Rights Council, while another delegation questioned the difference in the application of the procedure for remote voting in Geneva from what had been done in New York.

15. Many delegations reiterated the need to preserve and strengthen the sanctity of the general debate. One group of States reiterated its wish that the Working Group formulate guidelines for holding side events during the high-level week. Delegations reiterated that meetings organized in parallel with the general debate of the General Assembly, including those convened by the President of the General Assembly, should be kept to the critical minimum. Many speakers reiterated that multilingualism remained a core value of the United Nations and wished to achieve full parity among the six official languages, including on official websites. Delegations emphasized greater inclusion and participation of various stakeholders in the work of the Assembly, including youth and civil society organizations.

Thematic meeting: selection and appointment of the Secretary-General and other executive heads of the United Nations system

16. The Co-Chairs convened the thematic meeting on the selection and appointment of the Secretary-General and other executive heads of the United Nations system virtually on 23 April 2021 and heard statements from 22 delegations, including on behalf of three groups of States. The Co-Chairs stated that, in 2015, in its resolution 69/321, the General Assembly established the basic criteria for the selection of the Secretary-General, called for the Presidents of the General Assembly and the Security Council to issue a joint letter describing the entire process and proposed that the Assembly conduct interactive hearings with the candidates. Other issues on this thematic cluster remained under discussion, including for the Council to present more than one candidate; the call for a more inclusive, transparent and democratic process; the presentation of highly qualified candidates; and the question of the term of appointment of the Secretary-General. The Co-Chairs stressed that progress had been achieved thanks to the active engagement of the Member States and the cooperation between the Assembly and the Council.

17. Before the debate, the Working Group was briefed by the Director of the Global Strategy and Policy Division, Office of Human Resources, Department of Management Strategy, Policy and Compliance, on the gender and geographical balance of the executive heads of the United Nations system and the Senior Management Group of the Organization, as well as on the issue of candidacies of senior United Nations officials currently holding office, in accordance with paragraph 50 of resolution 73/341, reaffirmed in resolution 74/303. The Director informed the Working Group that 59 per cent of Secretariat staff were men and 41 per cent were women; 39 per cent were from the Western European and other States, 26 per cent were from African States, 19 per cent were from Asia-Pacific States, 9 per cent were from Eastern European States and 7 per cent were from Latin American and Caribbean States. Of the 45 members of the Senior Management Group, 31 members, or 69 per cent, were women. Of the 31 executive heads, 12, or 39 per cent, were women; 45 per cent were from Western European and other countries, 19 per cent were from African countries, 23 per cent were from Asia-Pacific countries, 6 per cent were from Eastern European countries and 6 per cent were from Latin American and Caribbean countries. The Director stated that, since 2016, the number of underrepresented and overrepresented Member States had decreased while the number of Member States "within range" had increased. To achieve geographical representation of Member States, the Secretary-General included a target for "geographical appointments" in the senior managers' compacts. With this target, all senior managers were required to make 50 per cent of appointments to geographical posts from unrepresented and underrepresented Member States. The Geographical Diversity Strategy of the Secretary-General, launched in 2020 and currently being updated, provided a road map and key resources to streamline the efforts to improve geographical representation within all the Secretariat entities. He also informed the Working Group that an important initiative currently under way included a series of consultations with heads of all entities in the Secretariat to accelerate their progress towards equitable geographical representation and gender parity. He added that there was a positive trend in the numbers on gender parity but that the pace was much too slow. Gender parity had been reached at the level of Under-Secretaries-General, among the resident coordinators and in the majority of the entities other than peacekeeping and special political missions. The promulgation of the policy on temporary special measures (ST/AI/2020/5) was a milestone in the efforts to attain gender parity. Progress continued to be monitored through the senior managers' compacts, which included the objective of achieving gender parity in the Professional and higher categories in the Organization. He said that the Office of Human Resources was developing a United Nations talent pool, a technology solution and database of talent from which recruiters across entities could draw to conduct outreach for their vacancies, including to key target groups, such as women and unrepresented and underrepresented Member States.

18. In the subsequent debate, delegations stressed the importance of a more inclusive, transparent and democratic selection process carried out in full compliance with Article 97 of the Charter and relevant provisions of the landmark Assembly resolutions 69/321 and 70/305, which continued to provide a good framework for ensuing an inclusive, transparent, well-structured and merit-based process for the selection and appointment of the Secretary-General. One delegation stated that transparency should be balanced with an understanding of the sensitivity of the process. In this regard, delegations welcomed the joint letter of the Presidents of the General Assembly and Security Council dated 5 February 2021 (A/75/780-S/2021/179) outlining the procedure for Member States presenting candidates and their subsequent consideration, thereby setting in motion the process of selecting and

appointing the Secretary-General for a term beginning in 2022. Delegations welcomed the decision by the incumbent Secretary-General to run for a second term and his willingness to meet the expectations of the United Nations membership regarding transparency and inclusivity in line with relevant Assembly resolutions, in particular his submission of a vision statement and his scheduled participation in an informal dialogue on 7 May 2021. One group of States pointed out that the joint letter and the organization of the informal dialogue, including town hall meetings, were an essential element of the selection and appointment process and should be the main framework to be followed. Another group pointed out the need for clarity regarding the nomination of candidates as well as their withdrawal. One delegation emphasized that there were stumbling blocks in the absence of detailed rules applying to all aspects of the appointment process, for example for the applicants who lacked a recommendation from any Member State. Another delegation welcomed the President's commitment to transparency by continuing to provide a section on the website of the Office of the President on the selection process for the Secretary-General.

19. Many delegations stressed the importance of civil society contribution to the informal dialogue and the town hall and urged that this be replicated and, where possible, strengthened to allow for greater participation, including through virtual means. Some called for more in-depth interaction with candidates within regional groups.

20. Speakers also stressed the importance of establishing a more specific timeline for the overall process. In this regard, one group of States proposed a timeline according to which the joint letter from the Presidents of the General Assembly and the Security Council encouraging Member States to nominate qualified candidates would be sent out in October of the year preceding the appointment; the deadline for the submission of candidatures would be 1 April; the deadline for completing General Assembly hearings would be set for 30 June of the appointment year in order for the process to be concluded upon entering the final quarter of the calendar year ahead of the start of the term of the new Secretary-General; and the recommendation of the Secretary-General and the resolution from the Assembly regarding the appointment of the Secretary-General would be finalized by 1 October of the appointment year to allow three months of preparation for the Secretary-General-designate. One delegation expressed disagreement on a strict deadline, adding that a competent candidate could submit her or his candidature late in the process and the Security Council should retain the flexibility to decide.

21. Delegations requested regular updates from the President of the Security Council to the wider membership on developments in the selection process and full transparency on the results of the straw poll process in a competitive scenario. Speakers proposed further discussion on the prospect of multiple candidates being nominated by the Security Council for consideration by the General Assembly. One delegation proposed a recommended shortlist of at least three candidates with gender parity and in line with best practice in other senior appointments at the United Nations. Another delegation proposed that, upon recommendation of the Council, the Secretary-General be appointed through a secret ballot in the Assembly.

22. Many delegations encouraged Member States to consider nominating women candidates for the position of Secretary-General, as a woman had never led the United Nations in its 75-year history.

23. Some delegations proposed having a thorough discussion on the term of office of the Secretary-General, including on a longer, single, non-renewable term for future appointments.

24. Delegations referred to the notes containing lessons learned from the selection process (see A/71/774-S/2017/93 and A/72/514-S/2017/846) and called for the further strengthening of future appointment processes. The possibility of preparing a compendium of best practices and lessons learned on the selection and appointment of the Secretary-General was mentioned, including a clear timetable for the selection process, to be made public by the Presidents of the General Assembly and the Security Council.

25. On the appointment of other executive heads of the United Nations system, many delegations expressed strong appreciation and support for the continued commitment of the Secretary-General to reaching gender parity across the Organization and welcomed the achievement of full gender parity in the Senior Management Group. Speakers stressed that, in line with the provisions of the Charter, the Secretary-General should exercise full independence in the selection of any senior official and urged candidates and Member States to desist from any actions that could compromise this principle. Speakers stressed that there should be no monopoly on senior posts and stressed the importance of recruitment taking place on as wide a geographical basis as possible, in line with resolution 46/232. They recalled the continued need for equal and fair distribution in terms of gender, linguistic and geographical balance of the executive heads of the United Nations system and the Senior Management Group. One delegation proposed that hearings be considered for senior officials appointed by the General Assembly. Another delegation pointed out that the Latin American and Caribbean States remained one of the most underrepresented groups in the Secretariat, together with the Eastern European States, and not only in senior positions.

Thematic meeting: strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly

26. The Co-Chairs convened the thematic meeting on strengthening the accountability, transparency and institutional memory of the Office of the President of the General Assembly on 11 March 2021 virtually. It included briefings by the Chef de Cabinet of the Office of the President of the General Assembly, on behalf of the President of the General Assembly, and the Under-Secretary-General for General Assembly and Conference Management. The briefings were followed by an interactive question-and-answer session and, subsequently, by remarks from 21 delegations, including on behalf of two groups of States. Opening the debate, the Co-Chairs invited views from delegations on ways to further strengthen the position of leadership of the President, including whether the role played by the President at the United Nations had reached its full potential, as well as the size and composition of the Office of the President.

27. The Chef de Cabinet of the Office of the President expressed appreciation to the Department for General Assembly and Conference Management for the excellent support that the Office had received, highlighted the experience of transitioning the Office into the seventy-fifth session and shared the efforts undertaken to increase transparency and accountability, while outlining the staffing and budget issues faced by the Office. One year after the shutdown of United Nations Headquarters in March 2020 due to the pandemic, the Chef de Cabinet expressed appreciation to the President of the General Assembly at the seventy-fourth session and his team, who had found creative ways to ensure the continuous functioning of the Assembly, despite unprecedented challenges. In assuming office in September, the President of the General Assembly at the seventy-fifth session faced challenges similar to those faced by previous Presidents, primarily in connection with the organization of the Office

and preparations for the high-level week within a short period. Referring to the previous discussions in the Working Group about the change of the opening date of the regular session while retaining the dates of the general debate, the Chef de Cabinet recommended reconsidering the issue of advancing the start of the session by at least one week. Owing to the pandemic, the Office had faced additional challenges. For example, all recruitment over the three months prior to the opening of the session had to be done remotely and many members of the Office were able to arrive only on the first day of the session. In 2020, the Office could not benefit from the annual retreat and instead participated in an informal dialogue organized by Finland in October. The induction programme was organized by the Department for General Assembly and Conference Management virtually, and the team had to carry out duties in hybrid mode, online and in person, which resulted in limited social interaction.

28. The Chef de Cabinet said that the seventy-fifth session would be remembered as special because of the first-ever general debate and a number of high-level meetings that had been convened in hybrid mode. Moreover, the Main Committees had concluded their work successfully by having adapted their working methods to hybrid operations. She recalled that the President had briefed the Assembly on his priorities several times, most recently in January 2021. He continued to provide updates on his activities through regular publication of the newsletters, convened regular briefings by the Secretariat on business continuity with the participation of the host country and continued the practice of convening regular monthly meetings with the Presidents of the Security Council and the Economic and Social Council to exchange information and strengthen coordination and cohesion, including the circulation of summaries of the discussions. The President also continued the practice of convening the morning dialogues with the permanent representatives, the summaries of which had been circulated online even though the discussions were considered informal.

29. With regard to staffing, the Chef de Cabinet reported that both gender parity and geographical balance had been achieved in the Office in 2021, with 56 per cent women, half of them in leadership roles. The Office comprised a wide variety of nationalities, and all regional groups were represented. To strengthen the institutional memory of the Office, 13 of the current members of the Office had served previous Presidents. The Office continued to rely on secondments and was grateful to the Member States for providing staff who had brought extensive experience and networks with them for the benefit of the Office. In terms of the allotment of posts from the regular budget, the Chef de Cabinet recommended reconsideration of a decision by the Assembly on strengthening the Office with an additional P-5 post. The post would not only strengthen the institutional memory of the Office but also cover the administrative and financial aspects of managing it. In terms of the regular budget, the Chef de Cabinet suggested also considering a review of the regular budget allocation to the Office, highlighting that, in 1998, Member States approved the establishment of an annual budget for the Office of the President of the General Assembly of \$250,000, to be adjusted for inflation and approved reductions. In 2020, the budget allocated for the Office was \$307,800. In 2021, that was reduced by the Assembly to \$210,800, or \$40,000 less than 12 years ago. The allocation covered hospitality, official travel and other expenditures related to the discharge of the official responsibility of the President. Owing to ongoing health restrictions, very little money was spent in these areas in 2021. Instead, much of the regular budget was consumed by the costs of servicing mandated meetings that were not covered elsewhere, such as extensions into lunchtime and into late evenings to exhaust the lists of speakers, the cost of interpretation on various virtual platforms and payment for non-mandated translation to support multilingualism. In this regard, the Chef de Cabinet urged Member States to be realistic when negotiating modalities for future mandated meetings while expressing full understanding for various political views. Unrealistic modalities had brought extra pressure on the Office in the implementation when sufficient time had not been planned to accommodate all speakers, for example. Referring to the unique challenge faced by the Office at the seventy-fifth session of having to carry out mandates that were postponed in 2020 as a result of the pandemic, she reassured Member States that the President was committed to fulfilling all outstanding mandates with the best possible quality. She asked delegations to carefully consider the already full calendar of meetings of the Assembly before mandating any new activities.

30. The Under-Secretary-General for General Assembly and Conference Management briefed the Working Group on the support provided by the Secretariat to the Office of the President of the General Assembly, which covered staffing, sources of funding and regular Secretariat support available to the Office, while highlighting the wide range of support provided from within the Secretariat, which transcended any one department. With regard to staffing, the Department covered the expenses of five staff members (two D-2, one D-1, one P-5 and one General Service) in the Office. In addition, and also from within its own resources, the Department made available two General Service staff members, who were located in the Office. as well as translators and text processors, as needed. The Department also provided protocol services, as required, and correspondence services. The Department of Operational Support provided a car and a driver for official purposes, as well as office space, including transitional office space during the three-month transition period. The Department of Safety and Security provided a detail of two security officers, including during travel. The President was entitled to select a spokesperson for the term of office from the Department of Global Communications, while legal guidance was provided by the Office of Legal Affairs on an as-needed basis. Other substantive departments and offices were ready to accommodate the needs of the President, as required, for the work of the General Assembly. The Department for General Assembly and Conference Management also provided administrative support for the President's official travels when financed by the United Nations and the trust fund in support of the Office of the President. In terms of other support, the Department fulfilled the role of focal point and assisted the Office throughout the year through conference management support, protocol and institutional memory. The Department would also continue the practice of organizing an induction programme for incoming Presidents.

31. With regard to funding, the 2021 budget was approved at \$210,800. Expenditures in the amount of \$282,100 were reported in 2020. The funding was normally complemented through the redeployment of funds at the discretion of the President in the course of the budget year to cover the costs of official travel, official hospitality, miscellaneous staff expenditures (such as overtime) and other expenditures (such as mobile phones). The President had full discretion over the use of these funds for the official activities of the Office. In the light of the static nature of the funding, a trust fund was established in 2010 for the purpose of complementing the regular budget resources with voluntary funds to support the Office and its programme of work. The General Assembly has stressed the importance of Member States' contributions to the trust fund and encouraged Member States to continue to contribute to it and to allow for unspent contributions from previous sessions to be made available for succeeding terms. Pursuant to the conditions of the trust fund agreement, contributions were usually either earmarked for specific purposes, that is, in support of specific meetings, or broadly utilized for general administrative, logistical and management support associated with a specific Assembly session. Since 2015, the programme support cost for the Office of the President trust fund has been reduced from 13 per cent to 7 per cent. For the seventy-fifth session, the contributors and amounts pledged and received had been listed on the website of the President.

32. In the subsequent question-and-answer segment, four delegations sought clarification on how to strengthen the Office and how the additional P-5 position could increase capacity for the institutional memory of the Office. In response, the Chef de Cabinet said that administrative and finance areas could be strengthened by creating a permanent post that carried this function to decrease the learning curve with the internal workings of the Organization for the incoming team in transition. On what the Assembly could do to avoid overburdening the Office with mandates, the Chef de Cabinet called upon the Member States to be realistic when drafting modalities, that is, not to expect that all Member States would have time to speak when only a one-day high-level meeting was mandated. She suggested building in an expectation in such cases that not all Member States might be able to speak. With regard to the transition period, the Chef de Cabinet responded by explaining how it was organized, highlighting that it was more difficult in 2021 owing to physical distancing and that the learning curve was steep, even with good support from the Secretariat. Moreover, as approved by the Assembly, the budget to support transition could be used only from mid-August. The Under-Secretary-General echoed the statement by the Chef de Cabinet, reminding the delegations to avoid the use of the phrase "within existing resources" when drafting resolutions, as recommended by the Advisory Committee on Administrative and Budgetary Questions and approved by the Assembly at its fifty-seventh session. He called attention to the fact that during the cash liquidity crisis this approach was no longer working, while expressing understanding of the political nature of discussions. On the question about existing measures to support institutional memory, the Under-Secretary-General recalled the induction programme, regular meetings and overall ongoing support from the Department for General Assembly and Conference Management, including its Executive Office on administrative and financial matters.

33. In the subsequent formal debate, 21 delegations spoke, including two groups. Speakers highlighted the importance of strengthening the accountability and transparency of the Office of the President of the General Assembly, including by holding interactive dialogues with the candidates. Many delegations commended the current and former Presidents for their leadership role, which enabled the Assembly to adapt its working methods and continue to perform its essential functions under exceptional circumstances brought about by the pandemic. Delegations welcomed the digital publication of documents by the President, including newsletters and summaries. Speakers referred to the adoption of an oath of office, as well as a code of ethics for the President of the General Assembly, as important milestones. One group suggested extending the practice to other senior posts. Delegations reiterated the need to allocate adequate human and financial resources from the United Nations regular budget to the Office and called for an increase in the regular budget of the amount allocated to it. Delegations recognized that the workload of the Assembly and the mandates given to the Office of the President continued to increase, with the pandemic causing additional strain. Against this background, one group called for efforts to be focused on further streamlining and prioritizing the work of the Assembly in line with our common agenda, as agreed in the declaration on the commemoration of the seventy-fifth anniversary of the United Nations (resolution 75/1). Many speakers welcomed secondments as a mechanism and expressed their continued willingness to loan staff. Delegations also emphasized the need to strive for both gender and geographical balance in the Office, while recognizing the strong achievement in this regard by the President at the seventy-fifth session.

Annex II

Updated inventory chart of General Assembly resolutions on the revitalization of the work of the General Assembly, issued pursuant to resolution 74/303

Explanatory note by the Co-Chairs of the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly (seventy-fifth session)

1. In accordance with paragraph 5 of General Assembly resolution 74/303, in which the Assembly decided that the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly should continue its review of the inventory of Assembly resolutions on revitalization annexed to the report of the Ad Hoc Working Group submitted to the Assembly at its seventy-third session (A/73/956) and, as a result, continue to update the inventory to be attached to the report of the Ad Hoc Working Group at the seventy-fifth session, the Co-Chairs, assisted by the Secretariat, have prepared the updated inventory chart for consideration by Member States.

2. The present inventory chart has been updated to reflect the progress achieved since the adoption of resolution 73/341.

3. The Co-Chairs, assisted by the Secretariat, obtained updated information, where possible, from relevant entities responsible for implementation.

4. The updated inventory chart retains the following two-part structure, which was also utilized in the report submitted at the seventy-third session:

(a) The first part contains unimplemented provisions, in order to focus on their follow-up;

(b) The second part contains implemented provisions, both those that required one-time action and those to be implemented on an ongoing basis, in order to keep track of previous achievements and provide the means to compare with and learn from past experience.

5. The inventory chart does not have a definite character and may be amended at any time by Member States through the Ad Hoc Working Group. Furthermore, it is not intended to, and does not, have any legal effect. It should serve only as a tool to facilitate discussions on the follow-up to the implementation of the previous related resolutions.
