Land violations committed in September 2021

Date	Time	Nature of violation
1 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 17 in Hula, 18 in Yarun, 4 in Duhayrah, 4 in Marwahin and 17 in Mays al-Jabal.
	0800	Inside the occupied Shab'a Farms, at Saddanah, opposite point OP4 of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL), Israeli enemy personnel used three trench diggers to continue levelling the dirt road leading to Tallat al-Saddanah, in the direction of the enemy's Ruwaysat al-Alam position. They also dug a trench about 1 m deep using four trench diggers and two trucks to move the dirt. They were escorted by soldiers who deployed in the area and took up combat positions, The work ended at 1730 hours. The construction vehicles remained where they were, while the enemy personnel left in the direction of occupied territory.
	1000	In occupied Lebanese territory opposite the town of Udaysah, near point TP36(2), an Israeli enemy patrol consisting of three military jeeps approached. Some nine soldiers in military uniform disembarked and pointed their weapons towards Lebanese territory.
	1930	In occupied Lebanese territory opposite the town of Udaysah, three Israeli enemy soldiers crossed the Blue Line. UNIFIL soldiers raised the United Nations flag and signaled to them to go back. The enemy soldiers left in the direction of occupied territory at 1937 hours.
2 September	-	Landmines left behind by the Israeli enemy were detonated as follows: 27 in Hula, 16 in Arab al-Luwayzah, 36 in Yarun, 3 in Duhayrah and 14 in Marwahin.
	0610	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 25 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement situated at the site, while the other 15 took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1500	Outside the town of Shab'a at Birkat al-Naqqar, while civilian Mahir Hamdan was herding livestock, his herd bolted towards the withdrawal line. At that point, from inside the occupied Shab'a Farms, four Israeli enemy vehicles approached. Enemy soldiers tried to corral the herd and lead it into the occupied Shab'a Farms, but were unable to do so. The herd moved back north of Birkat al-Naqqar, where it went with the herder towards the town of Shab'a.
3 September	_	Landmines left behind by the Israeli enemy were detonated as follows: 16 in Hula, 7 in Arab al-Luwayzah, 20 in Amra, 9 in Yarun, 4 in Duhayrah and 12 in Mays al-Jabal.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 personnel in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement situated at

5 September	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 personnel in military uniform approached. Then, several of the patrol members opened a metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement situated at the site, while the other 15 took up positions along the dirt road and pointed their weapons towards Lebanese territory.
