

Information from Non-Self-Governing Territories transmitted under Article 73 *e* of the Charter of the United Nations

Report of the Special Political and Decolonization Committee (Fourth Committee)

I. Introduction

- 1. At its 3rd plenary meeting, on 16 September 2022, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-seventh session the item entitled "Information from Non-Self-Governing Territories transmitted under Article 73 *e* of the Charter of the United Nations" and to allocate it to the Special Political and Decolonization Committee (Fourth Committee).
- 2. At its 1st meeting, on 29 September 2022, the Fourth Committee decided to hold a general debate on decolonization items (agenda items 51 to 55). The general debate on those items was held at the 2nd, 7th, 8th and 9th meetings, on 3, 11, 13 and 14 October.
- 3. At its 9th meeting, on 14 October, the Committee took action on item 51. Statements and observations made in the course of the Committee's consideration of the items are reflected in the relevant summary records.¹
- 4. For its consideration of the item, the Committee had before it the following documents:
- (a) Relevant chapters of the report of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples (A/77/23, chaps. V and XIII);
 - (b) Report of the Secretary-General (A/77/63).

5. At the 2nd meeting, on 3 October, the representative of the Syrian Arab Republic, in his capacity as Rapporteur of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, introduced the report of the Special Committee. At the same meeting, the representative of Cuba, in his capacity as Vice-Chair of the Special Committee, made a statement in which he gave an account of the activities of the Special Committee in 2022.

II. Consideration of a draft resolution contained in chapter XIII of the report of the Special Committee

- 6. At its 9th meeting, on 14 October, the Fourth Committee was informed that draft resolution I, entitled "Information from Non-Self-Governing Territories transmitted under Article 73 e of the Charter of the United Nations", contained in chapter XIII of the report of the Special Committee (A/77/23), had no programme budget implications.
- 7. At the same meeting, the Fourth Committee adopted draft resolution I by a recorded vote of 147 to 2, with 3 abstentions (see para. 8). The voting was as follows:²

III. Recommendation of the Special Political and Decolonization Committee (Fourth Committee)

8. The Special Political and Decolonization Committee (Fourth Committee) recommends to the General Assembly the adoption of the following draft resolution:

Information from Non-Self-Governing Territories transmitted under Article 73 *e* of the Charter of the United Nations

The General Assembly,

Recalling its resolution 1970 (XVIII) of 16 December 1963, in which it requested the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples to study the information transmitted to the Secretary-General in accordance with Article 73 e of the Charter of the United Nations and to take such information fully into account in examining the situation with regard to the implementation of the Declaration, contained in General Assembly resolution 1514 (XV) of 14 December 1960.

Recalling also its resolution 76/85 of 9 December 2021, in which it requested the Special Committee to continue to discharge the functions entrusted to it under resolution 1970 (XVIII),

Stressing the importance of the timely transmission by the administering Powers of adequate information under Article 73 e of the Charter, in particular in relation to the preparation by the Secretariat of the working papers on the Territories concerned,

Mindful of the non-fulfilment of the obligation to transmit information on some Non-Self-Governing Territories in accordance with Article 73 e of the Charter,

Recalling its resolution 75/123 of 10 December 2020 on the Fourth International Decade for the Eradication of Colonialism, and stressing in that regard the need to make real progress towards its full implementation,

Having examined the report of the Secretary-General, 1

- 1. Reaffirms that, in the absence of a decision by the General Assembly itself that a Non-Self-Governing Territory has attained a full measure of self-government in terms of Chapter XI of the Charter of the United Nations, the administering Power concerned should continue to transmit information under Article 73 e of the Charter with respect to that Territory;
- 2. Requests the administering Powers concerned to respect their obligations under Article 73 e of the Charter with regard to each Territory on the agenda of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples;
- 3. Also requests the administering Powers concerned, in accordance with their Charter obligations, to transmit or continue to transmit regularly to the Secretary-General for information purposes, subject to such limitation as security and constitutional considerations may require, statistical and other information of a technical nature relating to the economic, social and educational conditions in the Territories for which they are respectively responsible, as well as the fullest possible information on political and constitutional developments in the Territories concerned, including the constitution, legislative act or executive order providing for the

government of the Territory and the constitutional relationship of the Territory to the administering Power, within a maximum period of six months following the expiration of the administrative year in those Territories;

- 4. *Requests* the Secretary-General to continue to ensure that adequate information is drawn from all available published sources in connection with the preparation of the working papers relating to the Territories concerned;
- 5. Requests the Special Committee to continue to discharge the functions entrusted to it under General Assembly resolution 1970 (XVIII), in accordance with established procedures.
