Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Advisory Committee on Administrative and Budgetary Questions

Report of the Fifth Committee

Rapporteur: Mr. Marinko **Avramović** (Bosnia and Herzegovina)

1. At its 3rd plenary meeting, on 16 September 2022, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-seventh session the item entitled “Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Advisory Committee on Administrative and Budgetary Questions” and to allocate it to the Fifth Committee.

2. At its 11th meeting, on 4 November 2022, the Fifth Committee had before it the following documents:

(a) Note by the Secretary-General concerning the vacancies in the membership of the Advisory Committee on Administrative and Budgetary Questions that would occur as a result of the expiration of the term of office of six of its members on 31 December 2022 ([A/77/101/Rev.1](#));

(b) Note by the Secretary-General concerning a vacancy in the membership of the Advisory Committee on Administrative and Budgetary Questions as a result of the resignation of Donna-Marie Chiurazzi-Maxfield (United States of America), effective 31 December 2022. By that note, the Committee was informed of the nomination by the Government of the United States of Stephani Scheer to fill the vacancy for the remaining period of the term of office of Ms. Chiurazzi-Maxfield ([A/77/101/Rev.1/Add.1](#));

(c) Note by the Secretary-General concerning a vacancy in the membership of the Advisory Committee on Administrative and Budgetary Questions as a result of the resignation of Vidisha Maitra (India), effective 20 September 2022. By that note, the Committee was informed of the nomination by the Government of India of Surendra Kumar Adhana to fill the vacancy for the remaining period of the term of office of Ms. Maitra ([A/77/101/Rev.1/Add.2](#));



(d) Note by the Secretary-General containing the names of six persons nominated by their respective Governments for appointment or reappointment to the Advisory Committee on Administrative and Budgetary Questions for a three-year term of office beginning on 1 January 2023 ([A/C.5/77/5](#)).

3. At the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint or reappoint Udo Fenchel (Germany), Olivio Fermín (Dominican Republic), Carlo Jacobucci (Italy), Ji Haojun (China), Ji-sun Jun (Republic of Korea) and Matsuda Yukiko (Japan) as members of the Advisory Committee on Administrative and Budgetary Questions for a three-year term of office beginning on 1 January 2023 (see para. 5).

4. Also at the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint as members of the Advisory Committee on Administrative and Budgetary Questions Stephani Scheer (United States of America) for a term of office beginning on 1 January 2023 and ending on 31 December 2023 and Surendra Kumar Adhana (India) for a term of office beginning on _____¹ and ending on 31 December 2023 (see para. 5).

Recommendation of the Fifth Committee

5. The Fifth Committee recommends that the General Assembly appoint or reappoint the following persons as members of the Advisory Committee on Administrative and Budgetary Questions:

(a) For a three-year term of office beginning on 1 January 2023:

Udo Fenchel (Germany)
Olivio Fermín (Dominican Republic)
Carlo Jacobucci (Italy)
Ji Haojun (China)
Ji-sun Jun (Republic of Korea)
Matsuda Yukiko (Japan)

(b) For a term of office beginning on 1 January 2023 and ending on 31 December 2023: Stephani Scheer (United States of America);

(c) For a term of office beginning on _____¹ and ending on 31 December 2023: Surendra Kumar Adhana (India).
