Calendar of conferences and meetings of the United Nations for the biennium 2008-2009

Note by the Secretariat

1. The Secretariat is circulating herewith, as an annex to the present note, the calendar of conferences and meetings of the United Nations for the biennium 2008-2009 as adopted by the General Assembly in paragraph 2 of its resolution 62/225, taking into account other resolutions and decisions adopted by the Assembly at its sixty-second session.
2. The calendar of conferences and meetings of the principal organs of the specialized agencies, the International Atomic Energy Agency and treaty bodies established under the auspices of the United Nations for the biennium 2008-2009 is also contained in the annex.
3. In paragraph 4 of its resolution 62/225, the General Assembly noted with satisfaction that the Secretariat had taken into account the arrangements it had requested at its previous sessions concerning Orthodox Good Friday and requested all intergovernmental bodies to observe those decisions when planning their meetings. As required, the decision to avoid holding meetings on 25 April 2008 should be brought to the attention of the intergovernmental or expert bodies whose work programmes include that date. (In 2009, Orthodox Good Friday falls on 17 April.)
