Calendar of conferences and meetings

Adoption of the draft biennial calendar of conferences and meetings of the United Nations for 2016 and 2017

1. The present document contains the draft biennial calendar of conferences and meetings of the United Nations, which includes meetings of organs of the United Nations, their subsidiary bodies, special conferences and expert groups (see annex). Conferences and meetings of the main legislative and executive bodies of the specialized agencies, the International Atomic Energy Agency and treaty bodies established under the auspices of the United Nations are also listed for information.
2. After review by the Committee on Conferences at its substantive session, the draft biennial calendar will be included in the report of the Committee to the General Assembly, together with any updates and/or comments.
3. The Economic and Social Council will consider and approve the provisional calendar of conferences and meetings in the economic, social and related fields (E/2015/L.8) at its Coordination and Management Meeting, to be held from 20 to 22 July 2015. Since the 2015 substantive session of the Council will conclude on 22 July, which is 22 days after the date of submission of the present document, new mandates or changes to existing mandates adopted by the Council at its July Coordination and Management Meeting will be reflected in the updated draft calendar as mentioned in paragraph 2 above.
4. In the preparation of the draft biennial calendar, due regard has been taken of General Assembly resolution 53/208, in particular its paragraph 11, and paragraphs 5 to 9 of Assembly resolution 69/250, in which it was decided that United Nations bodies should be invited to avoid holding meetings on Orthodox Good Friday, Yom Kippur, the Day of Vesak, Diwali, Gurpurab and Orthodox Christmas and that these arrangements should be taken into account when drafting future calendars of conferences and meetings. During the biennium 2016-2017, these days occur on the dates set out in the table below.
