

Committee on Conferences Substantive session of 2020 8–14 September 2020

Agenda and programme of work for 2020

In accordance with General Assembly decision 74/555 of 15 May 2020, entitled "Extension of the procedure for taking decisions of the General Assembly during the coronavirus disease (COVID-19) pandemic", whereby the Assembly decided that its subsidiary organs might take decisions by means of a silence procedure, the annotated provisional agenda for the organizational session for 2020 of the Committee on Conferences was approved by the Committee under a silence procedure that ended on 4 June 2020. An agenda for the substantive session is accordingly issued in the present document for approval by the Committee on the basis of an annotated provisional agenda proposed by the Secretariat (A/AC.172/2020/L.1).

At its 556th meeting, on 9 September 2019, the Committee decided that the substantive session for 2020 would be held from 8 to 14 September 2020. In preparation for the substantive session, a briefing by the Secretariat will be held on 2 September 2020. Other briefings may be scheduled at the request of Member States.

All matters pertaining to conference management stemming from the mandates contained in General Assembly resolutions on the pattern of conferences will be discussed in the report of the Secretary-General (A/75/89), to be issued prior to the substantive session. Statistical and other relevant data are presented as information supplementary to the report.

The draft revised calendar of conferences and meetings of the United Nations for 2021 will be prepared pursuant to section I, paragraphs 1 to 11, of General Assembly resolution 74/252 of 27 December 2019 on the pattern of conferences.

The Secretariat will compile a list of requests for intersessional departures from the approved calendar of conferences and meetings for 2020, together with information on any action taken by the Committee.

The Secretariat will report on requests received pursuant to paragraph 15 of General Assembly resolution 47/202 A and section I, paragraph 7, of Assembly resolution 40/243, for action by the Committee.
