**1. Opening of the session**

The session will be opened by the Chairman of the Committee on Information.

**2. Election of officers**

At the beginning of the twenty-second session, the Committee will elect a Rapporteur to fill the post vacated by the elected member of the Bureau representing the Asian Group and a Vice-Chairman to fill the post vacated by the elected member of the Bureau representing the Group of Latin American and Caribbean States. The newly elected members of the Bureau will serve until the end of the original term, that is, the year 2000.

**3. Adoption of the agenda and programme of work**

The provisional agenda has been adopted on the basis of consultations among the members of the Bureau.

**4. Statement by the Chairman**

The Chairman will address the Committee at the opening meeting.

**5. Statement by the Under-Secretary-General**

The Under-Secretary-General for Communications and Public Information will address the Committee at the opening meeting.

**6. Commemoration of World Press Freedom Day**

Pursuant to General Assembly decision 48/432, 3 May has been declared World Press Freedom Day. It is the intention of the Committee to commemorate the occasion on 3 May.
