At the beginning of its thirty-ninth session, the Committee elected a Chair, two Vice-Chairs and a Rapporteur to serve for the subsequent two years. At the beginning of its fortieth session, the



Committee will consider filling the vacancy for the remaining Vice-Chair for a one-year term.
