



## Organization of the session

## D. Agenda and organization of work

- 1. At its 2nd meeting, on 11 May, the Ad Hoc Committee adopted the provisional agenda, as contained in document A/AC.291/1. The agenda was as follows:
  - 1. Opening of the organizational session.
  - 2. Election of officers:
    - (a) Election of the Chair;
    - (b) Election of the Rapporteur;
    - (c) Election of the Vice-Chairs.
  - 3. Adoption of the agenda and organization of work.
  - 4. Outline and modalities for the further activities of the Ad Hoc Committee:
    - (a) Procedural matters, including the rules of procedure for the functioning of the Ad Hoc Committee;
    - (b) Venue for the sessions of the Ad Hoc Committee;
    - (c) Timeline and schedule of work of the Ad Hoc Committee.
  - 5. Other matters.
  - 6. Adoption of the report on the organizational session.
  - 7. Closure of the organizational session.

## E. Outline and modalities for the further activities of the Ad Hoc Committee

- 3. The Ad Hoc Committee considered agenda item 4, entitled "Outline and modalities for the further activities of the Ad Hoc Committee", at its 2nd and 3rd meetings, held on 11 May. Statements were made by the representatives of the Russian Federation, Sri Lanka, Norway, the United States, the Islamic Republic of Iran, Liechtenstein, Canada, Malaysia, China, Portugal, New Zealand, Mexico, Australia, Japan, Turkey, the Republic of Korea, Switzerland, Costa Rica, Myanmar, Nicaragua, Austria, Indonesia, Cabo Verde, Cuba, India, France, Uruguay, Kyrgyzstan, the Netherlands, Romania, Jamaica, Italy, Egypt, the Philippines, the Bolivarian Republic of Venezuela, Ukraine, Argentina, Czechia, Israel, Germany, the United Kingdom of Great Britain and Northern Ireland, South Africa, Honduras, Pakistan, Bangladesh, Peru, the Dominican Republic, the Syrian Arab Republic, Chile, Papua New Guinea, Estonia, Belarus, the Democratic People's Republic of Korea, Guatemala, Guyana, Trinidad and Tobago, Nigeria, Eritrea and Ecuador.
- 4. Statements were made by the observer for the Holy See and by the representative of the European Union (on behalf of its member States and Albania, Bosnia and Herzegovina, Georgia, Montenegro, North Macedonia and the Republic of Moldova), in its capacity as observer.
