

I. Introduction

- 1. The Secretary-General has the honour to place before the General Committee, for its consideration, the following observations and proposals in connection with the report to be made to the General Assembly by the General Committee regarding the organization of the sixty-ninth regular session and future sessions of the Assembly, the adoption of the agenda and the allocation of items.
- 2. Over the years, the General Assembly has adopted a number of provisions aimed at rationalizing the procedures and organization of the Assembly. Some of those provisions are reproduced in the annexes to the rules of procedure of the General Assembly (A/520/Rev.17).
- 3. The Secretary-General wishes to draw the attention of the General Committee to the resolutions of the General Assembly on the revitalization its work, ¹ the annex to resolution 51/241, entitled "Strengthening of the United Nations system", and resolution 57/301, entitled "Amendment to rule 1 of the rules of procedure of the General Assembly and opening date and duration of the general debate", the provisions of which are reflected in the present document under the relevant sections.

II. Organization of the session

A. General Committee

- 4. The Secretary-General wishes to draw the attention of the General Committee to rule 40 of the rules of procedure and to document A/56/1005 (annex, paras. 9 and 10) pertaining to the functions of the Committee.
- 5. The Secretary-General also wishes to draw the attention of the General Committee to paragraph 5 of the annex to resolution 58/316 pertaining to the functions of the General Committee. The Committee may wish to recall in particular subparagraphs (e) to (h), according to which the General Committee shall continue to consider the further biennialization, triennialization, clustering and elimination of items of the customary agenda of the General Assembly; schedule informal briefings on topical issues; recommend to the Assembly a programme of, and format for, interactive debates on the items of its agenda; and consider ways and means to further improve its working methods to increase its efficiency and effectiveness in all aspects.
- 6. The Secretary-General further wishes to recall that, at the outset of each session, each Vice-President of the General Assembly shall designate a liaison person for the duration of the session. This designation may be made by means of a letter to the President (resolution 55/285, annex, para. 20).

B. Rationalization of work

7. The Secretary-General wishes to draw the attention of the General Committee to relevant resolutions relating to the rationalization of work, including the administrative and financial functioning of the Organization.²

- 8. The Secretary-General also wishes to draw the attention of the General Committee to paragraph 14 of the annex to resolution 55/285, which reads:
 - 14. As regards implementation of paragraph 7 of the annex to resolution 51/241, the President of the General Assembly, after consideration by the Assembly of the report of the Secretary-General on the work of the Organization, shall inform the Assembly of his assessment of the debate on the report in order for the Assembly to determine the need for further action.
- 9. The General Committee may wish to bring to the attention of the General Assembly paragraph 3 of the annex to resolution 58/316, paragraphs 8 and 9 of resolution 59/313 and paragraphs 25 and 26 of the annex to resolution 60/286 pertaining to the practices and working methods of the Main Committees.
- 10. The General Committee may also wish to bring to the attention of the General Assembly that the Main Committees shall meet in substantive session only after the end of the general debate and that the First Committee and the Special Political and Decolonization Committee (Fourth Committee) shall not meet simultaneously and may consider meeting in a sequential manner during the regular session of the General Assembly. This arrangement shall not apply if it affects their respective identities, programmes of work and effective consideration of their agendas (resolution 51/241, annex, paras. 31 and 36).
- 11. The General Committee may wish to bring to the attention of the General Assembly paragraph 13 of resolution 68/307, in which the Assembly encouraged the Main Committees:
- (a) To ensure adequate coordination in their work while avoiding overlap and duplication;
- (b) To elect the Bureau of each Committee at least three months in advance of the session for better coordination and for a smoother handover of the committees' work;
- (c) To benefit from their respective intranet and other online services to facilitate the smooth organization and timely conclusion of their work;
- (d) To share experiences, best practices and lessons learned concerning their respective working methods;
- (e) To further enhance sharing of information on the work and activities of the Main Committees within each Main Committee.
- 12. The General Committee may wish to bring to the attention of the General Assembly paragraph 14 of resolution 68/307, in which the Assembly requested each Main Committee to further discuss its working methods at the beginning of each session, and invited the Chairs of the Main Committees to brief the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly at the sixty-ninth session on any best practices and lessons learned with a view to improving working methods, as appropriate.
- 13. The General Committee may also wish to bring to the attention of the General Assembly the relevant provisions of resolution 68/307 concerning the interim arrangement adopted in decision 68/505 recommending the pattern for the rotation of the Chairs of the Main Committees for the forthcoming five sessions, namely the sixty-ninth to seventy-third sessions, as well as the guidelines on the election of

Chairs and Rapporteurs of the Main Committees as contained in the annex to the resolution.

14. The General Committee may further wish to bring to the attention of the General Assembly relevant provisions contained in resolution 68/307 relating to the request of the General Assembly to the Ad Hoc Working Group on the Revitalization of the Work of the General Assembly to prepare long-term arrangements concerning the election of the Chairs and Rapporteurs of the Main Committees of the Assembly with the aim of establishing a predictable, transparent and fair mechanism, in consultation with regional groups, and to submit them to the Assembly not later than at the seventy-second session, and the invitation to Member States to present proposals and begin early on to give attention to the matter of concluding a future arrangement, which would come into effect at the seventy-fourth session of the Assembly, with the annex to the resolution containing an option to be considered in this context.

C. Opening and closing dates of the session

- 15. In accordance with rule 1 of the rules of procedure, the sixty-ninth regular session of the General Assembly shall begin on Tuesday, 16 September 2014.
- 16. The General Committee may wish to recommend to the General Assembly that the sixty-ninth session of the Assembly recess on Tuesday, 16 December 2014 and close on Monday, 14 September 2015 (rule 2 of the rules of procedure and para. 4 of annex IV to the rules of procedure).
- 17. The General Committee may also wish to recommend to the General Assembly that, during the main part of the session, the First Committee complete its work by Wednesday, 5 November, the Special Political and Decolonization Committee (Fourth Committee) by Thursday, 13 November, the Second Committee by Wednesday, 26 November, the Third Committee by Wednesday, 26 November, the Fifth Committee by Friday, 12 December, and the Sixth Committee by Friday, 14 November 2014.³

D. Seating arrangements

18. In accordance with established practice, the Secretary-General has drawn lots for the purpose of choosing the Member State to occupy the first desk on the General Assembly floor from which the alphabetical seating order will begin. The name drawn was Cuba. The other countries will follow in the English alphabetical order and the same order will be observed in the Main Committees.

E. Schedule of meetings

19. The Secretary-General wishes to recall that, in view of financial constraints, meetings at Headquarters will not be serviced beyond 6 p.m. or on weekends, with the exception of the plenary of the General Assembly and the Security Council. Consequently, meetings of the Main Committees during the sixty-ninth session,

including informal meetings, should start promptly at 10 a.m. and be adjourned by 6 p.m. on weekdays. The Secretary-General also wishes to recall resolution 59/313, in which the Assembly strongly urged all officers presiding over meetings of the Assembly to start such meetings on time.

- 20. The Secretary-General wishes to draw the attention of the General Committee to paragraph 1 (b) of the annex to resolution 58/316, which reads:
 - (b) With effect from the fifty-ninth session of the General Assembly, the meetings of the plenary Assembly shall normally be held on Mondays and Thursdays.
- 21. Furthermore, the Secretary-General wishes to draw the attention of the General Committee to the fact that measures introduced to reduce costs relating to overtime will be strictly enforced.
- 22. The General Committee may wish to recommend to the General Assembly that, in accordance with past practice, it waive the requirement that at least one third of the members of the Assembly in the case of plenary meetings and one quarter of the members of a Main Committee in the case of Main Committee meetings be present in order to declare a meeting open and to permit the debate to proceed. This recommendation would be made on the understanding that such a waiver would not imply any permanent change in the provisions of rules 67 and 108 of the rules of procedure and that the requirement of the presence of a majority of the members for any decision to be taken would be maintained.
- 23. The General Committee may wish to draw to the attention of the General Assembly the need to enhance the coordination of the scheduling of high-level meetings and high-level thematic debates, with a view to optimizing the number and distribution of such events, and the possibility of scheduling future high-level meetings during the first half of the year, from within existing resources, taking into account the calendar of conferences (resolution 68/307).

F. General debate

- 24. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to resolution 57/301 and decision 68/512, the general debate for the sixty-ninth session shall begin at 9 a.m. on Wednesday, 24 September. The Secretary-General recommends that the general debate continue on Saturday, 27 September 2014, in order to maximize the number of speakers during that week. The general debate will continue from Monday, 29 September to Wednesday, 1 October 2014. The General Committee may also wish to bring to the attention of the Assembly that the list of speakers for each day shall be completed and no speakers will be transferred to the next day, notwithstanding the implications for hours of work. Furthermore, there shall be no time limits for statements in the general debate but the Assembly will indicate a voluntary guideline of up to 15 minutes for each statement.
- 25. The General Committee may also wish to bring to the attention of the General Assembly that, pursuant to paragraph 7 of the annex to resolution 58/126, the theme "Delivering on and implementing a transformative post-2015 development agenda" has been proposed for the general debate at the sixty-ninth session.

G. Conduct of meetings, length of statements, explanations of vote, right of reply, points of order and concluding statements

- 26. The General Committee may wish to draw the attention of the General Assembly to the relevant rules of procedure regarding the conduct of meetings, namely, rules 35, 68, 72, 73, 99 (b), 106, 109, 114 and 115.
- 27. The General Committee may also wish to draw to the attention of the General Assembly that explanations of vote should be limited to 10 minutes; that, when the same draft resolution is considered in a Main Committee and in plenary meeting, a delegation should, as far as possible, explain its vote only once, i.e., either in the Committee or in plenary meeting, unless that delegation's vote in plenary meeting is different from its vote in the Committee; and that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day and whenever such meetings are devoted to the consideration of the same item (decision 34/401, paras. 6-8 (A/520/Rev.17, annex V)).
- 28. The General Committee may wish to recommend to the General Assembly that points of order be limited to five minutes.
- 29. With a view to streamlining the procedures of the General Assembly and as another cost-saving measure, the General Committee may wish to recommend to the Assembly that it review the recommendations contained in paragraph 22 of the annex to resolution 51/241 and paragraph 23 of document A/52/855, regarding the length of statements.
- 30. The General Committee may wish to recommend to the General Assembly that, in order to save time at the end of the session, the practice of making concluding statements in the Assembly and its Main Committees should be dispensed with except for statements by the presiding officers (decision 34/401, para. 17 (A/520/Rev.17, annex V)). The General Committee may also wish to draw the attention of the Assembly to resolution 59/313, in which the Assembly invited Member States that are aligned with statements already made by the Chair of a group of Member States, where possible, to focus additional interventions that they make in their national capacity on points that have not already been adequately addressed in the statements of the group in question, bearing in mind the sovereign right of each Member State to express its national position.

H. Records of meetings

- 31. The Secretary-General wishes to recall that, as at past sessions, during the sixty-ninth session verbatim records will continue to be provided for the plenary meetings of the General Assembly and the meetings of the First Committee and summary records will be provided for the other Main Committees and the General Committee of the Assembly. In paragraph 76 of resolution 66/246, the Assembly stressed the importance of an open, transparent and all-inclusive United Nations, and decided to approve the live webcasting, and subsequent web storage, of all the formal meetings of its six Main Committees.
- 32. Furthermore, the General Committee may wish to draw to the attention of the General Assembly that the practice of reproducing statements in extenso as separate documents has been discontinued for all its subsidiary organs that are entitled to

summary records and that any exceptions to this rule may be made by the body concerned only if the statements are to serve as bases for discussion and if, after hearing a statement of the relevant financial implications, the body decides that one or more statements in extenso may be included in the summary record, or reproduced as separate documents or as annexes to authorized documents (resolution 38/32 E, paras. 8 and 9).

33. The General Committee may also wish to recommend to the General Assembly that the practice of not reproducing in extenso statements made in a Main Committee should be maintained for the sixty-ninth session.

I. Resolutions

- 34. The General Committee may wish to bring to the attention of the General Assembly that:
 - Whenever possible, resolutions requesting the discussion of a question at a subsequent session should not call for the inclusion of a separate new item and such discussion should be held under the item under which the resolution was adopted (decision 34/401, para. 32 (A/520/Rev.17, annex V)).
 - Efforts should be made to reduce the number of resolutions adopted by the General Assembly. Resolutions should request reports of the Secretary-General only in cases where that would be indispensable for facilitating the implementation of those resolutions or the continued examination of the question.⁴
 - In order to ensure that resolutions have greater political impact, they should be short, in particular as regards the preambular part, and should focus more on action-oriented operative paragraphs (resolution 57/270 B, para. 69).
 - Whenever possible, for the adoption by the General Assembly of agreed texts of resolutions and decisions, informal consultations should be carried out with the widest possible participation of Member States (resolution 45/45, annex, para. 1 (A/520/Rev.17, annex VII, para. 1)).
 - The terms "takes note of" and "notes" are neutral terms that constitute neither approval nor disapproval (decision 55/488, annex).
- 35. The Secretary-General encourages Member States to transmit all draft resolutions and decisions in electronic form and/or on paper in accordance with the guidelines outlined by the Secretariat. The Secretary-General furthermore encourages Member States to clearly indicate changes to previous resolutions in tracked changes format, using the previously adopted resolution as a base text. The Secretary-General also wishes to inform Member States that the submitters are responsible for ensuring that electronic and paper versions of draft resolutions and decisions are identical in content.
- 36. The General Committee may also wish to bring to the attention of the General Assembly rule 78 of the rules of procedure concerning discussions of and action by the Assembly on proposals. To ensure that copies of proposals may be circulated not

later than the day preceding the meeting at which they will be considered, proposals should be submitted well in advance of the meeting.

J. Documentation

- 37. The General Committee may wish to draw to the attention of the General Assembly that the Assembly, including its Main Committees, should merely take note of those reports of the Secretary-General or subsidiary organs that do not require a decision by the Assembly and should neither debate nor adopt resolutions on them, unless specifically requested to do so by the Secretary-General or the organ concerned (decision 34/401, para. 28 (A/520/Rev.17, annex V)).
- 38. The General Committee may also wish to draw the attention of the General Assembly to section III of resolution 57/283 B regarding the timely issuance of documents in the six official languages of the Assembly. The General Committee may furthermore wish to draw the attention of the Assembly to resolution 59/313, in which the Assembly requested the Secretary-General to ensure that documentation and reports are issued well in advance, in keeping with the six-week rule for the issuance of official documentation simultaneously in all official languages (see resolution 47/202).
- 39. The General Committee may wish to draw the attention of the General Assembly to resolutions 48/264 and 55/285, in which the Assembly emphasized that restraint should be exercised in making requests for new reports and requested more integrated reports, and to resolution 57/270 B, in which it recognized the need to avoid requesting duplicative reports from the Secretary-General.
- 40. The General Committee may wish to draw the attention of the General Assembly to resolution 67/297, in which the Assembly encouraged Member States, United Nations bodies and the Secretariat to continue to consult on the consolidation of documentation in order to avoid duplication of work, and to exercise the fullest possible discipline in striving for concise resolutions, reports and other documentation, inter alia, by referring to previous documents rather than repeating actual content and to focus on key themes; and further called on them to observe existing submission deadlines so as to allow for the timely processing of documents to be examined by intergovernmental bodies.
- 41. The General Committee may wish to draw the following to the attention of the General Assembly:
 - Resolutions should contain requests for observations from States or reports by the Secretary-General insofar as they are likely to facilitate the implementation of the resolutions or the continued examination of the question (resolution 45/45, annex, para. 10 (A/520/Rev.17, annex VII, para. 10)).
 - Member States and entities of the United Nations system should make a serious effort to submit their replies and inputs to requests for information or views pursuant to resolutions of the General Assembly within the prescribed deadlines (resolution 55/285, annex, para. 17).
 - Member States, when seeking additional information, are encouraged to request that they be provided with the information either orally or, if in

writing, in the form of information sheets, annexes, tables and the like (resolution 59/313, para. 17).

- 42. The General Committee may further wish to draw the attention of the General Assembly to paragraph 6 of the annex to resolution 58/316, paragraphs 16 to 19 of resolution 59/313 and paragraph 29 of resolution 60/286 concerning documentation.
- 43. The General Committee may wish to bring to the attention of the General Assembly that, pursuant to section IV, paragraph 21, of resolution 67/237, the Department for General Assembly and Conference Management will offer paper-smart services as an additional support to delegations during the sixty-ninth session.

K. Questions relating to the programme budget

44. The General Committee may wish to draw the attention of the General Assembly to rule 153 of the rules of procedure, which reads:

No resolution involving expenditure shall be recommended by a committee for approval by the General Assembly unless it is accompanied by an estimate of expenditures prepared by the Secretary-General. No resolution in respect of which expenditures are anticipated by the Secretary-General shall be voted by the General Assembly until the Administrative and Budgetary Committee (Fifth Committee) has had an opportunity of stating the effect of the proposal upon the budget estimates of the United Nations.

- 45. Pursuant to rule 153 of the rules of procedure, the Secretariat considers the financial implications of all draft resolutions and decisions of the General Assembly and its subsidiary organs. This process begins once the draft is submitted for issuance as a document of the Assembly. Until then, the Secretariat is not in a position to provide any official view as to whether a draft resolution or decision will have financial implications.
- 46. The General Committee may also wish to bring to the attention of the General Assembly that, in accordance with rule 153 of the rules of procedure, the consideration by the Administrative and Budgetary Committee (Fifth Committee) of any proposal involving expenditure before such a proposal is voted on by the Assembly is mandatory and the rule as formulated does not provide for any exceptions.
- 47. The General Committee may further wish to draw the attention of the General Assembly to the need for initiators of proposals with budgetary implications to clarify a timetable at an early stage with the Chair of the Administrative and Budgetary Committee (Fifth Committee) and the Chair of the Advisory Committee on Administrative and Budgetary Questions, in order to ensure full compliance with rule 153.
- 48. Also with regard to rule 153 of the rules of procedure, and paragraph 13 (d) of decision 34/401, which requires a minimum period of 48 hours before action is taken on a proposal so as to allow the Secretary-General to prepare the programme budget implications of proposals before the Assembly, the General Committee may wish to bring to the attention of the Assembly the fact that, in most cases, more than 48 hours are required for the Secretary-General to review the programme budget implications of proposals before the Assembly.

- 49. The General Committee may also wish to draw the attention of the General Assembly to paragraphs 12 and 13 of decision 34/401 (A/520/Rev.17, annex V), which read:
 - 12. It is imperative that Main Committees should allow sufficient time for the preparation of the estimate of expenditures by the Secretariat and for its consideration by the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee and that they should take this requirement into account when they adopt their programme of work.

13. Furthermore:

- (a) A mandatory deadline, not later than 1 December, should be established for the submission to the Fifth Committee of all draft resolutions with financial implications;
- (b) The Fifth Committee should, as a general practice, consider accepting without debate the recommendations of the Advisory Committee on Administrative and Budgetary Questions on the financial implications of draft resolutions up to a prescribed limit, namely \$25,000 on any one item;
- (c) Firm deadlines should be set for the early submission of the reports of subsidiary organs which require consideration by the Fifth Committee;
- (d) A minimum period of 48 hours should be allowed between the submission and the voting of a proposal involving expenditure in order to allow the Secretary-General to prepare and present the related statement of administrative and financial implications.
- 50. The General Committee may further wish to draw the attention of the General Assembly to regulation 5.9 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2000/8; first adopted in resolution 37/234, annex; the rules in the present revised edition are issued pursuant to resolution 53/207), as well as to Assembly resolution 54/236 and its decision 54/474. Regulation 5.9 reads:

Regulation 5.9. No council, commission or other competent body shall take a decision involving either a change in the programme budget approved by the General Assembly or the possible requirement of expenditure unless it has received and taken account of a report from the Secretary-General on the programme budget implications of the proposal.

Furthermore, the General Committee may wish to draw the attention of the General Assembly to paragraph 6 of its resolution 35/10 A, which reads:

- 6. Decides that all proposals affecting the schedule of conferences and meetings made at sessions of the General Assembly shall be reviewed by the Committee on Conferences when administrative implications are being considered under the requirements of rule 153 of the rules of procedure of the Assembly.
- 51. The General Committee may also wish to draw the attention of the General Assembly to section VI of its resolution 45/248 B on procedures for administrative and budgetary matters, in which the Assembly:

- 1. Reaffirms that the Fifth Committee is the appropriate Main Committee of the General Assembly entrusted with responsibilities for administrative and budgetary matters;
- 2. Reaffirms also the role of the Advisory Committee on Administrative and Budgetary Questions;
- 3. Expresses its concern at the tendency of its substantive Committees and other intergovernmental bodies to involve themselves in administrative and budgetary matters;
- 4. *Invites* the Secretary-General to provide all intergovernmental bodies with the required information regarding procedures for administrative and budgetary matters.
- 52. The General Committee may also wish to draw the attention of the General Assembly to the views expressed by the Advisory Committee on Administrative and Budgetary Questions on the use of the phrase "within available resources" and to the report in which the Committee emphasized the responsibility of the Secretariat to inform the Assembly thoroughly and accurately about whether there are enough resources to implement a new activity.

L. Observances and commemorative meetings

53. Considering past practice, the General Committee may wish to recommend to the General Assembly that it adopt a format for commemorative meetings that includes statements by the President of the General Assembly, the Secretary-General, the Chairs of the five regional groups and the representative of the host country.

M. Special conferences

- 54. The General Committee may wish to draw the attention of the General Assembly to the following:
 - The Committee on Conferences recommended that the General Assembly should instruct the Main Committees to review the number of special conferences of the United Nations already proposed and scheduled in their respective fields of activity prior to deciding upon the scheduling of new and additional special conferences, thus bearing in mind the relevant portions of General Assembly resolution 33/55 (recommendation 6 of the Committee on Conferences, adopted by the Assembly in decision 34/405, para. (b)).
 - The decision of the General Assembly that no more than five special conferences should be held in a given year and that no more than one special conference should be convened at the same time should be strictly implemented.⁸

• The existing principle that United Nations bodies should meet at their respective established headquarters, as provided for in General Assembly resolution 40/243, should be strictly enforced. Whenever the Assembly accepts an invitation from the Government of a Member State to hold a conference or meeting away from established headquarters, the additional cost should be borne in full by that Government. The methods of budgeting these costs should be improved so as to ensure that all additional costs are accounted for.⁹

III. Adoption of the agenda

- 65. The following items of the draft agenda have not been considered previously by the General Assembly:

In connection with item 9 of the draft agenda (Report of the Economic and Social Council), the Secretary-General wishes to recall paragraph 4 (c) of the annex to resolution 58/316, in which the General Assembly decided to consider the item in its entirety in plenary meeting, on the understanding that the administrative, programme and budgetary aspects should be dealt with by the Fifth Committee. The General Committee will recall that, at the fifty-ninth session, it took note of a clarification regarding consideration of the relevant parts of chapter I of the report by the Main Committees concerned. The General Committee may wish to recommend that the Assembly, when considering item 9 in its entirety in plenary meeting, take note of the clarification that, in implementing resolution 58/316, the relevant parts of chapter I of the report of the Economic and Social Council will be considered by the Main Committees concerned, under agenda items already allocated to them, for final action by the Assembly.
- 72. With regard to item 13 of the draft agenda (Integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic, social and related fields), the Secretary-General wishes to recall resolution 57/270 B, in which the General Assembly decided to consider under the item the chapters of the annual report of the Economic and Social Council relevant to the integrated and coordinated implementation of and follow-up to the outcomes of the major United Nations conferences and summits, including through the participation in its discussions of the President of the Council.
- 73. Also in connection with item 13, as well as item 116 (Follow-up to the outcome of the Millennium Summit), of the draft agenda, the Secretary-General wishes to recall paragraph 56 of resolution 60/265, in which the General Assembly decided to dedicate a specific meeting focused on development, including an assessment of progress over the previous year, at each session of the Assembly.
- 74. With regard to sub-item (b) of item 26 of the draft agenda (Social development, including questions relating to the world social situation and to youth, ageing, disabled persons and the family), the Secretary-General wishes to recall paragraph 2 of resolution 68/136, by which the General Assembly decided to devote one plenary meeting during the sixty-ninth session of the General Assembly to the observance of the twentieth anniversary of the International Year of the Family, in order to discuss the role of family-oriented policies in the elaboration of the post-2015 development agenda.
- 75. In connection with item 64 of the draft agenda (Report of the Human Rights Council), the Secretary-General wishes to draw the attention of the General Committee to paragraph 6 of resolution 65/281, by which the General Assembly decided to continue its practice of allocating the item to the plenary and the Third Committee, in accordance with its decision 65/503 A, with the additional

understanding that the President of the Council will present the report in her or his capacity as President to the plenary of the Assembly and the Third Committee and that the Third Committee will hold an interactive dialogue with the President of the Council at the time of her or his presentation of the report of the Council to the Committee.

In connection with item 119 of the draft agenda (Revitalization of the work of the General Assembly), the Secretary-General wishes to draw the attention of the General Committee to resolutions 58/316 and 59/313. In order to facilitate the work of the Main Committees, the General Committee may wish to recommend that the General Assembly also allocate item 119 to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.
- 82. With regard to item 133 of the draft agenda (Programme planning), the Secretary-General wishes to recall paragraph 2 of resolution 68/20, by which the General Assembly re-emphasized the role of the plenary and the Main Committees

The Secretary-General further wishes to recall paragraph 9 of resolution 60/257, by which the Assembly took note of the report of the Office of Internal Oversight Services (A/60/73) and encouraged intergovernmental bodies to make use of the findings in the programme performance report of the Secretary-General and evaluation reports in planning and policymaking. On that basis, the Secretary-General suggests that the General Committee recommend the allocation of item 133 to all the Main Committees and the plenary of the General Assembly to enhance discussion of evaluation, planning, budgeting and monitoring reports.
