Seventy-third session First Committee

Note by the Secretariat

1. At the 3rd plenary meeting of its seventy-third session, held on 21 September 2018, the General Assembly took decisions pertaining to the allocation of agenda items (see [A/73/252](#)), including to the First Committee (see annex).
