Seventy-third session Second Committee

Allocation of agenda items to the Second Committee

Note by the Secretariat

1. At the 3rd plenary meeting of its seventy-third session, held on 21 September 2018, the General Assembly took decisions pertaining to the allocation of agenda items (see A/73/252), including to the Second Committee (see annex).
