Article 9 - Text adopted by the Commission on Human Rights:

- "1. Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has had all the guarantees necessary for his defence.

Panama

It is proposed that the second paragraph of this article be made part of a separate article dealing with the right to security against ex post facto laws, as follows:

Article - No one shall be held guilty of any offence on account of any act or omission which did not constitute an offence under national or international law, at the time when it was committed. Neither can anyone be imposed a heavier penalty than the one that was applicable at the time the offence was committed. Union of Soviet Socialist Republics (E/800)
