

# Curricula vitae\*

# Patrick A. Chuasoto (Philippines)

Mr. Patrick A. Chuasoto is a career Philippine diplomat, with the rank of Chief of Mission Class II, currently serving as the Deputy Chief of Mission of the Embassy of the Republic of the Philippines in Washington D.C. He has been assigned to the Embassy since January 2014.

In the absence of an Ambassador, Mr. Chuasoto served as Charge d'Affaires, ad interim, from 30 June 2016 to 24 November 2017.

Prior to his current posting in Washington D.C., Mr. Chuasoto served as the Special Assistant of two Secretaries of Foreign Affairs from 2009 to 2013.

Mr. Chuasoto was previously assigned to the Permanent Mission of the Philippines to the United Nations in New York for seven years (2003 to 2009) where he held several positions in various United Nations bodies.

Mr. Chuasoto was Alternate Representative to the United Nations Security Council during the Philippines' membership in 2004–2005. His portfolio was the application of Security Council sanctions regimes and Security Council activities in the prevention of armed conflict, peacekeeping and post-conflict peacebuilding.

In 2008, he was elected as Chairman of the Committee on Conferences. He is the first and only Filipino diplomat to hold the post. Mr. Chuasoto was elected Rapporteur of the Fifth Committee (Administrative and Budget) for the 63rd Session of the United Nations General Assembly (2008–2009). He is only the fourth Filipino diplomat to have the distinction of being elected to serve in the Bureau of the Fifth Committee. He returned to the United Nations in May 20101 as a member of the Philippine delegation to the successful 2010 Nuclear Non-Proliferation Treaty Review Conference where the Philippines held the Presidency of the conference.

Before his posting in New York, Mr. Chuasoto served for five years (1998–2002) as Director for ASEAN Economic Cooperation where he handled all aspects of Philippine participation in ASEAN matters concerning trade, investment and finance, including the economic aspects of agriculture, energy, information technology, science & technology, tourism and transport & communications. He was also the focal point for ASEAN cooperation in combating transnational crime, particularly terrorism.

Mr. Chuasoto was conferred the Gawad Mabini Award with the Rank of Commander during the 115th Department of Foreign Affairs Foundation Day celebration on 31 July 2013.

He graduated cum laude from the Ateneo De Manila University with a Bachelor of Science degree Major in Management, Honors Program. He has a Diploma in Trade and Commercial Diplomacy from the Foreign Service Institute and masteral units in International Studies from the University of the Philippines. Mr. Chuasoto also completed the Strategic Management and Leadership Program for Career Ministers conducted by Asian Institute of Management.

Mr. Chuasoto is a member of American MENSA.
