Conclusions and recommendations of special procedures

Report of the Secretary-General

I. Introduction

- 1. The Human Rights Council, in its decision 2/102, requested the Secretary-General and the United Nations High Commissioner for Human Rights to continue their activities in accordance with all previous decisions adopted by the Commission on Human Rights and to update the relevant reports and studies.
- 2. The Commission on Human Rights, in its resolution 2004/76, requested the Secretary-General to issue annually conclusions and recommendations of the special procedures so as to enable further discussion of their implementation. The Commission also requested the High Commissioner to continue to prepare a comprehensive and regularly updated electronic compilation of recommendations made by the special procedures by country, where such did not yet exist. In paragraph 29 of the annex to its resolution 65/281, the General Assembly provided that the Office of the United Nations High Commissioner for Human Rights (OHCHR) would continue to maintain information on special procedures in a comprehensive and easily accessible manner.
- 3. The Secretary-General draws the attention of the Human Rights Council to the conclusions and recommendations included in annual reports and the relevant addenda thereto, submitted by the special procedures to the Council in 2019 at its fortieth, forty-first and forty-second sessions and to the General Assembly at its seventy-fourth session.¹

II. Conclusions and recommendations

4. In 2019, special procedure mandate holders presented 136 reports to the Human Rights Council. They also presented 46 reports to the General Assembly. The recommendations of special procedures are also available, searchable by country, in the Universal Human Rights Index.

A. Thematic reports

- 5. As illustrated by the list of themes addressed by special procedure mandate holders in their reports in 2019 (see annex), a variety of issues have been examined, and States and other stakeholders have been provided with advice on promoting and protecting human rights at the national, regional and international levels. In producing their reports, mandate holders have addressed specific recommendations not only to States and other actors but also to the United Nations, as their reports also relate to various aspects of the work of the United Nations.
- 6. Several reports related to the implementation of the Sustainable Development Goals. They included the report of the Special Rapporteur on the right to education, which focused on the implementation of the right to education and of Goal 4 in the context of the growth of private actors in education (A/HRC/41/37); the report of the Special Rapporteur on the right to food, which addressed the right to food in the context of the Goals (A/74/164); and the reports of the Special Rapporteur on the rights to freedom of peaceful assembly and of association, which focused on civil society participation in the implementation of the Goals (A/74/349) and on practical recommendations for the participation of civil society in the implementation of the 2030 Agenda for Sustainable Development (A/HRC/41/41/Add.2). The Special Rapporteur on the situation of human rights in Cambodia focused on the implementation of the Goals in Cambodia and specifically assessed those at risk of being left behind (A/HRC/42/60 and A/HRC/42/60/Add.1).
- 7. Access to justice was repeatedly addressed by different mandate holders. The Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context looked into access to justice for the right to housing (A/HRC/40/61), while the Independent Expert on the enjoyment of human rights by persons with albinism addressed the right to access to justice for persons with albinism (A/HRC/40/62). The Special Rapporteur on the rights of indigenous peoples looked more generally at the question of indigenous peoples and justice (A/HRC/42/37), while the Special Rapporteur on the situation of human rights defenders addressed, inter alia, access to justice, in his report on impunity (A/74/159).
- 8. The gender perspective and women's human rights featured prominently, with, for example, a report on the gender dimensions of the Guiding Principles on Business and Human Rights by the Working Group on the issue of human rights and transnational corporations and other business enterprises (A/HRC/41/43). Moreover, the Special Rapporteur on the situation of human rights defenders addressed the situation of women human rights defenders (A/HRC/40/60), while the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination focused on the gendered human rights impacts of private military and security companies (A/74/244). The Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment addressed the relevance of the prohibition of torture and other cruel, inhuman or degrading treatment or punishment to the context of domestic violence (A/74/148).
- 9. Furthermore, the Special Rapporteur on violence against women, its causes and consequences focused on a human rights-based approach to mistreatment and violence against women in reproductive health services, with a focus on childbirth and obstetric violence (A/74/137). The Working Group on discrimination against women and girls addressed women's deprivation of liberty (A/HRC/41/33). Lastly, the Special Rapporteur on the human rights of migrants produced two studies, one on the impact of migration on migrant women and girls (A/HRC/41/38) and another on good practices and initiatives on gender-responsive migration legislation and policies (A/74/191).
- 10. There was also a focus on prevention, with the report of the Special Rapporteur on the right to education who focused on the right to education and the prevention of atrocity crimes and mass or grave human rights violations (A/74/243). In this context, the Special Rapporteur on the promotion of truth, justice, reparation and guarantees of non-recurrence examined practical experiences of domestic reparation programmes (A/HRC/42/45) and addressed the question of apologies for gross human rights violations and serious violations of international humanitarian law (A/74/147).

- 11. Several reports related to migration issues. The Independent Expert on human rights and international solidarity looked at the criminalization or suppression of the rendering of humanitarian assistance to migrants and refuges who enter a State in an irregular manner (A/HRC/41/44). The focus of the reports of the Special Rapporteur on the human rights of migrants was on the impact of migration on migrant women and girls (A/HRC/41/38) and on good practices and initiatives on gender-responsive migration legislation and policies (A/74/191).
- 12. The environment also featured prominently, with a report on climate change and poverty by the Special Rapporteur on extreme poverty and human rights (A/HRC/41/39 and Corr.1) as well as a report on the right to development and disaster risk reduction by the Special Rapporteur on the right to development (A/74/163). The reports of the Special Rapporteur on the issue of human rights obligations relating to the enjoyment of a safe, clean, healthy and sustainable environment focused on the right to breathe clean air (A/HRC/40/55) and on climate change (A/74/161).
- 13. Emerging issues such as the impact of new technologies on human rights were addressed in the reports of the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression, which looked into surveillance and human rights (A/HRC/41/35) and hate speech online (A/74/486); in the report of the Special Rapporteur on the right to privacy, which focused on surveillance and health data (A/74/277); in the report of the Special Rapporteur on the rights to freedom of peaceful assembly and of association, which looked at opportunities and challenges facing the rights to freedom of peaceful assembly and of association in the digital age (A/HRC/41/41); and in the report of the Special Rapporteur on extreme poverty and human rights, which addressed the impact of the use of digital technologies in social protection systems on the enjoyment of human rights (A/74/493).

B. Country reports

- 14. Over the three sessions of the Human Rights Council, 62 country reports were presented by thematic mandate holders. The annex contains a detailed list of all the country reports.
- Fifteen visit reports concerned African countries: Botswana (Special Rapporteur on minority issues), Cabo Verde (Special Rapporteur on the right to development), Chad (Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination), Egypt (Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context), Kenya (Independent Expert on the enjoyment of human rights by persons with albinism, and Working Group on the issue of human rights and transnational corporations and other business enterprises), Lesotho (Special Rapporteur on the human rights to safe drinking water and sanitation), Morocco (Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance), Mozambique (Independent Expert on protection against violence and discrimination based on sexual orientation and gender identity, and Independent Expert on the enjoyment of all human rights by older persons), Niger (Special Rapporteur on the human rights of migrants), Nigeria (Special Rapporteur on trafficking in persons, especially women and children) and Tunisia (Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism, Special Rapporteur on freedom of religion or belief, and Special Rapporteur on the rights to freedom of peaceful assembly and of association).
- 16. Seventeen visit reports concerned countries in the Asia-Pacific region: Bhutan (Working Group on Arbitrary Detention), Fiji (Independent Expert on the enjoyment of human rights by persons with albinism), Indonesia (Special Rapporteur on the right to food), Kyrgyzstan (Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health), Lao People's Democratic Republic (Special Rapporteur on the sale and sexual exploitation of children, including child prostitution, child pornography and other child sexual abuse material, and Special Rapporteur on extreme poverty and human rights), Malaysia (Special Rapporteur on the sale and sexual exploitation of children, including child prostitution, child pornography and other child sexual abuse material, Special Rapporteur in the field of cultural rights, Special Rapporteur

on the human rights to safe drinking water and sanitation), Nepal (Special Rapporteur on violence against women, its causes and consequences), Republic of Korea (Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context), Saudi Arabia (Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism), Sri Lanka (Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism, and Independent Expert on the effects of foreign debt and other related international financial obligations of States on the full enjoyment of all human rights, particularly economic, social and cultural rights), Thailand (Working Group on the issue of human rights and transnational corporations and other business enterprises), Timor-Leste (Special Rapporteur on the rights of indigenous peoples) and Viet Nam (Special Rapporteur on the right to food).

- 17. Nine visit reports relating to Eastern Europe were presented: Armenia (Special Rapporteur on the rights to freedom of peaceful assembly and of association), Georgia (Independent Expert on protection against violence and discrimination based on sexual orientation and gender identity), Poland (Working Group on discrimination against women and girls), Republic of Moldova (Special Rapporteur on the situation of human rights defenders), Serbia and Kosovo² (Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment), Slovenia (Special Rapporteur on minority issues) and Ukraine (Independent Expert on the effects of foreign debt and other related international financial obligations of States on the full enjoyment of all human rights, particularly economic, social and cultural rights, Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment, Working Group on Enforced or Involuntary Disappearances).
- 18. Eight visit reports related to Latin America and the Caribbean: Argentina (Special Rapporteur on the right to food, Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment, Working Group of Experts on People of African Descent), Ecuador (Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression, Special Rapporteur on the rights of indigenous peoples), Honduras (Special Rapporteur on the situation of human rights defenders, Working Group on discrimination against women and girls) and Uruguay (Independent Expert on the enjoyment of all human rights by older persons).
- Thirteen visit reports related to countries in the Group of Western European and Other States: Austria (Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination), Belgium (Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism, and Working Group of Experts on People of African Descent), Canada (Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health, and Special Rapporteur on violence against women, its causes and consequences), France (Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism, and Special Rapporteur on the rights of persons with disabilities), Ireland (Special Rapporteur on the sale and sexual exploitation of children, including child prostitution, child pornography and other child sexual abuse material), Italy (Special Rapporteur on contemporary forms of slavery, including its causes and consequences), the Netherlands (Independent Expert on human rights and international solidarity), Sweden (Independent Expert on human rights and international solidarity) and the United Kingdom of Great Britain and Northern Ireland (Special Rapporteur on extreme poverty and human rights, and Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance).
- 20. In addition, the following country mandate holders presented reports about the situation in the country they have been mandated to report on: Special Rapporteur on the situation of human rights in Belarus, Special Rapporteur on the situation of human rights in Cambodia, Independent Expert on the situation of human rights in the Central African Republic, Special Rapporteur on the situation of human rights in the Democratic People's Republic of Korea, Special Rapporteur on the situation of human rights in Eritrea, Special Rapporteur on the situation of human rights in Eritrea, Independent

Expert on the situation of human rights in Mali, Special Rapporteur on the situation of human rights in Myanmar, Special Rapporteur on the situation of human rights in the Palestinian territories occupied since 1967, Independent Expert on the situation of human rights in Somalia, Independent Expert on the situation of human rights in the Sudan.

- 21. The Sustainable Development Goals were covered in several recommendations in country reports. The Special Rapporteur on the sale and sexual exploitation of children, including child prostitution, child pornography and other child sexual abuse material referred to them in regard to her visit to Malaysia (A/HRC/40/51/Add.3) and to the Lao People's Democratic Republic (A/HRC/40/51/Add.1). The Special Rapporteur on the right to food addressed the Goals in her conclusions following her visit to Viet Nam (A/HRC/40/56/Add.1), as did the Independent Expert on the effects of foreign debt and other related international financial obligations of States on the full enjoyment of human rights, particularly economic, social and cultural rights, following his visits to Ukraine (A/HRC/40/57/Add.1) and to Sri Lanka (A/HRC/40/57/Add.2), the Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context, in regard to her visits to the Republic of Korea (A/HRC/40/61/Add.1) and to Egypt (A/HRC/40/61/Add.2), and the Independent Expert on the enjoyment of human rights by persons with albinism, following her visits to Fiji (A/HRC/40/62/Add.1) and to Kenya (A/HRC/40/62/Add.3).
- 22. Furthermore, the Special Rapporteur on the rights to freedom of peaceful assembly and of association included the Sustainable Development Goals in his recommendations to Tunisia (A/HRC/41/41/Add.3) and to Armenia (A/HRC/41/41/Add.4), as did the Independent Expert on human rights and international solidarity in his reports on the Netherlands (A/HRC/41/44/Add.2) and on Sweden (A/HRC/41/44/Add.1), as well as the Special Rapporteur on the right to development following his mission to Cabo Verde (A/HRC/42/38/Add.1). The 2030 Agenda was also addressed by the Special Rapporteur on contemporary forms of slavery, including its causes and consequences, in her report on Italy (A/HRC/42/44/Add.1), by the Special Rapporteur on the human rights to safe drinking water and sanitation after his visit to Lesotho (A/HRC/42/47/Add.1), by the Working Group of Experts on People of African Descent following visits to Belgium (A/HRC/42/59/Add.1) and to Argentina (A/HRC/42/59/Add.2), and by the Special Rapporteur on the situation of human rights in Cambodia following her visits to that country (A/HRC/42/60 and A/HRC/42/60/Add.1).
- 23. The question of migration featured in the reports of the Special Rapporteur on the sale and sexual exploitation of children, including child prostitution, child pornography and other child sexual abuse material, following her visit to Malaysia, of the Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment, in his report on Serbia and Kosovo (A/HRC/40/59/Add.1), of the Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context, after her visit to the Republic of Korea, of the Working Group on discrimination against women and girls, following its visit to Honduras (A/HRC/41/33/Add.1), and of the Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health, in the context of his visits to Kyrgyzstan (A/HRC/41/34/Add.1) and to Canada (A/HRC/41/34/Add.2). Migration was naturally omnipresent in the conclusions and recommendations of the Special Rapporteur on the human rights of migrants following his visit to the Niger (A/HRC/41/38/Add.1).
- 24. The Special Rapporteur on violence against women, its causes and consequences further addressed migration in her report on her visit to Canada (A/HRC/41/42/Add.1), as did the Working Group on the issue of human rights and transnational corporations and other business enterprises after its visit to Thailand (A/HRC/41/43/Add.1), the Independent Expert on human rights and international solidarity in his report on the Netherlands and Sweden, the Special Rapporteur on trafficking in persons, especially women and children, following her visit to Nigeria (A/HRC/41/46/Add.1), as well as the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, in her reports on Morocco (A/HRC/41/54/Add.1) and on the United Kingdom (A/HRC/41/54/Add.2). Migration was also covered by the Special Rapporteur on contemporary forms of slavery, including its causes and consequences, in her report on Italy, by the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination, in its report on its visit to Austria

- (A/HRC/42/42/Add.2), and by the Working Group of Experts on People of African Descent following visits to Belgium and Argentina.
- 25. Conclusions and recommendations on the environment were made by the Special Rapporteur on the right to food following her visit to Viet Nam, by the Special Rapporteur on extreme poverty and human rights in his report on his visit to the Lao People's Democratic Republic (A/HRC/41/39/Add.2 and Corr.1), by the Working Group on the issue of human rights and transnational corporations and other business enterprises after its visits to Thailand and to Kenya (A/HRC/41/43/Add.2), and by the Special Rapporteur on the rights of indigenous peoples in her reports on Ecuador (A/HRC/42/37/Add.1) and on Timor-Leste (A/HRC/42/37/Add.2).
- 26. Lastly, several special procedure mandate holders presented reports on follow-up to visits. The Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression made recommendations within the follow-up to the visits to Côte d'Ivoire (2004), Israel and the occupied Palestinian territory (2011), Honduras (2012), Japan (2016) and Turkey (2016) (A/HRC/41/35/Add.2). The Working Group on Enforced or Involuntary Disappearances presented a report on the follow-up to visits to Peru and Sri Lanka (A/HRC/42/40/Add.1). The Special Rapporteur on the human rights to safe drinking water and sanitation produced four separate reports on follow-up to visits to Portugal, El Salvador, Botswana and Tajikistan (A/HRC/42/47/Add.3-Add.6).

C. Communications reports

- 27. The special procedure mandate holders presented three communications report, one at each session of the Human Rights Council. The March report contained communications sent by all mandate holders between 1 June and 30 November 2018 (A/HRC/40/79), the June report contained the communications that had been sent by all mandate holders between 1 December 2018 and 28 February 2019 (A/HRC/41/56) and the September report contained the communications sent by all mandate holders between 1 March and 31 May 2019 (A/HRC/42/65).
- 28. Several mandate holders also presented reports containing observations on communications sent and responses received: the Special Rapporteur on the situation of human rights defenders (A/HRC/40/60/Add.1 and Corr.1), the Special Rapporteur on extrajudicial, summary or arbitrary executions (A/HRC/41/36/Add.1) and the Special Rapporteur on the rights to freedom of peaceful assembly and of association (A/HRC/41/41/Add.1).

D. Other reports

- 29. The Chair of the Coordination Committee of Special Procedures presented the report on the twenty-fifth annual meeting of special rapporteurs/representatives, independent experts and Chairs of working groups of the special procedures of the Human Rights Council, including updated information on special procedures (A/HRC/40/38). The report was accompanied by an addendum with relevant facts and figures (A/HRC/40/38/Add.1). The report contains information on what has been achieved by mandate holders individually and as a system in 2019.
- 30. The Special Rapporteur on minority issues presented a report containing the recommendations made at the eleventh session of the Forum on Minority Issues, which was held on 29 and 30 November 2018 and considered the theme "Statelessness: a minority issue" (A/HRC/40/71).
- 31. The Independent Expert on the effects of foreign debt and other related international financial obligations of States on the full enjoyment of human rights, particularly economic, social and cultural rights, presented a report entitled "Guiding principles on human rights impact assessments of economic reforms" (A/HRC/40/57).
- 32. The Special Rapporteur in the field of cultural rights presented a report to mark the tenth anniversary of the mandate and took the opportunity to suggest strategies for advancing cultural rights during the next decade (A/HRC/40/53).

- 33. The Independent Expert on the enjoyment of human rights by persons with albinism presented a report on a round table on human rights and albinism which focused on seeking consensus and priorities on advocacy and research (A/HRC/40/62/Add.2).
- 34. The Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression presented a report giving an overview of submissions received for the preparation of his thematic report on surveillance and human rights (A/HRC/41/35/Add.3), as well as a summary of an expert consultation held as part of the preparation of the thematic report (A/HRC/41/35/Add.4).
- 35. The Working Group on the issue of human rights and transnational corporations and other business enterprises presented a report describing the proceedings and thematic recommendations of the seventh Forum on Business and Human Rights, held from 26 to 28 November 2018 in Geneva (A/HRC/41/49). The title of the 2018 Forum was "Business respect for human rights building on what works".
- 36. The Special Rapporteur on the human rights of internally displaced persons presented a report on the global and national activities under the twentieth anniversary of the Guiding Principles on Internal Displacement (A/HRC/41/40/Add.1).
- 37. The Special Rapporteur on violence against women, its causes and consequences presented a report on the 25 years of the mandate: an analysis of its evolution, current challenges and the way forward (A/HRC/41/42 and Corr.1).
- 38. The Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance presented a report on combating glorification of Nazism, neo-Nazism and other practices that contribute to fuelling contemporary forms of racism, racial discrimination, xenophobia and related intolerance, with a specific analysis of efforts by contemporary Nazi, neo-Nazi and other extremist groups to recruit and radicalize young people (A/HRC/41/55) and another report on antisemitism within this same framework (A/74/253).
- 39. The Special Rapporteur on the right to development presented a report on guidelines and recommendations on the practical implementation of the right to development (A/HRC/42/38).
- 40. The Special Rapporteur on the implications for human rights of the environmentally sound management and disposal of hazardous substances and wastes presented a report on principles on human rights and the protection of workers from exposure to toxic substances (A/HRC/42/41).
- 41. Finally, the Special Rapporteur on the negative impact of unilateral coercive measures on the enjoyment of human rights presented elements for a draft General Assembly declaration on unilateral coercive measures and the rule of law (A/HRC/42/46/Add.1).

III. Human Rights Council sessions overview

A. Fortieth session of the Human Rights Council

- 42. At the fortieth session of the Human Rights Council, the following 19 special procedure mandate holders 14 holders of thematic mandates and 5 holders of country mandates presented their annual reports:

- 43. The Special Rapporteur on the situation of human rights in Eritrea participated in the enhanced interactive dialogue on Eritrea, and the Independent Expert on the situation of human rights in the Central African Republic participated in the high-level interactive dialogue on the Central African Republic.

B. Forty-first session of the Human Rights Council

- 44. At the forty-first session of the Human Rights Council, the following 19 special procedure mandate holders 17 holders of thematic mandates and 2 holders of country mandates presented their annual reports:
