- 1. Honduras welcomes the recommendations made by the 85 States that actively participated in the constructive review of the human rights situation in Honduras during the thirty-sixth session of the Working Group on the Universal Periodic Review.
- 2. During the review, Honduras undertook to carry out a thorough analysis of the recommendations. To that end, it launched broad inter-agency consultations with 41 State institutions working in relevant areas, in order to carefully examine the 223 recommendations that had been made.
- 3. As a result of that process, it can be reported that, of the 223 recommendations received during the session of the Working Group on the Universal Periodic Review, none have been rejected, 203 have been accepted and 20 have been noted.
